Chair Aquino and Members of the Committee:

The Department of the Attorney General supports the nomination of Clark Hirota to the position of board member on the Hawaii Labor Relations Board (HLRB).

The HLRB primarily presides over matters related to public and private sector collective bargaining, pursuant to chapters 89 and 377, Hawaii Revised Statutes (HRS). It also hears appeals from citations and orders by the Hawaii Occupational Safety and Health Division, under chapter 396, HRS.

Mr. Hirota has the knowledge and experience necessary to make him an excellent contributor to the HLRB.

An attorney licensed in the State of Hawaii (he is currently on voluntary inactive status), Mr. Hirota has ten years of prior legal experience in the area of labor and employment law. This includes serving as an associate attorney for six years at the law firm of King, Nakamura & Chun-Hoon, where he practiced labor and employment law, and represented clients before administrative boards, including the HLRB. He was a Labor Counselor for the Office of the Staff Judge Advocate for six months where he appeared on behalf of the Army in labor arbitration proceedings, and before the Merit Systems Protection Board, Federal Labor Relations Board, and Equal Employment Opportunity Commission. He also served as a Deputy Corporation Counsel for the City

and County of Honolulu, where he was assigned to the Department of the Corporation Counsel's Personnel Section. There, he was an advocate in interest arbitrations, grievance arbitrations, and in administrative proceedings before the HLRB.

In addition to his legal experience, for the past fifteen years, Mr. Hirota has been directly involved in labor relations, as a Labor Specialist for the City's Department of Human Resources. In this capacity, he advised, represented, and advocated for various City departments in labor matters involving numerous public unions; conducted training on City policies and labor issues; assisted with interest arbitrations; and presided as a hearings officer over contested cases.

Finally, Mr. Hirota has experience presiding over proceedings similar to those of the HLRB. For nearly five years, he was a panel member on the Hawaii Health Systems Corporation's (HHSC) Merit Appeals Board (MAB), where he heard and decided appeals relating to the civil service of the HHSC. His duties on the HHSC MAB were similar to those he would perform on the HLRB, as both boards are responsible for hearing and deciding contested case hearings concerning management-employee disputes.

Based on the considerations above, we believe that Mr. Hirota will be an excellent addition to the HLRB, and we respectfully request this Committee to recommend that the Senate advise and consent to his appointment as an HLRB member.

#### TESTIMONY OF LOWELL K.Y. CHUN-HOON RE: GM 726, CONFIRMATION OF CLARK HIROTA TO THE HAWAII LABOR RELATIONS BOARD

Thank you for the opportunity to present testimony regarding the nomination of Clark Hirota to the Hawaii Labor Relations Board. I am pleased to support his nomination.

I have practiced labor law in Hawaii for more than 46 years and have represented public and private sector unions during that time, although I offer this testimony purely in my capacity as a private citizen. My practice includes a number of past appearances before the Hawaii Labor Relations Board and the National Labor Relations Board, and representing unions in hundreds of labor arbitrations since 1977. I also have had the good fortune to have served as Mr. Hirota's supervisor early in his career, when he was a young lawyer and associate at the lawfirm of King, Nakamura & Chun-Hoon from 1998-2004.

Mr. Hirota's resume attests to the vast and varied nature, as well as the depth, of his industrial relations experience. He has regularly confronted and addressed many of the most difficult and trying issues in this field of specialization-- employee discipline, seniority, personnel selection, outsourcing, union recognition, and the fair conduct of representational elections. I cannot say that I have always agreed with the positions he has taken on behalf of his institutional clients, and I do not anticipate I will agree with all of his future decisions, but I am confident that he will approach the task of adjudication with an open mind, an even temperament, and a passion to achieve justice. Moreover, he will handle the resolution of these disputes with a combination of common sense, intellectual rigor, and practicality that will promote fair and harmonious collective bargaining.

Although he is designated to be the Employer representative on the Board, I also know from direct personal experience that he is a person of compassion, generosity, and humility. He will be a gracious and supportive colleague to other board members. Behind his devotion to duty

and principle, there lies a quiet and refreshing sense of humor. That quality can be precious in the contentious realm of labor relations.

I remember that as a young attorney he was supportive but critical in his evaluation of the claims of each client, but took pains to assure that every client was given an opportunity to be heard and effectively represented, irrespective of what he personally thought of the merits of the client's claim. Mr. Hirota was skilled at cross examination and judicious in knowing the limits and boundaries of what he could honestly argue that was consistent with provable fact and in conformity with legal precedent. He was balanced and analytically precise in his legal judgments.

I also recall in particular that he was assigned to represent an immigrant worker at a major neighbor island resort who had been discharged. The employee had overzealously used powerful cleaning chemicals to clean a massive fish pond. While the pond was cleaned immaculately, the employee did not foresee the disastrous effect it would have on the population of beautiful koi.

Despite this ecological catastrophe, Mr. Hirota succeeded in securing the reinstatement of the grievant, and the grateful employee presented him, following his reinstatement, with a dignified sandstone carved nameplate for his desk. The case result was gratifying and reflected superb legal advocacy in overcoming serious but entirely unintentional employee misconduct.

In sum, I applaud Governor Green's appointment of Mr. Hirota to the Hawaii Labor Relations Board because Mr. Hirota is a person of unassuming integrity who has, as noted above, demonstrated high legal competence, firm adherence to ethical principles, and sound judgment and discretion. I urge that the Committee swiftly confirm his nomination.

#### **TESTIMONY OF TOM CESTARE**

Thank you for the opportunity to present testimony regarding the nomination of Clark Hirota to the Hawaii Labor Relations Board.

I am the former head of the National Labor Relations Board's Sub-Regional Office in Honolulu and worked for the NLRB for more than forty years. I am also currently a labor arbitrator and mediator. My testimony and endorsement of Mr. Hirota, however, is purely in my capacity as a private citizen who has known and worked with him in the past.

Trust and integrity are the cornerstones of stable and effective labor relations, and Mr. Hirota has embodied those qualities during the many years I have known him. While collective bargaining and grievance adjudication is an area which sometimes provokes significant conflict and disagreement, Mr. Hirota has always demonstrated thoughtfulness, patience, and an openminded and even-tempered manner in dealing with others while remaining committed to principle and the interest of the parties he represented.

The Hawaii Labor Relations Board performs an essential role regulating public and private sector industrial relations to ensure compliance with the legal standards of fair and proper conduct between employers, employees, and unions and is vital to ensuring justice and harmony in the workplaces across our state. Mr. Hirota holds the experience and qualifications necessary to perform these responsibilities with distinction.

Most recently, he has served as a Labor Relations Specialist for the Department of Human Resources, City & County of Honolulu for twenty-five years. Re: Nomination to the Hawai'i Labor Relations Board

Here are my responses to the questionnaire:

(1) Why do you wish to be a member of the Hawai'i Labor Relations Board?

I have been involved in labor for the past twenty-seven (27) years. For the first seven (7) years of my involvement in labor, I advised and represented various labor unions both in the private and public sector. My representation of the various labor unions included counseling and advocating on their behalf in labor arbitrations and representing them in labor disputes before the HLRB and the National Labor Relations Board (NLRB). Subsequently, I began working for the Department of the Corporation Counsel, City and County of Honolulu where my role evolved into representing the employer's interest in many different forums including labor arbitration, Civil Service Commission and the HLRB. Although I am no longer with the Department of the Corporation Counsel, I am currently a Labor Relations Specialist with the Department of Human Resources, City and County of Honolulu and have been in this position for the past sixteen (16) years. As a Labor Relations Specialist, I am responsible for advising various City departments on labor matters. These matters range from, but not limited to, daily operations, negotiations, collective bargaining agreement interpretation, past practices, investigations and grievance handling and strategies. I also advocate on behalf of the City in labor arbitrations, perform training on labor matters and stand as a trier of fact for City department in contested case hearings where conflicts preclude normal hearings officers from participating in certain cases. In recent years, I was also selected to be a panel member for the Hawai'i Health Systems Corporation (HHSC) Merit Appeals Board where contested case hearings for HHSC civil service employees were adjudicated. Based on my years of experience in the field of labor and based on my experience as a hearings officer and a Merit Appeal Board member I would like to further utilize my skills and experience as the representative for management on the Hawai'i Labor Relations Board.

(2) How do you perceive the role and responsibilities of a member of the Hawai'i Labor Relations Board?

Pursuant to Hawai'i Revised Statutes §89-5(b), the HLRB is composed of three (3) members: one member represents labor, one member represents management and the third member, the Board Chair whom represents the public. My role on the HLRB would be that of the management representative. Therefore, I would be responsible for hearing and deciding matters that are brought before the HLRB with interpretations of rule and laws from the perspective of management.

(3) Given your understanding of the role and responsibilities of a member of the Hawai'i Labor Relations Board, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Hawai'i Labor Relations Board?

As indicated above, for the past twenty (20) years I have represented management in all facets of labor. In addition, I have also represented both private and public sector unions in all facets of labor as well. This experience has given me the unique perspective and understanding of both sides in labor matters. In my current position, I have utilized my experience in the labor arena to advocate, counsel and to resolve countless cases in labor disputes. Likewise, I will bring and use my twenty-seven (27) years of experience, including my experiences as a hearings officer, in arriving and formulating fair and well-reasoned decisions.

#### (4) What do you hope to accomplish during your term of service?

In my early experience with the HLRB, decisions were not issued as quickly and/or consistently as one would have wanted or expected. Having researched the number of HLRB decisions from the mid 2000's to the present, it appears that the trend has been an increase in HLRB orders and decisions. I would work tirelessly to maintain this upward trend and ensure that decisions by the HLRB are issued in a timely and consistent manner. Recently, I attended a labor/management meeting where the three HLRB members spoke and gave their thoughts about the importance of what the HLRB is and what it does. If given the opportunity, I would also like to do more outreach in the labor community, to both employees and management, to further educate people of the importance of the HLRB and the role it has to those who fall under their authority.

(5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Hawai'i Labor Relations Board?

First, my background and experience. Although I would be representing management, I also understand and would consider the unions' perspective on labor matters.

Consequently, I would use this experience in my decision making process to render fair. informed and well-reasoned decisions. Second, I am very passionate about the work that I do. Not only would I bring my experience with me, I would also bring the passion I have for the work that I do. During my time as an advocate for both employers and unions, I have been approached with many different offers that would have taken me away from public service. Although some of the offers were guite lucrative, it simply did not appeal to me as work that would have the same meaning as my work with the City. When approached with the possibility of being a member of the HLRB, my initial reaction was of excitement and eagerness to be able continue my public work but at a higher level of public service. The final quality I would like to mention is fairness. In dealing with public sector unions for the past twenty (20) years, I believe myself to be fair in the handling of labor disputes and in counseling various City departments on how to handle matters stemming from collective bargaining. I have been able to resolve matters between the employer and unions by coming up with solutions that are both fair and reasonable to both sides. With the three gualities mentioned here, I strongly believe that if given the opportunity, I would be an asset to the HLRB and to the labor community.

### (6) Name one previous experience that would make you stand out. How would this benefit the Hawai'i Labor Relations Board?

The type of experience I think would stand out most would be those where I was given a task to complete that fell outside the scope of my normal work duties which I was able to successfully complete. Although I have been put in many similar type situations, the experience that I feel is appropriate in this context would be the time I was assigned to prosecute cases for the City Liquor Commission. There was a period of over two (2) years where the assigned Deputy was delinquent in prosecuting liquor license violations. This resulted in a backlog of a couple of hundred cases that needed to be scheduled and heard along with other violations that were being issued on a daily basis. To deal with the backlog, I had to become well versed in liquor laws and how to proceed with the process . Therefore, in addition to my regular full-time work on labor and employment matters, I was also tasked with prosecuting cases for the Liquor Commission who convened once a week. In less than a year, I was able to clear the backlog, as well as addressing the daily violations, by scheduling and hearing the cases. I grew so immersed in my additional assignment at the Liquor Commission that I also developed training for their inspectors and staff on various subjects

(7) Can you foresee any possible conflicts of interests that could arise during your service on the Hawai'i Labor Relations Board? How would you overcome any possible conflicts of interest?

I do not see any possible conflict of interests arising as I have not advocated on behalf of the City and County of Honolulu before the Hawai'i Labor Relations Board since 2007. If a conflict were to arise, however, I would be bound by any rules of ethics and/or rules of professional responsibilities that apply. Should this occur I would have to recuse myself from that particular case to avoid any appearance of impropriety. If a perceived conflict were to arise which did not rise to a level for which I would be bound to recuse myself, I am confident that I would be able to issue an objective decision on the matter.

If there are any other questions or if there is anything else I can provide you with, please do not hesitate to ask. Again, I thank you for your time and for giving me the opportunity to be considered for the representative of management on the Hawai'i Labor Relations Board.
