TESTIMONY OF LOWELL K.Y. CHUN-HOON RE: GM 727, CONFIRMATION OF HARRY YEE TO THE LABOR AND INDUSTRIAL RELATIONS APPEALS BOARD

Thank you for the opportunity to present testimony regarding the nomination of Harry Yee to the Labor and Industrial Relations Appeals Board. ("LIRAB") I am pleased to support his nomination.

I have practiced law in Hawaii for more than 46 years and one primary area of my specialization is workers' compensation. I have regularly appeared before LIRAB in hundreds of cases. For this reason, I have a deep and abiding interest in the leadership and administration of LIRAB, as well as the fair and efficient statewide administration of the entire system of industrial accident adjudication.

The nomination of Harry Yee to the Board is an excellent appointment which promises to benefit all stakeholders in the workers compensation system. I have known Mr. Yee since he began practicing law in Hawaii over thirty years ago, and I am familiar with both his fourteen years in private practice and his distinguished twenty year career with the U.S. Attorneys Office, where he served as Chief of the Civil Division for four years and prosecuted and defended numerous complex civil cases in federal court.

His extensive and diverse experience in civil litigation have prepared him exceedingly well for the demands he will face as an associate member of the Board. The high level of skill required to present and try cases in federal court is a skill directly transferrable to expediting the resolution of a high volume of administrative agency appeals. Indeed, Mr. Yee is so proficient at trial advocacy that he was asked in the past month to train U.S. Department of Justice attorneys at a federal conference in South Carolina. Since Mr. Yee defended the federal government in major medical malpractice cases, he has also become intimately familiar with medical practice and treatment, an indispensable asset to any industrial injury adjudicator.

Finally, there are unique characteristics that Mr. Yee brings that will add broader dimensions to the Board's expertise. Mr. Yee served early in his career as a Legal Aid lawyer in Boston; as the Clinical Director of the Boston College Law School Chinatown Clinical Program; and a Fieldwork Supervisor, Clinical Instructor, and Staff Attorney at the Harvard Law School Legal Services Center. In Hawaii he served for six years as a Commissioner and Chair of the Hawaii Civil Rights Commission and as legal counselor to the Chinese Chamber of Commerce for fifteen years. Thus, he fully comprehends the impact of discrimination and is well-versed in representing those who live in poverty and suffer hardship and privation.

Unlike the Board's current Chair and other associate member, who have had long careers as dedicated high level administrators in state government, Mr. Yee has represented injured workers during his fourteen years of private practice. This is a distinct and invaluable perspective for the Board's overall decision making, as he understands from direct experience the despair and frustration injured workers experience when they are denied surgery, cannot obtain a prescription refill for pain medications, or when temporary total disability is suspended. This emotional and economic pain is a day to day reality which no humane system of adjudication can ignore.

In my view, the Labor and Industrial Relations Appeals Board is fortunate to have a nominee of Mr. Yee's intellectual acumen, deep legal experience, and superior work ethic. The Committee on Labor and Technology should approve his nomination fully and without reservations.

Dear Chair Aquino, Vice Chair Moriwaki, and Members of the Committee:

I have represented injured workers in their workers' compensation claims for about 40 years. Earlier in my career, the Labor and Industrial Relations Appeals Board was traditionally and wisely comprised of 3 members with backgrounds of: (1) supporting carriers/employers, (2) supporting injured workers/unions, and (3) being an attorney with workers' compensation experience to serve as a "neutral" Chair. Unfortunately, beginning with Governor Lingle, this practice of striving for balance was abandoned, and many say that the Board has the appearance of being over represented by persons who supported carriers/employers.

Board Member Melanie Matsui recently resigned. Before her appointment to the Board, Member Matsui represented employers/carriers. Present Member Marie Laderta was formerly the Director of the Department of Human Resources which served as an "insurance adjuster" for certain State agencies. Present Chair Damien Elefante previously worked as an attorney in the Department of Taxation.

All Board Members are presumed to be neutral arbiters, however to the public there may be a lack of appearance of fairness in the composition of the Board. Confidence in receiving a fair shake is essential to all members of the public, but especially to workers who were injured at work. Confirming Harry Yee to the Board would be a great step in restoring the appearance of fairness and justice of the Board.

The Board is viewed as an "expert" administrative board. This means that decisions of the Board are presumed to be made by members who have substantial workers' compensation experience and knowledge. It is sometimes said that it takes at least 5 years of workers' compensation experience to start to become wellversed in the field. A Board member must be familiar with workers' compensation the workers' compensation statute, regulations, and case law, but also with Committee on Labor and Technology Page Two April 9, 2024

anatomy, physiology and medicine. Decisions by "expert" boards are given deference when reviewed by courts, and therefore it is very important that members have the requisite knowledge and experience.

Mr. Yee brings years of workers' compensation and litigation experience to the table. Confirming Mr. Yee to the Board would improve the image of the Board, especially those 20,000 workers injured at work each year, often permanently.

I strongly support the confirmation of Harry Yee, Esq., to the Labor and Industrial Relations Appeals Board.

I do claimant's Workers Compensation claims on Mau'i. My resume is at mauilaw.net.

I write to notify you of a vacancy on the Labor and Industrial Relations Appeals Board ("LIRAB") and to suggest that you support a candidate, Harry Yee, to fill that vacancy.

LIRAB reviews all workers' compensation appeals from the Department of Labor & Industrial Relations and plays a vital role in setting precedents for all work injury adjudications. Historically, one board member was considered a labor, management, or public/government representative on the three-person panel. However, during the Ige Administration, this practice was ignored. Damien Elefante, formerly Deputy Director of the Dept. of Taxation, was appointed Chair in 2020 when the two already appointed board members had previously represented Employers. (Melanie Matsui was formerly an insurance defense lawyer in private practice, and Marie Laderta was formerly Director of the Department of Human Resources Development.)

I request that you support Harry Yee, a highly experienced litigator who is leaving the U.S. Attorney's office after fourteen years in private practice, including regularly representing Claimants in industrial accident claims for the open position at LIRAB.

A copy of Harry's resume is enclosed but let me elaborate on why I think he would be an excellent candidate. In his two decades with the U.S. Attorney's Office, Yee was engaged in federal court representing the U.S. in medical malpractice cases, catastrophic tort cases, agency disputes, and other complex civil litigation. Because of the subject matter of his federal caseload and because workers' compensation was one of his areas of specialization in his earlier career in private practice, he has, of necessity, learned a great deal about medicine and anatomy, which is vital to serving as an effective advocate for injured workers. In his fourteen years of private practice, he regularly appeared before

Beyond that, Yee has had a lifelong commitment to civil rights and representing underserved communities. In college and law school, he was extensively involved in antipoverty, immigrant rights, and community-building programs in Boston Chinatown. When he first graduated from law school, he worked for Greater Boston Legal Services; was a Fieldwork Supervisor and Clinical Instructor at the Harvard Law School/Legal Services Center from 1982 to 1986; and later served as an Assistant Attorney General in the Civil Rights Division of the Department of the Attorney General for the State of Massachusetts. He moved to Hawaii in 1989. In the 1990's he was also the Chairperson and a Commissioner of the Hawaii Civil Rights Commission and a Director of the Hawaii Community Services Council.

As a personality type, Yee is hard-working, principled, and conscientious. He is unafraid of making hard decisions and resists intimidation. He has a visceral sympathy for the underdog and a lifelong commitment to combating inequality and racism. At the present juncture in the Labor and Industrial Relations Appeals Board's history, his presence is also badly needed because he understands injured workers and the unique frustrations that they experience—denials of medical treatment, delayed and denied payment of compensation, accusations of malingering, social ostracism, and the infuriating irrationality and bureaucratic indifference of employers, insurance carriers, and government agencies.

The current LIRAB board members, by their past careers, do not have these experiences. They simply have not been on the other end of the phone when a Claimant calls in pain but has had their prescription for Tramadol denied or had to explain why four months have passed without approval for a surgical consultation for a ruptured lumbar disc, and why the Disability Compensation Division has yet to set a hearing on the denial because the case is on appeal with LIRAB and must still be remanded. This is perhaps the exact reason why the tradition of balanced representation on the Board is sound social policy and why it never should have been abandoned.

My responses to your letter/questionnaire of March 28, 2024 are below and I have attached my resume for your consideration.

1. Why do you wish to be a member of the Labor & Industrial Relations Appeals Board?

I am seeking appointment to the Labor and Industrial Relations Appeals Board (LIRAB) to serve the people of Hawaii and more specifically to facilitate relief for injured workers and ensure fair adjudication of all claims and controversies. In furtherance of this goal, I would employ my 14 years of experience as workers compensation claimant's counsel and more than 20 years experience as an Assistant U.S. Attorney defending medical malpractice and tort cases for the federal government with patience and compassionate.

2. How do you perceive the role and responsibilities of a member of the Labor & Industrial Relations Appeals Board?
