Aloha Chair Keohokalole, Vice Chair Fukunaga, and Members of the Committee;

The International Brotherhood of Electrical Workers Local 1260 (IBEW 1260) would like to offer the following testimony in support of Governor's Message 737 ("GM 737").

IBEW 1260, is comprised of approximately 3,000 hardworking union members made up of a diverse workforce that consists of highly skilled and trained individuals working in electric utility generation, transmission, and distribution, as well as government, professional, and broadcast service contracts throughout the State of Hawai'i, in Guam and Wake Island.

IBEW 1260 supports GM 737 which submits for consideration and confirmation to the Board of Electricians and Plumbers (E&P Board), Gubernatorial Nominee, MILES KAMIMURA, for a term to expire 06-30-2028.

The E&P Board is charged with carrying out the provisions of Hawaii Revised Statutes, Chapter 448E as it relates to the established standards and licensure of electricians and plumbers in the state of Hawaii, and to insure the safety and welfare of the general public (*see* HRS 448E-4). Specific to electrical work, and according to HRS 448E and HAR 16-80-3, electrical work performed by a licensed electrician is limited to that within the scope and purpose of the National Electrical Code.

To the extent that decisions made by the E&P Board may directly and/or indirectly impact electrical work performed outside its authority and jurisdiction, we believe that as a member of the E&P Board representing the *public*, Mr. Kamimura's professional experience and background will allow him to critically consider and objectively decide on the many complex and often controversial issues that come before the Board without bias or predisposition. We look forward to working with Mr. Kamimura on issues important to the electrical industry and to IBEW Local 1260.
