DEPARTMENT'S POSITION: The Department of Human Services (DHS) appreciates the

intent of this bill as long as it does not reduce or replace the priorities identified in the Governor's budget.

**PURPOSE:** This bill increases from \$800 to \$1,600 the amount of death benefits paid by the Department of Human Services to cover the cremation and disposition costs for a deceased person who was eligible for medical or financial assistance at the time of the person's death and whose body is unclaimed. Effective 7/1/3000. (HD1)

The Committee on Human Services amended this measure by changing the effective date to July 1, 3000, to encourage further discussion.

In state fiscal year 2023, DHS paid a total amount of \$277,600 for this type of death benefit. For the benefit amount to double, the estimated increased appropriation will need to be \$277,600.

DHS supports this increase as long as it does not reduce or replace the priorities identified in the Governor's budget. DHS prefers that the increase be included in the executive budget bill as a recurring appropriation.

My name is Mitchell Dodo, on behalf of Dodo Mortuary, Inc. in Hilo, Hawaii and I am testifying in SUPPORT of HB 1533 HD1, Relating to Death Benefits, increasing the reimbursement to mortuaries from \$800 to \$1600.

Dodo Mortuary, Inc. & Crematory has handled the cremation, transportation, storage (60 days) and final disposition of unclaimed human remains on the Big Island on behalf of the State for decades but have only received \$800 in reimbursement to cover the cost of these services. Well beneath our current charges for minimal cremation type services.

Dodo Mortuary, Inc. & Crematory, as a result, have been covering the costs above the State's reimbursement level of \$800. We are also taking on the responsibility of holding and scattering or interring the remains following the cremations, adding additional cost to our company. Unfortunately, as costs of fuel, labor, and materials continue to rise, we can no longer sustain offering this service at the current reimbursement amount. Some Hawaii mortuaries have opted out of taking unclaimed remains because of this. An increase of the reimbursement amount would help offset the cost associated with performing cremations. The total cost increase of the adjustment in the reimbursement rate to the annual cost increase would not be significant in the state budget.

This statement is made on behalf of Mililani Group, Inc., a company doing business as Mililani Memorial Park and Mortuary (hereafter called "Mililani"). Mililani <u>SUPPORTS</u> HB1533 "Relating to Death Benefits" which advocates for an increase of the reimbursement paid mortuaries for the cremation, transportation, storage and final disposition of unclaimed persons. Mililani has declined to participate in this program as the reimbursable amount presently provided is not sufficient to cover our cost for these services. We may reconsider this decision should the amount of the reimbursement be increased as set forth in the Bill.

Mililani has been engaged in the business of funeral service and cemetery operations for more than 50 years and during this period, we have been able to deliver our services in a professional and highly competent manner. Based on our years of expertise, we strongly contend that the present reimbursement is insufficient to permit a mortuary to recover its direct costs and appreciate the review of this programs to implement an increase in the reimbursable amount.

FOR THE ABOVE REASONS, Mililani stands in strong support of the proposed HOUSE BILL 1533.
