- 2 **Department Testimony:** This measure seeks to reduce plastic waste by 1) prohibiting state
- 3 agencies from purchasing or using polystyrene food-service containers; 2) prohibiting vendors
- 4 contracted through a state agency from selling, offering for sale, providing, or using polystyrene
- 5 food-service containers at any site owned or leased by the State; and 3) prohibiting polystyrene
- 6 food-service containers from being sold, offered for sale, provided, or used at any state facility,
- 7 state-authorized concession, state-sponsored or state-permitted event, or state program.
- The Department of Health (Department) notes that the County of Hawaii¹, the County of
- 9 Maui², the City and County of Honolulu³, and the County of Kauai⁴ already prohibit food
- providers from using polystyrene foodware products. We respectfully offer that taken
- 11 collectively, the four county prohibitions create a defacto statewide ban on polystyrene foodware
- containers that precludes the need for a statewide law.

The American Chemistry Council (ACC) must respectfully oppose HB1585, legislation that would ban the purchase, sale, and use of polystyrene food service containers by state agencies and their contracted vendors beginning January 1, 2025.

ACC membership includes the leading suppliers and manufacturers of plastics foodservice packaging products, including polystyrene food and beverage containers. Though we support efforts to reduce plastic waste and increase the recycling and recovery of plastic packaging, we believe the Legislature should assess several important questions prior to moving forward with this policy. Key questions include:

- Will this legislation actually reduce waste or rather simply result in replacing one type of trash with another?
- Are there environmental impacts (e.g. energy use, water use, impacts on greenhouse gas emissions, trash generation, landfill waste, etc.) associated with the manufacture, distribution, use and disposal of likely alternative replacement products?
- Are likely replacement products recycled or composted within the State's existing recycling infrastructure and do viable, end use markets exist for these products?

Impacts on Trash Generation/Disposal/Litter

In addition to not considering important life-cycle environmental impacts, legislation that seeks to restrict the use of one type of packaging material (without any corresponding regulatory requirement on likely replacements) does not reduce the amount of waste or litter generated, but instead simply change the composition of the waste and litter stream. Bear in mind expanded polystyrene represents less than 1% of the waste stream.

Litter studies conducted following the enactment of a ban have shown an increase in the litter of alternative materials that is greater than the decline in the banned material. For example, when the City of San Francisco placed restrictions on the use of certain plastic foodservice products, the City found that replacement products became more dominant in the litter stream¹. For this reason, the California Water board rejected the use of bans as a compliance mechanism for waterborne trash reduction².

ACC believes there is an opportunity to craft meaningful and impactful packaging and food ware policy that considers the necessary role of packaging, including performance needs and assesses a multitude of attributes (e.g. recyclability, waste prevention, material efficiency, greenhouse gas emissions, collection and processing infrastructure, end markets, etc.) of all packaging materials. Combined, these considerations will help arrive at a policy solution that makes sense environmentally and provides the business community with practical and implementable compliance obligations.



A practical first step toward creating a more circular system for packaging, including food ware packaging made from all materials is to clearly understand the current recycling and composting collection system, including the types and quantities of food ware material in the waste stream, current recycling and composting rates for all food ware materials, sorting and processing infrastructure, end markets for collected materials, and funding necessary to achieve higher recovery rates for food ware material of all types. Simply banning polystyrene food service containers does not automatically mean those alternatives will be recycled or composted.

To that end, the Legislature will be considering HB 1688, legislation requiring the Department of Health conduct a comprehensive needs assessment to "determine what would be needed to transition to a more circular system with less waste generation, more reuse and the necessary infrastructure to sort and locally process recyclable materials through an extended producer responsibility program for packaging materials and paper products."

House Bill 1585 - Relating to Plastic Pollution - OPPOSE

Thank you for the opportunity to provide written testimony regarding *House Bill 1585 – Relating to Plastic Pollution* (HB 1585), which we respectfully oppose.

Founded in 1933, the Foodservice Packaging Institute (FPI) is the leading authority on foodservice packaging in North America. We support the responsible use of all foodservice packaging, while advocating for a fair and open marketplace for all materials. FPI's core members include raw material and machinery suppliers as well as packaging manufacturers, which represent approximately 90 percent of the industry. Additionally, some distributors and purchasers of foodservice packaging are part of FPI's affiliate membership.

As we have communicated previously, the foodservice packaging industry is committed to reducing the impact of its products on the environment and is dedicated to increasing their recovery. FPI has several special interest groups that bring together the supply chain to develop and promote economically viable and sustainable recovery solutions for foodservice packaging. These special interest groups include the Paper Recovery Alliance, Plastic Recovery Group, Paper Cup Alliance and Foam Recycling Coalition (FRC). More information on these groups and their efforts can be found here.

FPI supports policies and programs that enable increased recovery and diversion of foodservice packaging. However, we oppose restrictions that limit the use of any foodservice packaging. We believe that each foodservice package must compete in the marketplace based on its own merits of product performance and suitability, price competitiveness and, of course, impact on the environment.

It is worth noting that recycled foam polystyrene can be turned into new products. Through FPI's FRC, the industry has proactively led efforts to increase the recycling of foam polystyrene. As a result of the voluntary efforts of the FRC, approximately six million additional people in the U.S. and Canada have access to foam polystyrene recycling. More information on foam polystyrene recycling opportunities and U.S. end markets is available here.

It is our perspective that rather than focus on foodservice packaging prohibitions, the authors should work with stakeholders to amend <u>HB 1688</u> to conduct a needs assessment as the first step in identifying measures to reduce waste and enhance the recovery of packaging in Hawaii. We have offered comments to this effect on HB 1688, also before this committee.

We appreciate your consideration of this written testimony and our opposition to HB 1585.
