# In consideration of HB 1780, Relating to World Peace Day

# (WRITTEN TESTIMONY ONLY)

Chair Tam, Vice-Chair Martinez and the members of the committee:

The Office of Collective Bargaining (OCB) appreciates the intent of HB 1780, which designates the twenty-first day in September as World Peace Day and establishes World Peace Day as a state holiday in substitution of the existing Good Friday holiday. However, OCB offers the following comments on this measure:

- 1. While the Legislature is the governing body to both establish and remove official state holidays, the potential impact on public employees is a negotiable matter, subject to collective bargaining pursuant to Hawai'i Revised Statutes (HRS), §89-9.
- 2. This was evident when, as early as the mid-1970s, the exclusive representatives and the employers mutually agreed to remove references to HRS, §8-1 from the holiday provisions of the respective collective bargaining agreements. This action reflected the parties' agreement that holidays are a negotiable matter and cannot be solely legislated.
- 3. Also, the establishment of World Peace Day, as an official state holiday and the repealing of Good Friday would have no effect on public workers unless it is negotiated and mutually agreed to.

Chair Tam, Vice Chair Martinez, and Members of the Committee:

The United Public Workers, AFSCME Local 646, AFL-CIO ("UPW") is the exclusive bargaining representative for approximately 14,000 public employees, which includes blue collar, non-supervisory employees in Bargaining Unit 1 and institutional, health, and correctional employees in Bargaining Unit 10, in the State of Hawaii and various counties.

UPW provides **comments** on HB1780, which designates World Peace Day as a state holiday in place of Good Friday. Good Friday has been a recognized holiday since before statehood. Whether it is celebrated for religious or secular reasons, many of our members utilize this holiday to prepare for family gatherings on Easter Sunday.

Additionally, Good Friday is the only State holiday that can occur in the month of April. By replacing Good Friday with World Peace Day and shifting the legal holiday to September, this leaves a period of approximately 30 days, between Prince Jonah Kuhio Kalanianaole Day and Memorial Day, without a holiday for public employees.

Should this committee choose to recognize World Peace Day as a State holiday dedicated to observing 24 hours of non-violence and cease-fire, we would prefer that it be added to the schedule of designated holidays rather than replacing Good Friday.

My name's Cheyne Rippey, a Honolulu-born, educational leader on Oahu. I am writing to express my *strong opposition to HB1780*, which proposes to designate "World Peace Day" as a state holiday instead of the sacred Good Friday. This measure raises serious ramifications that warrant careful reconsideration.

Firstly, this bill infringes upon the interests of the majority population of our state, nearly two-thirds of which are Christians (aka Good Friday observers) https://www.pewresearch.org/religion/religious-landscape-study/state/hawaii/.

Secondly, replacing it with "World Peace Day" is discouraging to continue Hawaii residency as it disregards the values and traditions of our state and interests of our current population. "World Peace Day" has no state significance in the minds nor hearts of our residents. Instead, the Good Friday weekend yields record-breaking church attendance across the whole state out of any day in the year. As I hope you've seen, the whole weekend is a moment for mental-spiritual-health as families in Hawaii gather for observance, tradition, and true aloha.

Moreover, the proposed substitution seems to be discriminatory toward Catholics and Christians, as it marginalizes a religious observance with deep cultural and spiritual significance. This marginalization is systemic exclusivity.

Written testimony in support of HP1780 regarding World Peace Day.

In 2007 the state legislature approved a bill declaring September 21 to be Peace Day in Hawaii. The legislation was signed into law by then Governor Linda Lingle. That year, I began producing the annual "Parade and Festival for the United Nations International Day of Peace" under the auspices of the Honokaa Hongwanji Buddhist Temple. The mission of the parade and festival was to promote the existence of Peace Day in Hawaii. Many other events have been produced as part of the Peace Festival – peace poster contests, music and comedy concerts, 5K runs, guest speakers, "Read for Peace" in the local library, suicide prevention and awareness marches, Peace Movie Nights, "199,000 Cranes Project"(to remember those lost in the atomic bombings in Japan), Peace Gardens, peace education, etc. The parade always receives good coverage on the television stations broadcasting out of Honolulu as well as on the internet. These are the kinds of events and projects that communities and schools across the state could produce and participate in.

Despite the United Nations marking of the International Day of Peace for the past forty years, there are relatively few companion events of note in the State. (One exception is the event sponsored by Honpa Hongwanji Mission of Hawai`i – "Ring Your Bell for Peace" – which draws hundreds of participants from around the world.)

To my knowledge, Hawai`i remains the only state in the Union to have an "official" Peace Day, seventeen years after leading the way.

World Peace Day as a statewide holiday can become an excellent opportunity for the Aloha State to lead the way by example, teaching the world the values and meaning of the Aloha Spirit, which are synonymous with the values of Peace.

My name is Claire Tamamoto and I am testifying in favor of HB1780, establishing September 21, as World Peace Day as a state holiday. In 2007, the Hawaii Legislature passed SB866 and Governor Lingle signed the bill establishing Hawaii as the only state in the nation to recognize Peace Day in conjunction with the United Nations International Peace Day. In 2008 and 2009, Peace Day was recognized and celebrated on the State Capitol grounds by students, politicians, community groups such as the Spark M. Matsunaga Institute for Peace and Conflict Resolution, MADD, and Domestic Violence. The program included national guest speakers, religious groups representing our diverse cultures, and the recognition of individuals in our State that epitomized Peace through their actions. Your own Representative Scot Matayoshi was recognized for his program to reduce bullying as a teacher at Nanakuli High and Intermediate School. The University of Hawaii offers a BA degree in Peace and Conflict Resolution under their School of Communication and Information. Currently throughout our State various groups commemorate Peace Day, with parades, "Ring Your Bell for Peace" and school programs.

So you ask, isn't that enough, why do we need a World Peace Day state holiday? Holidays should commemorate and recognize important concepts and occasions. I have worked with youth for over 40 years in education and through community organizations. I think and feel that it is time to recognize September 21<sup>st</sup> as a state holiday. A World Peace Day state holiday would create greater awareness and elevate Hawai'i's commitment to world peace. World Peace manifests itself internationally and locally. In Hawai'i, our Aloha state, we see a rise in teen suicide from actual and cyber bullying, domestic violence, and hate crimes. We must do more. We owe it to our youth!

The current bill proposes World Peace Day as an alternative to Good Friday as a State holiday. Currently, Hawai'i is one of ten (10) states that recognizes Good Friday as a state holiday: Connecticut, Delaware, Hawai'i, Indiana, Kentucky, Louisiana, New Jersey, North Carolina, North Dakota and Tennessee. In addition, California, Texas and Florida recognize it as an optional or partial public holiday. These states varying from entire, partial or optional days off. For the states where Good Friday is a state public holidays: state offices, agencies and business are open and are not required to allow workers to take the day off or pay them for taking the day off. My support for this bill is not to minimize the importance of Good Friday but rather to support the universal and important concept of PEACE.

In closing, this summer, I traveled to Hiroshima in support of Hawai'i's Ohana Arts Youth Theater Company, who carried their message of PEACE to the people of Hiroshima. The message was not lost on a city that has experienced the long-lasting devastation of an atomic bomb. It was a moving and an inspiring experience to see and hear their message of "Peace on Your Wings". This message must continue globally so maybe one day, just maybe, there will be more youth that have experienced peaceful resolutions to conflict rather than rhetoric that incites war or conflict to our individual differences.

Subject: HB 1555 and HB1780 – Testimony in Opposition

There are two bills being heard at the legislature that I am aware of that proposes new state holidays. They are:

### HB 1555 RELATING TO STATE HOLIDAYS.

Designates the day of the second new moon after the winter solstice of every year as the Lunar New Year. Establishes the Lunar New Year as a state holiday.

### HB1780 RELATING TO WORLD PEACE DAY.

Designates World Peace Day as a state holiday in place of Good Friday.

While I support the intention of the events, I do not support them as holidays since, if any state holiday is approved, it should begin with the elevation of La Ku'oko'a as a state holiday. Originally bills (HB 1119, SB1451, SB3096) were introduced in 2019, for this event to be a state holiday. It took four years to result in a simple recognition of the event, rather than a holiday. I would also note that the majority of testifiers voted in support, and those who opposed did so on the basis of retaining Good Friday as a holiday.

SB731, now Act 011, 4/19/23, Designated November 28 of each year as La Kuokoa, Hawaiian Independence Day, to celebrate the historical recognition of the independence of the Kingdom of Hawai'i. Yet, this was a national holiday under the Provisional Government of Hawaii, the Republic of Hawaii, and the initial years of the Territory of Hawaii. La Kuokoa was included in the codified list of national holidays enacted by the Republic of Hawaii in 1896.

The legislature further found that during the reign of Kamehameha III, Great Britain and France recognized the independence of the Kingdom of Hawaii by joint proclamation on November 28, 1843. The United States followed on July 6, 1844. These leading world powers recognized Hawaii as an independent nation state due to the diplomatic work of Timoteo Haalilio, the first diplomat of the Kingdom of Hawaii, and his associate William Richards, who were sent as envoys of Kamehameha III to secure formal diplomatic relations with these countries.

In 1847, Kamehameha III required his Minister of Foreign Affairs, Robert Crichton Wyllie, to propose a suitable way to recognize and celebrate the anniversary of Hawaii's welcome into the family of nations. On October 15, 1847, Wyllie delivered his report, by Privy Council, to the King and ministers. That year marked the first official celebration of Hawaiian Independence Day, La Kuokoa.

Throughout the 1850s and 1870s, Hawaii celebrated La Kuokoa with luau, music, and marches. The celebration grew under the reign of King Kalakaua, with formal proclamations sent by official circular to the foreign diplomatic corps in Hawaii and the Kingdom of Hawaii consuls abroad, informing them of the holiday.

As with La Ku'oko'a, amend the bills to recognize these events, but not as a holiday.

The legislature may wish to do a resolution calling for the establishment of a committee to review the issue of state holiday, to affirm those that exist or recommend change; and to determine which events should be considered to replace or to add a state holiday, with preference to the indigenous people of Hawai'i and our history.
