I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports HB 1815, HD1, which includes agritourism in the definition of "enterprise" to authorize the Agribusiness Development Corporation to financially support businesses engaged in agritourism.

We strongly support agritourism as it represents an excellent revenue enhancement opportunity for farmers and ranchers as well as an educational opportunity for the public. Fostering the profitability of farmers and ranchers will significantly contribute to the State's goal of increased self-sufficiency.

The Agribusiness Development Corporation (ADC) was initiated by the agricultural industry as sugar and pineapple downsized. It was established to help transition Hawaii's agricultural industry from plantation agriculture to smaller diversified agricultural operations. Aloha Chair DeCoite, Vice Chair Wakai, and Members of the Senate Energy, Economic Development, and Tourism Committee,

The Hawaii Farmers Union is a 501(c)(5) agricultural advocacy nonprofit representing a network of over 2,500 family farmers and their supporters across the Hawaiian Islands. **HFUU provides comments HB1815.** 

Agritourism is an important component of Hawaii's agricultural industry, providing opportunities for farmers to diversify their income streams and connect with the community. However, without a clear definition of agritourism, there is a risk that the Agribusiness Development Corporation's efforts could be misdirected towards supporting recreational activities that do not align with the goal of promoting productive land use.

We recommend referencing HRS §205-4.5(13) to define agritourism as that which is conducted on working farms.

Under the current HRS §163D-2 statute the enterprise definition concludes "provided that the majority of whatever the corporation produces shall be produced for export." It is thus not clear how ADC would support agritourism for export. HFUU would recommend amending this language to enable ADC to support enterprises focused on local consumption as well.
