In consideration of HOUSE BILL 1840, HOUSE DRAFT 2 RELATING TO THE ENVIRONMENT

House Bill 1840, House Draft 2 proposes to appropriate funds to the Department of Land and Natural Resources (Department) to support long-term water quality monitoring and pollution source detection. The Department supports this bill, provided that its passage does not replace or adversely impact priorities indicated in the Executive FY 2025 Supplemental Budget Request.

The Department recognizes that the pollution impacts from the Lahaina fires are likely to persist in our coastal waters and therefore accumulate in the marine resources we are mission bound to manage and conserve.

Considering the expertise, detailed operating procedures, and quality assurance practices necessary to sustain coastal monitoring, allocating \$140,000 per year to support regular ongoing chemical and physical coastal water quality testing and storm sampling would be appropriate (per section 2, paragraph (1)). This level of annual funding would help ensure that the regular ongoing data collection for the impacted Lahaina burn area is sustained, and would allow for sampling at a total of 25 West Maui sites every three weeks, plus four storm sampling events per year.

Characterizing the many classes of contaminants found in the water, sediment and accumulating in the tissue of fish and marine invertebrates in the nearshore waters off Lahaina is essential for protecting the people of Hawaii from hazards in the marine environment, and ingestion of

contaminated seafood. This type of work requires very detailed and expensive lab analysis and is expected to cost \$450,000 per year (per section 2, paragraph (2)).

Additional agency staff time is needed to assist with coordinating and carrying out these critical water quality monitoring tasks. The expected costs for a full-time Aquatic Biologist III would be \$58,000 per year (per section 2, paragraph (3)) and for a full-time Aquatic Biologist IV would be an additional \$63,000 per year (per section 2, paragraph (4)). Establishing six Aquatic Biologist III positions and six Aquatic Biologist IV positions (one each for Kaua'i, O'ahu, Maui, Moloka'i, East Hawai'i, and West Hawai'i) would meet statewide water quality monitoring and pollution source detection needs. The total cost of these twelve biologist positions is \$726,000 annually.

Aloha,

Thank you for the opportunity to support HB 1840 HD2, Relating to the Environment. Taking care of our 'āina and making funding available for preventive measures to protect, restore and nurture our land and ocean is the best insurance policy against wildfires, floods, and other disasters.

We all saw the devastating effects of the wildfires on Maui last August. No one wants another wildfire, flood, or any other disaster in our islands. The Care for 'Aina Now coalition believes it is vitally important for our state to have funds dedicated to protecting and restoring our natural resources to prevent or mitigate the effects of climate events. This proactive, preventive approach to stewardship of our islands requires an investment in our 'āina. This measure is one of many initiatives that we support to increase funding for the incredibly important work that the Department of Land and Natural Resources does.

The Maui wildfires have now amplified to every resident, and indeed the world, that no region in the world is immune to the impact of this climate crisis. We are a coalition of individuals and organizations committed to supporting better management of the state's natural resources. We estimate that an additional \$360 million annually is needed to close the current budget shortfall in protecting our islands against climate threats and the impacts of tourism. At its most basic level, this funding is necessary for wildfire prevention strategies.

Natural resources are the lifeblood of our pae 'āina, providing us with the essentials for survival and the foundation for Hawai'i's economy, our very society. These resources include clean air and water, fertile soil, living coral reefs, stable coastlines and beaches, biodiversity and healthy forests. We commend the legislature, cognizant of the local and global threats to these riches, for declaring Hawai'i to be the first state in the nation to declare a climate emergency. Protecting and restoring these resources is a moral, economic, and ecological imperative.

Based on the foregoing, we support this bill and strongly advocate for increased support for long-term monitoring of water quality, as well as support for research efforts to better understand the environmental concerns linked to urban fires.

In addition, we also support including additional revenue to fund DLNR so that Hawai'i can:

- Remove flammable nonnative plants and restore sites with less flammable native plants.
- Restore coral reefs to help protect our beaches and coastal communities from sea level rise and storm surges, while also protecting the fisheries that draw tourists and sustain local residents.
- Restore watershed forests that protect our water quality and supplies, in addition to reducing the risks of fire.
- Provide grants to local communities to assist them in managing and restoring natural resources, including reducing their fire risks.

Preventing damage to natural resources is often more cost-effective than trying to restore them once they have been degraded. For example, restoring a polluted stream can be far more expensive than preventing pollution in the first place. Wildfire prevention can be significantly more cost-effective than paying for the cost of responding to wildfires and restoring damaged communities and natural resources. Legislators who allocate funding for protection and restoration are, in essence, making a sound long-term investment in their constituents well-being, and the environment.

We have a moral responsibility to protect the natural resources that sustain life on our islands. Future generations depend on the decisions we make today. Legislators have a unique role in shaping policies that reflect our ethical obligation to safeguard the environment for all living beings.

In conclusion, there are numerous compelling reasons why legislators should approve funding to protect, restore, and manage Hawai'i's magnificent and irreplaceable natural resources. Disaster resilience, climate change mitigation, clean water and air, sustainable agriculture, economic benefits, public health, long-term cost savings, biodiversity conservation, and ethical responsibility all underscore the importance of such investments. By allocating the necessary funds, legislators can secure a brighter and more sustainable future for all. It is a responsibility that cannot be ignored, and the benefits far outweigh the costs.

We look forward to working with you to ensure that our natural resources are at the forefront of policy-leaders' minds and that the state budget reflects these priorities.

Our coalition of organizations and small businesses listed below are writing in **strong support of HB1840 HD2 to generate funding for natural resource protection and restoration**. The Care for 'Āina Now Coalition is on a mission to enhance visitor stewardship, conserve our cultural and natural resources, and invest in our 'āina to keep our community safe.

The health of Hawai'i's environment is inextricably linked to the health of our people, communities, and future generations. We are Olan Leimomi Fisher and Kevin Chang, Kuaʻāina Advocate and Executive Director, respectively, testifying on behalf of Kuaʻāina Ulu 'Auamo (or KUA). "Kuaʻāina Ulu 'Auamo" stands for "grassroots growing through shared responsibility," and our acronym "KUA" means "backbone." Our mission is to connect and empower communities to improve their quality of life through the collective care for their biocultural (natural and cultural) heritage, serving as a "backbone organization" that supports creative and community-driven solutions to problems stemming from environmental degradation. Hawaiʻi's biocultural resources continue to be negatively impacted by political, economic, and social changes, and the increasing dangers of climate change make fostering and empowering resilient communities acutely critical.

Currently KUA supports three major networks of: (1) almost 40 mālama 'āina (caring for our 'āina or "that which feeds") community groups collectively referred to as E Alu Pū (moving forward together); (2) over 60 loko i'a (fishpond aquaculture systems unique to Hawai'i) and wai 'ōpae (anchialine pool systems) sites in varying stages of restoration and development, with numerous caretakers, stakeholders, and volunteers known as the Hui Mālama Loko I'a ("caretakers of fishponds"); and (3) the Limu Hui made up of over 50 loea (traditional experts) and practitioners in all things "limu" or locally-grown "seaweed." Our shared vision is to once again experience what our kūpuna (ancestors) referred to as 'ĀINA MOMONA – abundant and healthy ecological systems that sustain our community resilience and well-being.

KUA supports HB1840 HD2 as an incremental step toward 'āina momona.

This bill will provide the Department of Land and Natural Resources (DLNR) with the necessary funds to support long-term water quality monitoring and pollution source detection. Communities in our networks have long wanted to see greater capacity in water quality monitoring due to the effects of human-generated pollution in our streams and runoff into the nearshores negatively affecting fishery, limu, and loko i'a health and safe production. In addition, our Maui communities impacted by the devastating fires last year are still working on the many steps necessary to rebuild their places with thoughtful and aloha 'āina-based developments. As DLNR notes in its testimony, understanding and monitoring the many levels of contaminants due to the fires is "essential" for protecting our kama'āina and visitors alike from poisoned seafood.

As such, long-term water quality monitoring and pollution source detection should be a statewide priority with the growing threats of future fires and other environmental disasters due to climate change. It is extremely unfortunate that it takes the nation's most devastating wildfire to-date to refocus our governmental leaders to seriously consider the

already-deteriorated state of our environmental ecosystems. But alas, we all must start somewhere. The communities we work with commit their lives to ensuring the long-term health of our shared biocultural resources. They have cared for, and depended on, these biocultural resources since time immemorial, and hope to continue their sustainable practices forever through future generations of koa aloha 'āina. We believe our 'āina, the very foundation of our existence, is about long-term protection and steps necessary to once again achieve 'āina momona.

The Nature Conservancy (TNC) **supports** HB 1840, HD2, relating to the environment, which appropriates funds to the Department of Land and Natural Resources to support long-term water quality monitoring and pollution source detection.

Scientists have documented trends including reduced rainfall, higher evaporation rates, and declining stream flows in recent decades. These findings, coupled with the demand of an ever-increasing population, suggest that Hawai'i is entering an era of fresh water uncertainty. As extreme weather becomes increasingly common, it is bringing massive rainfall and flooding in some regions and widespread heat and drought in others, with disastrous impacts on both humans and nature. Aloha, I submitted this testimony under the HD1 version of the Bill, however it is worth submitting again with respect to understanding the massive impact of the PFAS chemical assault on Hawaii's environment. Of all the testimonies submitted do date, there appears to be only two individuals that oppose the measure – because of budgetary constraints which is obviously very important and understandable. However, perhaps it is time to communicate with the corporations (DuPont, 3M, Chemours ... etc.) that have caused this massive environmental nightmare of toxic substances that were known as far back as the 1950's to be harmful to humans. Regardless of this and as well as both DuPont and 3M stating in the 1960's and 1970's that PFAS are toxic and should be handled with care ... they did nothing to stop and/or educate anyone to the extent of the problems caused and/or being caused. It has been published by several news outlets https://www.theguardian.com/environment/2023/may/12/pfas-forever-chemicals-societal-costnew-report and even by the EPA in a letter to Alumni that industry PFAS profits are about \$4 Billion a year, but the amount estimated annually to fix the problem is \$17.5 Trillion globally. Who is responsible to pay for this damage? With that said, I respectfully re-submit my concerns as a toxicologist and ask that you consider not burdening your citizens with this expense, but put it back on the industries that caused the problem. Mahalo!

Hi, my name is Joe DiNardo. I have been a toxicologist since 1976 and I have worked with Hawaii on sunscreen issues since 2017. It is essential that Hawaii fund environmental testing because the amount and type of toxic materials that are available in the air, water and soil have significantly increase over the last few decades. Specifically, chemicals like PFAS can travel over 25 miles in the air with some of these chemicals staying in the air for up to 9 months. Additionally, some of these PFAS chemicals can last in the soil/water for up to 184 years and in human blood for up to 70 years. The EPA is tragically behind in protecting US citizens from chemical pollution - they are proposing a 4 parts per trillion (ppt) Maximum Contamination Level (MCL) for just drinking water for two PFAS chemicals - PFOA and PFOS. The dose that causes kidney cancer IN HUMANS is 0.007 ppt for PFOA and 1 ppt is the cancer causing dose for PFOS in animals. That is approximately 400 TIMES higher than the cancer dose that is KNOWN to produce human cancers and 4 times the levels that causes cancer in animals. In toxicology setting a dose this high above the carcinogenic levels would "normally" be call stupidity ... you cannot set a dose that is higher than the known cancer dose in humans and expect to protect the population!

The National Academies of Science committee found "SUFFICIENT EVIDENCE of an association for the following diseases and health outcomes: decreased antibody response (in adults and children), dyslipidemia (in adults and children), decreased infant and fetal growth, and increased risk of KIDNEY CANCER (in adults). AND found LIMITED OR SUGGESTIVE EVIDENCE of increased risk of BREAST CANCER (in adults), liver enzyme alterations (in adults and children), increased risk of pregnancy-induced hypertension (gestational hypertension and preeclampsia), increased risk of TESTICULAR CANCER (in adults), thyroid disease and dysfunction (in adults), and increased risk of ulcerative colitis (in adults)."

Maui, when last checked in 2022 it had approximately 1,600,000 ppt of PFOS in the ground water (Kahului Airport) ... that is 1.6 MILLION times above the dose that causes cancers in animals? With that said, Hawaii should also be moving towards testing the blood levels of its citizens. The EPA has finalized Method 1633 which establishes reasonable testing limits to identify 40 different PFAS analytes (there are tens of thousands of PFAS chemicals). This is the correct method to use to identify risk to people.

Lastly, PFAS are only one of the many environmental contaminants that we are all dealing with ... other toxic chemicals like Mercury can travel up to 1,000 miles in the air, so perhaps focusing on Maui is good, but testing all of the Islands would be better ... FYI ... Pearl Harbor had 2,000,000 ppt of PFAS (again, this is MILLIONS of times above the dose that causes significant health issues and CANCERS) ... I cannot emphasize enough the level of toxic chemicals (PFAS, Bisphenols, Phthalates, Heavy Metals, Pesticides ... etc.) that industry and the federal government has allowed us to be exposed.

Please support environmental testing of at least PFAS chemicals and please consider testing your citizens blood levels ... this is a significant problem that many States are having to deal with ... we must stop CHEMICAL POLLUTION if we all wish to continue living on this planet.

My name is Kaitlin and I am submitting written testimony in strong support of HB1840 HD2 and HB1841 HD2, both of which would increase funding to go towards our local needs and 'āina. It is clear our underinvestment in our environment is causing costly devastation, from firestorms, floods, and threats to public safety. Our best chance at avoiding the future and surmounting costs of environmental disasters is investing in resilience and restoration solutions today. Conservation is our best insurance policy.

It is important to invest in and take care of our environment. In return, the environment helps take care of us. More funding would allow for a healthy environment and a healthier community here in Hawai'i.

It is vitally important for our state to have funds dedicated to protecting and restoring our natural resources to prevent or mitigate the effects of climate events. This proactive, preventive approach to stewardship of our islands requires an investment in our 'āina. This measure is one of many initiatives that we support to increase funding for the incredibly important work that the Department of Land and Natural Resources (DLNR) does. Increasing funding for our natural resources is a pathway to a future where our keiki is safe, our environment is healthy, and residents and visitors benefit from the ecosystems we care for. Our community safety is at risk the more years we go without significant funding toward environmental protection and restoration.

I also support including additional revenue to fund DLNR so that Hawai'i can remove flammable nonnative plants and restore sites with less flammable native plants, restore coral reefs to help protect our beaches and coastal communities from sea level rise and storm surges, while also protecting the fisheries that draw tourists and sustain local residents. We need funding to restore watershed forests that protect our water quality and supplies, in addition to reducing the risks of fire, and to provide grants to local communities to assist them in managing and restoring natural resources, including reducing their fire risks.

Recent polling showed that 80% of Hawai'i residents agree state government programs are critical to protecting natural resources, from mauka to makai, and mitigating wildlife and flood risks. These programs need funding to protect us.

I urge the committee to pass all of these measures that would resource our State agencies and community organizations with the funding to protect our 'āina, restore our ecosystems, and manage our natural resources to build resilience and public safety.
