> On the following measure: H.B. 1966, RELATING TO HEALTH CARE

Chair Belatti and Members of the Committee:

My name is Gordon Ito, and I am the Insurance Commissioner for the Department of Commerce and Consumer Affairs' (Department) Insurance Division. The Department offers comments on this bill.

The purpose of this bill is to require health insurers, mutual benefit societies, and health maintenance organizations to provide health insurance coverage for various sexual and reproductive health care services and to apply the same coverage to health benefits plans under the Hawai'i Employer-Union Health Benefits Trust Fund, effective January 1, 2025.

We note that it is unclear whether the amendments in sections 2 through 7 of this bill, which require health plans to provide benefits for various sexual and reproductive health care services, would be construed as "in addition to the essential health benefits" within the meaning of 45 Code of Federal Regulations (CFR) § 155.170(a), or subject to

defrayment provisions under 45 CFR § 155.170(b) which apply to benefits "in addition to the essential health benefits."

For the Committee's information, Hawaii Revised Statutes section 23-51 provides, in part, that "[b]efore any legislative measure that mandates health insurance coverage for specific health services, specific diseases, or certain providers of health care services as part of individual or group health insurance policies, [sic] can be considered, there shall be concurrent resolutions passed requesting the auditor to prepare and submit to the legislature a report[.]"

Dear Chair Della Au Belatti and Vice-Chair Jenna Takenouchi and Members of the Health and Homeless Committee:

Members of AAUW of Hawaii thank you for this opportunity to testify in strong support of H.B. No. 1966 to ensure comprehensive coverage for sexual and reproductive health care services, including family planning and abortion for all people in Hawai'i.

After the disastrous **Dobbs v. Jackson** (2022) U.S. Supreme Court decision, this legislature came together to support SB 1, ensuring all Hawai'i people access to abortion as well as protecting our outstanding medical providers. Nevertheless, **rights** *without the ability to pay for necessary medical care* would *basically nullify* what was accomplished last year for so many women and others needing planned protection.

Hawai'i has long been a leader in advancing reproductive rights and advocating for access to affordable and comprehensive sexual and reproductive health care without discrimination. However, gaps in coverage and care still exist, and Hawaii benefits and protections have been threatened for years by a hostile federal administration under Trump that has attempted to restrict and repeal the federal Patient Protection and Affordable Care Act of 2010 (Affordable Care Act) and limit access to sexual and reproductive health care. The Trump administration was a nightmare: they made it increasingly difficult for insurers to cover abortion care and assembled a United States Supreme Court that restricted abortion access and that may eliminate the Affordable Care Act in the near future.

We understand that a host of the Affordable Care Act provisions could soon be eliminated, including coverage of preventive care with no patient cost-sharing. These changes would force people in Hawai'i to pay more health care costs out-of-pocket, delay or forego care, and risk their health and economic security. The COVID-19 pandemic cost thousands of people their jobs and health insurance. Forcing Hawai'i residents to pay more for preventive care would create a new public health crisis in the aftermath of a global pandemic.

Also access to sexual and reproductive health care is critical for the health and economic security of all people in Hawaii, particularly during a recession. Investing in no-cost preventive services ultimately saves the State money because providing preventive care avoids the need for more expensive treatment and management in the future.No-cost preventive services would also support families in financial difficulty by helping people remain healthy and plan their families in a way that is appropriate for them. Ensuring that Hawai'i's people receive comprehensive, client-centered, and

culturally competent sexual and reproductive health care is prudent economic policy that will improve the overall health of the State's communities.

Hawaii Medical Service Association (HMSA) appreciates the opportunity to provide comments on HB 1966, which will require health insurers, mutual benefit societies, and health maintenance organizations to provide health insurance coverage for various sexual and reproductive health care services. Applies this coverage to health benefits plans under the Hawai'i Employer-Union Health Benefits Trust Fund.

HMSA appreciates the legislature's intent to encourage access to sexual and reproductive healthcare services in Hawaii. While most of our plans to cover these services, some grandfathered plans opt out of them as allowed for by the Affordable Care Act. We would like to offer some concerns with the bill as currently written:

- 1. In the section relating to "Contraceptive Supplies" (page 20, lines 12-16) it is unclear how any health insurance plan would be able to offer coverage for a "partner of the insured".
- 2. It is also not clear whether the State can mandate a new coverage beyond the ACA that is a non-preventative service due to Section 1303 of the PPACA, as implemented in 45 CFR 156.280.<sup>1</sup>

### HB 1966 Relating to Health Care

Chair, Vice Chair, and committee members, thank you for this opportunity to provide testimony on this measure mandating coverage for a comprehensive category of reproductive health services, drugs, devices, products, and procedures.

### Kaiser Permanente Hawaii would like to offer comments.

Kaiser appreciates the intent of this bill to solidify the essential health benefits under the federal Patient Protection and Affordable Care Act of 2010, however, since last year's auditor's study concluded that "the sexual and reproductive health care services for which the bill would mandate health insurance coverage <u>are already covered by policies issued in the State of Hawaii</u>" and that "mandating that health insurers include coverage for the sexual and reproductive health care services listed in HB 1179 <u>does not change the status quo</u>", <u>Kaiser believes that this bill may be unnecessary</u>. See Page 9, *Study of Proposed Mandatory Health Insurance Coverage for Various Sexual and Reproductive Health Care Services (2023)* ("Auditor's Report"). Also, Kaiser is concerned that this bill is attempting to mandate new coverage beyond the ACA by including non-preventative services. For example, the Auditor's Report identified that certain of the bill's sexual and reproductive services "may be subject to cost sharing by the State of Hawaii, should the services described in HB 1179 be mandated." See Page 13, Auditor's Report. Therefore, as a non-preventative service (and non-essential health benefit under the ACA), standard office visit/hospital inpatient cost shares would apply.

As a section of the nation's leading group of physicians dedicated to improving health care for women, the Hawai'i Section of the American College of Obstetricians and Gynecologists (HI ACOG) **strongly supports HB 1966**, or the Reproductive Health Equity Act (RHEA), which would require health insurers and health maintenance organizations to provide coverage with no cost-sharing for various sexual and reproductive health care services.

As reproductive health care physicians, we see firsthand every day how people across the state depend on access to a wide spectrum of reproductive health care services, including screening and treatment for sexually transmitted infections, cervical cancer screening and treatment, contraceptive counseling and medications, abortion and miscarriage management, genetic counseling and testing, substance use and mental health disorders, and comprehensive prenatal and postpartum care. We have also seen the devastating consequences of delayed care due to financial concerns and inadequate insurance coverage. We have cared for patients who did not receive the standard-of-care cervical cancer screening because it is not covered by their insurance plan. We have taken care of pregnant patients with serious substance use and mental health disorders who were unable to receive treatment before, during, or after their pregnancy. It is critical that the people of Hawai'i have timely, affordable access to the full spectrum of reproductive healthcare.

Hawai'i has a proud legacy of progressive action and legislation protecting reproductive rights, access to abortion care, and family planning. With the overturning of *Roe v Wade* and more and more states restricting access to comprehensive reproductive health care, it is even more important that we pass legislation to protect our rights and access to the full spectrum of reproductive health care. We cannot depend on federal legislation to ensure access to this essential basic healthcare.

Hawai'i should join other states such as Oregon and Washington in passing RHEA. As the leading physicians in reproductive health care, we respectfully urge you to pass HB 1966.

Dear Chair Belatti and Members of the Committee,

Facing a potentially hostile federal administration and lawsuits threatening preventive services coverage, Planned Parenthood Alliance Advocates – Hawai'i (PPAA) strongly supports the Reproductive Health Equity Act ("RHEA"), a critical Women's Package bill aimed at fortifying ACA health benefits, safeguarding equitable access to abortion care, and protecting coverage of critical cost-saving preventive services.

The 2023 Auditor's report verified that there will be little-to-no financial impact of RHEA and that covering the no cost-sharing provisions will be immaterial and insignificant to insurance carriers' budgets. All people in Hawai'i – regardless of income, wealth, or type of insurance – should have access to the full range of preventive sexual and reproductive health services at no cost.

# The Reproductive Health Equity Act is a critical step toward health equity in Hawai'i by requiring insurance coverage of the full range of sexual and reproductive health care and critical preventive care services without cost-sharing.

Given the potential of a hostile federal administration and lawsuits like *Braidwood Management v*. *Becerra* threatening preventive services, it is more important than ever that the legislature act to ensure that nobody loses access to the health care and protections they depend on. RHEA will do just that.

We need legislation to codify the Affordable Care Act (ACA) preventive service coverage requirements in state law, ensuring that people in Hawai'i do not lose their access to no-cost preventive services such as birth control, well-person exams, PrEP, and life-saving cancer screenings. RHEA would also strengthen and expand these coverage requirements by no cost-sharing coverage of the full range of sexual and reproductive health care services, including abortion and vasectomy.

Without action, people in Hawai'i will continue to delay or forego care altogether due to out-of-pocket costs, risking their health and economic security. Even with the Affordable Care Act, one in five women with private insurance still pay some out-of-pocket costs for their contraceptive care, and 25 percent of women who are not using their preferred method say it is because they cannot afford it.[1] We are also already experiences some of the consequences of Hawai'i's coverage gaps in health outcomes: for example, Hawai'i's sexually transmitted infections (STIs) rates are the highest they have been in 30 years, with the STI rates more than doubling over the last ten years.

Last year, Hawai'i lawmakers took a step in the right direction by passing the shield law that protects access abortion care. We can further fortify Hawai'i's long-standing history in advancing abortion rights by passing the coverage requirements for abortion care in RHEA into law.

# **RHEA** will help us enact a cost-effective solution.

Protecting and expanding access to sexual and reproductive health is not only the right thing to do, it is also cost-effective for consumers and health plans alike. The services included in this legislation are basic components of comprehensive sexual and reproductive health care and are all associated with significant potential cost savings. That's because providing basic preventive care avoids the need for more expensive treatment and management down the road; for example, preventing unplanned pregnancies creates significant cost-savings, and early detection of sexually transmitted infections, diabetes, and cervical cancers lead to significant cost savings to the health system. Nearly all the services that RHEA requires are already mandated by the ACA, and even if some of the services are determined to be new mandated benefits, covering these services would likely be either cost-neutral or even cost savings for health plans in the long term.

The 2023 Auditor report reaffirmed RHEA's cost-effectiveness and verified that there will be little-to-no financial impact of RHEA, as nearly all the services are currently covered by health plans. Moreover, the Auditor notes that fiscal impact on health carriers of eliminating cost-sharing will, if any, be immaterial and insignificant to insurers' total costs. While covering these costs will likely have little impact on insurers, RHEA's no cost-sharing provisions will be indispensable to patients, who will benefit immensely from eliminating cost sharing for services like abortion or vasectomy.

# RHEA is similar to coverage requirements in other states.

Many other states have already implemented requirements found in RHEA, including the comprehensive sexual and reproductive health requirements. For example:

- Many other states have already implemented the requirements found in RHEA, including Washington, Oregon, Illinois, and California. Last year, Washington also passed a bill to ensure patients would not have to pay out-of-pocket for abortion care. This means <u>eight states</u> now mandate coverage of abortion services with no cost-sharing.
- In 2018, the Washington Legislature passed Substitute Senate Bill 6219, also known as the Reproductive Parity Act.[2] This legislation required that state-regulated health plans that cover maternity care provide substantially equivalent coverage for abortion care. It also expanded contraceptive coverage requirements beyond those in the ACA, including gender-neutral coverage of sterilization services for all enrollees and coverage of over-the-counter contraception. None of the requirements in this legislation was determined to be a new mandate that would trigger section 1311(d)(3) of the ACA. In 2024, Washington is also moving a bill to protect ACA preventive services coverage requires, HB 1957.
- In 2017, the Oregon Legislature passed House Bill 3391, also known as the Reproductive Health Equity Act.[3] This bill required comprehensive, non-discriminatory coverage of sexual and reproductive health care services. This included coverage of abortion and a wide range of other sexual and reproductive health care services at no out-of-pocket cost to the patient.
- In 2019, the Illinois Legislature passed the Illinois Reproductive Health Act, which required public and private insurance plans that provide pregnancy benefits to also cover abortions services any deductible, coinsurance, waiting period, or other cost-sharing limit that applies to abortion cannot be higher than what the policy requires for other pregnancy care.[4]

Several states have also put in place laws that codify existing requirements from the ACA to ensure that those important protections stay in place at the state level, no matter what happens at the federal level. For example, in 2017, Washington State enacted legislation requiring state-regulated health plans to cover all preventive services required to be covered under federal law as of December 31, 2016, without cost sharing.[6] The requirements of this legislation are broader than Hawai'i's RHEA, but the reproductive preventive health services are nearly identical to the coverage required in §431:10A-A(a)(1). In the fiscal note for Washington's legislation, the Washington Office of the Insurance Commissioner (OIC) noted that "[t]his bill does not have a direct fiscal impact on the OIC because the bill maintains coverage of preventive services with zero cost-sharing as they currently exist in Federal law and are currently being enforced by the OIC."[7] As OIC rightly stated, these are not new requirements: RHEA and similar legislation in other states simply require health plans to continue covering the basic health care that the ACA already requires them to cover. For example, states must already comply with coverage for any additional preventive women's services under 42 U.S. Code section 300gg-13 of the ACA; indeed, the scope of federally-required benefits expanded in December 2021.[8] These federal coverage requirements are already in place across the country and have already been well-defined.

Other states that have passed coverage requirements have found that continuing to require health plans to cover existing mandates in the ACA is simple and minimally burdensome. And other states have also determined that passing legislation that includes broader coverage requirements than those included in the ACA does not necessarily create new mandates because in some cases these coverage requirements simply clarify and codify the state's existing commitment to covering comprehensive sexual and reproductive health care. ACA requirements also continue to expand and evolve, making the impact of RHEA on Hawai'i minimal – for example, all plans that have an effective date of June 11, 2020 or later are now required to cover PrEP medication without cost sharing.

# Thousands of people in Hawai'i still lack access to the full range of reproductive health services.

Access to comprehensive sexual and reproductive health care is critical for the health and economic security of people in Hawai'i. RHEA will give more people in Hawai'i the ability to decide if and when they have children based on what's best for them and their family's circumstances. Hawai'i must continue its leadership in promoting all peoples' ability to access the health care they need and deserve, no matter what happens at the federal level. Please give Hawai'i families access to the health care they need to thrive by supporting HB 1966.

This testimony is submitted to support HB 1966, the Reproductive Health Equity Act (RHEA).

I share my personal experience in hopes of showcasing the vital importance of this bill. In my 20's I had an unplanned pregnancy which I sought advice from my OB/Gyn physician. I was not interested in continuing with the pregnancy, but the physician informed me that the pregnancy was too early to terminate and that blood tests would be in order. While waiting for those test results, I had severe abdominal pain and came back for an urgent appointment with this same physician- to which my complaints of pain were dismissed as cramps. Over the course of the next 2 weeks I called the physician's office and came in person multipole times because of acute abdominal pain, requesting a pregnancy termination but being dismissed each time with orders to complete further blood tests. In a few weeks time, I suddenly became paralyzed from the waist down and passed a large amount of blood. My partner carried me to the emergency room, where I lost consciousness from internal bleeding. The emergency room discovered that I had an ectopic pregnancy that had ruptured and I had lost a large amount of blood that required immediate emergency surgery. That procedure took me 2 weeks to recover with unpaid time off work, an additional 4 weeks of part time work, and hospital bill costs more than I could afford. After recovery, I never regained a menstrual cycle, and had to undergo therapy for post traumatic stress disorder from the near-death emergency. Years later when I was ready to have a child, I had no choice but to utilize assisted reproductive technology to conceive, which came at significant financial cost not covered by insurance.

All of these experiences could have been avoided, and my young adult life could have been reclaimed, had the medical provider honored my request to terminate the pregnancy.

As in my case, medical emergencies are often not clear until they are too late or almost too late; and laws creating obstacles to pregnancy terminations or removing an individual's autonomy regarding decisions about their pregnancy often cause avoidable physical, mental, and financial burden; or even death.

The RHEA will give more people in Hawai'i the ability to protect their health, which includes the ability to decide if and when they have children based on what's best for their individual circumstances.

Hawai'i must continue its leadership in promoting all people's ability to access the health care they need and deserve, no matter what happens at the federal level.

We are practicing family physicians in the State of Hawaii submitting testimony in support of HB1966. This bill would require insurance companies to cover essential sexual and reproductive health services including all contraceptives, STI testing, and abortion care without cost-sharing to the insured individual. This is consistent with current no-cost coverage for preventative health screenings as mandated by the Affordable Care Act. Many of these essential services are forgone by marginalized and underserved groups including minors and those with limited income due to cost or confidentiality concerns. We have cared for minors that decline testing for sexually transmitted infections or contraception because they cannot afford it or are not comfortable talking to their parents. This often leads to complicated health consequences and undesired pregnancies. Covering these essential sexual and reproductive preventative services decreases overall health care costs, as it allows individuals to plan families in their own time and have healthier pregnancies when they are ready. This bill would improve access to a breadth of preventative services, and would be a significant step toward promoting health for all people in Hawai'i.
