PURPOSE OF BILL: Appropriates funds to the Department of Education for the establishment of three full-time equivalent (3.0 FTE) Kaiapuni education curriculum specialist II positions and ten full-time

equivalent (10.0 FTE) Kaiapuni classroom teacher positions.

POSITION: Strongly Supports

Chair Dela Cruz, and Members of the Committee;

The Hawai'i Teacher Standards Board (HTSB) strongly supports HB2074, HD2, SD1, relating Kaiapuni education.

We need to support our Kaiapuni students and their schools with the licensed teachers and staff they need to meet their learning needs. The Kaiapuni program has expanded significantly over the last decade: they have increased both the number of Kaiapuni programs and their student enrollment; however they do not have enough teachers and staff to expand fully, and they should. The Kaiapuni program has been expanding in response to student and family demand as to provide "reasonable access to a Hawaiian immersion program" as required by the Clarabel case in the State Supreme Court in 2019. HTSB supports these efforts.

Kaiapuni programming requires professionals who have expertise in multiple disciplines including 'Ōlelo Hawai'i (the Hawaiian language) and their curriculum area or grade level. HTSB supports this bill's appropriations and the establishment of thirteen more positions for their Kaiapuni programming. It is a very important step to provide Kaiapuni programs with the specialized staffing they need for their expansion and sustainability. We support the measure so long as it does not adversely impact priorities identified in the Executive Supplemental Budget Request for FY2025.

The Hawai'i Teacher Standards Board asks your committee to support this bill.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS HB2074 HD2 SD1</u>, which appropriates funds to the Department of Education for the establishment of three full-time equivalent (3.0 FTE) curriculum specialist II positions and ten full-time equivalent (3.0 FTE) classroom positions for Ka Papahana Kaiapuni schools.

For Hawaiians, the life of our language, 'Olelo Hawai'i is tied to the health and well-being of our people and culture. "I ka 'olelo no ke ola, i ka olelo no ka make" is a revered Olelo No'eau proverb that translates to "Life is in speech/language, death is in speech/language." Ka Papahana Kaiapuni is an important program that both enhances the revitalization of our language and educates the next generation of students. Its success supports the health and well-being of Native Hawaiians, our language, and our culture.

Ka Papahana Kaiapuni programming has also been and continues to be integral to the State fulfilling its constitutional obligations: Article X, Section 4 of the Hawai'i State Constitution gives the State the duty to "promote the study of Hawaiian culture, history, and language." Further, the Constitution states that "the State shall provide for a Hawaiian education program" consisting of "language, culture, and history" in the public schools. The use of "community expertise shall be encouraged" as a suitable and essential means in furtherance of the Hawaiian education program.

As this bill notes, and as the Native Hawaiian Affairs Caucus of this Legislature has acknowledged by introducing this bill as an integral part of the Caucus's Legislative Package this session, demand for Hawaiian language immersion education has grown over the past decade despite resources declining. Kaiapuni programming requires professionals who have expertise in multiple disciplines including Hawaiian language and their curriculum area or grade level. OHA supports the appropriations being made by SD1 for the establishment of a total of 13 positions for Ka Papahana Kaiapuni programming.

It is an important and crucial step to provide Kaiapuni programs the specialized staffing that these Kaiapuni programs need for their expansion and sustainability.

Accordingly, OHA urges this Committee to **SUPPORT Ka Papahana Kaiapuni by advancing HB2074 HD2 SD1**. Mahalo nui for the opportunity to testify on this important issue.



Kākoʻo piha ka ʻOihana Hoʻonaʻauao o ke Aupuni Hawaiʻi (ʻOihana) i ka pila HB 2074, HD2 SD1. He noi kēia no 10 kūlana kumu Kaiapuni hou a me 3 kūlana laekahi hoʻonaʻauao Kaiapuni. The Hawaii State Department of Education (Department) fully supports HB 2074, HD2 SD1. The Department is requesting funding for 10 additional Kaiapuni teacher positions and 3 Kaiapuni Educational Specialist positions. In the past decade, the Department's Kaiapuni program enrollment has grown by almost 1,000 students to 2,374 students that are being educated in the medium of the Hawaiian language and 8 new schools in the Department to 22 schools in additional communities.

Growth of HIDOE Kaiapuni Enrollment in the Past Decade

The Kaiapuni program has experienced a 60% increase in both the number of available Kaiapuni programs and the number of students enrolled in the program. The Kaiapuni program has been expanding in response to student and family demand as well as to provide "reasonable access to a Hawaiian immersion program" as required by the Clarabel case in the State Supreme Court in 2019.

He kōkua nui ka puʻu kālā pekelala a me ka puʻu kālā a ke Kiaʻāina e kākoʻo ai i nā papahana koʻikoʻi no ka papahana Kaiapuni i kēia mau makahiki i hala akula. Federal pandemic education funding and the Governor's discretionary funds provided critical support for Kaiapuni program development over the last few years. These funds conclude at the end of this fiscal year. Legislative funding is necessary to sustain existing programs and to expand growing programs for next year and beyond.

Aloha mai e nā po'o a me nā lālā o ka 'Aha'ōlelo,

The 'Aha Kauleo (AKL) is the statewide council for the Papahana Kaiapuni, which provides proactive leadership, direction, and advocacy for the development and growth of its Hawaiian medium schools and advises directly through the Office of Hawaiian Education (OHE) of the Department of Education (DOE). AKL consists of parent and teacher representatives per elementary (K-6), secondary grades (6-12) and/or from each Hawaiian medium education site, and a principal representative, along with representatives from the University of Hawaii Hilo and Manoa, Brigham Young University-Hawaii, University of Hawaii-Maui College, Aha Punana Leo, Office of Hawaiian Affairs, Kamehameha Schools/Bishop Estate, and the Queen Liliuokalani Children's Center.

The 'Aha Kauleo is in **STRONG SUPPORT of HB2074** to appropriate funds to the Department of Education for the establishment of three full-time equivalent (3.0 FTE) curriculum specialist II positions and ten full-time equivalent (10.0 FTE) classroom teacher positions for Ka Papahana Kaiapuni schools.

First and foremost, this bill will ensure that the State upholds its constitutional responsibility to Article X, Section 4, "The State shall promote the study of Hawaiian culture, history, and language," Article XV, Section 4, "English and Hawaiian shall be the official languages of Hawaii" (Hawaii State Constitution, 1978). Furthermore, the State of Hawaii has two language medium pathways, English and Hawaiian. Whereas the English medium pathway has access to an abundance of resources, including specialists, consultants, and a much larger pool of potential teachers, the Hawaiian medium pathway needs to grow its own expertise amongst its communities and educators. For example, the English medium pathway can and has recruited teachers from out

of state to fill teaching positions. Adding more Kaiapuni teachers and specialists to the pool that supports the Hawaiian medium pathway allows for collaboration amongst Hawaiian medium educators across the state's 29 Kaiapuni schools to expand expertise, curriculum, assessment, resource development, and other vital needs for Kaiapuni education.

Kaiapuni teachers are a distinct specialty area with the linguistic and cultural competencies to teach a range of content, all through the Hawaiian language and worldview. Currently, the DOE funds 35 teacher positions across the DOE's twenty-two Kaiapuni schools. In the last decade, the number of Kaiapuni schools increased by eight, and by nearly 1,000 students. Yet, the allocated teaching positions have remained the same. Due to the shortage of teaching positions, the DOE schools have been forced to turn away many families because of the lack of teachers. Of concern is that there are six complex areas, including one island, where the DOE is not providing access to Kaiapuni education.

We urge the committee to **PASS HB2074** to ensure equitable access to Kaiapuni education on all islands in Hawai'i's public schools and uphold guidelines outlined in BOE policy 105-8.

Aloha mai e nā pua o ka wēkiu i ka 'Aha 'Ōlelo o ka pae'āina nei,

Mai ka lā hiki mai a ke komohana, mai ka moa'e aheahe a nā kona, aloha e nā hoa o nā kūkulu 'ehā o ke ao! My name is Wendy Akioka, also known as Kumu Kalae in my community. My son graduated from a kaiapuni school, my daughter attends my school, Ke Kula Kaiapuni o Kailua, and my husband teaches at another kaiapuni school, Pū'ōhala. I am also an active member of the 'Aha Kauleo and the chair of the Hawaiian Education Committee for the HSTA. Needless to say, Hawaiian education and kaiapuni is a part of our 'ohana and lifestyle.

I can provide a unique perspective, because I have worked in many capacities of the education system, from high school Hawaiian language teacher, to elementary kaiapuni teacher, to OHE resource teacher, to Early College Coordinator for kaiapuni under a grant a Windward Community College, back to high school kaiapuni teacher. I understand this system from various, unique perspectives.

I am writing in **STRONG SUPPORT of HB2074 HD2, SD1** - Relating to Kaiapuni Education.

SB2069 asks for three curriculum specialists. As someone who once worked at the HIDOE's Office of Hawaiian Education (OHE), where these positions would be housed, I know first-hand the daunting amount of work faced by the people there. The most difficult thing to do when working toward equity and restorative justice is to shift mindsets. The HIDOE's own strategic plan calls for this, however, without permanent positions to address it, they will find it difficult to meet that goal. The Department of Education needs more people at OHE to help them make decisions for the good of ALL, not for the good of the MOST. These are the voices that help us remind our friends at places like the Office of Talent Management what happens when they make swooping rules that do not consider the effect of requirements on those in unique, rich, Hawaiian settings, people whose specializations help our students find themselves and make connections in a decidedly Western academic context.

Regarding the ten teaching positions proposed in the first section of this bill, I admit that this affects me directly. Ke Kula Kaiapuni o Kailua began nearly three years ago out of thin air. My former principal, Stacey Oshio, agreed to make it happen when asked by Phyllis Unebasami, then I came in and voila! We had a program. The importance of a program like mine to its community is to provide a Hawaiian language pathway for the second largest Native Hawaiian population on Oʻahu, that is for the Koʻolau Poko area. It was only made possible because of the existing teacher positions from OHE, because when a new program starts up, there are rarely enough student numbers to support a teaching position under weighted student formula (WSF), especially at the high school level. In late 1990s to early 2000s, the HIDOE was given a set number of positions directly from the legislature because they recognized the burden the smaller numbers were placing on the programs and schools. However, since that time, the number of kaiapuni schools and programs have nearly doubled, yet OHE has not received any increase in positions to offset the growth. What happens now is that larger kaiapuni schools give up their positions in order to make room for programs like mine. The increase in 10 positions would ensure that I do not have to take from someone else to exist.

In conclusion, I urge the Committee to <u>PASS</u> HB2074 HD2, SD1. Mahalo for the opportunity to provide written testimony in support.

The Hawai'i State Teachers Association **supports** HB2074 HD2 SD1 which appropriates funds to the Department of Education for the establishment of three full-time equivalent (3.0 FTE) Kaiapuni education curriculum specialist II positions and ten full-time equivalent (10.0 FTE) Kaiapuni classroom teacher positions.

We know that the Hawaiian language is an official language of the State of Hawai'i. As an official state language, the state has an obligation to support the growth and use of Hawaiian. Currently, the state funds 28 kaiapuni (Hawaiian immersion) schools statewide. The state has also made a promise to increase access to Hawaiian language to all keiki in Hawai'i.

Although promises have been made and documented, the state still has failed to create a sustainable, measurable plan to expand the Hawaiian language to all our students. Although we have 28 kaiapuni schools in Hawai'i, only 15 of these schools have a pipeline to graduation. In addition, at most, only 39 English medium schools offer Hawaiian as a world language.

It is imperative to grow our own Hawaiian language speakers throughout the state so that there is a consistent pipeline of Hawaiian language speakers. These native speakers will be able to fill the critical shortage areas where the Hawaiian language is being taught.

To ensure that 'olelo Hawai'i is never endangered again and those opportunities to learn the Hawaiian language are available for all keiki in Hawai'i, the Hawai'i State Teachers Association asks your committee to **support** this bill.

KKOP is part of the growing Hawaiian immersion program throughout Hawaiʻi: there has been an increase of 8 kaiapuni schools and there has been an increase in students by almost 1,000 in the past 10 years. And yet the DOE only funds 35 teacher positions across the state for 22 schools. The students, kumu, and community of Ke Kula Kaiapuni O Pūʻōhala deserve the support from the Department of Education for equitable education.

HB2074 ensures that the State upholds its constitutional responsibility to Article X, Section 4, and Article XV, Section 4 of the Hawaii State Constitution (1978). It also ensures equitable access to resources and education specifically for Hawaiian immersion education in Hawai'i's public schools.

I am writing to **urge** the committee to fund **HB 2074 HD 2** to increase teacher positions and curriculum specialists for the Hawai'i Department of Education's (HIDOE) Office of Hawaiian Education (OHE) whose budget supports the Hawaiian Language Immersion Program (HLIP) also called Ka Papahana Kaiapuni. I trust that the committee knows the history of public schools very well and recognizes that our schooling system was a Hawaiian Language system for many, many years. And that it was through the efforts of our political and educational leaders that Hawaiian Language was reinstated into our public school system. **Thirty eight years later**, we are experiencing an increase in student enrollment across many communities in our state. The need is clearly evident and funding is critical.

My name is Rebecca Kapolei Kiili and I am a public school teacher for the HLIP at King Kekaulike High School (KKHS) in Pukalani, Maui. I am in my 19th year of teaching and have spent 5 years in elementary and spent the rest of my career helping to strengthen the high school immersion program. When I first entered this level in 2010, there was a severe lack of curriculum for high school immersion students, which left me having to develop my own entirely. At that time, there were only 2 teacher positions and while the enrollment numbers were smaller, the amount of courses that each teacher taught were beyond our contractual duties. I had to work to create curriculum and assessments for 7 subject areas in one school year. It was daunting for sure and I did the best that I could given the lack of resources, including time and money.

Today, we have 5 teacher positions at KKHS and our numbers are growing steadily each year. The need for teacher positions and curriculum specialists are vital to ensure that our students have a highly qualified teacher along with quality curriculum, instruction, and assessments. Everyone knows that investing in a child's education is key to that child's success in life. When the educational foundation is strong, students develop into well adjusted citizens who contribute to our community in ways that are positive and progressive. Students are less dependent on social services to live and thrive because their compulsory education has enriched their lives and given them the skills they need to succeed: confidence, esteem, efficacy, curiosity and tenacity.

Kula Kaiapuni programs not only strive to have our students academically ready for college, but also community and career ready. We work to provide them with rich cultural experiences in language, culture, and values that develop the whole child so that they become great citizens of

our community. Our matriculation rates as well as our college going rates exceed those of non-Kaiapuni students. Students learn how to work with diverse peer groups throughout their whole life and how to create community through their parent organization. Our Kaiapuni families are strongly rooted in Hawai'i and add so much value to the larger communities. This program is truly an exceptional model for education, and most especially Hawaiian education, in Hawai'i, for all of Hawai'i.

Investing in Kaiapuni today through **HB 2074 HD2** demonstrates our state's commitment to the value that we all seek to add to our communities by way of high quality education. **I strongly urge the committee to fund this bill.** The intent of this bill is to ensure that the next generation of Kaiapuni learners have the resources they need and deserve to become Hawai'i's citizens of the future. Invest in our children, invest in Hawai'i, invest in our public education system.

Thank you for your time, leadership, and funding Kaiapuni programs to provide the resources they need and deserve.

Aloha nui kakou, he wahi kama keia no Nu'uanu e ho'ike nei i ko'u kako'o nui no keia pila.

HB2074 will provide critical state funding to retain 13 teaching positions in kula Kaiapuni (Hawaiian immersion schools) that will otherwise disappear for the 24-25 school year when COVID era funding expires. Please pass this bill so our Keiki do not lose the 13 locally grown, locally educated teachers. We are in the midst of a severe shortage of teachers, and the Kaiapuni program already challenges its small teaching staff to go far above and beyond the demands that ordinary teachers are asked to do. Please make the necessary concessions to ensure this bill passes during this year's legislative session.

I am a former kumu kula kaiapuni (Hawaiian immersion school teacher) writing in strong support of this bill because of what it will do to alleviate the uniquely challenging burden that Hawaiian immersion school teachers. Hawaiian immersion school teachers are grossly overburdened in their teaching positions because there are simply not enough teaching positions for the job. This is the result of several unique issues facing Hawaiian immersion schools, listed below:

- 1) the small size and high demand for Hawaiian immersion schools means that teachers often handle very full classrooms, often in the high 20's per class.
- 2) there is a severe shortage of curricula and teaching materials in Hawaiian language, and existing materials are often outdated, so teachers spend a disproportionate amount of time developing their own teaching materials.
- 3) many Secondary/Subject teachers are stretched thin teaching multiple subjects or handling far more classes than any typical HIDOE teacher ever would.

I was introduced to the overwhelming burden faced by Hawaiian immersion school teachers when I worked as a Part-Time teacher at Ke Kula 'o Anuenue in Palolo, O'ahu. The high school science teacher at the time had to teach four subjects - Biology, Chemistry, Physics, and Plants and Animals of Hawai'i - for the entire 9-12 grade. There were only textbooks for three of the four courses, but it had been translated from an English textbook over 20 years ago, meaning that both the content and language in the text were outdated. The textbook did not come with lesson materials. As a casual hire Part-Time teacher, I lightened the full-time science teacher's load by teaching one of the four subjects, but even then, sometimes there was simply not enough time for

either of us to develop teaching materials for lessons each day, and the same lessons were sometimes repeated across multiple subjects.

In any other school, there would be four teachers, one for each subject, but at this Hawaiian immersion school, one single teacher bore the overwhelming burden of teaching four different subjects. Students' learning suffered as a consequence. At the same time, teachers in lower grades at Anuenue frequently had class sizes that were far too big - as many as 29 students - because of the huge and unmet demand for Hawaiian immersion education in Elementary school. The teaching positions added by this bill would go far to alleviate the overwhelming teaching load that immersion teachers uniquely face.

When I taught secondary science at another Hawaiian immersion school, I was responsible for teaching the science for all of 7-12 grade. This meant I faced a similar challenge of teaching multiple subjects. Because it was my first year teaching full time, I often needed help, but who were the educational support staff designated to help? They were also themselves teachers or administrators who were also overburdened for the same reasons I was. I found myself avoiding seeking help because I did not want to add to their burden, but my teaching praxis suffered as a result, students received a worse education, and I became burned out as a teacher. The curiculum specialist positions proposed by this bill would be an enormous gift that would go far to solve the problems I faced as a kumu kula kaiapuni.

I strongly urge you to move this bill forward and support similar legislation in the future in support of Ka Papahana Kaiapuni in Hawai'i. The kula kaiapuni in Hawai'i are a critical site where we can undo the historical wrongdoings that resulted in the near loss of our language and moreover offer a place to rediscover Hawaiian knowledge and perspectives. The place-based and culturally grounded education that takes place in our schools have been proven in research and practice to improve the education of our students and can serve as a model for other schools. But a prerequisite for this to happen is sufficient staffing for our unique schools' unique needs. Mahalo nui no kau kako'o i keia holomua no ko Hawai'i.

This bill will ensure equitable access to resources and education for Hawaiian immersion education in the state according to BOE policy 105-8 and ensure the state upholds its constitutional responsibility to Article X, Section 4, and Article XV, Section 4 of the Hawai'i State Constitution. Hawai'i is a dual language state and more resources are needed to support Hawaiian language education.

Schools need more teacher positions as new schools start and more students enroll. Schools also need more support with curriculum, instruction, and assessment, which the three curriculum specialists will help address.

In conclusion, I am in strong support of HB2074 HD2, SD1. I urge the Committee to PASS HB2074 HD2, SD1. Mahalo for the opportunity to provide written testimony in support.
