Chair Yamashita, Vice Chair Kitagawa, and Members of the Committee:

The Hawaii Military Affairs Council ("MAC") wishes to offer comments on HB 2084, HD1 which establishes a vacated homeless encampment clean up task force to identify parcels of land that require intergovernmental coordination to clean up vacated homeless encampments located on lands managed by government agencies, including but not limited to the United States Army Garrison Hawai'i, and execute a memorandum of understanding to clean up vacated homeless encampments located on the identified parcels.

The MAC was established in 1985 when the Chamber was appointed by the State to serve as the liaison to the military. The MAC advocates on behalf of Hawaii's military, and is comprised of business leaders, academic institutions, State and County officials, members of the CODEL, community leaders, labor unions and organizations and retired U.S. flag and general officers. The MAC works to support Hawaii's location as a strategic U.S. headquarters in the Indo-Asia-Pacific region which is crucial for U.S. national and homeland security.

The proposal to establish a homelessness encampment clean up task force within the Department of Transportation is well-intentioned. However, there is already an existing, effective collaboration between the United States Army Garrison and the Department of Transportation which successfully works on, among other issues, the challenges of homelessness on state- and federally-owned lands.

The Department of Transportation, with its clearance capability, has been working to address the environmental and public health hazards posed by vacated encampments. The proposed task force seems redundant given this established commitment and relationship. Most respectfully, it would be more beneficial to focus on strengthening this relationship and leveraging their combined capabilities.

I am writing the letter to provide support for HB 2084 which appropriates funds and establishes a vacated encampment clean up task force. As well, to enter into agreements to coordinate the clean up of vacated encampments located on lands managed by the U.S. Army Garrison.

I most recently worked with the office of Representative Trish La Chica regarding critical conditions of an encampment at Mile Marker 15 on Kamehameha Hwy. in Waipahu. This encampment was directly adjacent to the Koa Ridge Community where I reside with my family.

Representative La Chica's office identified outside agencies who contacted the residents of the illegal encampment to inform them of residential housing opportunities that would provide appropriate and safe shelter. Some months ago, a coordinated effort with the U.S. Army Garrison and the DOT and others, cleaned up the large encampment. The unsightly and unsafe site is now vacated, nightly altercations have ceased, occupants no longer roam the Koa Ridge Community and vehicles parked adjacent to the camp site no longer pose a traffic hazard along this busy stretch of Kamehameha Hwy.

It is my sincere hope HB 2084 passes and a Task Force is created and funding appropriated. Thank you for the opportunity to provide input.
