The Hawaii State Council on Developmental Disabilities **supports HB2216 HD2**, which increases the cap on state supplemental payments for type I adult residential care homes, licensed developmental disabilities domiciliary homes, community care foster family homes, certified adult foster homes, and type II adult residential care homes.

<u>DEPARTMENT'S POSITION</u>: The Department of Human Services (DHS) supports this measure so long as the current program appropriation is not reduced in HB1800 HD1 and respectfully requests amendments to effectuate the proposed increases.

<u>PURPOSE</u>: This measure increases the cap on state supplemental payments for type I adult residential care homes, licensed developmental disabilities domiciliary homes, community care foster homes, certified adult foster homes, and type II adult residential care homes. Effective 7/1/3000. (HD2)

The Committee on Human Services (HD1) amended the measure by making a technical, nonsubstantive amendment for the purposes of clarity, consistency, and style.

The Committee on Finance (HD2) amended the measure by:

- (1) Changing the caps on state supplemental payments for the various care facilities to unspecified amounts; and
- (2) Changing the effective date to July 1, 3000, to encourage further discussion.

DHS supports the proposed increase of the state supplemental payments (SSP) care rate by \$132.10 to \$784.00 for type I and \$892.00 for type II settings. So long as the current program budget appropriation is not reduced in HB 1800 HD1, increasing the monthly SSP rates by these amounts will not require additional general fund appropriation.

The Department respectfully requests additional amendments to insert October 1, 2024, on page 1, line 11, and page 2, line 3, and an effective date of the bill no later than June 2, 2024. The Social Security Administration advised that it could implement the new rates with 120-day notice prior to the effective month. June 3, 2024, is 120 days prior to October 1, 2024.

My name is Keali'i Lopez, and I am the State Director for AARP Hawai'i. AARP is a nonpartisan, social mission organization that advocates for individuals age 50 and older. We have a membership of nearly 38 million nationwide and nearly 140,000 in Hawaii. We advocate at the state and federal level for the issues that matter most to older adults and their families.

AARP supports H.B. 2216 HD1 which increases the cap on the state supplemental payments for type 1 adult residential care homes, licensed developmental disabilities domiciliary home, community care foster family and adult homes, and type II adult residential care home.

Hawaii's 1,600+ foster family and adult residential and domiciliary homes for our older and disabled adults are an integral part of our long term care system. These HCBS providers provide over 8,300 beds which are twice the number of the beds provided by the 46 licensed nursing home facilities in state. These HCBS residences are cost-effective, high quality and support people's preference to age in a home-like setting. Increasing the supplemental payment cap is long overdue. With the rising cost of living, these dedicated providers deserve this increase so that they can continue to care for Hawaii's aging population.

Chair Joy San Buenaventura, Vice Chair Henry Aquino, and Members of the Committees:

The Adult Foster Homecare Association of Hawaii (AFHA) **strongly supports HB2216**, which increases the cap on state supplemental payments for type I adult residential care homes, licensed developmental disabilities domiciliary homes, community care foster family homes, and certified adult foster homes and type II adult residential care homes.

Community care foster family homes (CCFFHs), which supplies over 2,000 beds statewide to elderly and disabled Hawai'i residents, have very minimal increase for over 15 years. We've borne the brunt of inflation and other cost increases.

We applaud the state for commissioning the Home and Community-Based Services (HCBS) Rate Study Report by Milliman on December 2022. Finally, someone has validated what we have been saying for the last 15 years. For years, it's as if no one has taken us seriously, taking us for granted. Finally, someone is recognizing our plight as an industry.

Based on the Milliman Report, the Department of Human Services, Med-Quest Division (Med-Quest) concluded: "It is also important to focus on HCBS providers who serve groups with high utilization of services and who have gone the longest without a rate update such as case management agencies, **community care foster family homes**, and adult day health and day care centers."

Ironically, the recognition of our hardship comes from an outside consultant from out-of-state. Perhaps a broader national perspective accentuates how far behind CCFFHs lag behind and how we are undervalued. We emphatically join Med-Quest in their observation that it is time "to revise how providers of long-term care are reimbursed to better meet current and future needs." Now is the time!

We were already the lowest paid in the nation – below even the "low" end of the spectrum according to Milliman. Inflation, which spiraled out-of-control, has exacerbated the challenges. Our industry and profession is one in which the younger generation in our country have little interest. Rarely does a young person today have ambitions to become a CCFFH or other type of care home. We need to set a solid foundation for the future.

#### About AFHA

The Adult Foster Home Association of Hawaii (AFHA) is the industry trade association of providers under the Community Care Foster Family Home program under the Department of Human Services, State of Hawaii. With a membership of almost 1000 providers, AFHA's mission is to promote the interests of providers as well as resident clients. AFHA members provide 24-hour care to resident clients 7 days a week, 365 days a year.

The costs of living here in Hawaii have escalated over the years. It's just so difficult financially for caregivers to survive especially with the cost of housing, food and other commodities here in Hawaii.

We save the State of Hawaii significant amount of money for providing care to our Kupuna's and disabled. It's time for the State of Hawaii to think about us so that we can continue to take of our vulnerable elderly and disabled.

For the reasons provided, we request that you pass HB2216.

#### **TESTIMONY**

#### HB2216

DEAR CHAIR, SAN BUENAVENTURA, VICE-CHAIR AQUINO AND ALL MEMBER OF THIS COMMITTEE:

First, I would like to thank you for this bill. I stand in support of this bill; however, I believe that the state could do much better by granting us, caregivers, a fair increase—enough so that we don't have to keep coming back every year to ask for an increase. As you're probably aware, we haven't had an increase for the last 15 years.

My mother opened our Type I Adult Residential Care Home (ARCH) over 50 years ago—where the entire family helped & support running the care home but over the years, a lot has changed—where family members either work full time to make a living or moved out of Hawaii—due to the rising cost of living. I took over our care home from mom when she retired over two years ago. Our care home is licensed through DOH to provide home for individuals—who needs placement & care is now my full-time job and source of my income. From the current Room & Board pay of \$1,544.90 per client a month (5 clients maximum but it could be less), I don't have much income left for me after expenses—as the cost of living in Hawaii has gone up tremendously. In addition, I think it's inhumane that I can't even go on vacation because it would cost too much to hire a live-in substitute.

I don't have help from my family so; therefore, I need to hire help to substitute for me when I do errands—to bring patients to their doctors' appointments—which always takes a lot of time, to do groceries, to go to my own personal appointments, etc. My care home pay doesn't allow me to hire a substitute caregiver because I am only getting paid from individuals (clients) who are NOT SUBSIDIZED through Medicaid. The current Room & Board (SSI/STATE SUPPLEMENT) is not feasible to keep our care home going while the cost of living continues to go up—year after year without a decent increase in our pay.

We provide 24/7, 365 days a year supervision to our clients; we're required to provide minimal supervision as our clients are Ambulatory—basically independent but not really because, sometimes, we deal with clients' w/behavior issues—especially when their medications aren't effectively helping. In this case, we would communicate with clients' doctors often to adjust/reevaluate clients until the right medication works effectively. Sometimes, a client can be difficult as they require constant guidance and reminders. In most cases when we admit a Client, their Level of Care only includes two doctor appointments every 3 to 4 mos. But during initial client visit to the doctor, they suddenly have too many additional doctors' appointments.

Type I ARCH doesn't have the Burden of Care Cost. I ask this committee to help secure a higher Level of Care for our clients/individuals who are not currently receiving Medicaid benefits. In doing so, I think that it will help resolve the underpayment issue for Licensed Homes Room & Board pay. Once our clients are granted a higher LOC, they will be able to receive Medicaid benefits—thus paying us, Caregivers, a little more. As the cost of living in Hawaii today is ranging from \$1,900 to \$2,400 per individual, we ask this Committee to increase our Room & Board pay by increasing the State Supplement to \$1,057—instead of \$784 as stated in your bill.

Your kind consideration and approval of the Room & Board pay by increasing the State Supplement to \$1,057 would be greatly appreciated--as it will enhance the lives and businesses of Caregivers.
