**POSITION: Strong Support** 

During the 2022 Legislative session, the workforce readiness program was established by the Legislature through Act 261. This Act established a workforce readiness program to provide opportunities for adult education students as well as high school students to earn Workforce Development diplomas or Career Foundations Certificates to ensure that these students acquire the necessary skills and credentials needed to become highly employable. Since then, McKinley Community School for Adults has successfully designed and implemented the Career Foundations curriculum that address the need for workforce preparation. In addition, an Entrepreneurship Program along with a Travel Guide training program is being designed with implementation scheduled for Summer 2024.

Currently, the program employs part time temporary teachers, that are at times transient. The program and students at McKinley Community School for Adults would benefit from full time teachers to expand and enhance the available offerings for workforce preparation and certification.

Also, McKinley Community School for Adults is partnering with the Kauhale homeless project to provide the Career Foundations certificate programs as well as GED certification utilizing appropriated Federal funds to minimize cost to participants. Plans are to provide the service to the Kauhale in Windward Oahu, Middle Street, Maui, and any future Kauhale's. This program will provide residents of these shelters the opportunity for education, employment and eventual transitioning into the community in which they reside. These resource teachers, in addition to servicing each of the campuses, would be assigned to coordinate workforce preparation programs with other related programs to facilitate successful implementation.

I am writing in strong support of HB 2242, HD2 that appropriates the necessary funds for four full-time equivalent (4.0 FTE) Career Foundations Certificate Program Teachers for McKinley Community School for Adults. The campuses that will be serviced, include Oahu, Maui, Lanai, Molokai, and Kauai. These teachers will serve as leads as well as instructors for the number of existing programs as well as expanding the service to other locations. Please support the need to develop a system that prepares a workforce with the skills valued by employers.
