Thank you for the opportunity to testify in support of Senate Bill No. 2951, which appropriates funds to the Agribusiness Development Corporation (ADC) to establish positions to maintain and improve the East Kauai irrigation system and for the maintenance of and improvements to the system.

The East Kauai Irrigation System (EKIS) includes the Hanamaulu Ditch, a branch of the system, that provides irrigation water to ADC tenants for their operations. At its peak, EKIS consists of 51 miles or ditch, 18 diversions and delivered 80-100 million gallons of water per day to the surrounding plantation lands. In recent years, following the departure of Lihue Plantation and the dissolution of the East Kauai Waters Users' Coop, the Hanamaulu Ditch has fallen into disrepair resulting in loss of water to affected ADC farmers and

ranchers. In many cases, ADC's tenants themselves have been doing minor repairs and maintenance to restore water access.

ADC is seeking funding and positions to preserve the EKIS, which could potentially provide thousands of acres of state and private land with access to irrigation water. Additionally, the funding will be used to ensure the associated reservoir spillways are compliant with all relevant dam safety requirements.

These are critical safety issues that need to be addressed immediately.

ADC believes these investments will ensure the system can deliver a reliable source of water for another hundred years. Furthermore, ADC will be able to attract and support agribusinesses and producers to promote agriculture and preserve the region's rural character.

Aloha Chair Yamashita, Vice Chair Kitagawa, and Members of the Committee:

The Department of Hawaiian Home Lands (DHHL) **supports with amendments** this bill which appropriates funds to the Agribusiness Development Corporation to establish positions to maintain and improve the East Kauai irrigation system and for maintenance of and improvements to the system, effective 7/1/3000.

The DHHL appreciates the intent of this bill and the inclusion of Hawaiian Home Lands (HHL) in the purposes section of the bill. Kaua'i includes over 20,000 acres of HHL, with approximately 526 acres in the Wailua area which once was and again could be served by the East Kauai Irrigation System.

Water in Hawaiii is held as a public trust resource, a status which derives from laws in the Hawaiian Kingdom as well as common law, case law, and State Constitutional provisions. A number of laws and policies at the State level have been enacted and / or ruled on which, at least in black letter law, provide mechanisms for addressing the water needs of native Hawaiians on Hawaiian Home Lands. However, the challenges we face in water access and management are very significant. The DHHL supports this measure as a step in the right direction.

DHHL would encourage the Committee to consider amending the bill to make the intent to help serve DHHL lands explicit in the funding mechanism on page 4 with part (I) of Section 1 of the bill to read: "Appropriating funds to the agribusiness development corporation for maintenance of and improvements to the east Kauai irrigation system including design, construction and maintenance of improvements to the system that will ensure water delivery to the Department of Hawaiian Home Land's Wailua lands."

In consideration of HOUSE BILL 2263, HOUSE DRAFT 1 RELATING TO THE EAST KAUA'I IRRIGATION SYSTEM

House Bill 2263, House Draft 1 proposes to appropriate funds to the Agribusiness Development Corporation (ADC) to establish positions to maintain and improve the East Kaua'i Irrigation System and for maintenance of and improvements to the system. **The Department of Land and Natural Resources (Department) supports this measure.**

The East Kaua'i Irrigation System was formerly under the management of the East Kaua'i Water Users Cooperative (EKWUC) via a month to month revocable permit. On September 3, 2019, the EKWUC voted against the continuation of their revocable permit which expired on December 31, 2019. The irrigation system, including the reservoir, has since reverted to the Department's management beginning January 1, 2020. The Department's current oversight of the irrigation system is focused on addressing public health and safety and preserving the viability of the irrigation system for future use, but not for the continued delivery of water to various users. As an interim measure, the Department has used its limited operating funds to hire a contractor to operate and maintain the system on a limited basis to address public health and safety issues.

The Department's primary objective has been to identify an appropriate agency that can assume management and operation of the system as had previously been done by EKWUC. Working toward this goal, the Department has had discussions with ADC regarding transferring the system to ADC for operation and management. The Department understands that ADC would need financial and staffing support and believes this measure would satisfy that objective, thus ensuring the ongoing operation of the irrigation system by ADC in support of local agriculture.

Furthermore, the Department does not have the resources and expertise to function as a water delivery provider, which would be inconsistent with the Department's mission of natural, cultural, recreational and historical resource management and protection.

The EKIS has long been a vital lifeline for agricultural production on Kauai's eastside. For many years, this irrigation system allowed thousands of acres of land to be utilized for profitable agricultural production. After Lihue Plantation shut its doors, the irrigation system's future remained unclear.

Formed in the early 2000s, the East Kauai Water Users' Coop (EKWUC) assumed management of the state-owned irrigation system after the Department of Land and Natural Resources (DLNR) indicated that they intended to do something other than operate the system. With previous support from the legislature and the County of Kauai, the EKWUC successfully operated the system for 18 years. In 2020, due to financial and workforce capacity limits, EKWUC forfeited attempts to obtain a long-term license required by DLNR. My name is Les Milnes and I **support HB2263, HD1**. I am the president of the Kalepa Koalition, an Hawaii agricultural cooperative of the farmers and ranchers who hold long-term licenses on 6,500 acres of State land behind Kalepa Ridge on Kauai and under the administration of ADC.

The East Kauai Irrigation System services a large portion of the Kalepa lands; most of the farmers, ranches and the huge Mahipapa LLC (formerly Green Energy Team) biomass project on a 1,000 acres utilize the system through Hanamaulu Ditch or off the Upper and Lower Aahoaka Reservoirs. A large parcel of Hawaiian Home Lands is serviced by the east side of the system. Also, the system can delivery water to some 2,000 agriculture acres north of the Kalepa lands behind Kapaa.

The system was previously managed by the East Kauai Water Users Cooperative, of which I was an integral part. However, following the Maui water use decision cancelling the ability of DLNR to issue year-to-year revocable permits for water, it simply became impossible for the Coop to finance the very high cost of obtaining a long term lease. Indeed, even well funded businesses, such as KIUC, have been unable to obtain longterm licenses, despite decades of effort. These State-owned water systems can only be managed by State agencies, in this case ADC which has come forward to take over the system. Their efforts to take over the system are in line with the State's declared intention to provide water for agriculture. ADC sees the need to protect this immense and irreplaceable resource absolutely essential for the present needs and future development of Kauai's farmers and ranchers.

I respectfully request that this bill be passed.

Chairperson Yamashita and Members of the Committee:

My name is Jerry Ornellas and I **support HB2263**, **HD1**. I was the president of the East Kauai Water Users' Cooperative which managed the State-owned reservoir and ditch system in the Kapaa/Kalepa area from 2001 to 2020 under a year-to-year revocable permit from the Department of Land and Natural Resources.

On September 20, 2016, the Cooperative was informed by DLNR that as a consequence of the East Maui irrigation decision we would have to seek a long-term water lease. We were given three years to complete the application process which included an Environmental Impact Statement—alone beyond our monetary resources to pay for—as well as other complex requirements. Even if we had the monetary resources to meet the requirements, we could only bid on the system at public auction with no guarantee that we would ultimately be awarded a lease for the system.

Once the three years expired at the beginning of 2020, DLNR no longer could legally renew the system's revocable permit, the Coop ceased operation. The irrigation system, including the recently renovated Wailua and Upper Kapahi Reservoirs, reverted to DLNR control (including dam safety oversight). DLNR has minimally managed the north side of the system since.

Our system includes three reservoirs and 22 miles of ditch which has historically serviced thousands of acres of State and private lands. In particular, it can supply irrigation water to more than 1,000 acres of the State Kalepa lands located between Kapaa and Lihue, and a similar amount of private former cane lands mauka of Kapaa town. When first taken out of sugar cane in 2001, the Kalepa lands had gone into pasture, but in the last few years, through the good action of the Agribusiness Development Corporation, nearly 500 acres to date has been leased to farmers who are actively developing their crops, including ginger, bananas, noni and sweet potatoes. This is only possible because the Coop provided these farms with water through Hanamaulu Ditch.

These Kalepa lands in particular are in a precarious position. Technically, the Hanamaulu Ditch remains under DLNR control, while the surrounding land has been transfered by executive order to ADC. Since the water coop shut down,

there has been no formal permit or license issue to operate the ditch, and no formal management. Grove Farm continues to supply South Fork water to the ditch, and the local farmers and ranchers maintain the water flow in the ditch. The ditch also supplies the Hawaiian Homelands mauka of Kalepa ridge from Reservoir 21. This, again, is being done on an informal, permit-less basis.

Aside from the State lands and private Kapaa parcel, the Coop system can service thousands of acres of so-called "marginal lands"—those not taken by the cane companies and now privately owned. These are located throughout Kapaa and are or could be productive agricultural lands, such as my own farm.

In 2001, ITC Water Management, hired by the State to evaluate the East Kauai system, estimated the cost to build it in 2001 to be in excess of \$200 million. We are talking about the potential loss of a substantial and irreplaceable State asset.

We are therefore in favor of HB2263 allowing the East Kauai system be taken over by the Agribusiness Develoment Corporation. This is in keeping with the mandate of Article XI, Section 3, of the State Constitution: "The state shall conserve and protect agricultural lands, promote diversified agriculture, increase agricultural self-sufficiency and assure the availability of agriculturally suitable lands."

Furthermore, Hawaii Revised Statue 167-1, Irrigation Water Development, states: "Findings and declaration of necessity. It is important to the welfare of the people of Hawaii that agricultural production be developed as fully as possible. It is further found that water presently tapped for irrigation is inadequate for the fullest development of the economy of the State. It is therefore hereby declared that additional water and water facilities are necessary for the development of agriculture in the State."

The statue recommends development of new water facilities, what to say of preserving the ones we already have.

In 2003, the Department of Agriculture released its comprehensive Agricultural Water Use and Development Plan which analyzed the development and present status of State's plantation-developed irrigation systems and concluded that the East Kauai System was among five State systems "important and viable to Hawaii's growing diversified agricultural industry."

The Agribusiness Development Corporation is the natural State agency to manage this public water system, as is the pattern in most other states in the country. It is also the only long-term, permanent way to manage the system for the benefit of our citizens.

I respectfully ask that you pass this bill.

Testimony on HB2263, HD1 Relating to the East Kauai Irrigation System February 26, 3:30 AM, Conference Room 308

Chairperson Yamashita and Members of Committee:

We are writing today to **support HB2263, HD1**. We were a founder member of the East Kauai Water Users' Cooperative Board of Directors and understand the vital importance of these ditch systems for agriculture in each part of Kauai. The Coop closed down at the beginning of 2020, unable to afford the cost of applying for a long-term license as required by BLNR. It was clear to us at the time that only a State agency could manage the system and were greatly encouraged when ADC expressed strong interest in doing so.

The water supplied by the system is important to the Church for both its 70 acres of fee-simple land in Wailua Homesteads just below Wailua Reservoir and its 300+ acres on Kalepa lands now held by the Church under a 35-year license agreement with ADC. Lateral One ditch from Wailua Reservoir supplies water to the Church's land and is used for our veggie growing and by our cows. In addition, the water flow is a major asset to the property, for beauty, as a sanctuary for various birds and plants and as a sacred meditation garden for over 15,000 Hindu pilgrims each year.

The agriculture industry remains an essential component of Hawaii's economic landscape and is only possible with a reliable supply of water. The East Kauai system can irrigate 4,000 acres of productive farm land which has in past years produced millions of dollars worth of sugar cane. Its multiple reservoirs and 30 plus miles of ditch are an irreplaceable State-owned resource valued by experts at hundreds of millions of dollars.

We urge your committee to back the community's grass roots efforts to preserve and operate this system through the Agribusiness Development Corporation.

Aloha Chair Yamashita, Vice-Chair Kitagawa, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports HB 2263, HD1, which appropriates funds to the Agribusiness Development Corporation to establish positions to maintain and improve the East Kauai irrigation system and for maintenance of and improvements to the system.

Since the demise of plantation operations across the islands, we have seen the erosion of irrigation systems. Ditches that carried water fell into disrepair with major leaks in the system and in cases such as Ka'u, cracks in tunnels created enough losses that there was no longer a significant flow of water. The Legislature continues to advocate for increased self-sufficiency, sustainability, and food security. Agriculture will play a key role in the achievement of these goals and for there to be agriculture, water is critical.

The East Kauai Irrigation System previously serviced 12,500 acres of agricultural land on Kauai. The repair and maintenance of this 21-mile irrigation system are critical for Kauai's farmers who depend on the East Kauai Irrigation System for their operations. Water availability is a basic necessity needed by farmers and ranchers to maintain and expand their production, particularly in times of drought. Having access to a reliable and affordable water supply is a key factor when Hawai'i's farmers and ranchers are making decisions to start new or expand existing operations.
