Summary of Bill:

The bill proposes to clarify the cumulative voting requirements for condominium association meetings.

Proposed Change:

The first sentence clarifies the process applies to a condominium election held with cumulative voting pursuant to the bylaws.

The remainder recognizes that owners may also use write-in names of individuals who have not been nominated. This proposed change clarifies that owners will have the right to cumulatve vote for both <u>nominees</u> and <u>write-in candidates</u>.

[§514B-124.5] Voting for elections; cumulative voting. (a) <u>If an election is to be held</u> <u>by cumulative voting pursuant to the bylaws</u>, [If the bylaws provide for cumulative voting for <u>an election at a meeting</u>,] each unit owner present in person or represented by proxy shall have a number of votes equal to the unit owner's voting percentage multiplied by the number of positions to be filled at the election.
