This testimony is presented in SUPPORT OF HB2317 HD1 with one proposed change. (Unfortunately, none of us can be physically present today due to previous condominium annual meeting commitments.)

<u>Summary of Bill</u>: The bill proposes to clarify (a) the proxy deadline to Hawaiian-Aleutian Standard Time, and (b) the use of internet statements as part of the meeting notice.

Proposed Change:

The sentence that begins on line 3 in HB2317 HD1 begins with, "<u>The</u> mailing of the written statements by the association shall include an internet link informing owners that [longer] statements shall be available on the Internet."

We suggest it be clarified by stating:

"In that event, the mailing of the written statements by the association shall include an internet link informing owners that [longer] statements shall be available on the Internet."

We request that HB2317 HD1 be approved by the Committee with the above amendment.

The committee may want to reconsider the language of "electronic file" in the current house draft one. That currently would allow a text file (.txt) to be submitted that can contain over 16,000 words and will fall under the 100 kilobyte limit. A PDF file, another commonly used electronic file format would allow over 4,000 words and also be smaller than 100 kilobytes. It is unlikely that the committee intended for proxy election statements be the length of a novelette.

"Statement in an electronic file not to exceed 300 words"
