Chair Nakashima, Vice Chair Sayama, and Members of the Committee:

My name is Randy Leong, and I am the Cable Television Administrator of the Department of Commerce and Consumer Affairs' Cable Television Division. The Department supports this bill.

The purpose of this bill is to identify and address remaining obstacles to digital equity in the State and to establish the digital equity grant program, to be implemented and administered by the Hawaii Broadband and Digital Equity Office under the Department of Business, Economic Development, and Tourism (DBEDT), to award grants for digital equity projects that will increase digital literacy and broadband and digital access for rural and socio-economically disadvantaged populations across the State.

Digital equity is essential to enable all residents of our State to fully participate in today's economy and society. The Department recognizes the benefit of a state-level grant program focused on closing the digital divide for those most in need by funding

projects to be conceived and implemented by experienced stakeholders to achieve universal access. These projects could help to bridge the State's digital equity gap and allow all residents to benefit from the services and opportunities afforded by digital access no matter where they live or their circumstances.

The Department thus strongly supports this bill but defers to DBEDT and the Hawaii Broadband and Digital Equity Office on the specific provisions of the bill.

Chair Nakashima, Vice Chair Sayama, and Members of the Committee:

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA <u>SUPPORTS</u> House Bill No. 2359, House Draft 1, RELATING TO THE HAWAII BROADBAND AND DIGITAL EQUITY OFFICE.

By way of background, the HPCA represents Hawaii's Federally Qualified Health Centers (FQHCs). FQHCs provide desperately needed medical services at the frontlines to over 150,000 patients each year who live in rural and underserved communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of healthcare.

The bill, as received by your Committee, would:

- (1) Identify and address remaining obstacles to digital equity in all areas of the State; and
- (2) Establish the Digital Equity Grant Program to award grants and create an environment in which all individuals and communities in the state have the information technology capacity needed for full participation in society, democracy, and the economy.

This bill would also take effect on July 1, 3000.

Hawaii has long been at the forefront of integrating newer technologies into daily life. One example of this is Hawaii's Telehealth Law which has served as a model across the United States. Yet, it was only after COVID struck our islands that this law became fully integrated into daily life.

Today, it is common practice to ZOOM or SKYPE with your health practitioner instead of physically going to the provider's office for a visit. When COVID first hit our islands, many health providers had to limit the number of patients that could be serviced in-person because of a scarcity of Personal Protective Equipment, restrictions in the gatherings of groups, and the need for changes to the physical arrangement of examination rooms and other diagnostic facilities.

For people with adequate broadband access, telehealth was a lifeline for the provision of essential primary health care services. Yet, health care facilities in rural areas experienced the same problems when COVID hit. They too had to limit the number of patients they could see. But because these communities lacked adequate broadband access, they were effectively cut off from primary care. Many were forced to bear their maladies until it became necessary to go to the emergency room.

Because of this, the HPCA views the lack of broadband access in rural areas as an issue of social equity. In this day and age, everyone should have equal access to health care. Telehealth was envisioned as the means of leveling the field between urban and rural areas. The lack of broadband ensures that urban and rural communities remain unequal.

For these reasons, the HPCA urges your favorable consideration of this measure.

My name is Keali'i Lopez and I am the State Director for AARP Hawai'i. AARP is a nonpartisan, social impact organization that advocates for individuals age 50 and older. We have a membership of nearly 38 million nationwide and nearly 140,000 in Hawaii. We advocate at the state and federal level for the issues that matter most to older adults and their families, including telehealth. **AARP supports H.B. 2359 HD1** which establishes the digital equity grant program to award grants to applicants to deploy digital equity projects to covered populations in the State.

The pandemic has underscored vast disparities in high-speed internet access and has also underscored the importance of high-speed internet access to older adults. Achieving digital equity is especially important for older adults: reliable, affordable high-speed internet access is critical to the well-being of adults (e.g., telehealth, connection to family and friends, civic engagement, distance learning, remote work, etc.) AARP recognizes the value and significant benefits of digital technology that can improve the lives of kupuna. While more and more of our members, especially those aged 50-59, are using their mobile devices and tablets to access information about their health, we still need to reach those over the age 65 whose technology adoption rate is only 64%. Achieving digital equity requires addressing disparities in access and adoption. Thank you very much for the opportunity to testify in support of H.B 2359, HD1.

Re: Testimony providing support for HB 2359 HD1

Aloha Honorable Chair, Vice-Chair, and Committee Members:

Thank you for this opportunity to submit support for HB 2359 HD1to establish a Digital Equity Grant Program within the Hawaii Broadband and Digital Equity Office. If established, this fund would endeavor to leverage the work of community and non-profit groups to provide digital literacy training for individuals to participate in the fast-growing digital world.

Having a high-speed fiber internet connection and services to address the digital equity needs of all households opens up a world of opportunity. Broadband is essential for business and government operations, delivering telemedicine, education, remote work, staying in touch with family and friends, and so much more. Fiber-optic cables carry 10,000 times more bandwidth than traditional copper cables, enabling fast upload speeds and a superior experience with services such as video calls and security cameras. Fiber technology is also more energy-efficient, more durable, and less susceptible to elements such as water and electromagnetic interference. Hawaiian Telcom is the only Hawai'i internet service provider that has invested more than \$1 billion over the last ten years to expand and support its fiber optic network and serve its customers.

In 2023, Hawaiian Telcom awarded \$140,000 to community organizations working to address digital equity and empower communities across the state. In addition, Hawaiian Telcom expanded its fiber-optics network to 65,000 new locations and is on track to build 60,000 new locations in 2024.

Hawaiian Telcom is also bridging digital divide as a participating service provider in the federal Affordable Connectivity Program (ACP). ACP provides internet service discounts of up to \$30 per month for eligible households and up to \$75 per month for residents on Hawaiian Home Lands. Hawaiian Telcom continues to offer federal Lifeline discounts for internet or telephone services to qualified residents.

Since the FCC launched ACP on December 31, 2021, the depletion of \$14 billion Congress appropriated for this federal program has been swifter than originally anticipated. The Federal Communication Commission (FCC) recently ordered all participating service providers to take steps to wind down their programs because the ACP will run out of funding around April 2024. This wrinkle should give us all pause to consider that while the State will see a temporary infusion of approximately \$14 million toward digital equity services, there is no additional federal funding for continued operations or services beyond the initial investment. Ostensibly, it is in the State's interest to fully commit to investing its digital equity award to support the work of community and non-profit organizations to deliver digital literacy and access services to those in need.

The Chamber works on behalf of its members and the entire business community to improve the regional and State economic climate and help Kapolei businesses thrive. We are a member-driven, member-supported organization representing the interests of all types of business: small, medium or large, for profit or non-profit businesses or sole proprietorship.

The Kapolei Chamber is also a member of the Broadband Hui.

The Kapolei Chamber of Commerce is in <u>strong support of HB 2359 HD1</u> that establishes the Digital Equity Grant Program to award grants to applicants to deploy digital equity projects to covered populations in the State.

This measure would provide the programming needed for future funding opportunities. These opportunities will support and adopt the goals set forth in the State's Digital Equity Declaration. The Digital Equity Grant Program will help to ensure digital literacy and equitable access to internet to help eliminate the "digital divide" and help our underserved communities including those in West O'ahu.

We also need to increase digital capacity in West O'ahu for our small businesses to spur on economic growth and bridge some of the gaps existing today including access and capacity issues with online learning, pursuit of employment opportunities, and access to essential services online.

The need for digital equity is apparent even in the City and County of Honolulu and is not only applicable to rural areas of our state. West O'ahu's growing population of almost 200,000 includes the Wai'anae Coast, 'Ewa, and Waipahu. In Kapolei and 'Ewa alone households are expected to exceed 56,000 by the year 2035 and over the next 30 years the population in Kapolei and 'Ewa will increase by 40 percent and housing by 52 percent. The Native Hawaiian and Pacific Islander population in East Honolulu is 3.4% and 39.7% in Wai'anae. The number of persons living in poverty in Wai'anae the is 24.4%.





COMMENTS ON H.B. 2359, H.D. 1 – RELATING TO THE HAWAII BROADBAND AND DIGITAL EQUITY OFFICE

Chair Perruso, Vice Chair Kapela, and Members of the Committee.

Thank you for the opportunity to provide **comments and proposed amendments on H.B. 2359, H.D. 1**, a bill that would establish the Digital Equity Grant Program to award grants to applicants to deploy digital equity projects.

As the largest broadband provider in the state, Charter supports efforts to promote digital equity and broadband access and we support the intent of this bill. A key aspect of reducing the digital divide is by investing in broadband infrastructure, digital navigators and literacy tools, affordability programs, and access to hardware.

Charter believes that every Hawaii resident should have reliable access to the Internet. We will continue to help bring the benefits of broadband and access to the internet to those who need it most. Hawaii is slated to receive over \$200 million in federal grants for broadband infrastructure in the immediate future (via the Coronavirus Capital Project Fund and Broadband, Equity, Access, and Deployment Program), in addition to private investments already being made by the industry. The

Digital Equity Grant Program should prioritize funding projects related to broadband adoption and affordability programs, which are separately supported by federal funding.

Charter requests amending the bill to better define the scope of approved projects and exclude broadband infrastructure projects from the program. This will ensure that broadband adoption efforts and broadband availability efforts are each given the independent attention needed to properly address these very different issues. Infrastructure availability and digital equity are both important, but they are different problems requiring different, independent solutions. Specifically, we suggest the following amendments:

• Page 3, Line 6, insert the following new language:

"Broadband infrastructure" means the same as "broadband infrastructure" defined in §206R-1.

• Page 6, Line 3 – Page 6, Line 10 shall be amended to read as follows:

-3 Eligible projects. The office may award grants for eligible projects; provided that on the date the application is submitted, the project areas to be served by the project shall include covered populations. The eligible projects may include projects that further develop and promote digital literacy, broadband affordability, digital navigators, access to digital devices, wireless community networks, and other innovative digital inclusion projects. Projects that include the deployment of broadband infrastructure are ineligible.

In 2021 and 2022, Charter extended its network to reach an additional 27,000 homes and small businesses in Hawaii, investing more than \$200 million across the state. Charter is a member of

DBEDT's weekly Broadband Hui to assist in strategic broadband planning and closing the digital divide. Additionally, Charter participated in the FCC's Emergency Broadband Benefit Program (EBB) and is now participating in the \$14.2 billion federal Affordable Connectivity Program (ACP). The EBB, and now the ACP, has helped connect over 59,000 eligible households in Hawaii with high-speed broadband during. Broadband internet access is more important than ever and the ACP offers a tremendous opportunity to help low-income families stay connected, providing eligible households a discount of up to \$30 per month toward broadband service and up to \$75 per month for households on the Hawaiian Home Lands.
