Testimony of DAWN N. S. CHANG Chairperson

In consideration of HOUSE BILL 2375 RELATING TO FUNDS

House Bill 2375 proposes to reinstate the Governor's authority to transfer funds to cope with the effects of natural disasters, for operating purposes, or to supplement the Department of Land and Natural Resources' Fire Fighter's Contingency Fund. The Department of Land and Natural Resources (Department) supports this measure.

The Department supports the Governor's ability to respond rapidly to a natural disaster and to transfer funds to the Department to fund its emergency response operations. The Department's Division of Forestry and Wildlife is the primary responder for wildfires on 26% of the land area in Hawai'i and has approximately 150 staff trained to respond to not only fire but to support other departments in their response to natural disasters, such as flooding and hurricanes. While the Department's wildfire suppression budget has increased to meet its ten-year rolling average of expenditures, there is the possibility of an extreme wildfire season or other prolonged disaster response, such as a catastrophic hurricane or volcanic eruption, that would require additional funds to support continued emergency operations.

RELATING TO FUNDS

The Department of Budget and Finance strongly supports this bill.

House Bill No. 2375 reinstates the Governor's authority to transfer funds for operating purposes, in the case of a natural disaster, or to supplement the Department of Land and Natural Resources' Firefighter's Contingency Fund (FCF). These boilerplate provisions were previously included in the General Appropriations Act to provide the Governor with authority to transfer funds for operating purposes, natural disaster, or to add funds to the FCF.

This bill reinstates three provisions that were removed from Act 88, SLH 2021, as amended by Act 248, SLH 2022, and not included in Act 164, SLH 2023, to allow the Governor to better serve the State and the public interest.
