# In consideration of **HOUSE BILL 2476** RELATING TO OCEAN RECREATION MANAGEMENT

House Bill 2476 proposes to designate all ocean waters of the State within 3,000 feet from shore as ocean recreation management areas (ORMAs); and prohibit commercial activities in ORMAs on weekends and state and federal holidays unless authorized by the Board of Land and Natural Resources. The Department of Land and Natural Resources (Department) strongly supports this administration measure.

The Department's Division of Boating and Ocean Recreation administers the ORMA Program, which aims to reduce and prevent user conflict by designating specific areas where certain ocean recreation activities can occur, thereby keeping users separate and ensuring protection of natural resources by prohibiting activities in certain sensitive areas.

There has been a rapid expansion of commercial ocean recreational activity within a relatively short period of time, leading to overuse of boating facilities, strain on natural resources, and user conflicts between recreational and commercial ocean users. The authority provided in this bill would give the Department more control over the types and locations of ocean activities in state waters in order to reduce user conflicts and preserve natural resources.

When commercial ocean operators opposed House Bill 1090 (2023), which was ultimately vetoed by the Governor, they stated that weekend closures would be an acceptable alternative to the provisions of HB1090. Therefore, this measure proposes that on all weekends and state and federal holidays, commercial operations in state ocean waters be prohibited which would allow residents to enjoy the ocean waters, as well as allow natural resources to recover.

# In consideration of BILL NO HB2476 RELATING TO OCEAN RECREATION MANAGEMENT

Chair Ichiyama, Vice Chair Poepoe and members of the Committee. The Department of Business, Economic Development and Tourism (DBEDT) supports House Bill 2476 that prohibits commercial activities in Ocean Recreation Management Areas (ORMA's) on weekends and state and federal holidays unless authorized by the Board of Land and Natural Resources.

My name is Greg Howeth and I own Lahaina Divers Inc., a scuba diving charter business that operates, or rather operated, from Lahaina small boat Harbor on Maui until the devestaing fire on August 8, 2023. I hope to resume operations as soon as our harbor and town can be rebuilt..

I strongly oppose HB2476. We do not have an ocean recreation management problem, we have an ocean resource access problem. The only new harbors built oin the last 30 years were all done privately. The state has failed to fund any new harbors even though the population of HI has grown exponentially durring the same timeframe. This bill is simply a means to enact HB2477, should it pass.

Hawai'i's ocean recreation industry conservation and safety practices have been developed over decades of experience, operating in the conditions, unique to our islands.

To establish this new ORMA, would allow the state to take commercial permits away from established companies, and give them to the highest bidder. This wiould be devestating to our local, small businesses and ensure that only the large mainland corperations will be able to afford a permit. This also incourages a system of investing the least,in conservation, good ocean stewardship, in training and equipment, as a company would have no security of continued operation under this plan.

Aloha,

My name is Doug Lomenzo. I am the General Manager of Aquatic Life Divers, a recreational dive business in Honokohau Harbor in Kailua-Kona, Hawaii. I strongly oppose this bill. It would be highly detrimental to the ocean recreation industry in Kona and across the rest of the State of Hawaii. Therefore, it would have significant negative consequences to the economy of the State. The concept proposed by this bill must be deferred until the members of the industry have a chance to weigh in.

# To Whom it May Concern:

I am submitting written testimony regarding my opinion on HB2476. I am highly opposed to this bill for many reasons. As a former owner/operator of a small sportfishing outfit in Honokohau Harbour, this bill will ensure any small charter business will fail. We were a small time operator and our margins were slim, in fact, so slim that we are not profitable, due to the large number of boats in direct completion. However, we love to fish, and have turned our hobby into a profession that supports local tourism as well as allows us to enjoy the water, while supporting the marine industry in the area. We have enjoyed hosting families from across the nation achieve their dream fish. Any increase in fees to DOBAR will completely wipe small operators ability to continue operations.

If a small business are unable to continue operation due to losses, they would be force to sell their business, but under HB2476, this is no longer an option. We purchased our company and boat in 2022 at a fair price of \$465K, which is a large chunk of our retirement. Our intentions were to run the charter business, then sell a few years down the track. However, our plans changed and we put our business up for sale. Under this bill, we will have take a complete loss as we would no longer be able to sell. This is akin to eminent domain, yet in most cases of eminent domain, a person or company is offered a reasonable compensation for their property by the state.. I suggest that if the state is indeed interested in "buying back" the charter licenses, then they should actually pay for it, rather than take it.

Under this legislation, many small charters businesses will fail entirely. The local marine industry will fail. Jobs will be lost.

Please consider voting NO of HB2476.

I strongly oppose HB2476. This bill is based on subjective opinion without known facts or data.

This bill would automatically cut a minimum of 15% of the gross revenue from one of the largest industries in the State of Hawaii. Ultimately this would be a reduction of employment of 15% or more as well. There will be a ripple effect of this revenue decrease in third-party support businesses to the commercial charter industry, as well as felt throughout the entire state economy.

This bill also assumes that the commercial charter industry is only for tourists and not for locals, this is untrue. With the passing of this bill, it will cut a great section of working citizens off from access to the ocean and charters.

Many small charters will not be able to sustain their companies off this large of a revenue drop and will be forced to shutter their businesses, lay off their employees, and liquidate their assets. On top of this, if HB2477 passes, the state would then profit off their losses by auctioning off the commercial use permit to the highest bidder.

# **Background**

- UFO Chuting of Hawaii, Inc is a family owned parasail and fishing business established in **Lahaina Maui in 1985**.
- Founded by Greg VanderLaan, a 1979 graduate of the United States Merchant Marine Academy, Kings Point NY
- Created the winch boat parasailing system to SAFELY launch and recover participants from the stern platform of the vessel. This system is now the gold standard for all parasail operations worldwide due to safety, minimal environmental impacts.
- UFO employs up to 50 local multi generational and cultural community <u>members.at</u> its Lahaina and Kona parasail operations locations
- Generate over \$1m in GE taxes, DLNR Harbor fees, Hawaii State, Federal income and payroll taxes annually.
- Lahaina, Maui parasail annual 7 month operating season is May 16- Dec 14 annually since 1992 by statute and DLNR rule to protect humpback whale migration.

#### **Operations**

- UFO launches and recovers vessels daily, weather permitting, during May 16- Dec 14 annually from DLNR Mala Wharf boat ramp Lahaina since 1985.
- No passenger loading or truck/trailer parking is utilized at DLNR Mala Wharf boat ramp facility.
- Assisted trailer boat launch and recovery of vessels from Mala Ramp takes approximately 1-2 minutes and all trucks and trailers are parked offsite at the UFO baseyard

- UFO operates under Kaanapali ORMA permits established in 1992 and loads passengers by lightering from ingress and egress ORMA loading zones at Kaanapali Beach
- All flight operations take place in the ORMA parasail zone 3000'+ offshore at vessel speeds of less than 15 knots.

# Conservation of resources and multi user conflicts.

- In 2004 UFO took the bold environmental initiative and voluntarily switched the fleet to more expensive ultra low sulfur fuel for a significant reduction in the amount of particulate matter and other pollutants released into the environment 5 years ahead of the EPA requirement for marine diesel engines that use ULSDF.
- UFO provides no in water activities that would harm the resource thru sunscreens and body oil.
- UFO operations have <u>ZERO</u> ocean resource and facility user conflicts with multicultural local community members or their ability to practice their cultural rights. or access the ocean resources from DLNR facilities.
- Utilization of the Kaanapali Beach loading ORMA permit eliminates the need for 80% of our customers to travel by road or park to access the activity.

# Conclusion

<u>UFO Parasail</u> and its 50 employees and supporting vendors, <u>strongly oppose</u> prohibiting commercial use of the ORMA's on weekends and state and federal holidays. There is absolutely no intrinsic value towards conservation or user conflicts for this prohibition. This would be an existential provision for the industry based on the following analysis.

- 1. 365 days in the year.
- 2. 250 days if weekends and state and federal holidays are prohibited.
- 3. Maui parasail is currently prohibited from Dec 15-May 15 by State law. 152 days
- 4. Available days to operate annually would be reduced to 98 days from May 16-Dec 14.
- 5. Based on average 20% weather cancellations May 16-Dec 14 annually **there would be 78 days available for operations.**

UFO has survived 5 month seasonal whale closure, 2 Gulf Wars, 9/11, 2008-2013 recession, 2020/1 worldwide pandemic and the 2023 August fires which destroyed our beloved town. With a stroke of a pen, probiting weekends and holidays would be the end of our 40 year business that selflessly supported our Lahaina and Maui community with scholarships, charitable contributions and public service too long to list.

I understand the dialogue regarding tourism management, but cherry picking a few family owned businesses is clearly a low hanging fruit strategy with no effectiveness on tourism management.

I am writing to express my strong opposition to 2476 HB RELATING TO COMMERCIAL OCEAN RECREATION MANAGEMENT, creates ORMAs on all coastlines and prohibits commercial activity on weekends and holidays. As a small native Hawaiian business owner with a tour boat operation, these proposed regulations would have a severe impact on our operations and potentially jeopardize our ability to remain viable.

After losing our home, shop, place of business and small boats in the Lahaina Fire, our hope of rebuilding remains in our ability to resume full operations. Adding more restrictions to small native-owned businesses like mine will further put us out of business after all our losses and competing with the larger commercial operations that have multiple locations and larger capacity vessels.

I've been in communication with other businesses operating out of Mala Boat Ramp since the emergency restrictions have been in place for that location and with the current weekend and holiday restrictions on top of the normal weather limitations operators deal with regularly, this has cut back work for many employees and crew members up to 50% per month. Not only that, many Kamaaina that do enjoy commercial tours like whale watching are unable to participate without the weekends or holidays available as they often work Monday through Friday jobs or will island hop for the weekend to whale watching on Maui.

I am a native Hawaiian who owns a small ocean recreation business that focuses on education and small group eco-tourism. This bill would restrict where we can operate and when we can operate which could further put my small company out of business before we even get to rebuild after the fire. If we are no longer able to stay in business we would be

forced to move off island as it would eliminate our jobs, income, home and community. As a native Hawaiian, I would be forced to leave my home and island because decisions are being made by a group that has no accountability to the people they are making the decisions for. There is no benefit to this bill for the community, especially native Hawaiian's like myself. Find a way for these positions to be elected and with a term instead of giving them more power.

I understand the importance of effective ocean recreation management, and I appreciate efforts to strike a balance between conservation and commercial activities. However, the current language of the bill fails to consider the practical implications on businesses like mine, which are unfairly targeted and constantly blamed for various issues.

The ocean recreation industry is often unfairly singled out for environmental concerns, safety issues, or other challenges that are not solely within our control. While we are a small, eco-minded native owned business committed to responsible practices, this bill unfairly places the burden on our industry without considering the broader context and the shared responsibility of all stakeholders.

The Ocean Tourism Coalition (OTC) represents hundreds of tour operators and charter boat businesses statewide. I am writing to express my strong opposition to HB2476 that aims to prohibit Hawaii commercial boat operations on weekends and holidays. HB2476 will not achieve its intended goal and will have devastating consequences on the tour boar industry.

- 1. **Impact on Local People and Businesses:** Prohibiting commercial boat operations exclusively on weekends and holidays disproportionately affects local people and businesses that depend on these days for a significant portion of their income. These operators play a vital role in our local economy, providing valuable services and contributing to the tourism industry, which is a crucial economic driver for Hawaii. Where are the bills seeking to shut down big mainland businesses (e.g., Wal-Mart, Costco, McDonalds, etc.) in Hawai'i to for 30% of the year? Only local people and local businesses will be hurt by this bill.
- 2. **Increased Congestion at Beaches:** Rather than alleviating congestion, such a prohibition is likely to have the opposite effect. The vast majority of tour boat activities take people away from beaches to offshore locations. Preventing these tours from operating will force more residents and tourists to beaches and on-land recreational areas. This will not only negatively impact the overall visitor experience but will create challenges for local residents seeking to enjoy their recreational time.

- 3. **Singling Out a Single Industry:** HB2476 singles out commercial boat operations, creating an inequitable regulatory environment. Countless other tourism related activities in Hawai'i impact our islands, yet only boat tours are targeted.
- 4. **Negative Economic Impact:** The bill's restriction on commercial boat operations will result in a negative economic impact on operators. Taking away two to three days of a week will drastically decrease revenues and lead to job loss and business loss. Many operators based out of Lahaina are barely surviving at under 50% capacity. Taking away 30% or more of their revenues will all but guarantee they will go out of business. In addition, the boat business is weather dependent. As a result, one weekend could represent 100% of a business's revenue if an operator is unable to operate on the other days due to weather (e.g., Kona storms)

In conclusion, OTC urges this Committee to not pass HB2476. While the intention may be to address congestion and environmental concerns, the proposed approach will not achieve its stated goal and will lead to the termination of many local businesses.

The designation of all ocean waters within 3000 feet from shore as a ORMA under the complete and arbitrary oversight of the Board of Land and Natural Resources, with zero legislative input or control, and zero appeals or community input, is a dangerous precedent allowing misuse and the potential of massive unemployment and small business closures.

The burden of permitting, authorizations, and regulation on an overstretched department, while making small businesses pay for it through an unfair auction process, is tantamount to setting up an illegal bribery situation.

The special designation in this law to limit activity on weekends has no logical reason, except perhaps easing the work schedule on DLNR? Limiting operations to weekdays assumes all chartered boat operations exist for tourists alone, not our Hawaii residents. This is tantamount to barring local access to the ocean, which goes against our laws, and the very nature of the mission statement of the Board of Natural Land and Resources, which is to "Enhance, protect, conserve and manage Hawaii's unique and limited natural, cultural and historic resources held in public trust for current and future generations of the people of Hawaii nei...". It is NOT to auction permits to the highest, foreign visitor with deep pockets, while pricing our local people out of small business, or even barring access on weekends to locals using the ocean.

The last part of the DLNR mission statement, "... Hawaii nei, and its visitors, in PARTNERSHIP (emphasis added) with others from the public and private sectors." Where is any partnership with local businesses in this proposed insult of the law? Where is the partnership with legislature? This is, along with HB2477, a money and bribery grab by DLNR and it's Non-Hawaii interests, to take power

and oversight away from the Hawaii State Legislature, to cripple local businesses and employers and even ocean-loving cultural practitioners. Please Strike down this horrible power grab and serve your electorate.

I am writing to express my strong opposition to HB2476, which proposes significant restrictions on commercial ocean activities in state waters, particularly on weekends and holidays. As an Ocean tour business, these proposed regulations would have a severe impact on our operations and potentially jeopardize our ability to remain viable.

We are a small family ocean recreation business that runs 2 boats out of state facilities and runs business from the shore. Prior to the fire we had 10 employees and took people scuba diving, whale watching and in general enjoy and educate people on the preciousness of our oceans.

This bill would make it hard for us to have a viable business. There was a time where we could afford to run 5 days a week, and we did so. But the increasing costs of operation, coupled with trying to offer an affordable product for the general population has made it necessary to work more. Removing our ability to offer more trips on weekends and holidays in periods of high season to produce more revenue would severely impact our ability to stay in business and our survival in the industry.

I understand the importance of effective ocean recreation management, and I appreciate efforts to strike a balance between conservation and commercial activities. However, the current language of the bill fails to consider the practical implications on businesses like mine, which are unfairly targeted and constantly blamed for various issues.

I propose that we get an independent surveyor to conduct surveys and get to the bottom of these issues to find solutions that can help resolve issues without putting people out of business. Many issues relating to our business and our entry point (Mala Pier) stem from a cluster that happened April 2021. Back then we were all getting started up after a hiatus for COVID. We were not ready for tourism the travel restrictions outside of the US brought to Hawaii. We had issues for a month and since then, as a daily user of Mala 6 days a week, I have not had a problem getting our boats in and out of the water and have not been late for a trip more than a handful of times. That shows me that it is accessible for everyone to use without extended wait times. I wish we could have independent surveyor make reports on the actual situation and make informed decisions based on that.

The commercial ocean recreation industry is often unfairly singled out for environmental concerns, safety issues, or other challenges that are not solely within our control. While we are committed to responsible practices, this bill unfairly places the burden on our industry without considering the broader context and the shared responsibility of all stakeholders.

I urge the committee to reconsider the proposed restrictions and work towards a solution that accommodates the interests of both conservation and the local business community.

Collaborative discussions with stakeholders could lead to a more balanced approach that achieves the intended goals without unfairly scapegoating our industry.

Thank you for considering my testimony, and I hope that we can find a mutually beneficial resolution.

We have dock space we always leave open and we leave prime parking locations open for resident parking. We park and rinse down our boat on our private property away from the harbor. Aloha,

Lahaina multiple business owner here.

I implore you to please vote "NO", on this ridiculous and over reaching bill. We employe as many as 22 individuals, many with families, some Hawaiians and all people who deserve to make a living. Every portion of this bill reeks of strong-arming one of the largest groups of GET and Harbor Tax payers.

On a recent count on West Maui taken after the fires, there are around 950 people that work aboard commercial vessels. With a workforce of around 7,000 people, we are one of the largest employers on West Maui. Cutting weekends and Holidays results in a 33% reduction in revenues and will result in a corresponding 33% reduction in workers required. So you would be firing around 300 workers in just Lahaina alone. Many of these are people that work part time, often over the weekends, for supplemental income. Which is often a necessity for anyone trying to earn enough to survive on West Maui. During fowl weather months, this means that if we have to cancel 3 days for weather during week days, we may only have 2 days of income for a 9 day period, IF there are no Holidays. One of our businesses is already operating under these ridiculous "no weekend or Holiday" rules at Mala Wharf. During the recent Holidays, our team (some of which lost their homes and everything they owned in the fires) was so excited to have a small sense of normalcy and return to work, but these rules only allowed us to run during 4 days of a 10 day Holiday period, as Christmas AND New Years both feel on a Monday. This ended up being a breaking point for some of our team and they gave up and left island. So this policy has ALREADY, cost West Maui valuable jobs and has cost small businesses negative revenue. We refunded more money for the already booked weekend and Holiday trips than we made over the 4 days we were "allowed" to run. Do you think our customers (and yours, since the ONLY economy here is tourism) care what day it is when they want to go on a whale watch? Also, most of our Kama'aina customers visit us on the weekend when kids are out of school. So, sorry kids, the State says you can't go on a whale watch unless you skip school? This is crazy.

This bill states that some facilities are over-crowded or over-used due to commercial operators. How about re-investing some of the millions we pay into DLNR into facility

improvements or upgrades. Mala Wharf is, and has been, a shit hole, with ankle breaking potholes, homeless camps and has only two launch ramps and is tied for the most derelict facility in Maui County with Kihei boat ramp. Lahaina Harbor was, literally, falling apart, before burning. Senator McKelvey, and Elle Cochran, have done an admirable job helping to procure funding for these derelict facilities, but these funds just bring the facilities back up to codes. Why no investment in actual improvements. How about coming up with a plan to address ways to improve with the people that use it (both Rec. and Commercial) and pay loads of taxes to use it. There's plenty of space to build a "commercial" just by adding on to the North side of existing ramp! This would fix everybody's complaints and could be paid for in just a few months of the taxes we all already pay.

Originally, a handful of Mala recreational users complain about how crowded the facility, ramp or parking lot was, now it's a ghost town and you just put in the no weekends and Holidays rule, did you NOT know that most all the recreational boats burned too! Funny part of this is, almost ALL the trailer parking stalls are taken by support vessels (zodiacs) for Kaanapali Beach Catamarans (8 of 10 this past Saturday). Do you know why? DLNR was pressured by the same small, yet vocal group, to not allow the Kaanapali Beach Cats to keep their support vessels on or near the beach! So beach cat companies were forced by DLNR to trailer their zodiacs to Mala and take the majority of the parking spaces there. DLNR CREATED THIS PROBLEM by not leading, but by being weak with appeasement.

Expanding an ORMA out to one mile makes no sense either. You can't enforce what you already have, why would you possible think you could enforce a 10X's larger area? You can't keep the homeless out of the dumpster. You can't even plan far enough in advance to purchase trucks for all your new DOCARE officers. You can't stop the dozens of already illegal charters happening throughout the state with. You can't identify who is fishing for profit, are these people paying GET and Harbor taxes?

Our lives trying run a business in Hawaii is hard enough, some of you should try it sometime. On top of that, now we have to rebuild a town, a community, and our businesses and try to keep our sanity. All while having to service all of our new debt required to keep our businesses operational. It would be great to have a supportive and thoughtful government, especially in this time of need. Instead you're out there trying to fire my employees and make life even more difficult, biting the hand that feeds you....

My name is Antoinette Davis; it has been my honor to represent the Activities and Attractions Association of Hawaii (A3H), a not-for-profit 501c6 trade organization, since 1997 (27 years) as their Executive Director. **A3H strongly opposes HB2476**.

In a recent statewide survey with Activities and Attractions, I posed the question this Bill proposes. From the graph below, all respondents strongly opposed any closures for holidays or weekends.



Most of their customers are visitors who don't usually know what day it is. In searching the internet, I could not find vacation destinations that close their commercial activities on the weekends and holidays. There are also Kama'aina customers, who, like most residents, have weekends and holidays off and can go on a whale watch, guided hike, bike, or scuba dive now. If this Bill passes, they must take time off of work. No playcation for residents.



Cutting back on these small businesses' income potential, which is already naturally reduced by Mother Nature due to inclement weather days (20% of the year), is a sizeable purposeful decrease when the economy is already down.

In the same survey I asked members about their business expectations for 2024. Only 2% expected a stellar year similar if not better than 2019. **64% expect 2024 to be slower than previous years.**

Dear Chair Ichiyama, Vice Chair Poepoe, and Committee Members:

We are legal counsel for a hui of commercial use permit holders throughout the State and respectfully **oppose** House Bill 2476.

HB2476, along with HB2474, HB2475, and HB2477, is "part of a comprehensive ocean recreation management package" put forth by the Department of Land and Natural Resources. While we agree there is room to improve the management of ocean recreation, unfortunately, we do not believe the actions proposed in HB2476 achieve that aim.

As an example, HB2476 seeks to reduce overcrowding by expanding its "management tools" for commercial activity. However, it then exempts boats from commercial harbors from needing a permit to conduct commercial activity in ocean recreation management areas. Furthermore, it's unclear why ocean recreation management areas need to extend more than half a mile offshore to address overcrowding—this issue would occur much closer to shore.

HB2476 also seeks to "prohibit commercial ocean activities statewide on weekends, state holidays, and federal holidays, unless authorized by the [BLNR]." This would have a devastating impact on small businesses. Additionally, this would effectively prevent most locals (*e.g.*, those who work or have school during the week) from being able to enjoy commercial ocean activities.

Thank you for the opportunity to provide testimony in opposition to HB2476. We respectfully ask that the Committee **defer action on HB2476**.

I am writing to express my strong opposition to House Bill (H.B.) No. 2476, which addresses ocean recreation management and introduces changes to Section 200-37 and Section 200-38 of the Hawaii Revised Statutes.

While we acknowledge the Department of Land and Natural Resources' (DLNR) responsibility for ocean recreation management, we are deeply concerned about the potential implications of the proposed amendments.

H.B. 2476, however, proposes a statewide prohibition on commercial ocean activities during weekends and holidays, unless explicitly authorized by the Board of Land and Natural Resources. Furthermore, the bill's intention to address complaints about overcrowding and commercialization raises concerns about the impact on local businesses. I urge you to consider alternative measures that strike a balance between the concerns raised in the bill and the livelihoods of local businesses. I would like to voice my strong opposition to HB2476 relating to Ocean Recreation Management.

The blanket creation of an ORMA that would immediately encompass all waters within the proposed area(s) is far too broad and the impacts of such a sweeping change deserve to be discussed and the input of all stakeholders, especially those that would be the most impacted by them, appropriately considered. Additionally, the proposed restrictions on operating commercial activities in any of the proposed ORMA areas on weekends, state and federal holidays will have a significant adverse impact on commercial operators, their team members and the local community.

For our specific organization, if we were unable to provide commercial activities on weekends, state and federal holidays, it would lead to a reduction of upwards of 20% of our workforce. This combined with the reduction of expenditures on those ancilliary services that we utilize to support those commercial activities (catering, supplies, parts, etc...), would have a real impact in our community and for those members of our community that depend on us for their livelihoods.

It should also be noted that the proposed changes in the bill will make it harder for island residents to enjoy the services that commercial charters provide. Most full-time island residents work Monday thru Friday, and if the proposed amendments were to pass, it would restrict or severely limit their ability to enjoy the same services that visitors to our state get to enjoy. Commercial charters are not and should not be for only tourists to enjoy. With respect and consideration for hearing my testimony, thank you for this opportunity; respectfully, Paul Exner.

#### **TESTIMONIAL POSITION:**

Paul Exner is opposed to H.B. NO. 2476, A Bill For An Act Relating To Commercial Ocean Recreation Operations.

#### FACTUAL ARGUMENTS AND DATA:

Prohibiting commercial ocean recreation activities statewide on weekends, state holidays, and federal holidays, unless authorized by the board of land and natural resources will immediately lower the gross revenue by 104 days of potential operation per year; this legislation will effectively reduce the potential revenue from Commercial Operators by 33.1%.

- \* 104 Weekend Davs
- \* 17 State and Federal Holidays
- \* 121 Total Days Per Year
- \* 33.1% Reduction in Potential Operation

Many commercial operators have children who attend school during the week, and weekends in this case are an important time to work and operate their vessel commercially while their partner tends to the children on the weekends and holidays.

Any reduction of allowable commercial operation days by law effectively reduces the gross potential earning of the business which results in the following:

- \* The need to shift operational bookings away from prohibited days to focus efforts on doing business on "allowed" days.
- \* Acceptance of lower gross revenue which effectively results in a shrinking business to the point where fixed costs cannot be proportionally reduced, effectively placing financial strain on the business and emotional stress on the operator.
- \* Heightened operational hours for Merchant Mariners beyond what is physically and legally allowable to Mariner Workers as they maximize their work efforts on "allowed" days in hopes of surviving financially.

Many local residents of Hawaii who work during the week also participate in commercial activities on the weekends such as SCUBA Diving tours, Boat Clubs, Sailing Activities, Surfing Lessons, Etc. Prohibiting commercial activities on Hawaiian resident's off-days effectively means this segment of the community will no longer have access to commercial ocean services by lowering their recreational opportunities and likely incentivizing them to undertake the commercially prohibited activities on their own with less experience than commercial operators offer.

Commercial tourism offerings for ocean recreation activities will be directly curtailed by 33.1% effectively limiting one segment of Hawaii's overall tourism enjoyment and appeal to draw visitors to the State's economy.

General Excise Tax and Hawaii State Corporate Tax will shrink from this industrial segment by 33.1%.

Designating all ocean waters of Hawaii within three thousand feet seaward of the base line of the territorial sea as Ocean Recreation Management Areas will immediately remove near shore access to commercial operators effectively alleviating an immeasurably large percentage of what can be observed by ocean lovers as most interesting things to look at are in depths of less than 40 feet. The 3,000' off-limit designation allows operators access to waters further than 56.8% of one statute mile. The average depth of Hawaiian waters 3,000' from shore is presently not calculated but I estimate it's average depth at greater than 500 ft., likely much more.

Designating an in-operable zone for commercial operators within 3,000' from shore effectively pushes safe operation into offshore waters greatly more susceptible to extreme oceanographic conditions such as Orographic Vorticity, deep-water currents, high wind driven waves typically double or triple the size of wind-waves within 3,000' of shore; this in-operable zone designation without a doubt leads to an arbitrary constraint of seamanship decision making placing excessive stress on Merchant Mariners who are stripped of their autonomy and options to adhere to International Maritime Organization conventions described in the SOLAS Convention (Safety Of Life At Sea). This 3,000' designation creates an artificial and dangerous precedent for Merchant Mariners with above average proportion because they operate in Hawaiian waters where it's well known and understood that near-shore operation is considerably safer.

#### DEMONSTRATION OF POSITION:

I, Paul Exner, in 2018 invested financially in good faith (my life savings) in belief of Hawaii's permit structure to purchase a Hawaiian Corporation with holding of Ocean Commercial Permits, and I follow the legal permitting process in every manner and detail with the legally supported expectation that I acquired my permits believing in a basic premise of commercial operation that the industry has operated under for many years. I have invested my life in the stability of Hawaii.

The prohibitions proposed by HB2476 on the industrial stability of Commercial Operators, namely: 1) A 33.1% reduction in earning potential by unjustifiably limiting days of operation, and 2) A 3,000' prohibition of commercial operation from shore, will absolutely create an unsustainable constraint on commercial operators, and heighten the stress of normal vessel operation well outside reasonable decision-making of Merchant Mariners by arbitrarily forcing them to operate in offshore waters and forming hesitancy within their awareness to pilot their vessel safely and appropriately where human life, and environmental and tangible assets are at stake.

#### CONCLUSION:

In consideration of the facts, I cannot foresee ANY legal justification for the actions that would likely follow the passing of HB2476 to explain how a commercial operation business could be expected to survive financially while improving the safety of ocean recreation.

We **strongly oppose** House Bill 2476 and believe it poses a significant threat to Hawai'i's commercial boating industry, and, by extension, the entire tourism sector.

We are particularly concerned about a provision in HB 2476 that designates all ocean waters in the State within 3000 feet from shore as ocean recreation management areas (ORMAs). This bill will prohibit commercial activity in the ORMAs unless authorized by a use permit, and the department may designate zones where specific recreational and commercial ocean activities may occur. This seems extreme and a massive undertaking. We firmly believe in streamlining government regulations to provide predictability for businesses. Measures such as this create barriers, uncertainty, and distrust.

We are also surprised that this bill prohibits commercial activities on weekends and state and federal holidays unless authorized by the Board of Land and Natural Resources. This will drastically reduce operations and could force companies out of business. It also unfairly penalizes residents who only have those days off to enjoy commercial boating activities. We have boating companies on our coastline that have offered well-known kama'aina programs and specials for decades.

#### HB2476 - ORMA

I strongly oppose HB2476. I represent myself as a Kaua'i resident passionate about my community and as a business owner, leading and managing Holo Holo Charters, a snorkeling and sightseeing boat tour operator on Kaua'i. While this bill does not directly impact my business as we operate out of a Dept of Transportation Harbor, I stand by my fellow commercial ocean users to protect our industry and livelihood.

As commercial ocean users, we know these waters best and know and understand the problems and opportunities, best. I agree that better management is needed and historically DOBOR/DLNR has been inadequate in supporting that, directly leading to the current issues. Work with us to find solutions.

You won't find anyone more experienced or knowledgeable besides the people who are literally out there every single day. Our staff are super passionate about the ocean, that's why they choose careers in our industry. They are residents who spend their days off recreating on and in the ocean. We understand the problems you are trying to solve, but your method is completely backwards.

There is no sensical reason to eliminate commercial boating on weekends and holidays. We supply a recreational service for thousands of people (primarily visitors) on weekends and holidays. Take away that service and those thousands of people are now finding something else to do that day; further clogging our parks, beaches, shops and restaurants.

Currently, I must book a restaurant reservation 2-3 months in advance to have a weekend date night with my husband. Now I would be competing with thousands of others for a dinner reservation on the weekend because they can't do an afternoon tour that day.

Having studied sustainable business and environmental carrying capacities I recognize our resources are near a breaking point. But mandating all businesses in this industry are closed two days a week is not only illegal it is unjust and does not support your intention.

I encourage my team to not just share problems but solutions too. So, I will share my solution that may be unpopular but I believe it provides a more reasonable and realistic approach to your intention of providing our resources with a rest. Instead of eliminating the same operating days for everyone across the board, merely shifting the burden to other areas, allow operators to choose the days that work for their particular business. Permits could come with an operating restriction stating that you can only run 300 days of the year, businesses can select what works best for their vessel scheduling, maintenance needs, planned vacations, etc. The resources still get a rest but you're not completely eliminating all tour options for two days of each week.

Eliminating weekends and holidays amounts to 118 days on average. Divided by 365 days, that amounts to 32.3% or roughly one third of business annually.

We employee over 50 people on Kaua'i, paying them a real living wage, investing in their skills and development, and providing actual careers that they are passionate about and can support their families. This bill would force layoffs for 1/3 of staff in businesses like ours. How would you feel about cutting 16 members of your staff?

Workers would be forced to work a Monday through Friday schedule, further impacting our congested roadways. They would be forced to lose a day of work when they have scheduled doctor, dmv, or other appointments that are already confided to Monday through Friday.

We support local suppliers, vendors, caterers, and others who depend on our business and would be significantly impacted by a 32% reduction in business.

The demand is still going to be there, and the market adapts. So, I guarantee you are just going to end up with illegal operators trying to take advantage of the system. "Go meet uncle at the dock Saturday morning and bring cash." There is already a lack of enforcement by DOCARE, I have no faith that they would succeed in eliminating that extremely dangerous activity.

It's expensive, difficult and frustrating to run a business, but we do it because we are truly passionate about creating memorable ocean experiences for our guests. We are the most invested in our ocean resources and are committed to delivering a safe and quality product every day. We use the ocean daily and know how to share the resource with commercial and recreational users. We are not the problem.

As a Scuba Diving Professional, these proposed regulations would have a severe impact on our operations and potentially jeopardize our ability to remain viable.

I have been an Open Water Scuba Instructor for the past decade. I have had the pleasure of working in a number of countries including Honduras, Indonesia, Samoa, Thailand, and Malaysia. Several years ago I returned to the United States to work in Maui. I joined Dive Maui in Lahaina, Hawaii and have been working there for over two years. Together with the owners, we have worked to create a successful scuba training facility helping to train not only recreational divers but also dive professionals. Always as a part of these courses, we emphasize conservation and ocean protection. We aim to create ocean ambassadors who will spread the word to others on saving and protecting the ocean and the importance of Hawaii in that mission.

We have been fortunate to have steady customers year around, without a measurable high or low season. Even during the pandemic, scuba diving was bringing tourists to Maui. This tourism brings money, jobs, and helps to cement Hawaii's reputation as a worldwide premier tourist destination.

In addition, between December and April, Dive Maui operates daily whale watching trips. I work as a whale naturalist on these trips. This business not only brings in tourists to Maui. But also educates thousands of people each season on the importance of conserving and protecting our ocean. We speak at great length about whales, the ocean, and the role of humanity in protecting both. Therefore, limiting, restricting or ending Dive Maui's ability to educate and train the public

will have a detrimental effect on tourism, conservation, and the public's perception of Hawaii's role in ecotourism.

I understand the importance of effective ocean recreation management, and I appreciate efforts to strike a balance between conservation and commercial activities. However, the current language of the bill fails to consider the practical implications on businesses like mine, which are unfairly targeted and constantly blamed for various issues.

The scuba industry is often unfairly singled out for environmental concerns, safety issues, or other challenges that are not solely within our control. While we are committed to responsible practices, this bill unfairly places the burden on our industry without considering the broader context and the shared responsibility of all stakeholders.

I urge the committee to reconsider the proposed restrictions and work towards a solution that accommodates the interests of both conservation and the local business community. Collaborative discussions with stakeholders could lead to a more balanced approach that achieves the intended goals without unfairly scapegoating our industry.

I would appreciate the opportunity to further discuss my concerns during any upcoming hearings or meetings regarding this bill. Thank you for considering my testimony, and I hope that we can find a mutually beneficial resolution.
