HOUSE BILL 2590 RELATING TO FOOD SECURITY

Chair Gates, Vice Chair Kahaloa and Members of the Committee:

The Office of Hawaiian Affairs (OHA) **SUPPORTS HB2590** which would appropriate funds to allow the Hawai'i Food Bank to purchase food from local farmers. OHA believes that food security, including access to culturally relevant, healthy, regionally produced foods are critical to the safety and security of the people of Hawai'i.

In the aftermath of the devastating wildfires of August 2023 that caused significant loss of life and destruction to the Lahaina community, the State House of Representatives found that the Hawai'i Foodbank only has about 3 weeks of food on hand at any given time, and that the Hawai'i Foodbank is limited by storage capacity. The House further noted that in the event of a disaster that affects the operability of the Port of Honolulu, food resupply could be disrupted or cut off across the State of Hawai'i.² In light of the vulnerabilities to Hawai'i's food supply in the event of a disaster, it is critical that Hawai'i prioritizes food security for the safety of all the people of Hawai'i.

The United States Department of Agriculture (USDA) noted that as of 2021, 93% of all farms in Hawai'i were family farms and accounted for 55% of farmland and 52% of all agricultural products sold and government payments.3 The USDA additionally noted that small family farms with a gross cash farm income of less than \$350,000 per year accounted for 91% of all Hawai'i farms.4 Many small farmers in Hawai'i face challenges such as "increased competition from industrial-scale farming operations both domestically and overseas, as well as not being positioned to absorb rising operational costs like these larger competitors."5

Thank you for the opportunity to submit testimony on behalf of Young Brothers, LLC ("YB") offering **SUPPORT** for House Bill 2590 – Relating to Food Security.

YB is a common carrier by water, transporting property by tug and barge between the islands of Oʻahu, Hawaiʻi, Kauaʻi, Maui, Molokaʻi, and Lānaʻi. YB is currently the only water carrier authorized to transport property under Chapter 271G, Hawaii Revised Statues ("HRS") (i.e., the Hawaii Water Carrier Act), subject to the regulatory authority of the Public Utilities Commission of the State of Hawaii ("PUC"). Since 1900, customers across Hawaii have relied on YB's frequent, regular, and universal sailings to serve as the bridge that connects all communities in this island-state.

This measure would appropriate funds for food bank purchases from local farmers, with the funds to be administered by request for proposal via the Hawaii Department of Agriculture.

Food security remains a critical issue in Hawaii. This measure will help address these food security challenges while also investing in local agriculture. The Hawaii Foodbank's Farm to Foodbank program, which was launched in March of 2020, has successfully provided healthy, locally-grown produce within communities across the state by working with partner agencies and organizations to distribute food to the community. On behalf of Hawai'i Foodbank, I am writing in **strong support of HB 2590**, which appropriates funds for food bank purchases from local farmers, with the funds to be administered by request for proposal via the department of agriculture.

Food insecurity is a critical issue in Hawai'i, where one in six residents lacks comprehensive access to healthy, nutritious food. One in four children is food insecure. Hawai'i has the highest cost of living in the nation, and inflation has driven food prices up by more than 25% since before the pandemic—greatly exacerbating the problem and putting far too many families at risk of going hungry, or making impossible choices between food and rent, food and medicine, or food and transportation. Food insecure households are especially vulnerable to a natural disaster, as they do not have the capacity to set aside a fourteen-day supply of food and water.

The Farm to Food Bank program addresses these critical needs while investing in our local food systems at the same time. Every dollar in the Farm to Foodbank program does double duty—not only is it invested in local agriculture, supporting our local farmers, helping to buoy our local economy and food system, and decreasing our dependence on imported food, but it allows us to provide fresh, healthy, Hawai'i-grown produce and proteins to those we serve. We know that food insecurity is highly correlated with negative health outcomes such as diabetes and heart disease, and that as budgets grow tighter, households tend to shift towards less expensive food options—which are often highly processed and significantly less healthy. The ability to provide fresh produce to those we serve will have a long-term positive effect on the health of our entire community.

Hawai'i Foodbank established our Farm to Foodbank program during the pandemic through a partnership with the Hawai'i Farm Bureau, with a commitment to purchase locally produced foods from local farmers and ranchers when their regular markets shut down. For the first three years of the Farm to Foodbank program, Hawai'i Foodbank purchased and distributed more than seven million pounds of local produce and proteins, funded primarily through COVID-era federal pandemic relief funds. Since those funds have lapsed, we have continued to fund our Farm to Foodbank program through private philanthropic support and other sources, and are currently purchasing between 25,000 – 30,000 pounds of local produce per week, including culturally relevant products such as poi, 'uala, and 'ulu. HB2590 would allow us to continue and grow these important programs.





Hawai'i Foodbank is Hawai'i's largest hunger relief organization, fiercely dedicated to our mission of nourishing our 'ohana today while working to end hunger tomorrow. We work with a network of more than 200 partner agencies across O'ahu and Kaua'i to provide food assistance to an average of more than 150,000 people each month.

Hawai'i Foodbank provides all food, including locally purchased produce, to our network of partner agencies free of charge, and our partner agencies then distribute that food into our communities directly. Last year, we distributed food for more than 16.2 million meals across the islands we directly serve, including nearly 5 million pounds of fresh produce. Together with the Maui Food Bank, serving Maui County, and The Food Basket, serving Hawai'i Island, our network of food banks and partner agencies provide food assistance to all those facing hunger across the State.

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. Chair Gates, Vice Chair Kahaloa, and committee members, thank you for this opportunity to provide testimony on HB 2590, which appropriates funds for food bank purchases from local farmers, with the funds to be administered by request for proposal via the department of agriculture.

Kaiser Permanente Hawai'i SUPPORTS HB 2590.

Kaiser Permanente is one of the nation's largest not-for-profit health plans, serving 12.6 million members nationwide, and more than 274,000 members in Hawai'i. In Hawai'i, more than 4,200 dedicated employees and more than 650 Hawai'i Permanente Medical Group physicians and advanced practice providers work in our integrated health system to provide our members with coordinated care and coverage. Kaiser Permanente Hawai'i has more than 19 medical facilities, including our award-winning Moanalua Medical Center. We continue to provide high-quality coordinated care for our members and deliver on our commitment to improve the health of our members and the 1.4 million people living in the communities we serve.

Kaiser Permanente supports policies that ensure all Hawai'i residents have access to affordable, high-quality health care. Further, Kaiser Permanente supports "whole-person care," including the provision of access to services and resources that address beneficiaries' physical health, mental health, and social needs.

Kaiser Permanente prioritizes food security as an area of community health focus, meaning that all people, in all communities, have access to sufficient, affordable, and nutritious food that meets





their food preferences and dietary needs for an active and healthy lifestyle. However, we know that food insecurity has increased due to the effects of inflation and the COVID-19 pandemic. As a result, Kaiser Permanente provides grants to Hawai'i food banks administering The Emergency Food Assistance Program's (TEFAP) Farm to Food Bank Program, which serves a critical role for many families facing food insecurities.

The grant funds served a twofold purpose through the food purchasing program. First, the funds are used as a match to draw down Federal funds, which require a 1:1 match. Additionally, Kaiser Permanente's grant funds support farm-direct bags of fresh produce for low-income seniors receiving a monthly supplemental food box through the Commodity Supplemental Food Program (CSFP), a USDA program that Hawai'i Foodbank runs in partnership with the Office of Community Services.

To ensure communities have reliable access to healthy food, Kaiser Permanente supports policies that minimize barriers to and maximize enrollment in federal nutrition assistance programs, such as SNAP, and support for federal nutrition standards for school meals, including meals with more fruits, vegetables, and whole grains, and less sodium and trans fats.

Our work is guided by our belief that access to nutritious food plays a critical role in supporting community health. Kaiser Permanente has also piloted interventions using medically tailored meals and launched a prescription produce program to help patients access fresh produce. By studying the effectiveness of these programs, Kaiser Permanente is building an evidence base for future policy interventions that reduce health care costs and improve patient outcomes.

Over the last few years, one of the most pressing issues for many local families has been food insecurity. With many out of work and surviving on government unemployment support, communities have relied on the efforts of food banks and local food producers to meet their basic need to eat.

In response to the COVID pandemic, federal monies injected into Hawai'i through county initiatives helped grow a local farm-to-food bank effort, in which food banks were able to purchase local products for distribution to needy communities. This effort was a win-win-win, in that local food producers had a market to sell their products when hotels and restaurants shuttered their doors, local families received fresh and nutritious food products made locally island-wide, and food banks that were struggling to purchase shelf-stable food due to nationwide shortages were rescued by Hawai'i's farmers and ranchers who provided local food to their communities.


The Coronavirus Pandemic disrupted Hawai'i's local food systems and caused many local producers to lose their local markets. Many catered to tourism, large-scale events, hotels, restaurants, cruise ships, farmers' markets, and school lunch programs, which were non-existent during Hawai'i's shutdown.

Like small businesses around the state, without open and consistent markets, local farmers and ranchers will decrease food production levels and will likely downsize and/or go out of business. To help address the state's food security during the pandemic, Hawai'i's Foodbanks partnered with local food producers to ensure that farmers and ranchers could survive.

At the onset of the pandemic, Hawai'i's Foodbanks partnered with farmers and ranchers to provide local agricultural produce and proteins for their food assistance programs. As organizations that aggregate and distribute food, Foodbank staff brought valuable logistical insight to these programs. The combined efforts of Hawai'i's Foodbanks, the Hawai'i Farm Bureau, and other partner organizations allowed tens of thousands of families to have access to food during unprecedented times. This win-win partnership connected local producers that lost markets and revenue sources due to COVID-19 with the Hawai'i Foodbank to meet the increased demands of feeding Hawai'i's communities.

HB 2590 will provide funds to Hawai'i's food banks that support non-profit and community feeding programs by providing locally grown or produced foods to communities in need. This will also help Hawai'i's farmers and ranchers while also providing local nutritional food to those who need it most.

According to Feeding America, more than 50,000 – or one in six – Hawai'i children are facing hunger. ¹ Especially with highest cost of living and the second-most expensive groceries in the nation, ² it is nearly impossible for the low-income families in Hawai'i to afford to buy healthy food, such as fresh fruits and vegetables.

In addition, it is well established that the stresses of childhood poverty have both immediate and long-term effects on keiki's physical and mental health, behavioral self-control, academic achievement, and earnings as adults.³

My name is Kilia Purdy-Avelino. I am a homesteader from Hoolehua, Molokai. I am in strong support of HB2590. Pre-COVID-19 pandemic, I worked for Alu Like which provided the youth program qualifying families with food from the food bank. There were about a dozen families/households. When COVID hit, food bank agencies were asked if anyone would be willing to put their contacts out for the public to be able to get these services. We did. And, we went from a dozen households to 80! Then, we started to notice that the food supply coming from Maui decreased. For a small island like Molokai with limited resources, it put us on high alert to find ways to resolve the problem. As a farmer, knowing other farmers who sold products with Sustainable Molokai's Mobile Market, and having conversations with some on excess produce, I approached the ED of Sustaibale Molokai to see if there was a way they could coordinate those farmers to help with our Molokai food bank supply. That initiative with many community partners - individuals and agencies, including the Maui/Molokai Food Bank, became known as Ho'oku'ikahi Aloha Molokai and took us farther than we could imagine paying for fresh Molokai farmed produce, shrimp, fish, and also working with the Molokai Hunting club and other community volunteers for deer meat, that supplied our island through the pandemic and still till today.

My name is Charla Teves. I am a college student and a life-long resident of Honolulu. This year, I was named one of five national Stephen J. Brady Scholars by the Sodexo Stop Hunger Foundation. I am testifying in support of HB 2590.

When I was a senior in high school, two Honolulu radio DJs mocked a popular singer for her experiences with childhood hunger. Along with the rest of our community, I was shocked by their insensitivity. It opened my eyes to the intensive needs right here in my hometown. I am asking for your help to adopt policies that will eliminate hunger in our lifetime.

One in five Hawaii children struggle with hunger, according to Feeding America. At more than 55,000 children, they would fill the Stan Sheriff Center four times over and still overflow into the parking lot. In 2021, I was one of 100 students nationwide awarded a Youth Service America and Sodexo Stop Hunger grant which enabled me to convene a Hawai'i virtual end hunger summit. Many state legislators, community leaders, students, and young adults convened to share their ideas such as supporting a statewide food policy and school gardens. I learned so much from the experience that I can no longer remain quiet. Since then, I have volunteered with many food drives and in other ways to help end hunger. Based on these experiences, I know for sure that your support of food banks in Hawaii will make a difference.
