#### Chair Perruso and Members of the Committee:

The Department of the Attorney General provides the following comments.

This bill: (1) requires the Leeward Community College Waianae Moku to establish and report to the Legislature on a program to support and assist students who are twenty-four years old or younger and ineligible to apply for federal financial assistance through the Free Application for Federal Student Aid application because they are unable to access their parents' tax information; and (2) makes an appropriation for the purpose of this bill.

Article X, section 6, of the Hawai'i Constitution gives the Board of Regents of the University of Hawai'i "exclusive jurisdiction over the internal structure, management, and operation of the university." Section 6 further provides: "This section shall not limit the power of the legislature to enact laws of statewide concern. The legislature shall have the exclusive jurisdiction to identify laws of statewide concern." If the Committee decides to pass this bill, we recommend an amendment that adds a statement identifying this bill as a law of statewide concern.

HB 2633 - RELATING TO ACCESS TO EDUCATION

Chair Perruso, Vice Chair Kapela, and Members of the Committee:

The University of Hawai'i supports the intent of HB 2633, which provides support and resources to assist the University of Hawai'i – Leeward Community College (LCC), Wai'anae Moku Education Center (WM) students, that are under twenty-four years old and that are unable to submit the Free Application for Federal Student Aid application due to their inability to retrieve parents' tax information.

This assistance program would provide qualified students with funding to cover direct education costs. Currently, tuition for full-time (12 credits) Hawai'i residents is \$3,144 for tuition and \$70 in student fees per year. Cost of attendance typically includes costs related to books, supplies, housing, and food among other expenses to provide a basis for financial planning. For students living with parents or relatives, the estimated cost of attendance is \$15,184 per year; whereas, for those living independently, the estimated cost of attendance is \$25,180. For reference, the Pell Grant, Federal Financial Aid for 2023-24 is capped at \$7,395.

At present, 31% of WM students are recipients of the Pell Grant, while 70% of the student body is aged 24 years and under. Given the WM enrollment, about 50 students would be potentially eligible under this program. It is important to note, that for eligibility, LCC students enroll at the College and not at WM, and therefore defining a WM student will be based on residence zip code OR course section enrollment at WM.

The University of Hawai'i supports the intent of HB 2633, as long as its passage does not replace or adversely impact priorities as indicated in our BOR Approved Budget.

## LEEWARD COMMUNITY COLLEGE WAI'ANAE MOKU

Testimony of Rick Kang, ATE Program Coordinator at Leeward Community College Waianae Moku

My name is Rick Kang, and I am the ATE Program Coordinator at Leeward Community College Waianae Moku. In 2015, I founded the Access To Education (ATE) program in response to the challenges students shared with me regarding their struggles in college classes. ATE is dedicated to providing resources and support to a diverse group of students, including those who were previously incarcerated, children of incarcerated parents, in recovery from drug and alcohol abuse, victims of sex trafficking, survivors of domestic violence, and those who were in foster care or adoption.

The majority of our students come from single-family homes, and many live with someone other than their parents or are houseless. The brokenness in their homes often results in students below 24 years old not having access to their parents' tax information, making them ineligible for financial aid such as the Pell Grant and other need-based scholarships that require a FAFSA application.

Currently, the ATE program has 70 students, and every semester, there are several prospective students unable to enroll or continue their education due to financial constraints. These students often resort to taking out loans or accumulate outstanding financial balances that prevent them from returning to school. In the Spring 2024 semester, I took the initiative to provide financial assistance to four students, covering their Fall 2023 tuition, despite their ineligibility for financial aid.

All four of these students are not financial aid eligible, highlighting the urgent need for additional support. I wholeheartedly endorse this bill, as it will empower students who, through no fault of their own, face barriers to attending college. The ATE program is well-prepared to implement this bill, as we already assist every student in applying for financial aid and scholarships. For those unable to access their parents' information or deemed ineligible for financial aid, we collaborate with our students to explore alternative options and establish sustainable financial plans.

This bill is not just about education; it is about breaking down financial barriers and providing opportunities for a brighter future. I urge you to support this legislation, which aligns with the mission of the ATE program to empower and uplift students facing unique challenges in their pursuit of higher education. Thank you for your attention to this critical matter.
