Comments:

Thank you for the opportunity to testify on HCB 196. I'm in support 110 %. I would like to add my reasons for this Resolution to assist in helping us in East Maui, for housing needs. My concerns are as follows:

- 1. Negative impacts to our existing County, State and National fiscal and infrastructural highways, bridges, Schools and Parks. The over whelming tourist industry are pushing our community out of their space and place to function as family for gathering.
- 2. Our Kupuna has minimal access to medical and Hospice care. Most times they are flown out for better care. They deserve their own place and space to live their lives in dignity, instead of living in crowded home conditions and being neglected because the families are too busy working.
- 3. The already rising Property market values going up to \$2 \$3 million is far fetch for many. Also the worst part is the possibility that awardees from the outside may decide to sell their homes due to financial hardships with the lack of jobs or realize they really can't live in Hana.
- 4. Majority of our economic working group consist of poor to middle class with minimum wages will pose competition. Hana has a lack of jobs on top of that and some, like me my Husband and grand daughter, has to travel to Central maui on a daily routine. Others travel to the westside too.
- 5. Existing living conditions consists of 4-5 generations in a home. It's so critical to support these Family (s) to have quality in being happy and healthy.
- 6. Hana's remoteness for disaster needs are critical like floods, land slides, Hurricane, fires and so on yet, we are the minority for response.
- 7. The natural resources, culture and the unique traditional character are well maintained that outsiders could pose a detrimental compromise unintentionally by not understanding the engaging practices to live or exist in Hana. Possibly depleting our resources by not truly understanding to perpetuate our life style for taro farming, gathering and hunting purposes.

Theres so much more but I hope these will help.

The Solution in supporting this Resolution?

Is to push the Award Preference of tracing at least 3-generations for the equity of family for generational wealth by making an administration rule change to set the precedence for an amendment for lineal descendants for those who live and work in Hana or create a way of applying a pre-qualifying criteria consideration with the Honouaiakea Project for setting the precedence.

I am 100 % in support of this bill because I feel there is an urgent need in Maui Hikina (East Maui) for housing needs for the generations of families all living in one household and living space.

Lack of housing, and the desire to continue to live in Hāna in the lifestyle of our kupuna is a hard choice to make for many. One needs to weigh the benefits of

continued generational learning and practicing traditional and cultural practices against making a livable wage to afford purchasing a home to start and raise a family. For those who choose to stay in Hāna, this means finding a job that will earn you a living that supports yourself and your future family. Every newly wed couple is faced with the situation of finding a home to live and raise a family...for some this means continue living at home, with mom, dad, often times with grandparents, and perhaps even other siblings and their families... THIS IS and has been the scenario for at least the last 50 years...I know because I've lived this lifestyle, and I see it all around me. Households are busting at the seams, as children grow to adulthood and raise their own 'ohana.

We need DHHL to take care of the East Maui generational families. Don't open East Maui to those living elsewhere, because Hāna cannot support more people moving in. We need to mālama our generational Hawaiians who live, support and call Hāna home NOW! Afterwards, as other opportunities come up then open to others, but for now MĀLAMA KA PO'E O KE KAI'ĀULU O HĀNA!

Those Hawaiians who can trace their genealogy back 3 generations and qualify to be on the list for East Maui awards are vested and committed to living the Hāna lifestyle. They are ma'a or used to the lifestyle of no large stores, no nightlife (really), no fast food places, high cost of living, limited jobs, limited medical care, limited emergency response, and last but not the least, Hāna's remoteness in times of disasters like hurricanes, tsunamis, landslides, and fires.

My concerns:

Negative impacts to our existing County, State infrastructural highways, bridges, Schools and Parks as you plan for more people living in Hāna. We are already experiencing minimal access to medical care, even non-emergency visits like giving birth and IV for dehydration require a flight out on the air or regular ambulance.

I fear the influx of new people to Hāna will create competition for our already stressed workforce situation. Most of our economic working group consist of poor to middle class with minimum wages, and succession is difficult since most will usually stay in one job until retirement age. Worst case scenario is if a person getting a DHHL award in Hāna, moves here, can't adjust to the lifestyle, can't get a job, THEN decides to sell their award due to financial hardships of living in Hāna.

Community based nonprofit organizations in Hāna have committed decades of work to sustainably managing our natural resources and traditional practices for gathering. There is a chance outsiders could pose a detrimental compromise albeit unintentionally, by not understanding the "traditions" and practices to live or exist in Hana. Possibly depleting our resources by not understanding the need to preserve and perpetuate our lifestyle of taro farming, gathering and hunting.

Aloha, my name is Bailey Spry, and I am writing in support of this resolution. I am not Native Hawaiian and have lived in Hāna only 10 years, but I understand the importance of prioritizing lineal descendants of Hāna in the DHHL homestead awards. Like elsewhere on Maui, there is an intensifying housing crisis in Hāna. Maintaining the current quota for award prioritization could potentially exacerbate this crisis in Hāna by bringing outside families into East Maui while Hawaiian households in Hāna become increasingly overcrowded. Basing waitlist prioritization and awards on lineal and generational descendants IS the culturally appropriate option, and is the responsibility of the Department of Hawaiian Homelands. Mahalo.
