

TESTIMONY FROM THE DEMOCRATIC PARTY OF HAWAI'I

HOUSE COMMITTEE ON HIGHER EDUCATION AND TECHNOLOGY

MARCH 15, 2024

HCR 34/HR 23, DECLARING DISINFORMATION AND DIGITAL HATE SPEECH AS THREATS TO DEMOCRACY AND URGING DEPARTMENTS AND AGENCIES TO ADDRESS THESE THREATS

POSITION: SUPPORT

The Democratic Party of Hawai'i <u>supports</u> HCR 13/HR 6, which declare disinformation and digital hate speech as threats to democracy and urge state departments and agencies to address these threats.

Democracy is fragile.

On January 6, 2021, far-right ideologues tried to tear apart the delicate fabric with which our society's governing bonds are woven and forcefully overturn the will of our nation's voters. The insurrection at the United States Capitol left citizens reeling from the audacity of the attempted coup and searching for answers about how to prevent future assaults on our republic.

Even in Hawai'i, the aftermath of the January 6th attacks was painfully felt. Security barricades were erected on the grounds of the Hawaii State Capitol in advance of Inauguration Day, after threats were made against political officials throughout our country. At a time when pandemic protocols emptied the people's house of visitors, the Capitol riots only further alienated elected leaders from the constituents they serve.

As Congress's investigation into the insurrection has revealed, much of the madness that occurred on January 6th was organized online. Cyberspace is no longer an undiscovered frontier. Today, our virtual and actual lives have become inextricably comingled. If we are not careful, though, technological advancement can generate the digital reproduction of inequality, discrimination, and violence.

According to a 2018 report published by the data clearinghouse Statista, 64 percent of teenagers in the United States have encountered hate speech on social media. At the same time, incidents of political violence have been escalating. The Washington Post reported in 2021 that right-wing extremists have been involved in 267 plots or attacks in the U.S. since 2015, resulting in 91 fatalities.

Furthermore, over half of the deaths caused by right-wing confrontations were committed by people who voiced support for white supremacy. Many of those outbursts were organized virtually amidst the shadows of social media. Washington Post's investigation found that from 2015 to 2020, the use of websites and social media by right-wing extremists rose in five of the six years that the news outlet studied, leading Georgetown professor George Hoffman to call social media a "propellant" for the spread of violent extremism.

During the pandemic, disinformation about vaccine safety and healthcare protocols spread almost as rapidly as the virus itself. To effectively cure our society of anti-scientific hysteria, it is imperative that we equip our state to identify factual evidence and employ sound reasoning when addressing the consequences of misinformation, disinformation, digital discrimination, and online hate speech.

It can be easy to neglect the foundations of our democracy. From housing insecurity to financial instability to the climate crisis, our society is simultaneously facing many pressing challenges. If we safeguard the pillars of our public sphere from digital mayhem, however, then we will give future generations a chance to resolve those concerns with tranquility and hope.

Respected individuals serving in the House of Representatives,

Greetings, I am Melvin Dizon, and I am an actively involved social worker in our community, dedicated to promoting the overall welfare of our members. Presently, I address this assembly to convey my unequivocal endorsement of House Concurrent Resolution No. 34. This resolution acknowledges the grave dangers that disinformation and digital hate speech present to our democratic system, as well as the pressing necessity to comprehensively tackle these concerns.

Throughout my daily interactions with various populations, I am confronted with the detrimental consequences that disinformation and digital hate speech have. These are tangible, real forces that undermine the trust and unity that are essential for the well-being of our communities. I have personally witnessed the upheaval of families, the indoctrination of young minds with extremist ideologies, and the exploitation of the weak through the cynical tactics of digital disinformation.

There exists a substantial correlation between the rise in prevalence of mental health concerns within our communities and the escalation of digital hate speech. Prolonged psychological trauma may ensue as a consequence of the stress, anxiety, and occasionally severe fear that ensue from the target of or exposure to hate speech. As a social worker, I frequently provide assistance, counseling, and intervention to those impacted on the front lines. However, in light of the expanding magnitude and intricacy of this issue, proactive, systemic solutions are not sufficient; rather, they are mandatory.

The resolution's recommendation to establish public safety plans is an essential measure in protecting our public institutions and personnel against the dangers posed by online organized violence. Nevertheless, this pertains not solely to safeguarding, but rather to fostering resilience. By expanding opportunities for media literacy and providing training on how to recognize and address digital hate speech and disinformation, we enable communities and individuals to resist the spread of false information.

Moreover, the implementation of trauma-informed protocols signifies an acknowledgment of the profound and frequently concealed harm caused by cyberbullying. By adhering to these protocols, individuals can receive the kind of informed, sensitive assistance that is indispensable for their recovery and reestablishment of safety and autonomy.

While advocating for resolute measures from all state departments and agencies, it is crucial to

bear in mind that combating disinformation and digital hate speech transcends policy considerations and touches upon fundamental human dignity. It pertains to safeguarding the well-being, dignity, and respect of each person within our society.

I strongly implore the legislature to adopt this resolution so that it may serve as a model for other states. We can collaboratively create a future in which digital spaces serve as conduits for knowledge, connection, and empowerment, rather than as locations for discord, deceit, and despondency.

I express my gratitude for your dedication and focus on this pivotal matter.
