Comments:

My name is Wesley Shinkawa and I am the principal of Kapolei High School. I am writing in support of HB45 and humbly ask that the Committee on Transportation urge the Department of Transportation to install speed bumps and speed limit signage on the portion of Kapolei Parkway between Kapolei High School and Kapolei Middle School. Your support and immediate action to improve safety for students, parents, and staff on Kapolei Parkway between Kapolei High School and Kapolei Middle School is critically warranted.

Here are my reasons for this request:

- **High Traffic Volume and Speeding:** This stretch of Kapolei Parkway experiences a significant volume of traffic, particularly during morning and afternoon school hours. Unfortunately, many drivers exceed the posted speed limit, creating a dangerous situation for pedestrians crossing the street.
- **Proximity of Schools:** With Kapolei High School and Kapolei Middle School located directly on Kapolei Parkway, there is a constant flow of students, parents, and staff crossing the street throughout the day. The current conditions pose a serious risk to their safety.
- **Limited Visibility:** Having such a long stretch, of this six (6) lane highway, can limit driver visibility, further increasing the risk of accidents involving pedestrians.
- Accident History: There have been a concerning number of near misses and/or accidents on this section of Kapolei Parkway. This data underscores the urgent need for safety improvements.

Proposed Solutions:

- **Installation of Speed Bumps:** Speed bumps are an effective traffic calming measure that can significantly reduce vehicle speeds and create a safer environment for our students, pedestrians, and community.
- Clear and Consistent Speed Limit Signage: Ensure clear and well-maintained signage displaying the designated speed limit throughout this section of the highway.
- Additional Safety Measures: Please consider additional safety measures such as increased police presence during peak school hours.

The safety of our children and the entire school community is paramount. I urge the Committee on Transportation and the Department of Transportation to prioritize this issue and take

immediate action to implement these solutions. Let's not wait for another tragic event to occur to seriously consider this matter; let's be proactive. Thank you for your time and consideration.
