# SENTATE BILL 1119 PROPOSED RELATING TO THE WORKS OF ART SPECIAL FUND

Dear Chair Lee and members of the Committee,

The SFCA respectfully **SUPPORTS** S.B. 1119 which appropriates funds to begin the process of community engagement to develop plans for a potential future memorial, monument, or other appropriate means to properly honor and respectfully recognize the memory of those who lost their lives or were impacted by the August 2023 Maui wildfires.

The SFCA supports the concept to commission a memorial, monument, or other appropriate means to properly honor and respectfully recognize the memory of those who lost their lives or were impacted by the August 2023 Maui wildfires. If it is the desire of the Legislature, the SFCA will form an Art Advisory Committee (AAC) following the SFCA's Collection Management Policy for all new works of art. AAC's are comprised of individuals who are informed in the subject of the place and nature of the project to, assist with the selection of location, defining the medium and theme of the work of art, recommending an artist, and review of design proposals.

SFCA supports the future appropriation of funding to implement the proposed intent, provided doing so does not replace or adversely impact priorities indicated in the Executive budget.
