Water is one of life's true joys. It surrounds our islands; it can bring us together and be a source of lifelong memories. Water can be dangerous and deadly, and requires our respect. I'm writing to support the Duke Kahanamoku License Plate bill to raise money for local aquatic safety grants to help address our drowning epidemic. And of course, Duke Kahanamoku is one of the most famous people to have grown up in your district and has become a symbol of Hawai'i's aloha spirit, water sports mastery, and hospitality.

As a reminder, we are facing some grim drowning statistics in Hawai'i:

- Hawai'i has the second-highest drowning rate for residents in the nation.
- Drowning is now the leading cause of death of Hawai'i children aged 1-16.
- Drowning is the leading cause of injury-related death for tourists.

As the parent of a drowning victim, I understand these statistics and the cost to our community, perhaps better than most. My daughter Charlotte "Sharkey" Schaefers, 5, drowned in 2004 while trying to save a friend who had fallen into a poorly maintained and clogged detention pond that had become a drowning hazard.

I am part of the Hawai'i Water Safety Coalition, and we are working on a statewide water safety plan, which will have recommendations to bring down the terrible drowning rates in our state. Drowning isn't an individual problem; it is a community problem. Rescues are expensive and put our first responders and other Good Samaritans in our community at risk. Visitor deaths threaten our reputation as a top visitor destination. Community deaths hurt the soul of Hawai'i and leave an irreplaceable gap in our collective ohana.

The money from the license plates could also be used for drowning prevention campaigns and outreach, swimming lessons and junior lifeguard programs, and perhaps adding rescue tubes where warranted. I believe these measures would save lives.

Just like my daughter, who stood on the banks of a flooded pond and watched her friend struggling, you have a life-or-death decision to make. Let me remind you that even though the risks were great, my daughter Sharkey didn't hesitate. She saved a life. Will you work with us to save lives?
