
Testimony on S.B. 2079 – RELATING TO THE IMPORTATION OF PLANTS AND ANIMALS

Our office has been working with Senator Glenn Wakai along with various Departments and stakeholders to explore ways to transform the current paper-based system to include an electronic option. The current statutory language prevents the State from capturing the information referenced in the declaration form in an electronic format. Amendments contained in S.B. 2079 will allow the State to have the flexibility to modernize the current process.

In consideration of **SB 2079** RELATING TO THE IMPORTATION OF PLANTS AND ANIMALS.

Chair Dela Cruz, Vice Chair Moriwaki, and members of the Committee.

The Department of Business, Economic Development and Tourism (DBEDT) supports the intent of SB 2079 which allows the State of Hawai'i Plant and Animal Declaration Form to be distributed, completed, and transmitted electronically.

DBEDT is in agreement that the Hawai'i Plant and Animal Declaration Form helps to prevent harmful pests from being brought into Hawai'i's unique environment, agriculture, and communities and that the existing law, as written, is not clear as to whether electronic forms may be used.

DBEDT respectfully requests that the collection of visitor characteristics continue to ensure the reporting of tourism research. The tourism data collected is useful for government agencies to plan and improve infrastructure, businesses to understand the needs of visitors, and economic forecasting. We also recognize the benefits that the digitization of the form offer, such as better efficiency, automated workflows, easy accessibility, data accuracy, and being environmentally friendly.

SENATE BILL NO. 2079 RELATING TO THE IMPORTATION OF PLANTS AND ANIMALS

Chair Dela Cruz, Vice Chair Moriwaki, and Members of the Committees:

Thank you for the opportunity to provide testimony on Senate Bill No. 2079 relating to the importation of plants and animals. This bill allows the State of Hawaii Plant and Animal Declaration Form to be distributed, completed, and transmitted electronically.

The Department agrees with the intent of the bill and offers comments.

The Department appreciates clarifying that there are both a paper and electronic form that can be used. However, the Department does not believe that the addition of "paper" on page 4, line 15 is necessary. While it is unlikely that defacing of a digital form could or would occur, removing the distinction does not appear necessary for determining if there is a violation and should there be some way of digitally defacing the form, it would be best to not be precluded from seeking a penalty.



Regarding HRS 150A-5(2)(B), the Department also appreciates the clarification on submission of the forms to the Department. However, this bill implies that the forms, whether digital or not, will be given to the Department prior to passengers and their baggage departing the airport or seaport, however, with both forms now in use, timing of submission also needs clarification. The Department suggests the following language to clarify this section:

"(B) Completed <u>paper</u> forms shall be collected by the transportation company and be delivered, immediately upon arrival, to the inspector at the first airport or seaport of arrival. Completed electronic forms shall be transmitted to the inspector prior to passengers departing the first airport or seaport of arrival. Failure to distribute or collect <u>paper</u> declaration forms, [or to] immediately deliver completed <u>paper</u> forms, or transmit completed electronic forms prior to passengers departing is a violation of this section;"

Regarding HRS150A-5 sections (7) and (8), the Department believes that the five changes of "such" to "another" or "the" is unnecessary as "such" refers to the specific decision or situations that precede each statement containing "such", ensuring clarity.

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports SB 2079, which allows the State of Hawai'i Plant and Animal Declaration Form to be distributed, completed, and transmitted electronically.

HFB recognizes the importance of preventing destructive invasive species from entering the State and how difficult it is to manage those that become established in our islands. We appreciate the difficult work of HDOA and its partners in preventing entry and their efforts to eradicate or control these detrimental animals, insects, weeds, diseases, and other pests.

Our ports-of-entry biosecurity program is essential to prevent invasive species from entering the state. The State of Hawai'i Plant and Animal Declaration Form helps prevent new invasive species from entering Hawai'i when completed by passengers and flight crews arriving in Hawai'i. Converting the current paper form to an electronic form will increase the number of completed forms which can help decrease the number of restricted plant and animal species entering the state.

Aloha Chair Dela Cruz and Members of the Way and Means Committee,

My name is Tim Carson, and I am President and CEO of SMS Research and Marketing Services, Inc. I am the current vendor that processes the paper Hawai'i Plant and Animal Declaration Forms. I am writing to offer my strong support for SB2079, which proposes to streamline and digitize the paper forms. Even as the incumbent vendor processing the paper forms, I believe this bill represents a crucial step forward towards efficiency and increased user-friendliness which we believe will ultimately result in increased response rates.

Having processed the paper forms for many years, SMS has witnessed firsthand the inefficiencies inherent in the current processes. These inefficiencies include manual processes of receiving the paper forms (physically picking up the forms at Honolulu International Airport and having them delivered via FedEx each day from the neighbor islands), manually scanning each form by flight (approximately 4 million forms a year), and having a team verify the data where from the forms where the software we use is unable to read handwriting). SB2079 presents a clear and practical solution to address these issues.

Additionally, SMS is currently working with the Hawai'i Department of Agriculture and the Hawai'i Department of Business and Economic Development and Tourism on a limited pilot to digitize the form and test out the methodology (how the passengers will know to complete the form in advance of boarding the plan (communication plans, QR codes at check-in, at the gate, on the plane, etc.), test response rates, how the Hawai'i Department of Agriculture will receive and reviews the forms as the passengers arrives, etc.). This bill will allow us to proceed with such a pilot and determine true feasibility.

I strongly urge the Ways and Means Committee to pass SB2079.
