# In consideration of SENATE BILL 2143 SENATE DRAFT 1 RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES

Senate Bill 2143 Senate Draft 1 proposes appropriate funds to the Wildfire Management Branch of the Department of Land and Natural Resources Division of Forestry and Wildlife to provide grants to nonprofit organizations for wildfire preparedness and mitigation programming. The Department of Land and Natural Resources (Department) supports this measure provided that its passage does not replace or adversely impact priorities indicated in the Executive FY 2025 Supplemental Budget Request.

The Department's Division of Forestry and Wildlife (DOFAW) is the primary responder for wildland fires across 1,368,002 acres of the State of Hawai'i's forested watersheds (or 26% of the land area in Hawai'i) and supports federal and county responders on the remaining regions of the State. DOFAW is also tasked with coordinating prevention outreach and planning efforts, which include assisting communities in developing Community Wildfire Protection Plans, encouraging communities to join the National Fire Protection Association's Firewise Community Program, and applying for federal grant programs like the United States Forest Service's (USFS) Wildland Urban Interface Grant Program and Community Wildfire Defense Grant Program. DOFAW does not have the staffing capacity or resources to adequately provide programming for all the State's wildfire preparedness needs and instead partners with nonprofit organizations such as the Hawai'i Wildfire Management Organization to fill this gap. Wildfire prevention nonprofits cannot count on receiving federal grant funding annually through DOFAW and are often outcompeted by larger, national nonprofits for federal grants. Therefore, it is necessary to secure permanent State funding to support nonprofit partners that provide education, training, and support for communities and large landowners to manage fire risks through mitigation plans and projects. will increase the Department's capacity to assist communities in planning, preparing, and mitigating the potential impacts of future wildfires that are growing in frequency, size, and duration due to increased periods of drought coupled with heavy loading of wildfire fuels on unmanaged lands. There is an urgent need for additional funding and resources for the State's fire service to do pre-suppression work such as fuel reduction and improved forest management, maintain readiness and capacity for fire suppression, and restore and recover landscapes in the aftermath of wildland fires. By funding pre-suppression and recovery, including wildfire preparedness and mitigation programming, public exposure to catastrophic wildland fires will decrease.

Aloha Chair Ichiyama, Vice-Chair Poepoe and Honorable Committee Members,

My name is Dr. Davianna Pōmaika'i McGregor and I am testifying today on behalf of the Protect Kaho'olawe 'Ohana in strong support of SB3327,SD1.

SB3327\_SD1, when passed, will implement decades-long recommendations to try to have the Water Commission be free from the variable influence of changes in gubernatorial politics. The proposed changes will enable the Commissioners and their staff to better focus on protecting our state's islands' water resources and fulfilling their kuleana.

The proposal to have the CWRM deputy position become an Executive Director who reports directly to the Water Resource Management Commission, is a positive structural change, similar to the structure of the Kahoʻolawe Island Reserve Commission (KIRC). This structure has been effective for the KIRC in its focus on healing the island of Kahoʻolawe. Having the BLNR chair serve as a member of the commission, instead of the chair has also been effective for the KIRC. Instead on the KIRC, the commissioners take a poll on who should serve as chair and forward their recommendation to the Governor. Most state commissions have volunteer chairpersons - Kahoʻolawe Island Reserve Commssion, Land Use Commission and the UH Board of Regents.

The bill would also increase fines for violations of rules. We support this. Again, for Kahoʻolawe, substantial fines have served to make the rules that protect the island's marine resources more effective.

I write to you today in resolute **support of SB 2143**, a pivotal piece of legislation that seeks to allocate essential funds to the Wildfire Management Branch of the Department of Land & Natural Resources. This allocation is aimed at providing nonprofit organizations with vital grants for wildfire preparedness and mitigation programming. We are writing as the co-directors of the nonprofit that has been at the forefront of wildfire prevention and preparedness for over 20 years, before others even acknowledged or were aware of the issue.

Hawaii Wildfire Management Organization (HWMO) serves as the state's primary hub of wildfire prevention, mitigation, planning, and collaborative risk-reduction and post-fire recovery projects. We were founded in 2000 to fill in the gaps of our fire and forestry agencies, who do not have the capacity for this type of work. Until August of last year, wildfire has been de-prioritized by everyone except our organization. We have written every wildfire protection plan in Hawaii since 2010 and have mapped every ignition and large fire since 1999. We run the only community wildfire preparedness program (Firewise Communities Program) for the state and do so for DOFAW. We also co-lead a fire science exchange network for the state (Pacific Fire Exchange) in partnership with UH-Manoa. Since August, we have had a 1500 percent increase in requests for our technical assistance, prevention and mitigation resources, and programming. Our fire departments, forestry, and emergency management agencies have been sending concerned citizens our way, as we have strong partnerships with these agencies, and have been serving in this capacity for a very long time already.

Our organization stands firmly behind the passage of this bill, recognizing the pivotal role that nonprofit organizations play in the realm of wildfire preparedness and mitigation. These organizations are often the bedrock of expertise, community engagement, and resource mobilization needed to implement highly effective programs. Some 22 lots were scorched, but fortunately no structure was lost. The fire season is with us again with 3 smaller fires in our vicinity on February 25 and two on March 7. The Hawai'l Fire Department was able to extinguish those fire rapidly.

With the constitution of the Fire Protection Subcommittee our Ranch is getting organized address the rapidly increasing challenges of Wildfire:

- Owners education and alignment of Ranch regulations to Firewise best practices
- Fire risk mitigation both from individual owners and the KR community. Vegetation
  Control within the Ranch through mechanical methods and grazing, and maintenance of
  fuel breaks such as those opened by the Department of Transportation.
- Organization of the Ranch emergency response and training
- Improving infrastructure resilience
