Subject: Senate Bill (SB) 2230 Relating to Fireworks

I am Kazuo Todd, Chair of the Hawaii State Fire Council (SFC). The SFC strongly supports SB 2230, which imposes a statewide limitation on consumer fireworks, except by permit for use at cultural events.

The SFC continually advocates for increased limitations on the use of explosives by the general public. The widespread use of fireworks endangers the public. Members of the public experienced firework-related injuries during recent New Year's Eve celebrations in Honolulu. The Emergency Medical Services (EMS) responded to at least eight incidents, including eye injuries, serious burns, and more. Six out of the eight cases resulted in permanent disfigurement, involving the loss of limbs and eyesight. The age of victims ranged from six-years old to senior citizens. A 28 year-old male suffered a fatal head injury from fireworks on New Year's Eve 2022-2023. On April 8, 2011; 5 fatalities resulted from an accidental fireworks explosion at the Waikele Self Storage facility in Waipahu, Hawaii.

Indeed, every New Year's Eve, first responder agencies throughout the state experience high operational tempo from fireworks misuse; with incident call volume occasionally exceeding available resources. to 23 fireworks-related fires from 8 a.m. on Dec. 31 and 8 a.m. on Jan. 1. The department responded to eight fireworks-related blazes during the same time period of 2022 to 2023. According to the National Fire Protection Association, fireworks cause more than 19,500 fires each year.

Fireworks are known ignition sources for building fires and wildfires in Hawaii. To protect the public, property, and the environment; the SFC urges your committee's support on the passage of SB 2230.

Aloha Chair Wakai, Chair Lee and Members of the Committees,

Thank you for allowing me to submit testimony on behalf of Phantom Fireworks in **OPPOSITION** to Senate Bill 2230 – Relating to Fireworks. This bill seeks to ban all fireworks, including consumer fireworks, except by permit for cultural events. Although Phantom Fireworks supports the intent of the bill to control the spread of illegal fireworks, this bill would not achieve such purpose.

Consumer fireworks are an important part of Hawaii's local culture. In addition to ethnic cultural events such as Chinese Lunar New Year or festivals with dragon dances, locals enjoy celebrating with fireworks on other occasions. In fact, the largest use of consumer fireworks is during New Year's Day and 4<sup>th</sup> of July celebrations. A statewide ban would not prevent the illegal fireworks from continuing to be sold but would encourage the illegal sale as has continued since Honolulu's ban in 2010. The better approach would be to provide better regulation and increase the enforcement of current laws, including fireworks sales outside of the allowed time periods.

Simply put, the outright ban of all fireworks during the most popular fireworks periods would not serve to address the sale and use of illegal fireworks. We appreciate the willingness of the legislature to tackle the issue of illegal fireworks, and we are

thankful to be able to continue to work with the many Representatives and Senators who are committed to finding the appropriate solution. For these reasons, we urge the committee to defer Senate Bill 2230.

Aloha Chairs Wakai and Lee, Vice Chairs Elefante and Inouye, and members of the Committees:

American Promotional Events, Inc. **opposes** Senate Bill 2230. The measure proposes a statewide restriction on consumer fireworks which we firmly believe that it will not yield the anticipated results.

In 2010, the Honolulu City Council banned most consumer fireworks. The unintended consequence of this action was a surge in black market activities as consumers sought alternative sources for fireworks that had lit up the skies for years.

Fast forward to today, and we find ourselves amidst an unprecedented proliferation of illegal aerial devices. Despite numerous legislative attempts to bolster enforcement and penalties, the situation remains largely unchanged. A near-total ban, rather than curbing the use of fireworks, has inadvertently fueled the black market and led to unintended consequences. As such, a similar statewide near-ban would likely lead to the same undesirable outcomes.

Instead of pushing consumers towards the black market, we should be exploring safer alternatives. We can take a cue from states like New York, New Jersey, Arizona, and Delaware, which have revised their bans on consumer fireworks. These states now permit the sale of less disruptive fireworks such as fountains and ground spinners.

Currently, fireworks are permitted in 49 states, the District of Columbia, and Puerto Rico. It's clear that people across the nation, including Hawaii, have a deep-seated love for fireworks. They are a cherished part of our New Years, 4th of July, and cultural celebrations. Therefore, it's crucial that we find a balance that respects this tradition while ensuring the safety and peace of our communities.

### TESTIMONY OF TINA YAMAKI PRESIDENT RETAIL MERCHANTS OF HAWAII FEBRUARY 12, 2024 SB 2230 RELATING TO FIREWORKS

Good afternoon, Chair Wakai and Chair Lee and members of the Senate Committee on Public Safety & Intergovernmental & Military Affairs and the Senate Committee on Transportation and Culture & the Arts. I am Tina Yamaki, President of the Retail Merchants of Hawaii.

The Retail Merchants of Hawaii was founded in 1901, RMH is a statewide, not for profit trade organization committed to the growth and development of the retail industry in Hawaii. Our membership includes small mom & pop stores, large box stores, resellers, luxury retail, department stores, shopping malls, local, national, and international retailers, chains, and everyone in between.

We respectfully oppose SB 2230. This measure imposes a statewide limitation on consumer fireworks, except by permit for use at cultural events.

Hawaii's Asian culture is steeped deep into the tradition of using fireworks in belief that it wards off evil and welcomes in good luck and happiness. This is practiced by many during the New Year at midnight to bring in good luck and happiness for the new year. At weddings and business openings, firecrackers are used to drive away evil spirits. A ban on fireworks will only lead people to purchase them on the illegal market.

While we understand the intent of this measure, this type of legislation will not curtail the use of illegal fireworks in Hawaii. Aerial fireworks have been banned for several years in the state and yet we continue to see them year after year lighting up the skies from people's residences, from the street fronting people's homes, and at beaches to name a few. We have already seen that time limits on the use of fireworks are overlooked as we continue to see illegal ariels and "bombs" weeks before the actual holiday. People for years after the ban have found ways to purchase those illegal aerials and they will do the same for fireworks. We also want to point out that the already illegal aerial devices and fireworks like that of bottle rockets, roman candles, and mortar-and-shell fireworks as well as homemade fireworks caused the highest rates of significant injury.

Instead of a ban, we need to find other means to enforce the laws and penalties on those who use illegal aerials and "bombs" and who also bring them into the islands. We need to ensure that the Illegal Fireworks Task Force that includes state narcotics agents, deputy sheriffs, county police officers, the Department of the Attorney General, and federal agencies including Homeland Security Investigations, the U.S. Postal Inspection Service, U.S. Customs and Border Protection, U.S. Coast Guard Investigative Service, and the Bureau of Alcohol, Tobacco, Firearms and Explosives has the tools and laws needed to apprehend those who are bringing in, distributing/selling and using the already illegal fireworks.

On behalf of the Hawaiian Humane Society, thank you for considering our support for Senate Bill 2230, which imposes a statewide limitation on consumer fireworks, except by permit for cultural events.

Hawaiian Humane supports any attempt to restrict fireworks from residential neighborhoods. As this measure points out, illegal fireworks fill our neighborhoods with unexpected explosions that terrorize pets and people alike while disrupting what should be joyous times for local families.

By limiting the issuance of fireworks permits to cultural events, this measure has the potential to reduce what are now legal fireworks sales and thereby make importing illicit supplies more difficult.

SB 2230 highlights the perennial nature of this issue. In fact, the problem only seems to get worse. Hawaiian Humane has long educated our community about keeping pets safe from the terror of fireworks around New Years and July 4, but these bombs increasingly go off for months at a time without warning. That makes it impossible for pet owners to prepare and creates sustained stress on people and animals, which can do lasting damage to their emotional, mental and physical health. Neither people nor animals should have to take tranquilizers just to survive the impacts of their neighbors' illegal behaviors.

We urge the committee to pass this measure. Mahalo for your consideration.
