ON SENATE BILL NO. 2386

### RELATING TO ELECTIONS

February 9, 2024

Chair Rhoads and members of the Senate Committee on Judiciary, thank you for the opportunity to provide comments on Senate Bill No. 2386. This bill establishes presidential preference primary elections for the 2028 election cycle.

The following outlines the operational matters related to the conduct of a presidential preference primary election and notes the legal considerations on specific sections of the bill.

### **Operational Matters**

The presidential preference primary would be conducted as a single-party primary such that voters must first select a political party and then only vote for the candidates associated with their selected political party. Votes for the candidates of another political party would not be counted. Additionally, nonpartisan presidential candidates would not have the option of appearing on the presidential preference primary election ballot and would continue to need to petition and fulfill the requirements under HRS § 11-113 to appear on the general election ballot.

All expenses are to be borne by the State, including those attributable to voter registration by the counties, unlike in a combined election in which the counties are solely responsible for voter registration costs. Our initial estimate of the costs associated with the State's responsibilities under HRS § 11-110(b)(3)(B) is listed below and is based on servicing over 997,000 registered voters, estimated based on a 5% increase in registered voters for each of the

next 3 elections (2024, 2026, and 2028) from the most recently completed 2022 election cycle. It does not include the expenses associated with the responsibilities of the county clerks under HRS § 11-110(b)(3)(A) that the State will ultimately need to pay.

This would be part of our FY 2026-27 annual budget request.

Another consideration may be to move the regularly scheduled primary election to an earlier date to include the presidential preference primary as a contest. Holding a presidential preference primary election with the primary election may improve voter participation, as historically, turnout for single contest elections is lower. Also, the costs would be reduced as it becomes part of the operation of the primary election.

### Legal Considerations

We raise the following legal concerns:

## Section 1: HRS § 11-62 Qualification of political parties; petition.

The bill establishes the deadline to qualify as a political party for the presidential preference primary election as no later than the 90th day prior to the close of candidate filing for the election. We envision there could be political parties that do not qualify prior to the presidential preference primary, but that they do meet the deadline to appear on the primary election ballot in August. HRS § 11-62(a)(1). In such a situation, we would understand HRS § 11-113 to permit such a duly qualified party to submit names to our office for inclusion on the general election ballot for president and vice president.

Section 3: HRS § 11-174.5 Contests for cause in general, special general, special, and runoff elections

Given that the focus of the bill is on the presidential preference primary election, we would suggest removing Section 3 of the bill that addresses the general election. Any amendments to the handling of the presidential election itself in the general election might be better addressed in a separate bill.

## Section 7: HRS § 12-3 Nomination paper; format; limitations

Given that a prospective presidential candidate may not be an actual member of the state political party they wish to affiliate with, as they are instead a member of the corresponding national party or the same political party in another state, it may be appropriate to amend HRS § 12-3(a)(7) by adding the following language at the end of Page 11, Line 10:

; provided that in a presidential preference primary a party includes membership in the national party or an affiliated political party in another state who will be sending delegates to the same national convention as the party defined in section 11-61.

## Section 9: HRS § 12-5 Nomination papers: number of signers

We would recommend amending the first sentence of the proposed language of HRS § 12-5(a) to read on Page 16 at lines 19-20 as follows: "Nomination papers for candidates for president in the presidential preference primary election shall be signed by not less than twenty-five registered voters of the State."

### Section 10: HRS § 12-6 Nomination papers: time for filing: fees

We would suggest the filing fees for federal offices be kept similar to that of state offices after factoring in the discounted filing fee provision of HRS § 12-6 that functionally caps the fee at \$75 for the statewide office of governor and lieutenant governor. We may face a challenge concerning the filing fees for federal offices being significantly higher than the discounted filing fee many state and county office candidates pay. Having said that, HRS § 12-6 does include a provision for waiving the filing fee for a person who is indigent and submits a petition with a requisite amount of signatures, but it also could be subject to challenge if it is considered to be too burdensome.

### Section 11: HRS § 12-7 Filing of oath

As a point of clarification, Section 11 of the bill appears to require presidential candidates in the presidential preference primary election and the general election to take and subscribe to an oath. Also, it could arguably require the vice presidential running mate in the general election

to sign. This may create issues with the requirements of HRS §§ 11-113(c)(1)(B) and (2)(A), which include "[a] statement that each candidate is legally qualified to serve under the provisions of the United States Constitution." This statement is not signed by the presidential and vice presidential candidates but instead by appropriate party officials.

Given this, it may be appropriate to limit the oath in HRS § 12-7 to just any presidential candidate who seeks to participate in the presidential preference primary election. Otherwise, the proposed language in Section 11 of the bill may have unintended consequences if a presidential candidate at the national convention of a political party is chosen who did not sign the nomination paper oath as they did not participate in the presidential preference primary election.

# Section 12: HRS § 12-8 Nomination papers; challenge: evidentiary hearings and decisions

The bill on Page 23, Lines 6-17, appears to authorize a political party to be able to challenge a candidate as not being a member of their political party. Given that candidates may be members of the national political party or an affiliated political party in another state, we would suggest that the bill clearly permit the state political party leadership to challenge those who claim to be associated with the national party or an affiliated party in another state who will be sending delegates to the same national convention.

### Section 20: Effective Date

Given that there may be administrative matters that will need to be addressed, we would request that the effective date of the bill be changed to July 1, 2026.

Finally, as a housekeeping matter, we would recommend that HRS § 11-1 be amended to include a definition of a presidential preference primary election that would read as follows:

"Presidential preference primary" means an election whereby candidates associated with a political party receive votes to be its presidential nominee at its national convention. The political party will send delegates to its national convention in accordance with the convention's rules concerning delegates from each state, which may or may not ultimately factor in the results of the presidential preference primary election.

SB 2386 would establish a presidential preference primary elections for the 2028 election cycle.




The results from the survey show OVERWHELMING support (91.3%) for a Closed Primary no matter who runs it, which coincides with what is dictated to the DPH by our foundational documents.

It should be noted that the 2 people that did not give a 2<sup>nd</sup> choice picked "Party-run Presidential Primary – CLOSED" as their 1<sup>st</sup> choice.

Given the responses from our members, plus the Caucus' long-standing position on this matter, and what is in the Democratic Party of Hawai'i's foundational documents in our Constitution<sup>1</sup> and Resolution<sup>2</sup> the Stonewall Caucus can ONLY be able to support a CLOSED Presidential Primary. The Caucus understands for the State to run a closed Presidential Primary it would require an amendment to the State Constitution.

Yes, the questions that were asked in 2023 were about the 2024 Presidential Primary but as you saw our Party's Constitution has not changed nor has the Resolution been with rescinded. This means they are both are guiding documents and there has been ZERO requests for any change in the Caucus's position from our members.

The Caucus can also think of a lot of better ways of spending \$6+ million dollars; shelters for homeless unaccompanied minors, free meals for public school students, hardening our public schools for when the next big hurricane hits, etc. It should be noted that when a similar bill was debated in 2023 the price tag for this endeavor went up with every hearing and we were never given a final estimated cost.

Without any amendments to the bill to ensure a closed Presidential Primary and guarantees that this would increase participation we must oppose SB 2386.

### DPH Constitution as amended by the State Convention 05/28/2022

### Art. I, Sec. 1

The Democratic Party of Hawai'i believes that its primary election, a state-imposed mandatory nomination procedure, ought to be open to participation of only such persons as are willing to declare their affiliation with and support for the Party, either through public registration to vote, or through maintenance of membership in the Party. The Party further believes that the current Constitution and laws of the State of Hawai'i, by maintaining secrecy of affiliation, and by compelling the Party to admit to its nomination procedures those who may have no interest in, or actually oppose the interests, values, and platform of the Party, do violence to the Party's associational freedoms and the individual freedoms of its membership to define their own political views, guaranteed under the Constitution of the United States.

### Art. VIII, Sec. 8

The resolving clauses of resolutions, except for those clauses that refer to a specific date, event, or legislative session, once adopted by delegates at a convention of the Democratic Party of Hawai'i shall represent the official policies of the Party and shall remain in force and effect until rescinded or amended by the delegates at an annual or special convention.

Aloha Chair Rhoads, Vice Chair Gabbard, and Committee Members,

This is one of several bills this session that pave the way to eliminate our Party-run Presidential Caucuses which are done in person with Voter ID and hand-counted paper ballots at the caucus voter precinct locations. The counting is done in the presence of official observers and designated observers representing each presidential candidate.

This bill proposes to replace our Party-run Caucuses with State-run Primaries run by mail-in ballots and counted by election software source code. The election software source code is managed and controlled by a non-government contractor, Hart Intercivic. There are many risks related to the use of software such as malware and hacking vulnerabilities.

Procedurally, both major political parties of the U.S.which are the Democrat Party and the Republican Party officially nominate their candidate for president at their respective national conventions. Each of these conventions are attended by a number of delegates who are selected in accordance with the given party's bylaws. The results of the presidential primaries and caucuses bind many of these delegates, known as pledged delegates, to vote for a particular candidate. Both parties also have a group of unpledged delegates.

Please vote NO on SB2386.

Chairman Rhoads and members of the Senate Committee on Judiciary:

I am testifying STRONGLY AGAINST S.B. 2386

This bill seeks to establish a Presidential Party Preference Primary Election in the State of Hawaii. There is no need for such a primary. National party conventions are assemblies under Amendment I, US Constitution. As such, the conduct of these conventions are matters for the Assembly to determine. The bill appears to acknowledge this in SECTION 16, which would amend Chapter 12 Section 41 with a new subsection (d):

"(d) Political parties shall send delegates to their respective national conventions in accordance with the convention's rules concerning delegates from each state, which may or may not factor in the results of the presidential preference primary election."

Thus, the proposed primary is nothing but a "beauty pageant" that will cost the state money to no discernible purpose. In particular, if rules for a party National Convention provide for determining delegates prior to April in the election year, the whole exercise is meaningless.

Specific concerns:

SECTION 2 amends Chapter 11 Section 173.5 subsection (b) by adding:

"provided further that the right of a presidential candidate to the office shall depend upon the outcome of the national electoral vote."

I have no idea what this means. The "right" is fully determined by Amendment XII and Amendment XX to the US Constitution; there is no room for state opinion on this.

SECTION 11 amends Chapter 12 Section 7 by requiring a candidate for presidential election or presidential preference election to file an oath as provided in that section. This oath requires, in part:

"I will support and defend ... the Constitution and laws of the State of Hawaii"

Article II Section 1 US Constitution contains the oath of office for the President. There is no reason for a President to swear an oath to Hawaii, in particular to support Hawaii constitution and laws. I doubt this could be enforced.

Honorable Members of the Legislature,

This testimony stands in opposition to SB2386, underpinning significant constitutional concerns and urging a reconsideration of its enactment. The bill, by introducing restrictive measures on political party qualifications and election procedures, potentially infringes upon the foundational principles of freedom of expression and equal protection under both the U.S. and Hawaii State Constitutions.

The First Amendment's guarantee of political expression and association is at risk if the bill's stringent requirements limit the diversity of political discourse. The Fourteenth Amendment's Equal Protection Clause may be contravened by provisions that disproportionately impact smaller or emerging parties, undermining the equity of our electoral process.

Similarly, the Hawaii State Constitution enshrines rights that could be compromised by the bill's enactment, particularly those related to political freedom and equitable participation in elections.

ALOHA Chair Rhoads, Vice Chair Gabbard, and Members of the Committee

I am writing to urge your support for SB 2386, which aims to establish a State Run Presidential Preference Primary election in Hawaii beginning in 2028. I believe all registered voters in our state deserve the right to participate in this crucial aspect of the electoral process, just as they do in State Run Primaries and General Elections.

Currently, the process of selecting Presidential candidates in Hawaii excludes a significant portion of our electorate.

- In the 2020 election cycle only 80,000 enrolled members of the Democratic Party of Hawaii received a ballot for the Party Run Presidential Primary.
- Fewer than 40,000 actually participated in the primary.
- In contrast, In the subsequent General Election, the Democratic Party candidate received a total of 366,000 votes in Hawaii.
- This means over 300,000 voters who supported the Democratic candidate in the General Election never received a Ballot to vote in the Party Run Presidential Primary and were effectively disenfranchised from the primary process.

It is evident a large percentage of voters are denied their fundamental right to participate in selecting Presidential candidates under the current Party Run Presidential Primary process. The Democratic National Committee recognized this issue in 2023 and strongly recommended all State Democratic Parties transition to State Run Presidential Primaries due to their improved procedures and controls and their ability to get a ballot to registered voters.

Hawaii currently stands among a handful of states that do not rely on State Run Primaries as the norm, and was only approved on an exception basis. Passing SB 2386 would provide our state with four years to plan and budget for the 2028 cycle, ensuring a smooth transition to this more inclusive electoral process.

When considering the cost of implementing a State Run Presidential Primary, it's essential to weigh the value of allowing all voters to participate against restricting the vote to a small group of registered party members. The right to vote is priceless, and ensuring its accessibility to all citizens should be a priority for Hawaii.

I encourage you to support SB 2386 and help ensure Hawaii's electoral process is fair, inclusive, and reflective of the will of all its citizens.
