1 Fiscal Implications: This measure may impact the priorities identified in the Governor's

2 Executive Budget Request for the Department of Health's (Department) appropriations and

3 personnel priorities.

4 **Department Testimony:** The Department of Health (Department) supports SB2401, SD2, HD1,

5 which appropriates funds for the Counties of Kauai, Maui, Hawaii, and the City and County of

6 Honolulu (CCH) to implement feral chicken control programs and the Department to implement

7 a feeding feral animal education campaign.

8 As the Department has previously testified, the Department acknowledges the need for control of

9 feral chickens by the CCH and other county agencies and supports an educational campaign to

10 reduce the amount of feeding of feral animals statewide. Feral animals, whether chickens, cats,

11 or other animals can increase the feral populations which is not in the best interest of the animals

12 themselves, the environment, or in some cases, human health. Educating residents and visitors

13 about the adverse effects of feeding feral animals is crucial to the success of any feral animal

14 reduction program in Hawaii.

In crafting an educational campaign, the Department will collaborate with other government and
private agencies or organizations with similar interests and priorities.

Thank you for the opportunity to testify on Senate Bill 2401, SD2 HD1. This bill appropriates funds to each county as a grant-in-aid for the implementation of feral chicken control programs. Appropriates funds to the Department of Health for a feeding of feral chickens' education campaign. The Department expresses our **strong support** but prioritizes the budget items identified in the administration's executive budget and legislative package.

This past fall, the department convened the working group to discover best practices with the City and County of Honolulu's feral chicken program, further conversations statewide led to a similar request for the County of Hawaii and County of Maui which the legislature included in SB2401, SD2. Expanding the program to each county as a grant-in-aid for feral chicken control programs allows the counties to put together programs that are most effective for their residents.

On behalf of the Hawaiian Humane Society, thank you for considering our comments on Senate Bill 2401, SD2, HD1, which appropriates funds to each county as a grant-in-aid for the implementation of feral chicken control programs, appropriates funds to the Department of Health for a feeding of feral animals education campaign, and takes effect 7/1/3000.

Hawaiian Humane is grateful to the sponsors of this measure for looking at this issue holistically rather than presupposing that lethal control is the only possible strategy to curb the feral chicken population. Education is a key component. We also advocate for stronger enforcement against cockfighting operations to reduce a primary source of this population, as well as prevent animal cruelty and protect human beings from associated illegal activities.

Regarding the birds that are already on the landscape, we advocate for the adoption of an avian birth control program, which is more humane and less costly than lethal eradication. We were excited to learn that the state Department of Agriculture plans to submit a Special Local Need (SLN) registration to the U.S. Environmental Protection Agency, which would allow already existing avian birth control products to be used to curb the chicken population. We would encourage using the funding provided by this measure to implement humane population management strategies.

## TESTIMONY ON SB 2401, SD2, HD1 RELATING TO FERAL CHICKENS

Aloha Chair Yamashita, Vice-Chair Kitagawa, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports SB 2401, SD2, HD1, which appropriates moneys to each county as a grant-in-aid for the implementation of feral chicken control programs and makes an appropriation to the Department of Health for a feeding of feral animals education campaign.

Across the State, various feral species are creating havoc on agriculture as well as the ecosystems in which they exist. They continue to destroy crops and pasture lands by devouring any vegetation as they continue to spread.

The feral chicken and rooster populations in Hawai<sup>°</sup>i have skyrocketed and have become an ever-increasing problem. Aside from roosters crowing in the hours before dawn, the feral chickens damage crops, spread weeds, threaten native plants, and are a road hazard. The noise, health issues, and environmental damage from feral chickens have become major concerns and must be controlled.

These feral populations can pose a danger, especially as populations grow and their health is jeopardized due to inadequate food. Diseases they normally tolerate will become serious debilitating illnesses that could jeopardize our domestic livestock and poultry industries. Such fears are not unreasonable, as incidences such as bovine tuberculosis spread from feral pigs have been documented in Molokai.

Hawai'i's farmers and ranchers are working to provide Hawai'i with an increased level of self-sufficiency but will not be able to do so if their products are consumed or damaged by feral animals. Feral chickens and roosters can cause major damage to property, agriculture (crops and livestock), Hawai'i's native species and ecosystems, and Hawai'i's

cultural and historic resources. They can also threaten the health of people, wildlife, pets, and other domestic animals. As Hawai'i's feral animal populations continue to expand, these damages, costs, and risks will only keep rising. The State and Counties need to develop a long-term management plan that includes a feeding of feral animals education program to address this ever-growing problem.

Thank you for this opportunity to testify on this important subject.

Comments:

I strongly support this bill SB2401 SD2HD1. Feral Chickens/Roosters are a huge nuisance on all islands, but on Oahu especially in Ewa, but can be found right in town. They crow at all times, noisy if chased away, and multiply by the dozens with some nest holding a dozen eggs. Their nests are found everywhere behind front doors, alongside trees and they damage the lawns of any open grass spaces. On Kauai, illegal cock fighting roosters cages were destroyed and released into communities during the hurricanes and found hens that have also been released. Retaliation by some are feared in our own communities.

This bill should also be extended to feral cats. People continually feed these cats several times a day, where they're skill at hunting is lost, which could have been useful in decreasing the rat and bird populations. They spread diseases and flees to other animals that pass by, especially dogs on leashes that are taken care of by their owners. Their feces, even in litter boxes need to be carefully disposed of and could be the cause of the deaths of many sea animals close to shore. Cats are being neutered or spayed and brought back to their original spaces and certain groups defy the laws of the state or the neighborhood will intentionally and continually feed them because of the lack of laws and probably the lack of staff of the Hawaii Humane Society. The push for animal rights is stronger than the push for people's rights! Even experimental animals at the University of Hawaii was stopped in the 1970s due to supposedly well intentioned organizations. So who do they need to test on???

Please support SB2401.SD2.HD1.
