# SENATE BILL NO. 2414 RELATING TO SUSTAINABLE FOOD SYSTEMS

Chair Gabbard, Vice Chair Richards and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill 2414. This bill establishes an 11-member Sustainable Food Systems Working Group (Working Group) that is to develop an Interagency Food Systems Plan (Plan) that is linked to goals established by the United Nations. The Plan will address seven broad areas and once implemented, will result in a more sustainable, resilient local food economy that enhances and sustains the environmental, economic, and social health of the community.

The Working Group is administratively attached to the Department of Agriculture (HDOA). This measure establishes an unspecified number of sustainability specialist positions with HDOA and appropriates funds for the same. There is an additional appropriation to HDOA to support the establishment and operation of the Working Group and includes potential purchase of services for a fee. The Plan and its recommendations for the implementation of the Plan are to be submitted to the 2025 Legislature. The Department supports and offers comments for amendments to this measure.



The Working Group is to be co-chaired by the HDOA Chair and the Director of the Department of Business, Economic Development, and Tourism, and a single representative from each house of the State Legislature as selected by the Speaker of the House and the President of the Senate, respectively. The selection of a single person with knowledge from each of the seven broad areas are to be made by the two legislative representatives (Page 2, lines 15-20).

HDOA recommends including a requirement to have agricultural operators represented in the 11-member Working Group and requests legislative guidance in defining and describing how farmers, ranchers and producers will be at the heart of the Plan to achieve a more sustainable food system. The Department appreciates that the discussions will add content to the Hawaii Farm Bill currently in development.

- 1. Food as a human right and health food for all;
- 2. Social equity and food justice;
- 3. Food system resilience;
- 4. Agriculture and food system sustainability;
- 5. Food at the center of a circular economy;
- 6. Sustainable education, workforce development, and fair labor; and
- 7. Good food governance

The HDOA is cautiously optimistic that the effort of the Working Group will result in a measurable, science-based, and functional Plan that will promote the State's highest priorities of increasing the economic viability of existing agricultural operations and assist in the establishment of new ones in direct support of increasing local food self-sufficiency and exports.

The HDOA suggests that a requirement for the sustainability specialist positions in the HDOA to assist in the development of the Plan be well-versed in Hawaii agriculture at the farm and ranch level and be specialists in sustainability.

Aloha Chair and Members of the Committee,

I am writing to express my strong support for the bill that establishes the Sustainable Food Systems Working Group within the Department of Agriculture. This bill will help Hawaii achieve a more robust, sustainable, equitable and resilient food system that benefits the health, economy and environment of our state.

I believe that this bill is timely and necessary to address the challenges and opportunities that our food system faces in the context of climate change, global competition, food insecurity and public health. <u>Hawaii imports about 85% of its food, making it vulnerable to disruptions in supply chains, price fluctuations and natural disasters1</u>. At the same time, Hawaii has abundant natural resources, cultural diversity and innovative potential to produce more of its own food, support local farmers and food businesses, and enhance food access and affordability for all residents2.

The Sustainable Food Systems Working Group will bring together key stakeholders from various sectors, including agriculture, business, education, health, environment and community, to develop a comprehensive and integrated food policy framework and a food system resilience and equity strategy for Hawaii3. These documents will provide a vision, goals, objectives, indicators and actions to guide the state's efforts to transform its food system in alignment with the United Nations Sustainable Development Goals and the Aloha+ Challenge4. I understand and give credits to the lunch workers for making lunch to feed about 2,600 students, but using imported foods from the mainland is not supporting the local farmers in Hawaii. Its saddening to know that schools are buying GMO cornseed from Monsanto that were sued because they were spraying a cancer causing pesticide on their plants. The government buys cornseed from a company that spreads CANCER CAUSING PESTICIDES on their plants. Let that sink in. Its cheaper to ship it from the mainland because of the land resources they have, but we are an island, we have such limited resources. If we go on lockdown for shipping, we only have food to last us about 3-10 days; by purchasing products from local farmers, it is more sustainable and we would have access to fresher foods. By buying from local farmers, produce would be more fresh and provide more nutrients to students. As someone who doesn't eat the school lunch because the portions are too small, and it just isn't appetizing to me, I would eat the lunch if the school and government provided more local foods for me to eat.
