DEPARTMENT'S POSITION: The Department of Human Services (DHS) supports the measure and defers to the Department of Agriculture. DHS respectfully requests that any appropriation not reduce or replace priorities identified in the executive budget.

PURPOSE: This bill appropriates funds to the Department of Agriculture for the continued administration of the Hawaii Healthy Food Incentive Program and to provide matching funds to beneficiaries who participate in the Supplemental Nutrition Assistance Program. Declares that the general fund expenditure ceiling is exceeded.

The Hawaii healthy food incentive dollar-for-dollar matching program helps SNAP participants double their purchasing power. Especially during this time of elevated food costs, continuing the program doubles the value of SNAP participants' benefits spent on Hawaiigrown fresh fruits and vegetables. This program also supports local farmers and keeps food dollars in the local economy.

9 The DOH strongly supports the public health justification for Hawaii's DA BUX Double

10 Up Food Bucks Program (DA BUX) as one component of a comprehensive approach to improve

- 11 the availability and accessibility of healthy foods to improve health outcomes for our
- communities, especially for people who face greater health and income disparities. The DA

BUX, allows a dollar-for-dollar match on locally produced fresh fruits and vegetables for SNAP

14 recipients.

Major health authorities including the U.S. Department of Agriculture, Centers for
Disease Control and Prevention, and the World Health Organization recommend increasing fruit
and vegetable intake as a means to prevent chronic disease and improve overall health.^{1,2,3}
However, access to fresh produce for income-limited individuals can be difficult and contributes
to poorer diets and higher rates of chronic disease than middle class and wealthy individuals with
more options where they live, learn, work, play and gather.^{4,5}

Hawaii has the highest cost of living in the nation with food costs that are twice the 7 national average.⁶ In Hawaii, less than one in five adults reported eating five or more servings of 8 9 fruits and vegetable a day (2021 Behavioral Risk Factors Surveillance System). Data continues 10 to show a decline in meeting these dietary recommendations for an eating routine with a healthy plate of whole fruits, a variety of vegetables, whole grains, and lean proteins and dairy. Between 11 12 2019 and 2021, the percentage of adults who ate five or more servings of fruit and vegetables a 13 day decreased from 17 to 14 percent while the percentage of adults who ate one serving or no servings increased from 7 to 8 percent.⁷ 14

Nutrition incentive programs similar to the DA BUX are prevalent around the U.S. and
recognized as a "win-win-win" for farmers, families, and local businesses. Data from these
interventions have shown improvements in dietary behaviors, reduction in household hunger and
food insecurity, and increased sales of local produce by more than their dollar value alone. ^{8,9,10,11}

The DOH urges the passage of S.B. 2421 which will allow for continued funding and the
possible expansion of this extremely important program that provides much needed support to
Hawaii's families, local farmers, and the economy.

The Office of Economic Revitalization (OER) **strongly supports** SB2421 to fund Hawai'i's Double Up Food Bucks program (DA BUX), which makes locally-grown produce affordable for Hawai'i's low income consumers.

The federal food stamp program–better known as SNAP–is essential to battling the hunger crisis in low-income Hawai'i households. The data used by the USDA to justify a family's monthly SNAP allotment does not accurately measure the cost of food in Hawai'i. Hawai'i families run out of money by the end of the month when purchasing groceries, making fresh, locally grown fruits and vegetables unaffordable. This results in most of these SNAP funds being spent on cheap, imported food. To stimulate the local economy, Hawai'i's DA BUX program can keep these federal funds right here by doubling the amount available for families receiving SNAP to purchase fresh, local produce.

DA BUX offers a 100% return on a very modest investment. The \$2 million proposed in this bill would be matched with another \$2 million in federal dollars, which will allow the program to expand to more retailers and communities across the islands. This matched investment will put more local foods into the hands of our community, and more money into the hands of our local farmers and businesses.

This program is a win for local families, local farmers, and our local economy. Thank you for the opportunity to provide testimony on SB2421.

The Hawai'i Hunger Action Network, a coalition of more than twenty local organizations with the mission to advocate for food security for Hawai'i households, appreciates the opportunity to testify in **STRONG SUPPORT OF SB 2421.** This bill would provide matching funds to support the successful Hawai'i Healthy Food Incentive Program (better known as DA BUX), which provides a 50% discount on locally-grown fruits and vegetables for Hawai'i customers who use the supplemental nutrition assistance program (SNAP).

SNAP is an economic lifeline for low-income Hawai'i residents, providing around \$60 million per month in federal dollars to purchase groceries to nearly 100,000 Hawai'i families. While this is a vital asset for Hawai'i's economy, the individual monthly allotment is often still not enough to afford fresh, locally grown fruits and vegetables, which can be more expensive than imported or packaged foods. This results in most of these dollars leaving the islands—right into the pockets of major mainland food companies, rather than getting recirculated locally into our local agriculture industry.

DA BUX is an elegant and cost-effective solution. By offering a 50% discount on locally-grown produce to SNAP shoppers, the program channels more of these federal stimulus monies to our local farms and food businesses. In fact, to date, DA BUX has directly supported over 530 local farms. Local food hubs have reported a 186% increase in local produce sales to SNAP shoppers. And the program is projected to directly result in nearly \$5 million annually (2023) in local produce sales.

DA BUX has been thus far funded almost entirely by a federal (USDA) grant program known as GusNIP, matched with philanthropic donations and in-kind support from local nonprofit organizations. While this has worked for several years, the program is in grave danger of losing its federal match unless we can prove dedicated annual match funding. This legislation would provide not just funding, but also assurance to the USDA that Hawai'i is committed to seeing this program succeed well into the future. The \$2 million proposed in this bill would be matched with another \$2 million in federal dollars, and this will allow the program to expand to even more retailers and communities across the islands.

Thank you for the opportunity to testify. DA BUX is a rare opportunity that benefits everyone: families, farmers, and the business community. We appreciate your consideration and encourage you to pass SB 2421.

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports SB 2421, which appropriates funds to DOA for the continued administration of the Hawai'i healthy food incentive program and to provide matching funds to beneficiaries who participate in the supplemental nutrition assistance program.

SNAP offers nutrition assistance to eligible, low-income individuals and families, increasing their food purchasing power and improving their nutrition. SNAP also provides economic benefits to farmers participating at farmers' markets, roadside stands, CSA programs, grocery stores, and other food retailers.

Some of HFB's farmers' markets participate or have participated in the SNAP program. We believe that access to locally grown fresh fruits, vegetables, and protein to low-income individuals and families provides benefits to both SNAP participants and Hawai'i farmers and ranchers.

The Double Up Food Bucks program works by doubling the value of federal Supplemental Nutrition Assistance Program (SNAP) benefits spent on locally grown fruits and vegetables at participating farmers' markets, grocery stores, food hubs, and community-supported agriculture projects. In Hawai'i, the Double Up Food Bucks program is managed by The Food Basket and is known as "DA BUX" Double Up Food Bucks. The DA BUX program presents a "win-win" scenario by supporting local farmers with an increased customer base and low-income families who receive double the purchasing power for healthy, Hawai'i-grown produce.

The Healthy Eating + Active Living (HEAL) Coalitionⁱ, a program of the Hawai'i Public Health Institute (HIPHI), is in **Strong Support of SB2421**, which provides funding to the Department of Agriculture for the Hawai'i Healthy Food Incentive Program.

DA BUX is a triple win for families, farmers, and the local economy.

The Hawai'i Healthy Food Incentive program, or DA BUX, provides a 50% discount on Hawai'i-grown produce for SNAP recipients. Incentivizing SNAP dollars for local fruits and vegetables stretches food dollars for families, especially with increasing food costs. Through this program, SNAP participants can bring home healthy, local food; local farmers gain new customers and increase income; and more money goes into and grows our local - a "triple win."

The demand for DA BUX has risen significantly over the last several years.

Year after year, this program has significantly grown its impact. Local food sales continue to increase: 2019 saw \$220,354 in sales; by December 2023, local food sales through DA BUX were projected to be \$4.7Mⁱⁱ. That money has brought healthy foods to homes while positively impacting our local economy.

DA BUX provides a strong return on investment.

SNAP is proven to stimulate the economy by being an economic multiplier. Every SNAP dollar spent generates an estimated \$1.54 in economic activityⁱⁱⁱ. These dollars ripple out throughout the supply chain, supporting farmers, retailers, and food distributor employees; these people, in turn, spend their dollars to help support economic activity further and so on. With \$2M from the state, the program becomes

eligible for an additional \$2M in federal matching funds from the Gus Schumacher Nutrition Incentive (GusNIP) Program. State funding helps to ensure sustainable funding for DA BUX.

A positive impact on health and food.

DA BUX's focus on locally grown produce helps to bring healthy foods to homes and supports the local agricultural industry. Studies have found that a lack of food security is associated with diet-related chronic diseases such as diabetes and high blood pressure^{iv}. Supporting local agriculture also aligns with the renewed calls to increase local food production and decrease Hawai'i's dependence on imported goods for a more sustainable and resilient food system.

A \$2 million investment can help expand the program to more stores.

The DA BUX program has seen significant growth. It started with KTA in Hawai'i County and is now accessible statewide through Times, KTA, Foodland, and participating farmers' markets. These stores are locally-based and operated, ensuring economic amplification.

The \$2M state investment will increase the program's reach and participation by engaging more people through educational campaigns in areas where there has been stalled growth, as well as provide the ability to engage more retail outlets that were unable to participate due to limited funding.

DA BUX is a triple win for farmers, families, and the local economy. This investment also supports health. We strongly support this measure and respectfully ask you to **pass SB2421**.

The Hawaii Food Industry Association is comprised of two hundred member companies representing retailers, suppliers, producers, manufacturers and distributors of food and beverage related products in the State of Hawaii.

Chairs, Vice Chairs, and Members of the Committee,

HFIA is in strong support of this measure. The Hawaii Healthy Food Incentive Program, also know as Double Up Food Bucks, or DA BUX, is a way combat food insecurity, support healthy eating, and support Hawaii's agricultural sector.

During the COVID-19 pandemic and economic crisis, food insecurity in our state soared to unprecedented levels, at the same time the local agricultural sector suffered disproportionate economic losses. The Double Up Food Bucks program has been a vital tool to increase the produce buying power of Hawaii consumers who use the Supplemental Nutrition Assistance Program (SNAP), and helps grow our local agricultural sector. Continuing to fund this important program will ensure that the many benefits continue.

Fruits, vegetables, and healthy proteins tend to be more expensive per calorie than less healthy foods, which makes eating healthy a challenge for those with limited food budgets. Doubling the purchasing power for SNAP users makes it easier to choose fruits, vegetables, and healthy proteins when shopping. Data has shown that families use the Double Up Food Bucks Program eat more fruits and vegetables, a greater variety of fruits and vegetables, and

fewer unhealthy foods. Getting more fruits and vegetables for each SNAP dollar also means that low-income families will have more in their budget to spend on things like housing and healthcare.

By prioritizing locally grown agricultural products this program also helps Hawaii farmers and encourages retailers to stock Hawaii grown produce and protein. This helps promote a resilient food economy where local farmers are selling to local stores that sell to local customers.

This Double Up Food Bucks program also brings vital funds into our state. The program is supported by GusNIP grants and other funding sources. By investing in this program the state is encouraging continued support and funding from other sources and pulling resources into Hawaii's food systems. Each dollar spent in this program goes into Hawaii's agricultural sector and circulates from there into the larger local economy. This is a win for SNAP users, a win for Hawaii farmers, a win for Hawaii retailers, and a win for Hawaii's economy.

Ulupono Initiative <u>strongly supports</u> SB 2421, Relating to Supplemental Nutrition Assistance Program Incentives.

Dear Chair Gabbard, Chair San Buenaventura, and Members of the Committees:

My name is Micah Munekata, and I am the Director of Government Affairs at Ulupono Initiative. We are a Hawai'i-focused impact investment firm that strives to improve the quality of life throughout the islands by helping our communities become more resilient and self-sufficient through locally produced food, renewable energy and clean transportation choices, and better management of freshwater resources.

Ulupono strongly supports SB 2421, which appropriates funds to the Department of Agriculture (DOA) for the continued administration of the Hawai'i Healthy Food Incentive Program and to provide matching funds to beneficiaries who participate in the Supplemental Nutrition Assistance Program (SNAP).

Ulupono strongly supports the Hawai'i Healthy Food Incentive Program within the DOA because of the program's transformative effects on community hunger and health, local agriculture, and overall economic vitality. At the heart of this program is the highly impactful "DA BUX" Double Up Food Bucks Program, ran statewide by The Food Basket and representing a triple-win solution for our communities. Through the program, SNAP-eligible participants are empowered to double their purchasing power toward healthy, locally grown fruits and vegetables, concurrently benefitting local farmers. Importantly, these dollars stay within our state, which benefits our local economy.

Furthermore, this program's leveraging of federal funding at a 1:1 match demonstrates a prudent approach to maximizing resources for optimal impact.

The impact is clear: Hawai'i residents have faced a 26% increase in food prices since January 2020. Through DA BUX, \$10 of SNAP benefits transforms into \$20 of Hawai'i-grown produce for individuals and families who most need it (Last year, 160,000 Hawai'i residents received SNAP assistance).

The impact is far reaching for local farmers: Since 2020, DA BUX purchases have benefitted more than 470 farm producers and eight distributors through farm product sales. This facilitates the expansion of markets for local ag producers.

The impact is growing: Local produce sales to SNAP shoppers at participating farm direct retailers increased an average of 531% from 2019 to 2021. These numbers substantiate the need to support our local community as food insecurity continues to increase.

Additionally, DA BUX directly supports the Maui community recovery from the August 2023 wildfires.

- Prior to the wildfires, Maui County experienced the largest increase in poverty in the state as the percentage of households in Maui County living below the federal poverty line rose from 6% in 2018 to 16% in 2022.¹ Approximately 11% of Maui County residents face food insecurity, resulting in \$17 million in annual costs to address food insecurity and hunger in the county, based on data from Feeding America.²
- As of August 2023, there were 14,540 SNAP participants or 7,921 SNAP households on Maui Island. DA BUX alleviates food insecurity by reducing hunger and improving the overall well-being of Maui families by doubling their purchase power for fresh locally produced fruits and vegetables at 13 DA BUX retail locations across Maui Island, including grocers, food hubs, and farmers markets.
- DA BUX also expands the customer base of Maui Island producers, many of whom struggled with market closures following the wildfires.³ There are currently 72 Maui farmers/producers that are supported by the program with increased sales and farm profits. Food sales driven by the program on Maui Island has increased from \$97,661 in 2020 to \$768,225 projected in 2023 (based on the latest data)—nearly a 700% increase.

We are hopeful the State will consider a \$2 million appropriation, per year, for the DOA program to support DA BUX. A \$2 million investment by the State would receive a direct match of \$2 million in federal funding. Furthermore, our analysis shows that, with that level of state funding in place, the potential economic impact created by DA BUX in Hawai'i reaches nearly \$13 million.

We appreciate the Legislature's attention to this highly impactful program and look forward to sustained funding to support our SNAP community and our local producers.



Opportunity to Expand a Proven, Highly Impactful Program

Historically, the DA BUX program has been primarily funded by federal grants and philanthropic/ private funding (representing almost all of total program funds). Since its inception, DA BUX has received \$13.7 MILLION in funding. The State funding of \$594,000 represents 4% of total funding to the program to date.

Secure and sustained State funding for DA BUX program is the key to federal and philanthropic funding matches. An appropriation of \$2 million in State funds can generate significant leverage:

- Stimulate economic activity of about \$13 million (6.4x State funding) while increasing local food production for local consumption.
- \$2 million in State funds can be matched by \$2 million in federal dollars from a Gus Schumacher Nutrition Incentive Program (GusNIP) arant, as well as \$4 million from SNAP purchases, resulting in \$8 million going toward local food purchases and supporting local farmers.
- Given the impact achieved and successful track record, State funding will be a worthwhile investment and position the DA BUX program for future federal funding.
- Other states have recognized the benefit and impact of Double Up Food Bucks programs by investing their state funds in expanding and sustaining their programs. There are 24 states that have invested state funds in their Double Up Food Bucks programs, totaling approximately \$158 million from 2015 through 2024.

HOW 'DA BUX' WORKS

The DA BUX Double Up Food Bucks program offers each Supplemental Nutrition Assistance Program (SNAP) participant a DA BUX Access Card or voucher to be used at point of sale to double their purchasing power when they buy locally grown fruits and vegetables — \$10 of SNAP benefits is worth \$20 of Hawai'i grown produce. Thus, each \$1 funded into the program provides \$2 worth of local food purchases.

THE CHALLENGE

In fall 2023, the program was denied federal funding primarily due to a lack of a sustained State funding. Based on the projected spend down rate, current funding of the DA BUX program will only last through August 2024. Hawai'i SNAP beneficiaries have been hit with both increasing food costs and decreasing SNAP benefits. This situation creates a significant need to help feed lowincome families AND support local agricultural food producers.

THE OPPORTUNITY

DA BUX is a triple-win solution because it doubles the purchasing power of low-income SNAP families for healthy, Hawai'i-grown produce; it supports local farmers with an increased customer base; and it benefits the entire island community by keeping dollars in the local economy. AN APPROPRIATION OF \$2 MILLION IN STATE FUNDS WILL BRING IN ADDITIONAL FEDERAL FUNDS TO SUSTAIN. EXPAND AND EXTEND THE STATEWIDE DA BUX DOUBLE UP FOOD BUCKS PROGRAM. Given the broad

benefits of DA BUX for our state, it is imperative to secure sustained funding for DA BUX and ensure it is a staple service providing economic relief to SNAP households and directly supporting local agricultural food producers across the islands.



RE: SENATE BILL NO. 2421 – RELATING TO SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM INCENTIVES.

Chair Gabbard, Chair San Buenaventura, and Members of the Committee:

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA <u>SUPPORTS</u> Senate Bill No. 2421, RELATING TO SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM INCENTIVES.

By way of background, the HPCA represents Hawaii's Federally Qualified Health Centers (FQHCs). FQHCs provide desperately needed medical services at the frontlines to over 150,000 patients each year who live in rural and underserved communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of healthcare.

This bill, as received by your Committee, would appropriate an unspecified amount of general funds for fiscal year 2024-2025, to be expended by the Department of Agriculture, for the continued administration of the Hawaii Healthy Food Incentive Program and to provide matching funds to beneficiaries who participate in the Supplemental Nutrition Assistance Program (SNAP).

SNAP, formally known as the "Food Stamps Program", is the largest federal food assistance program that is currently in operation. It provides food-purchasing assistance for low- and no-income people. SNAP provided assistance to approximately 40 million persons in 2018, at an expenditure of \$57.1 billion. Approximately 9.2% of American households received SNAP benefits at some point during 2017, with approximately 16.7 of all children living in households receiving SNAP benefits.

Founded during the height of the Great Depression, SNAP is the cornerstone of our national social safety net. It is intended to prevent mass starvation precipitated from unemployment and homelessness. The program was also seen as a way of helping the poor while boosting the economy and ensuring that America's farmers would obtain a fair price for their labors by allowing government to purchase and distribute excess goods in time of crisis.

The COVID-19 Pandemic demonstrated how food scarcity and poverty threatened the health and welfare of our citizens in times of dire crisis. With so many people unemployed, entire families struggled to put food on the table on a consistent basis. Lines at the food bank and food drives stretched for miles and people waited for hours to receive surplus food.

The HPCA has strongly endorsed this Program in previous years and we continue to urge your support. Additional SNAP benefits for a recipient can mean the difference between having to decide whether someone's last amount of cash will go for food or rent or medications or other necessities.

Aloha Chairs Gabbard and San Buenaventura and Members of the Committees:

My name is Keali'i Lopez, and I am the State Director for AARP Hawai'i. AARP is a nonpartisan, social mission organization that advocates for individuals age 50 and older. We have a membership of nearly 38 million nationwide and nearly 140,000 in Hawaii. We advocate at the state and federal level for the issues that matter most to older adults and their families. AARP strongly supports S.B. 2421 which appropriates funds to the Dept .of Agriculture for the continued administration of the Hawaii Healthy Food Incentive program and to provide matching funds to beneficiaries who participate in the Supplemental Nutrition Assistance Program (SNAP).

Older workers and retirees living on a fixed income already know all too well that inflation and rising food prices are stretching household budgets in ways that make it harder to put food on the table. Some of them may face life challenges as they age—such as experiencing a medical crisis, job loss, or death of a spouse or other loved one—that may result in financial instability and make it difficult to afford food. For example, newly widowed older adults experience higher poverty rates, greater housing cost burdens, and challenges to getting the help they need.

Supplemental Nutrition Assistance Program (SNAP) benefits are a crucial ingredient in the food budgets for many Hawaii residents especially kūpuna. Food assistance for low-income older adults is essential; food insecurity has significant negative impacts on older adults, particularly on their health. Older adults who are food insecure are more likely than their food-secure counterparts to have limitations on activities of daily living, have conditions like diabetes and depression, and experience heart attacks. Research shows that SNAP enrollment among older adults is associated with fewer hospital and emergency room visits and long-term care admissions. Enrolling in SNAP can also lead to increased well-being, especially among older adults. As inflation continues driving up the costs of groceries and other necessities, programs like SNAP that help eligible older adults are especially important. SNAP benefits increase food security and reduce monthly food costs. Further funding the Hawaii Healthy Food Incentive Program and SNAP benefits can help ensure low-income kūpuna have the resources they need. We encourage you to support the appropriation of funds for the continued administration of the Hawai'i healthy food incentive program, otherwise known as DA BUX. This program benefits Hawai'i's food system in three vital ways:

- 1. Offers discounts on Hawai'i grown fruits and vegetables to low-income SNAP recipients, allowing them to purchase more healthy food.
- 2. Empowers farmers compete with lower cost imported produce and increase their sales.
- 3. Supports the local economy, generating increased revenue for participating retailers.

Farm Link's mission is to transform local food production into a thriving industry and make good local food accessible to everyone on O'ahu. We work with over 200 Hawai'i farmers, ranchers, and food makers, to serve more than 1,300 customers per month with direct home delivery of over 500 local products. To ensure equitable access, we automatically apply the DA BUX 50% discount on produce and poi for customers using SNAP and provide free delivery for their orders. In 2024 18% of our revenue was derived from customers using Supplemental Nutrition Assistance Program (SNAP-EBT) and DA BUX to purchase their groceries. Farm Link's SNAP revenue grew by over 583% between 2021 and 2023. DA BUX is clearly motivating and empowering families to purchase and consume more healthy produce, while providing a steady market for Hawai'i farmers.

State investment is critical to the long-term sustainability of DA BUX and its ability to provide positive, lasting economic and well-being impact. A \$2 million State investment will unlock a matching \$2 million in federal grant dollars from the USDA Gus Schumacher Nutrition Incentive Program (GusNIP). As the GusNIP only accepts proposals that secure 100% non-federal matching funds, a State investment is critical to the program's FY '24 GusNIP application.

On behalf of Hawai'i Foodbank, **I support SB 2421**, the healthy food incentive program and to provide matching funds to beneficiaries who participate in the supplemental nutrition assistance program.

Food security is a critical issue in Hawai'i, where one in six residents lacks comprehensive access to healthy, nutritious food. SNAP is one of our most important anti-hunger programs, offering choice and healthy options for families who need extra support putting food on the table. We strongly support DA BUX, which doubles the purchasing power of SNAP when it is used for locally produced food.

• **DA BUX increases consumer purchasing power.** Locally grown produce is often more expensive than imported items. DA BUX stretches dollars farther and makes it possible for more people to choose local.

• **DA BUX advances nutrition, health and well-being.** Healthy food can also be more expensive, and we consistently hear requests for more produce and healthy proteins from our distribution partners and the people we serve. DA BUX makes these desired, healthier food items more affordable.

• **DA BUX invests in farmers and statewide food security.** With an estimated 85%-90% of our food imported, programs that support Hawai'i farmers are important to us all. Hawai'i Foodbank regularly purchases from local farmers, and programs that invest in local production capacity help us better support those we serve.

Hawai'i Foodbank is Hawai'i's largest hunger relief organization, fiercely dedicated to our mission of nourishing our 'ohana today while working to end hunger tomorrow. We work with a network of 200 partner agencies across O'ahu and Kaua'i to provide food assistance to an average of more than 150,000 people each month. Last year, we distributed food for more than 16.2 million meals across the islands we directly serve, including 5 million pounds of fresh produce. Together with the Maui Food Bank, serving Maui County, and The Food Basket, serving Hawai'i Island, our network of food banks and partner agencies provide food assistance to all those facing hunger across the State.

My name is Lucas McKinnon, and I am the Managing Director of the Hawai'i Good Food Alliance (HGFA). The other founding organizations are listed below. HGFA is a 501(c)(3) corporation formed by a statewide collaboration of organizations that are engaged in the production and distribution of food with the goal of rebuilding thriving community food systems. HGFA is a cross-sector network of food producers, food hubs, food banks, farmers markets, and healthcare providers from each major Hawaiian island. Our mission is that we join together—with a sense of urgency—to raise community voice and support one another in the belief that each and every person in Hawai'i can share in healthy, locally produced food.

DA BUX benefits the state's food system through three different ways. First, DA BUX offers a 50% discount on Hawai'i grown fruits and vegetables to low-income recipients of the SNAP program (formerly known as food stamps), allowing them to purchase more, healthy food. Second, DA BUX helps farmers increase their customer base and compete with imported produce. And third, DA BUX supports the local economy, generating increased revenue for the participating food retailers across 100+ statewide locations. Several of our member organizations offer DA BUX through their retail operations, allowing them to offer affordable local produce to all of their SNAP customers.

A \$2 million State investment will serve as significant match funds needed to unlock federal grant dollars from the USDA Gus Schumacher Nutrition Incentive Program (GusNIP). As the GusNIP only accepts proposals that secure 100% non-federal matching funds, a State investment will strengthen the program's FY '24 GusNIP application. In addition, this bill declares that the general fund expenditure ceiling is exceeded, and makes locally-grown produce affordable to Hawaii's low-income residents.

Food insecurity has doubled since the pandemic, making 1 in every 6 individuals in our state food insecure. This not only impacts those in poverty, but our ALICE households as well. Recent data shows that <u>44% of our community</u> is living below the ALICE threshold. **ALICE stands for Asset Limited, Income Constrained, Employed**, and refers to households who are employed but whose incomes are not sufficient to meet their basic costs.

Aloha United Way's 211 Information & Referral call center has been the primary entity conducting SNAP prescreening in our community since FY2018. Food as a category remains the second highest requested need from 211 callers after affordable housing. Access to healthful food that is also affordable is a rare commodity for SNAP beneficiaries. This measure not only benefits the SNAP consumers, but also serves to support our local farmers.

Thank you for the opportunity to testify and for your action to support Hawaii's households with this measure. We urge you to pass SB2421.

Chair Gabbard, Chair San Buenaventura, and committee members, thank you for this opportunity to provide testimony on SB 2421, which appropriates funds to the Department of Agriculture for the continued administration of the Hawai'i Healthy Food Incentive Program and to provide matching funds to beneficiaries who participate in the Supplemental Nutrition Assistance Program.

Kaiser Permanente Hawai'i SUPPORTS SB 2421.

Kaiser Permanente is one of the nation's largest not-for-profit health plans, serving 12.6 million members nationwide, and more than 274,000 members in Hawai'i. In Hawai'i, more than 4,200 dedicated employees and more than 650 Hawai'i Permanente Medical Group physicians and advanced practice providers work in our integrated health system to provide our members with coordinated care and coverage. Kaiser Permanente Hawai'i has more than 19 medical facilities, including our award-winning Moanalua Medical Center. We continue to provide high-quality coordinated care for our members and deliver on our commitment to improve the health of our members and the 1.4 million people living in the communities we serve.

Kaiser Permanente supports policies that ensure all Hawaii residents have access to affordable, high-quality health care. Further, Kaiser Permanente supports "whole-person care," including the provision of access to services and resources that address beneficiaries' physical health, mental health, and social needs.

Kaiser Permanente prioritizes food security as an area of community health focus, meaning that all people, in all communities, have access to sufficient, affordable, and nutritious food that meets



their food preferences and dietary needs for an active and healthy lifestyle. However, we know that food insecurity has increased due to the effects of inflation and the COVID-19 pandemic. As a result, Kaiser Permanente provides grants to Hawai'i food banks administering The Emergency Food Assistance Program's (TEFAP) Farm to Food Bank Program, which serves a critical role for many families facing food insecurities.

The grant funds served a twofold purpose through the food purchasing program. First, the funds are used as a match to draw down Federal funds, which require a 1:1 match. Additionally, Kaiser Permanente's grant funds support farm-direct bags of fresh produce for low-income seniors receiving a monthly supplemental food box through the Commodity Supplemental Food Program (CSFP), a USDA program that Hawai'i Foodbank runs in partnership with the Office of Community Services.

To ensure communities have reliable access to healthy food, Kaiser Permanente supports policies that minimize barriers to and maximize enrollment in federal nutrition assistance programs, such as SNAP, and support for federal nutrition standards for school meals, including meals with more fruits, vegetables, and whole grains, and less sodium and trans fats.

Our work is guided by our belief that access to nutritious food plays a critical role in supporting community health. Kaiser Permanente has also piloted interventions using medically tailored meals and launched a prescription produce program to help patients access fresh produce. By studying the effectiveness of these programs, Kaiser Permanente is building an evidence base for future policy interventions that reduce health care costs and improve patient outcomes.

We support SB 2421 because it will continue to fund the continued administration of the muchneeded Hawaii healthy food incentive program which helps to continue to meet the food security needs of the people of Hawai'i.

JULIA ZEE We are in strong support of SB2421 and the appropriation of funds for the continued **SECRETARY** administration of the Hawai'i Healthy Food Incentive Program, otherwise known as DA BUX Double Up Food Bucks, or DA BUX.

In keeping with The Food Basket's (TFB) overarching mission to "end hunger", we are the WARREN LEE statewide administrator for DA BUX. TFB established DA BUX as a statewide program in partnership with the Hawai`i Good Food Alliance upon receiving a \$985K federal grant SAMANTHA through the USDA Gus Schumacher Nutrition Incentive Program (GusNIP) in 2019. Additionally, we secured the 100% non-federal matching funds that GusNIP requires. We scaled the program in 2021 after receiving two additional GusNIP awards totaling \$7.6M in federal dollars. Today, TFB administers DA BUX at 59 food retailers across 100+ locations statewide, including grocery stores, farmers markets and food hubs, providing support to more than 530 farms. DA BUX partner retailers continue to offer 50% discounts on Hawai'i grown fruits and vegetables solely to low-income customers paying with SNAP food dollars (formerly known as food stamps).

Philanthropy has largely carried the weight of our GusNIP match needs over the years; however, we cannot expect philanthropy to meet this need over the long term. We are

humbly requesting the State to invest \$2M per year in DA BUX to support program sustainability and continuous affordable healthy food access to SNAP recipients. Furthermore, a State commitment will be leveraged in our FY '24 GusNIP application to unlock \$2M in federal funds to meet the grant's requirement of a 100% non-federal match.

While a wide range of financial support and programs were available during the pandemic, Hawai'i's low-income residents are perhaps now more in dire need of this support as pandemic relief wanes and inflation rates have soared above historical averages. Sustained high participation in SNAP above pre-pandemic levels and climbing food insecurity in Hawai'i are indicative of the widespread economic hardship residents continue to face. The Food Basket remains steadfast in our commitment to ensuring DA BUX savings for local fruits and vegetables will be continuously available for these households.

We respectfully ask your committee to pass this bill.

Balanced Hawaii Eats, LLC, is creating recipes for people to follow that will help Hawaii families and those who have Hawaii ties eat healthier and promote greater mindfulness about what they eat and how food impacts their bodies.

In addition to the position of the legislature in general as stated in Section 1 of the bill, here are other factors that confirm why this bill should pass and continue through the legislative process:

- Eating more fruits and vegetables that are minimally processed indirectly helps to address the long-term issue of medical professional shortages in the islands. Bills were passed in 2022 to assist with medical education training (Act 262) and loan repayment for health care professionals (Act 263). Family and friends must often wait weeks to obtain appointments with their primary care physician that is likely due to this shortage. Healthy diets for Hawaii residents can help with preventing and/or controlling chronic diseases which require regular medical provider monitoring and can help to free-up medical resources over time.
- Easier access to fresh fruits and vegetables will mean fewer sick days for working adults, less sick days for their children, and faster recovery days if they are sick. The economy hurts even more if in this current state of employee shortages across most industries people are not able to work because they are ill or taking care of ill dependents as we witnessed during the COVID-19 pandemic.
- People who want to eat more fresh fruits and vegetables when within their budget are hard working and disciplined: they are willing to wash, cut, and prepare these items over convenience foods for their overall health despite their many responsibilities. They are the same type of people that are responsible and will work hard to make ends meet, do what they can to improve their financial situation, and will not purposefully stay within a lower income bracket just to continue to receive SNAP or other government benefits.
- Families that want access to fresh fruits and vegetables and locally produced meats also want to teach their keiki about the long-term benefits of healthy eating and the benefit to the local economy. It takes years to develop this foundation of thinking in our youth. Those who are not financially able to obtain this type of food have an uphill challenge to teach this

to their children. They are not able to model this type of eating at home when housing or other household expenses take priority over healthy food.

• Lastly, kupuna who are struggling to make ends meet may not feel compelled to prioritize healthy eating and focus on medication. The funds intended for the Hawaii healthy food incentive program through SB 2421 will provide not only financial assistance but help to minimize stress and more serious mental health crises to our seniors who may be less familiar with and/or less willing to seek out mental health services.

Any financial stress to the State of Hawaii's budget can be negated by the overall widespread benefit of sending funding to the Hawaii healthy food incentive program and approving SB 2421.

POSITION: SUPPORT

The Democratic Party of Hawai'i **<u>supports</u>** SB 2421, relating to supplemental nutrition assistance program incentives. Pursuant to the "Economic Justice and Labor" section of the official Democratic Party of Hawai'i platform, the party "supports government investments of tax revenue in community development, government anti-poverty programs, and the transition to a sustainable, green economy."

Through the national Double Up Food Bucks Program, Hawai'i has the opportunity to expand access to healthy foods for low-income residents who are eligible for supplemental nutrition assistance program benefits. Currently implemented in more than 25 states, the Double Up Food Bucks Program provides matching federal grant moneys to state programs that incentivize the use of supplemental nutrition assistance program benefits for the purchase of fresh produce.

Act 153, Session Laws of Hawaii 2019, created the Hawai'i healthy food incentive program, now commonly known as the DA BUX double up food bucks program. The DA BUX double up food bucks program began first

with a pilot program in 2012 by Kokua Kalihi Valley Comprehensive Family Services on the island of O'ahu and The Kohala Center on the island of Hawai'i. The program provides a dollar-for-dollar match to supplemental nutrition assistance program beneficiaries who purchase locally grown fruits, vegetables, and proteins at participating farmers' markets, grocery stores, and community-supported agriculture projects.

By the end of 2021, the pilot program was available at 57 food retailers across 98 market sites and pick-up locations, including grocery stores, farmers' markets, and community-supported agriculture programs. From 2020 to 2021, DA BUX supported 470 farm producers and eight distributors. Each dollar reimbursed to participating DA BUX food retailers for their issued discounts on local produce has an economic multiplier of 2.1, meaning that each program dollar issued for local produce incentives contributes \$2.10 to Hawaii's economy. Thus, a \$3,000,000 investment by the state in this program would allow for a federal funding match that will contribute at least \$12,600,000 to the local economy annually.

On behalf of Hawai'i Children's Action Network Speaks!, I am writing in **SUPPORT of SB 2421**. This bill appropriates funds to the Department of Agriculture for the continued administration of the Hawai'i Healthy Food Incentive Program ("DA BUX") and to provide matching funds to beneficiaries who participate in the Supplemental Nutrition Assistance Program (SNAP).

Investing DA BUX is investing in our keiki, as nearly two-thirds of SNAP (formerly known as food stamps) participants in Hawai'i are in families with children.¹ Especially with highest cost of living and the second-most expensive groceries in the nation,² it is nearly impossible for the low-income families in Hawai'i who qualify for SNAP to afford to buy healthy food, such as fresh fruits and vegetables.

That's where DA BUX comes in. It is designed to help low-income families afford fresh produce, by doubling the value of their SNAP benefits when they purchase Hawai'i grown fruits and vegetables.

DA BUX truly is a triple-win for our state. First, it **helps families** afford fresh produce, which benefits their health and well-being.³ Second, it **helps local farmers** by increasing their sales. And third, it **helps our local food stores and markets** by bringing more dollars to them and keeping those dollars in the local economy.

SNAP shoppers' local produce purchases at DA BUX grocery stores nearly tripled in January 2022 compared to 2019, and at DA BUX farm direct retailers those sales were more than five times larger.⁴ In addition, every \$1 spent on DA BUX is estimated to create \$2.30 in local economic activity.⁵

Thank you for the opportunity to submit testimony in support of **S.B. 2421** which would appropriate funds to the Department of Agriculture for the continued administration of the Hawai'i Healthy Food Incentive Program and to provide matching funds to beneficiaries who participate in the Supplemental Nutrition Assistance Program (SNAP).

Hawai'i Appleseed is committed to a more socially and economically just Hawai'i, where everyone has genuine opportunities to achieve economic security and fulfill their potential. The strengthening of SNAP through incentive programs is a critical evidence-based approach to achieving this vision. Serving more than 130,000 residents and generating \$630 million annually in our state's local economy, SNAP is an economic lifeline for Hawai'i's struggling households.

2023 brought several devastating cuts to SNAP benefits in Hawai'i.

- 1) The end of the SNAP emergency allotments left SNAP participants facing the largest SNAP benefit cliff in history. The average household lost \$82 in monthly benefits and some of our most vulnerable households like those with kupuna lost up to \$238.¹
- 2) The USDA updated its estimates of how much it costs the average family to buy food in each U.S. state and territory. This data is used to set the maximum amount of SNAP EBT benefits a household can receive for groceries each month. While every other state in the nation saw an increase in their monthly SNAP benefits, Hawai'i received a 20 percent drop in its adjustment (spread over the next five years) because of gaps in Hawai'i-specific food price data available to the USDA. While local advocates and the federal delegation are working hard to inform the federal government on how to remedy this issue, the benefits cut will stay in place until federal regulations are able to be changed.

Already food insecure households are seeing hundreds of dollars less in benefits while Hawai'i residents continue to experience the highest cost of groceries in the nation.

SNAP incentives like those proposed in S.B. 2421 help increase SNAP participants' purchasing power by providing an additional subsidy for SNAP users when they purchase local fruits and vegetables. The federal program that funds this incentive requires a one-to-one match, meaning that every dollar the state invests will be matched by federal funding. Therefore, a \$2 million investment by the state would be doubled with matching federal funds. Factoring in the \$2.10 multiplier would ultimately result in more than \$8M in local economic impact.² Passing this bill would be an impact investment for the State, channeling much-needed capital into local businesses and farms.

Hawai'i's existing SNAP incentive program, known as <u>DA BUX</u>, has already been enormously successful and popular among SNAP users, retailers, and farmers alike. According to the latest program outcomes report, DA BUX has already directly supported 470 farm producers, eight distributors, and increased local produce sales by 531% at farm-direct retailers.

We are writing to voice our strong support of SB 2421 and the appropriation of funds for the continued administration of the Hawai'i Healthy Food Incentive Program, otherwise known as DA BUX Double Up Food Bucks, or DA BUX.

KKV has learned from the community how important access to fresh, local, healthy, and cultural foods are important to the diets of native, pacific islander and low-income community residents. For the past decade, we have been working to increase access to these foods which support local farmers, ranchers and producers, while improving nutrition and health. Unfortunately, funding to promote improved access is sporadic and there is a great need for programs like DA BUX to be consistently funded so that community-based organizations can support the improvements we need in our local food system

DA BUX benefits the state's food system through three different ways. First, DA BUX offers a 50% discount on Hawai'i grown fruits and vegetables to low-income recipients of the SNAP program (formerly known as food stamps), allowing them to purchase more, healthy food. Second, DA BUX helps farmers increase their customer base and compete with imported produce. And third, DA BUX supports the local economy, generating increased revenue for the participating food retailers across 100+ statewide locations. Several of our member organizations offer DA BUX through their retail operations, allowing them to offer affordable local produce to all of their SNAP customers.

A \$2 million State investment will serve as significant match funds needed to unlock federal grant dollars from the USDA Gus Schumacher Nutrition Incentive Program (GusNIP). As the GusNIP only accepts proposals that secure 100% non-federal matching funds, a State investment will strengthen the program's FY '24 GusNIP application. State investment is critical to the long-term sustainability of DA BUX and its ability to provide positive, lasting impact both for the economy and the well-being of individuals across the state.

We operate a 35-acre certified organic banana farm on Oahu that primarily sells wholesale. Most other banana farms in the state have gone out of business, largely due to the price that most retailers would pay being too low to operate a banana farm.

DA BUX has been a vital part of our farm's continued survival as many of the retailers we sell to (including Farm Link) offer DA BUX to their SNAP customers and therefore can pay us a fair price per pound. We would have sold approximately 30% less volume and gotten 40% less per pound if DA BUX was not around.

Comments:

I am in strong support of senate bill 2421 that appropriates funds to the State Department of Agriculture (DOA) for the implementation of Act 153, SLH 2019. This law authorizes DOA as the administering agency of the Hawai'i Healthy Food Incentive Program (HHFIP), otherwise known as DA BUX Double Up Food Bucks, or DA BUX. DA BUX benefits many aspects of the state's food system. By offering a 50% discount on Hawai'i grown fruits and vegetables for low-income SNAP-EBT

shoppers, DA BUX helps farmers increase their customer base and compete with imported produce, while also supporting the local economy, generating increased revenue for 59 participating food retailers across 100+ statewide locations. Additionally, DA BUX is stretching the food budgets of low-income households and increasing their consumption of Hawai'i grown fruits and vegetables. DA BUX is also providing critical support for Maui's economic recovery from the Maui wildfires. DA BUX has already proven it can increase sales and profits for Maui County farmers. Three Maui County food hubs report an average 114% increase in local produce sales to SNAP shoppers over the past two years. Statewide, a \$2 million State

investment has the potential to generate \$12.8 million in economic activity.

Furthermore, a \$2M per year recurring State investment will ensure the survival of the DA BUX program, which is currently set to expire on August 31, 2024. State funding will be leveraged to request matching federal funds from the USDA Gus Schumacher Nutrition Incentive Program (GusNIP) in the 2024 funding cycle. State funding has the potential to unlock these federal GusNIP dollars, as the GusNIP requires funding requests to include documentation of 100% non-federal match as well as a "sustainable funding plan." State investment is critical to the long-term sustainability of DA BUX and its ability to provide a positive, lasting impact economically, for farmers, and for the wellbeing of individuals across the state.
