Aloha Chair San Buenaventura, and Members of the Committee:

My name is Keali'i Lopez, and I am the State Director for AARP Hawai'i. AARP is a nonpartisan, social impact organization that advocates for individuals age 50 and older. We have a membership of nearly 38 million nationwide and nearly 140,000 in Hawaii. We advocate at the state and federal level for the issues that matter most to older adults and their families.

AARP supports S.B.2471 which appropriates funds to support the Dept. of Health's Senior Fall Prevention Program.

According to the U.S. Centers of Disease Control and Prevention (CDC), "falls among adults aged 65 and older are common, costly, and are the leading cause of fatal and nonfatal injuries among older adults. In the United States, over 14 million, or one in four, adults ages 65 and older (older adults), report falling each year. While not all falls result in an injury, about 37% of those who fall reported an injury that required medical treatment or restricted their activity for at least one day, resulting in an estimated nine million fall injuries." In most cases, falls are preventable especially if people take steps to reduce the risks by making their homes safer, proper medications and health management, and engage in strength and balance exercises such as tai chi. The Hawaii Department of Health has had a successful senior fall prevention program that includes certified tai chi classes, and it has expanded these classes to over thirty locations and all YMCA5 statewide. Exercise programs like Tai-chi and other falls prevention education and awareness efforts should be continued and supported to reduce the risk of fall-related injuries especially among Hawaii's older residents.
