The League of Women Voters of Hawaii <u>supports SB2702</u>, adding language to the Hawaii Revised Statutes which specifies that the practice of election fraud intimidation includes carrying any firearm or weapon and photographing the face of any voter without permission from both the voter and an appropriate election official when those actions occur at or near a voter service center, place of deposit, or polling place.

This additional language added to our Hawaii Revised Statutes not only reinforces our commitment to a free and fair electoral process but also sends a clear message that the state prioritizes the safety and well-being of its citizens, ensuring that every voter can participate in elections without facing intimidations or threats.

Section 1. (B)(12). Every person who knowingly broadcasts, televises, circulates, publishes, distributes, or otherwise communicates, including by electronic means or advertisement, false information about the time, date, place, or means of voting with the purpose of impeding, preventing, or otherwise interfering with the free exercise of the elective franchise.

<u>Photography in Public</u>: It is our 1st Amendment right to photograph in public places. The ACLU and state of Hawai'i Attorney General agreed that it is a 1st Amendment right to take photographs in public, as affirmed in this 2016 case put forth by the ACLU. The Voter Service Centers are government buildings open to the public. Almost all of the places of deposit on Oahu are in public parks. Are all the newscasters going to need to get permission from every voter inside the Hales and on the sidewalks before filming?

If our lawmakers want to change the laws regarding photography in government buildings open to the public; this is not the section of the Hawaii Revised Statutes in which to address it. All the other sections of this bill need to be scrapped as they are contradicting Hawaii Revised Statutes.

Please vote NO on sB2702.

Dear Chair Rhoads and Members of the Committee,

On behalf of GIFFORDS Law Center to Prevent Gun Violence, the gun violence prevention organization founded and led by former Congresswoman Gabrielle Giffords, I submit the below testimony regarding SB 2702.

Armed voter intimidation is a serious issue and we appreciate the committee's attention to this matter. SB 2702 represents an important step forward in recognizing the inherently intimidating effect firearms have in these spaces, building on existing law prohibiting the open or concealed carrying of firearms in a polling location.

The Effect of Guns on Voter Intimidation

Last fall, GIFFORDS partnered with the Brennan Center for Justice to release a new report, simply titled <u>*Guns & Voting*</u>,¹ which detailed the risks rising gun violence and armed intimidation pose to U.S. elections and voters. What we found was that the intersection of firearms and the democratic process has become a cause for grave concern, with election spaces transforming into potential flashpoints for armed intimidation and extremist activity.

The 2024 election will unfold in a transformed legal environment. In a majority of states, gun advocates have successfully pushed deregulation of firearms in legislatures and the courts. Gun sales also soared during this time. In fact, gun sales were <u>83% higher</u> in March 2020 than they were in March 2019.² Overall, Americans purchased an estimated <u>22 million guns</u> in 2020, an

increase of nearly 65 percent over the previous year's sales.³ In the following two years, Americans bought more than <u>42 million guns</u>.⁴

This same environment in which guns proliferate has witnessed a rising tolerance towards armed extremism and political violence:

- Presently, nearly <u>1 in 4</u> Americans polled believe violence could be necessary to "save the country."⁵
- Threats against members of Congress are ten times higher than they were in 2017.⁶
- <u>The Violence Policy Research Center</u> at the University of California, Davis, found that 12.4 million Americans would be somewhat, very, or completely willing to kill a person in a situation in which they believe force or violence is justified to advance an important political objective.⁷
- More than <u>47.7 million Americans</u>, including those who don't own guns, think it is somewhat, very, or extremely likely that they will be armed with a gun in the next few years in a situation in which they think force or violence is justified to advance an important political objective.⁸

Unfortunately, election sites, election officials, and even voters have now become the targets of armed extremists across the country. The 2022 midterms saw election denial activists engage in a variety of intimidating or potentially intimidating tactics, including aggressive poll-watching efforts, armed "surveillance" of dropbox sites, and protests at counting facilities. In Arizona, false conspiracy theories about electoral fraud perpetrated at drop boxes led activists to organize "dropbox tailgate parties," which placed angry—and often armed—protesters just outside the 75-foot electioneering perimeter established by Arizona law.⁹ These intimidating tactics have extended even further, often even to voter and candidate homes. In at least <u>19 states</u>, door-to-door "canvassing" efforts were reported in which civilians knocked on doors to purportedly identify voter fraud.¹⁰

New studies have found that armed intimidation at the polls has a direct consequence on democratic engagement. A 2022 study by the <u>Global Project Against Hate and Extremism</u> indicated that less than half of respondents—merely 41 percent—now feel secure at their polling stations.¹¹ Likewise, almost one-third of respondents expressed significant apprehension regarding the possibility of violence or shootings on Election Day. Minority and historically disenfranchised voters indicated even higher levels of concern about violence at the polls.

Similarly, rising harassment and intimidation has resulted in a <u>mass exodus</u> of election workers across the country.¹² According to a <u>nationwide poll of Election workers</u> conducted by the Brennan Center for Justice, 11% of current officials say they are very or somewhat likely to leave before November 2024.¹³ Over half say they are concerned for the safety of their colleagues and staff and 30% admitted to having personally been abused, harassed, or threatened because of their job as a local election official.

Complementary Approaches

To address the direct threat of firearms to voters and election officials, GIFFORDS and the Brennan Center worked to develop an approach that recognizes the inherently intimidating effect of firearms at or near polling locations. This model law could serve as a helpful complement to address the problem of voter intimidation.

Under this approach, there would be a prohibition on threats, coercion, or intimidation, or attempts at such, against any person (1) voting or attempting to vote; (2) urging or aiding any person to vote or attempt to vote; (3) exercising any powers or duties to administer elections, or (4) on the basis of their past or present involvement as an election official.

These prohibitions would be enforceable by the application of a rebuttable presumption inspired by Section 11b of the federal Voting Rights Act recognizing that openly carrying a firearm while interacting with or observing those engaged in voting is inherently intimidating:

In any suit to enforce this provision, a person who openly carries a firearm, imitation firearm, or toy gun while interacting with or observing any of the activities described in subsections (a)(1) through (3) of this section shall be presumed to have engaged in intimidation prohibited by this act in the absence of an affirmative showing to the contrary by a preponderance of the evidence.

Under this approach, election officials, the attorney general, and any other aggrieved person would have the right to bring a civil suit for equitable relief.

Aloha Senate Judiciary Committee Chair Rhoads and Committee Members,

I strongly oppose SB2702.

While I understand that your intent is to ensure the safety of voters, there are several areas of major concern with this bill.

1. Redefining the definition of election fraud to include "intimidation":

The US Elections Assistance Commission (EAC) defines election fraud as, "The misrepresentation or alteration of the true results of an election" (page 36 of EAC Glossary of Election Terminology https://www.eac.gov/sites/default/files/glossary_files/Glossary_of_Election_Terms_EAC.pdf).

The addition of the word "intimidation" to the verbiage "election fraud" creates a nonsensical term that has **nothing** to do with the definition of election fraud.

1. SB2702 duplicates already existing Sensitive Places law, and at the same time unlawfully reextends it to certain public places that have been successfully challenged in court:

The August 8, 2023 ruling on Hawai'i's Sensitive Places law in the United States District Court, District of Hawaii <u>Wolford vs. Lopez case</u> struck down the section of the law pertaining to firearms at public parks; *"the portions of Haw. Rev. Stat. § 134-A(a)(9) prohibiting the carrying of firearms in beaches, parks, and their adjacent parking areas"* (emphasis my own).

All of Oahu's ballot places of deposit are in public parks, with the exception of the ones at Kapolei Hale and Honolulu Hale. The other counties also have ballot places of deposit in parks. This bill is in direct contradiction of the Wolford vs. Lopez case.

1. Photography in Public:

It is our 1st Amendment right to photograph in public places. The ACLU and state of Hawai'i Attorney General agreed that it is a 1st Amendment right to take photographs in public, as affirmed in this 2016 case put forth by the ACLU.

The Voter Service Centers are government buildings open to the public.

Are all the newscasters going to need to get permission from every voter inside the Hales and on the sidewalks before filming?

This provision risks unfairly stigmatizing responsible gun owners and infringing upon their constitutional rights.

Additionally, the bill's language lacks clarity and specificity, leaving room for misinterpretation and arbitrary enforcement. Without clear guidelines on what constitutes intimidation or improper photography, there is a risk of selective enforcement and undue burden falling disproportionately on certain groups.

While the goal of safeguarding the integrity of our elections is unquestionably important, S.B. NO. 2702 is not the appropriate means to achieve this aim. I urge you to reject this bill in its current form and explore alternative solutions that prioritize both election integrity and individual liberties.

It seems that the author of this bill and other bills that have been submitted by the same author have a common theme of infringing on the constitutional rights of the citizens of this state and country, as well as to control the elction processes that limits transparency and accountability. As an elected representative, if the testimonies submitted by the citizens are overwhelming in opposition or in favor... the elected official should vote accordingly as what the citizens choose and not what the elected official chooses as each electied official is to be a voice of the people, NOT over the people.
