TESTIMONY ON SENATE BILL 2731 RELATING TO SPECIAL LICENSE PLATES FOR IRAQ AND AFGHANISTAN WAR VETERANS

Aloha Chair Dela Cruz, Vice-Chair Moriwaki, and members of the committee:

I am Bruce Oliveira, Interim Director of Hawai'i Office of Veterans Services, State of Hawai'i, Department of Defense.

The Department of Defense (DOD) provides written testimony in **SUPPORT** of HB2731.

This measure, if passed, creates license plates to honor Veterans of the Iraq and Afghanistan Conflicts. Since both conflicts happened concurrently, many veterans in the State of Hawaii served in both theaters.

Creating a special license plate for Iraq and Afghanistan veterans is an expression of gratitude for their service in protecting, not only our state citizens, but the citizens of our nation. This plate continues our recognition of veterans from World War II, the Korean War, Vietnam, and the Persian Gulf War who can apply for a specialty license plate from these conflicts. The veterans of the Iraq and Afghanistan conflicts have sacrificed their lives to defend the citizens of the United States. Existing law does not include special license plates for Iraq and Afghanistan veterans; therefore, this measure will create license plates to honor the veterans of the Iraq and Afghanistan conflicts.

Eligible veterans for any of these distinctive license plates would have to show proof of eligibility from the Department of Defense or their service with a Form DD 214 or other official documentation of wartime service.

The DOD supports the intent expressed in this measure as long as its implementation does not impact or replace the priorities set forth in the Executive Budget.

I thank you for the opportunity to provide testimony in **SUPPORT** on HB2731. I urge you to honor our Hawaii Veterans who have served during America's war of the 21st Century by supporting this legislation establishing this distinctive veteran license plate.

The Hawaii Military Affairs Council ("MAC") supports SB 2731 which creates license plates to honor Iraq and Afghanistan veterans.
