The Office of Hawaiian Affairs (OHA) offers **SUPPORT** for **SB2757**, which would align sex trafficking laws in Hawai'i with federal laws regarding the exploitation of a minor. This crucial initiative represents a significant step towards combating the heinous crime of sex trafficking and providing justice for victims, particularly Native Hawaiians who are disproportionately impacted by this form of exploitation.

Sex trafficking is a pervasive and devastating crime that preys on the most vulnerable members of our society, including minors. By aligning Hawai'i's sex trafficking laws with federal standards regarding the exploitation of minors, we can ensure that perpetrators who exploit children for commercial sex are held accountable to the fullest extent of the law. This alignment would streamline prosecution efforts and provide law enforcement agencies with the necessary tools to effectively investigate and prosecute cases of child sex trafficking.

Aligning Hawai'i's laws with federal standards sends a clear message that our state is committed to protecting the rights and well-being of all individuals, especially our most vulnerable populations. Native Hawaiians, in particular, are disproportionately affected by sex trafficking due to a combination of factors such as socioeconomic disparities and historical trauma. Studies have shown that Native Hawaiian women are especially vulnerable to trafficking. The majority (43%) of sex trafficking cases are kānaka maoli girls trafficked in Waikīkī, Oʻahu. 157% of participants served through the Manaʻolana Program at Child & Family Services are Native Hawaiian females who have experienced human trafficking. Therefore, enacting legislation to strengthen sex trafficking laws is especially critical for protecting Native Hawaiian communities and ensuring that they receive the support and resources they need to combat this issue.

In conclusion, the Office of Hawaiian Affairs urges this committee to **PASS SB2757**, By doing so, we can strengthen protections for victims, hold perpetrators accountable, and provide much-needed support to Native Hawaiian communities who are disproportionately affected by this crime.

Chair Rhoads and Members of the Committee:

The Department of the Attorney General ("the Department") provides the following comments on this bill.

The bill's stated purpose is to align Hawaii's sex trafficking laws with federal law by making the commercial sexual exploitation of a minor a form of sex trafficking.

This bill seeks to:

- (1) Move the offense of commercial sexual exploitation of a minor from being a standalone offense under section 712-1209.1, Hawaii Revised Statutes (HRS), to being charged as a form of sex trafficking under section 712-1202, HRS:
- (2) Change the state of mind for the offense of sex trafficking from "knowingly," to "intentionally, knowingly, or recklessly";
- (3) Add the offense of commercial sexual exploitation of a minor--now a form of sex trafficking--as an enumerated offense that qualifies for the offense of habitual commercial sexual exploitation under section 712-1209.5, HRS; and
- (4) Make the offense of habitual commercial sexual exploitation a class A felony in certain circumstances.

The proposed addition of paragraph (c) to section 712-1202(1), HRS, on page 5, line 12, through page 6, line 2, takes the wording of the offense of commercial sexual exploitation of a minor under section 712-1209.1, HRS. In doing so, the bill changes the

structure of 712-1209.1(1), HRS, making the requirement that the defendant be over the age of eighteen apply only to "solicits, offers to engage in, or requests to engage in sexual conduct with a minor in return for anything of value;" while the original wording of 712-1209.1(1), HRS, makes the age requirement applicable to all the various ways to commit the offense of commercial sexual exploitation of a minor. To retain the original effect of 712-1209.1(1), HRS, the Department suggests amending page 5, line 12, through page 6, line 2, to read as follows:

- (c) (i) Offers or agrees to provide anything of value to a member of a police department, deputy sheriff, or other law enforcement officer who represents that person's self as a minor to engage in sexual conduct;
 - (ii) Provides anything of value to a minor or third person as compensation for having engaged in sexual conduct with a minor;
 - (iii) Agrees to provide or offers to provide anything of value to a minor or third person for the purpose of engaging in sexual conduct with a minor; or
 - (iv) Solicits, offers to engage in, or requests to engage in sexual conduct with a minor in return for anything of value; and the person is eighteen years of age or older.

The Department also suggests amending the new subsection added as section 712-1202(6), on page 6, line 19, through page 7, line 7, to read as follows:

(6) Subsection (1)(c)(iii) and (iv) shall not apply to any member of a police department, deputy sheriff, or other law enforcement officer acting in the course and scope of duties; provided that the member of a police department, deputy sheriff, or law enforcement officer is engaging in undercover operations; provided further that under no circumstances shall sexual contact initiated by the member of a police department, deputy sheriff, or law enforcement officer; sexual penetration; or sadomasochistic abuse be considered to fall within the course and scope of duties.

It is not necessary for the exception to apply to subsection (1)(c)(i) or (ii), because a law enforcement officer representing that person's self as a minor should not engage in any of the conduct outlined in the proposed subsection (1)(c)(i), nor should any undercover officer engage in sexual conduct with a minor, as outlined in the proposed subsection (1)(c)(ii).

As written, section 4 of the bill, on page 7, line 8, through page 8, line 17, proposes to add the offense of commercial sexual exploitation of a minor--now a form of

sex trafficking under new section 712-1202(1)(c), HRS--to the list of enumerated offenses that can be used to define someone as a habitual commercial sexual exploitation offender under section 712-1209.5(2), HRS. Nevertheless, based on the bill's reference to this potentially being "the instant offense" (see page 8, lines 15-17, adding, "[] provided that habitual commercial sexual exploitation is a class A felony when the instant offense is sex trafficking under section 712-1202(1)(c)"), we believe the bill actually intends to add commercial sexual exploitation of a minor--now a form of sex trafficking under section 712-1209.5(1), HRS--as one of the "triggering" offenses for habitual commercial sexual exploitation. If that was indeed the intent, we believe that is unnecessary and ask that section 4 be deleted in its entirely, as it would always be easier for prosecutors to charge and prove sex trafficking under the new section 712-1202(1)(c), HRS--a class A felony--as a standalone offense, rather than proving section 712-1202(1)(c) merely as a qualifying offense for habitual commercial sexual exploitation under 712-1209.5, also a class A felony.

That said, if the Committee wishes to add commercial sexual exploitation of a minor--now a form of sex trafficking under section 712-1202(1)(c)--as one of the enumerated offenses for the definition of "habitual commercial sexual exploitation offender" (instead of a triggering offense for habitual commercial sexual exploitation), that could address a possible, though highly unlikely, scenario. In theory, if someone is convicted of sex trafficking under 712-1202(1)(c), which is a class A felony with a twenty-year prison term and no possibility of probation (see section 712-1202(2)); and

However, as we believe such an amendment is unnecessary, as explained above, we do **not** recommend that these amendments to section 712-1209.5(1).

⁽¹⁾ A person commits the offense of habitual commercial sexual exploitation if the person is a habitual commercial sexual exploitation offender and [provides,]:

⁽a) <u>Provides</u>, agrees to provide, or offers to provide a fee or anything of value to another person to engage in sexual conduct[-]; or

⁽b) Commits a new offense of sex trafficking under section 712-1202(1)(c).

that person is released on parole after serving less than ten years in prison; and that person then commits the "triggering" offense of commercial sexual exploitation² (i.e. involving a prostituted person over the age of 18 years old) while still on parole; and that person already had another prior conviction within the past ten years for one of the offenses enumerated under section 712-1209.5(2); then that person could now be charged with habitual commercial sexual exploitation as a class A felony. Thus, if the Committee prefers that the triggering offense of commercial sexual exploitation, typically a petty misdemeanor, be charged instead as a class A felony in this particular type of scenario, the Department suggests amending section 712-1209.5(3) on page 8, line 16, as follows:

(3) Habitual commercial sexual exploitation is a class C felony[-]; provided that habitual commercial sexual exploitation is a class A felony when one or more of the prior convictions used to meet the definition of "habitual commercial sexual exploitation offender" is sex trafficking under section 712-1202(1)(c).

To maintain consistency in the state of mind requirement pertaining to the age of the minor (or undercover officer posing as a minor), the Department also suggests amending 712-1202(4), HRS, found in the bill on page 6, lines 13-16, to read as follows:

(4) The state of mind requirement for the offense under subsection (1)(b) and (c)(ii) is not applicable to the fact that the victim was a minor. A person is strictly liable with respect to the attendant circumstance that the victim was a minor.

² Pursuant to section 712-1200.5(1), HRS: "A person commits the offense of commercial sexual exploitation if the person **provides**, **agrees to provide**, **or offers to provide a fee or anything of value to another** [i.e. another adult] **to engage in sexual conduct**." (Emphasis added.) This is the same language used as the triggering offense for habitual commercial sexual exploitation under section 712-1209.5(1), HRS.

This bill amends Hawai's Penal Code to align it with federal law regarding the sex trafficking of minors by, *inter alia*, repealing the Commercial Sexual Exploitation of a Minor offense under HRS § 712-1209.1 and creating an equivalent offense within HRS § 712-1202 and related statutes. We support this measure because it recognizes the severity of child sexual exploitation by making the sex trafficking of minors a Class A felony offense, on par with the penalty for the sex trafficking of adults. We also support this measure because it allows convictions for sex trafficking of minors to count as prior convictions for the offense of Habitual Commercial Sexual Exploitation under HRS §712-1209.5.

TESTIMONY IN SUPPORT OF SB 2757 RELATING TO SEX TRAFFICKING

Hawaii Youth Services Network (HYSN) supports SB 2757 Relating to Sex Trafficking.

Homeless youth who are living on their own on the streets have few options for meeting their basic survival needs. Homeless youth often trade sex for food, money or a place to sleep. They are vulnerable to being recruited into prostitution and other forms of commercial sex work by adults.

I would like to share the story of one of these victims., When Maile (name changed to protect privacy) was 13, she ran away from home. She told me, "I met an older man, he was like an uncle to me. He put me up in a hotel room and I thought I was safe. . . But then I found out the true meaning of 'Nothing in life is free."

Minors who engage in sex work do it out of desperation or because they were deceived by someone they trusted.. They are victims, not criminals. And the people who recruit and exploit them are truly engaged in sex trafficking.

SB 2757, RELATING TO SEX TRAFFICKING

FEBRUARY 13, 2024 · JDC HEARING

POSITION: Support with amendments.

RATIONALE: Imua Alliance <u>supports and suggests amendments</u> for SB 2757, relating to sex trafficking, which aligns state sex trafficking laws with federal law by making the commercial sexual exploitation of a minor a form of sex trafficking.

Imua Alliance is a victim service provider for survivors of sex trafficking. Over the past 15 years, we have provided comprehensive direct intervention (victim rescue) services to over 200 victims, successfully emancipating them from slavery and assisting in their restoration, while providing a range of targeted services to over 1,000 victims and individuals at risk of sexual exploitation. During the pandemic, demand for victim services to our organization skyrocketed by 330 percent, driven in part by a fivefold increase in direct crisis calls.

Each of the victims we have assisted has suffered from complex and overlapping trauma, including post-traumatic stress disorder, depression and anxiety, dissociation, parasuicidal behavior, and substance abuse. Trafficking-related trauma can lead to a complete loss of identity. A victim we cared for in 2016, for example, had become so heavily trauma bonded to her pimp that while under his grasp, she couldn't remember her own name. Yet, sadly, many of the victims with whom we work are misidentified as so-called "voluntary prostitutes" and are subsequently arrested and incarcerated, with no financial resources from which to pay for their release.

Sex trafficking is a profoundly violent crime. At least 23 percent of trafficking victims in Hawai'i report being first exploited before turning 18, according to a recent report, with the average age of trafficked keiki's initial exposure to exploitation being 11. Based on regular outreach and monitoring, we estimate that approximately 150 high-risk sex trafficking establishments operate in Hawai'i. In a recent report conducted by the State Commission on the Status of Women, researchers from Arizona State University found that 1 in every 11 adult males living in our state buys sex online. When visitors are also counted, that number worsens to 1 in every 7 men walking the streets of our island home and a daily online sex buyer market of 18,614 for O'ahu and a total sex buyer population for the island of 74,362, including both tourists and residents.

ASU's findings are grim, but not surprising to local organizations that provide services to survivors of sex trafficking. Imua Alliance, for example, has trained volunteers to perform outreach to victims in high-risk locations, like strip clubs, massage parlors, and hostess bars. More than 80 percent of runaway youth report being approached for sexual exploitation while on the run, over 30 percent of whom are targeted within the first 48 hours of leaving home. With regard to mental health, sex trafficking victims are twice as likely to suffer from PTSD as a soldier in a war zone.

Greater than 80 percent of victims report being repeatedly raped and 95 percent report being physically assaulted, numbers that are underreported, according to the United States Department of State and numerous trauma specialists, because of the inability of many victims to recognize sexual violence. As one underage survivor told Imua Alliance prior to being rescued, "I can't be raped. Only good girls can be raped. I'm a bad girl. If I want to be raped, I have to earn it."

Accordingly, we support measures to advance our state's fight against sexual servitude, including this bill's alignment of state law with federal law by making buying sex from a minor a form of sex trafficking, something that will significantly help with the proper identification of child survivors. That said, we urge you to amend this measure by leaving section \$712-1209.1 in place as a lesser included offense to maximize the tools available to law enforcement to address child sexual exploitation that occurs on our shores.
