<u>DEPARTMENT'S POSITION</u>: The Department of Human Services (DHS) appreciates the intent of this bill as long as it does not reduce or replace the priorities identified in the Governor's budget.

<u>PURPOSE</u>: The purpose of this bill is to appropriate funds to the Department of Human Services for Medicaid coverage under the Children's Health Insurance Program for incomequalified pregnant persons and children, regardless of immigration status, and declares that the general fund expenditure ceiling is exceeded.

DHS believes there is a clear benefit to the state to ensure all residents, regardless of immigration status, have access to health care. DHS supports the increase in appropriation detailed in this bill as long as it does not reduce or replace the priorities identified in the Governor's budget. For reference, DHS prefers that the increase be included in the executive budget bill as a recurring appropriation so that the coverage will be ongoing. Per <u>Senate</u>

<u>Concurrent Resolution 183 SD1 (2023)</u>, DHS completed its <u>report</u> on this matter. The general fund appropriations in the bill are based on cost estimates in the report to provide coverage for 500 pregnant women and 4,000 children.

Testimony in Strong Support of SB 2783 Relating to Medicaid Stubmitted by The Hawai'i Friends of Civil Rights Co-Chairs Amy Agbayani and Pat McManaman

The Hawai'i Friends of Civil Rights works to achieve equity, justice, inclusion, uphold civil rights, and eliminate discrimination. We stand in **Strong Support of S.B. 2783.** 

Long-established medical consensus holds that prenatal care is fundamental to reproductive and infant health. The lack of access to prenatal care increases the risk of premature birth and low birth weight and is a factor in a range of poor health outcomes experienced by undocumented pregnant women and their babies, including higher rates of labor and delivery complications and premature births. Many of these negative outcomes pose long-term development risks to newborn U.S. citizen children and could be avoided with full access to prenatal care.

In a recently released report, the Hawaii Department of Health reported that from 2018 to 2021, the maternal death rate in the United States increased from 17.4 to 32.9 per 100,000 live births and that disadvantaged populations including Native Hawaiians and other Pacific Islanders, Black, and American Indian and Alaska Native persons have the highest rates of

pregnancy-related deaths. The report further noted that approximately 80% of pregnancy-related deaths are preventable requiring a multilevel approach that includes ensuring quality care for all pregnant and postpartum persons.<sup>1</sup> Additionally, the Kaiser Family Foundation (KFF) noted that expanding Medicaid coverage regardless of immigration status resulted in improved outcomes including increases in average gestation and birth weight among newborns.<sup>2</sup> Med-Quest's estimate for providing Medicaid coverage for an estimated cohort of 500 undocumented pregnant persons is \$744,000 in state funds for pregnancy-related services and 2 months of postpartum care. Extending postpartum care an additional 10 months would increase state-funded costs to \$1,364,000.<sup>3</sup>

Long-standing medical consensus also holds that healthcare services for children are fundamental to their well-being and development. Nevertheless, even in bona fide emergencies, undocumented immigrants in Hawai'i hesitate to utilize emergency rooms to access healthcare for their undocumented immigrant children. Their fears that they and their uninsured children may be reported to the United States are not unfounded. The Med-Quest Division, Department of Human Services estimates coverage for approximately 4,000 income-qualified undocumented children will range from \$2,976,000 to \$9,600,000 in state funds.

With one of the lowest national rates of uninsured persons and a leader in healthcare,

Hawai'i has the opportunity to reaffirm its commitment to healthcare through this measure and to

recognize the substantial federal and state tax contributions made by Hawai'i's undocumented residents, reported at \$65.3 million and \$47.6 million respectively in 2018.<sup>4</sup>

AlohaCare appreciates the opportunity to provide testimony in **support of SB2783**. This measure would provide Medicaid coverage through the Children's Health Insurance Program (CHIP) for children and pregnant persons who would otherwise qualify for coverage if not for their immigration status.

Founded in 1994 by Hawai`i's community health centers, AlohaCare is a community-rooted, non-profit health plan serving over 80,000 Medicaid and dual-eligible health plan members on all islands. Approximately 40 percent of our membership are keiki. We are Hawai`i's only health plan exclusively dedicated to serving Medicaid and Medicaid-Medicare dually-eligible beneficiaries. Our mission is to serve individuals and communities in the true spirit of aloha by ensuring and advocating for access to quality, whole-person care for all.

AlohaCare is committed to ensuring and advocating for access to quality health care for all, regardless of immigration status. While estimates range, according to Pew Research Center estimates, in 2016, Hawai`i was home to 45,000 undocumented immigrants, making up 17% of the state's immigrant population and 3% of the state's total population. The same study estimates that undocumented workers are overrepresented in the state's labor force at 4.5% primarily in the leisure/hospitality and agriculture industries.¹ According to the American Immigration Council, using 2021 American Community Survey data, millions of undocumented immigrants across the nation are working, contributing billions of dollars to the U.S. economy. In Hawai`i in 2021, the American Immigration Council

estimates the number of undocumented immigrants at 30,977 paying \$69.5 million in federal taxes and \$43.9 million in state and local taxes.<sup>2</sup>

According to testimony from Hawai'i Friends of Civil Rights to the Senate Health & Human Services Committee on SB842, many of the 45,000 undocumented persons in Hawai'i secure health care insurance through the Hawaii Prepaid Health Care Act while approximately 11,000 undocumented immigrants are uninsured—with 43% of these households reporting incomes below 200% of the federal poverty level—and are unable to access the health care they need to live healthy, stable lives and be fully participating members of our communities.

Hawai'i's Medicaid program currently provides coverage of emergency medical services to individuals who are ineligible for Medicaid due to immigration status. This emergency coverage is provided to stabilize the emergency medical condition, but Medicaid does not cover any follow-up visits resulting from the emergency visit.

AlohaCare supports this measure to ensure access to preventive and comprehensive care for all, regardless of immigration status, and to strengthen the Medicaid program. Mahalo for this opportunity to testify in **support of SB2783**.

Thank you for the opportunity to submit testimony in **SUPPORT of SB2783**, which appropriates funds to the Department of Human Services for Medicaid coverage under the Children's Health Insurance Program for income-qualified pregnant persons and children, regardless of immigration status.

Approximately five hundred pregnant persons and four thousand income-qualified children in our state face the harsh reality of being denied affordable healthcare simply due to their immigration status. Improving access to healthcare has a profound impact on short and long-term outcomes for these patients. Children born to undocumented immigrant mothers without insurance coverage are more likely to have negative health outcomes<sup>1,2</sup>. Conversely, those with Medicaid coverage are less likely to be born premature or with a low birthweight. Furthermore, these children are more likely to have receive higher education and require fewer public services in their future<sup>3</sup>. Investments for our patients are not only a moral obligation, but a financially prudent one. A recent study in the National Bureau of Economic Research found that "over the long-run, the government more than recoups the cost of its initial investment of providing Medicaid coverage to these families"<sup>3</sup>.

To improve outcomes for all of our patients, the HMA stands in strong support of this measure.

HI ACOG thanks the Hawai'i State Legislature for showing its commitment to improving maternal health in Hawai'i by recently approving funds to extend Medicaid postpartum coverage to 12 months. Thank you for the opportunity to <u>SUPPORT</u> SB 2783 – RELATING TO MEDICAID which appropriates funds for the Department of Human Services to purchase health care services for certain low-income, uninsured immigrants.

The American Cancer Society Cancer Action Network (ACS CAN), the nonprofit, non-partisan advocacy affiliate of the American Cancer Society advocates for public policies that reduce death and suffering from cancer. ACS CAN works with federal, state, and local government bodies to support evidence-based policy and legislative solutions designed to eliminate cancer as a major health problem.

The Affordable Care Act (ACA) expanded health insurance coverage to millions of Americans. However, despite these coverage gains, twelve years after the law was enacted approximately 27 million people in the United States remain uninsured. Data shows that noncitizens are more likely to be uninsured. In 2020, 26% of lawfully present individuals and 42% of undocumented immigrants were uninsured, compared to only 8 percent of U.S. citizens.<sup>ii</sup>

The American Cancer Society Cancer Action Network believes that everyone should have a fair and just opportunity to prevent, detect, treat, and survive cancer. Cancer impacts everyone and key to eliminating disparities and ensuring health equity is to guarantee that all individuals have access to affordable coverage. Access to care for those who are undocumented not only ensures that serious diseases like cancer can be detected and treated earlier but also often means better patient outcomes and less costs to the individual and the system.

This position is an extension of ACS CAN's existing work to advocate for access to affordable, comprehensive coverage to better prevent, treat and survive cancer regardless of citizenship status thereby ending cancer as we know it for everyone.

Aloha Chair San Buenaventura, Vice Chair Aquino, Chair Keohokalole, Vice Chair Fukunaga, and Members of the Committees,

The Legal Clinic ("TLC") submits testimony in **SUPPORT of SB2783**, advocating for the fundamental right to equitable healthcare access for all individuals, regardless of immigration status. Recognizing healthcare as pivotal to public health, SB2783 addresses the current denial of affordable healthcare to approximately 500 pregnant individuals and 4,000 income-qualified children in the state. Evidence-based studies highlight the heightened risks associated with limited healthcare access for pregnant individuals and their newborns. While twenty states provide Medicaid coverage to income-qualified pregnant residents, Hawai'i encounters challenges related to the high cost of neonatal care. The proposed Act seeks to allocate funds to the Department of Human Services to authorize Medicaid coverage for income-qualified pregnant individuals and children, irrespective of immigration status. Babies born in Hawai'i will, by definition, be born U.S. citizens. If the parent is undocumented, or awaiting documentation, the parent may be fearful to request hospital or other medical assistance, before, during, or after giving birth. This legislation aligns with TLC's core values of human rights and access to justice. By supporting SB2783, we aim to contribute to a more inclusive and healthier community, ensuring that vulnerable populations receive the essential healthcare services they need.

#### Comments:

As an OBGYN in Hawaii, I am consistently seeing patients covered under Medicaid. Medicaid already insures about 50% of pregnant patients in the nation, but it does not provide coverage to one crucial group in Hawaii. That group is recent immigrants. I recently was caring for a patient in our free clinic who is a recent immigrant to Hawaii. She just delivered a baby without prenatal care, and now was struggling with postpartum depression. While she was able to get postnatal care (although the clinic was not reimbursed), she was unable to get in person behavioral health services. She struggled for months to figure out her immigration status, all the while struggling with a new infant and severe postpartum depression. This bill would have changed the support she was able to receive in a crucial period.

I think of those who are affected by the Maui fires, and the associated depressive disorders that have followed. Not unlike my patient, those who are working on their immigration status will not be able to recieve care. Maui is already a place with limited providers, and those providers are unlikely to take someone who is not covered by Medicaid when they are already overburdened.

Please vote yes on SB2783 to provide care coverage to every member of our community. Mahalo.

I am a Maternal-Fetal Medicine physician in Hawai'i and part of my job entails diagnosing devastating fetal malformations. I'll always remember a particular case of a young woman who was getting her first ultrasound late in pregnancy. Rather than joyful news, I had to tell her that her baby had a major congenital defect and may not survive long after birth. Moreover, the baby's condition could make her critically ill as well. This family needed such intensive care for the pregnancy including referrals to specialists, additional specialized ultrasound exams, and monitoring of the baby to prepare for delivery. Due to her immigration status and inability to obtain medicaid, we could not even schedule her next appointment let alone provide any of the additional services she needed. If our aim is to dismantle barriers to healthcare and limit perinatal morbidity, we must care for pregnant people regardless of their immigration status. I support SB 2783 which would provide medicaid coverage to income-qualified pregnant persons and children regardless of immigration status.

I'm an OBGYN on Oahu, and I have cared for many patients who could not obtain insurance due to their immigration status. I recall one patient who was flown to Oahu emergently from Maui for very preterm labor, and spontaneously delivered her nonviable pregnancy soon after. She didn't speak English, and through an interpreter she told me that she did not seek prenatal care because she did not have immigration status. She relocated with her partner to Maui for construction work. Immigrants have always been part of Hawai'i's community and deserve the right to affordable health care without fear of repercutions of their immigration status or inability to pay. I myself was an immigrant and recall how hard my parents worked to afford health care for us, and how we had to scrape by. I strongly support SB2783 so that I can care for all of my patients equally.
