I am writing to share why I oppose SB2845. This bill would greatly affect all young law abiding citizens who simply wish to legally participate in training at a firing range with a responsible adult. This will take away the opportunity to simply take my son to go shoot in order to teach him to hunt and to provide for himself. I also know of other organizations that might be negatively affected by this sort of bill. The Kids Safe Firearms training course teaches kids of the basic principles to ensure safety regarding firearms. They sell a ticket for the classes and in the second class children, while with their parents or guardians are taught how to safely use a .22 caliber firearm in a safe range setting. This course has had an amazing impact across the nation and is a non profit organization that aims to curb gun violence and to instill values of respect and knowledge of the reality of firearms. This organization would potentially be breaking a law by selling a ticket to the class and then providing ammunition to the children who are using it in a firearm at the range. This is taught by a NRA certified master firearms instructor and is the safest way possible to introduce safety knowledge to the youth. This same idea is taught from uncles, aunties and family friends who allow young adults to learn how to safely operate a firearm while at a range. This bill would make that all illegal. That is a sad abuse of power and law. The 18 year old who wants to shoot a firearm before joining the army, like the more than 10 individuals I have taken personally to the range to shoot for their first time would have been illegal if that was law then. I have personally trained three 18 - 20 year old men how to properly shoot a rifle at the public range, and all 3 went on to join the army and qualify as marksmen and go into an career that defends this very right. Just simply handing the ammo to the person under 21 would be against the law as that is transfering of ammunition. Selling it should be allowed if you are not wanting to pay for them to learn. As a responsible firearms owner it is my duty to be aware of who handles my firearms at a range and at all times. If I feel they are responsible and able to shoot at the range then I should be allowed to help inspire education and respect of responsible firearm handling to the next generation.

This bill is absurd and should not be allowed to be passed. Such a sad day for America if this is passed along with all the other disgraceful bills aiming to take away our second amendment right. My ancestors have 3 men who fought in the Battle at Kings Mountain in the revolutionary war. They were all hunters and respected individuals who were not a danger to anyone until their freedom was abused and they were threatened in their homes. Of the 3 men that fought was my great x6 grandfather Moses Cavitt, who died in that battle. Alongside him were two of his seven sons, Moses Cavitt II and his 15 year old son, Patric Cavitt. Honorable Members of the Senate Public Safety, Intergovernmental, and Military Affairs Committee,

I am writing to express my strong opposition to **SB2845**, which seeks to restrict the sale, ownership, and possession of ammunition based on age. While I appreciate the intent to enhance safety, I believe this bill raises several critical issues that warrant reconsideration.

## 1. Second Amendment Rights:

The Second Amendment of the United States Constitution protects the right of the people to keep and bear arms. Civil rights extend beyond the Second Amendment. By restricting ammunition sales based on age, we risk infringing on other constitutional rights, including due process, equal protection, and privacy. We must strike a reasonable balance that respects both safety and individual liberties.

# 4. Efficacy and Impact:

o It is essential to evaluate the effectiveness of such restrictions before enacting a law with this level of impact to law-abiding citizens. I've seen no reference to studies or reports demonstrating a clear benefit to public safety by restricting access to ammunition for law-abiding adult citizens under the age of twenty-one. If the goal is to increase public safety by reducing gun violence, we should explore comprehensive approaches that address root causes (e.g., Mental health, training/education, etc.) rather than singling out ammunition sales.

In conclusion, while public safety is important, we must ensure that any legislation does not inadvertently undermine our constitutional rights or disproportionately affect law-abiding citizens. I urge you to reconsider the provisions of SB2845 and seek alternative solutions that promote safety without compromising civil liberties.

Dear Senator Wakai, Senator Elefante, and Committee Members:

I am writing to ask you to pass SB 2845 to protect Hawai'i families by ensuring that Hawai'i has clear laws and requirements relating to owning and carrying a firearm. I speak as a parent of a teen and a young adult, and the daughter of an Army combat veteran who was a firearms coach and competitor. I believe that owning a firearm is a privilege that belongs to people who are fully capable of understanding and respecting that privilege. Decades of research into brain development shows that human brains are not fully developed until the mid- to late-twenties. As adolescents age, their impulse control improves and their ability to foresee and understand consequences also improves. As they emerge into their twenties, young adults are able to make more responsible choices for themselves and society.

Delaying the use of items that can easily lead to deadly consequences, such as alcohol and firearms, until brains are more mature, is a rational, science-based approach to public health and public safety. SB2845 is a common-sense approach to ensuring responsible gun ownership.

Research on mass shootings show that a majority of mass shootings in the last 5 years were committed by men aged 21 and younger. As a mother of a teenager in a Hawai'i public high school and a young adult who also attended public school in Hawai'i, I can assure you that our young people deal with the threat of a school shooting on a daily basis. News of school shootings elsewhere hit our young people hard. As our world grows more connected, many Hawai'i young people have a connection to schools on the mainland where shootings occur. And our teens wonder, "when will we be next?"

This is a horrible way for our children to grow up. Wondering not if, but when they and their friends will have to run or hide from a person at school with a deadly weapon, intent on killing as many people as possible. This is a daily threat to them.

Furthermore, suicide is the third leading cause of death for young people in the US, and access to firearms increases the risk that they will attempt and succeed at killing themselves. A study published in *Annals of Internal Medicine* found that approximately 90% of suicide attempts with a gun end in death, compared with about 4% of other suicide attempts ending in death. The CDC has found that almost half of youth suicides are committed with a firearm.

Delaying legal gun ownership until age 21 is an appropriate response to changes in our society and research shows that this legislation will save lives. I urge your committee pass SB 2845 to protect our keiki, from brutal, preventable gun violence.

Restricting the younger generation from firearm use is just ridiculous. I grew up around and using firearms and that is how I learned to be responsible around them. Under 21 restrictions have already been found unconstitutional already.

### Aloha kakou,

I am writing to express my strong opposition to SB 3196 and SB 2845, relating to firearms. I hope you will take a moment to consider the statements below and understand my reasoning.

The Second Amendment to the United States Constitution states, "A well regulated militia, being necessary to the security of a free state, the right of the people to keep and bear arms, shall not be infringed." This amendment was added to the Bill of Rights due to the experiences of our country's founders in the time leading up to the American Revolution and Declaration of Independence. Their voices went unheard when the British monarchy created laws that placed undue burden on the people of the original colonies. When our founders refused to comply, the British military attempted to confiscate stores of ammunition and weapons in an effort to disempower them and force them to submit to King George III's laws. These were the actions that instigated the battles of Lexington and Concord, starting the American Revolution. The founding documents of the United States of America were written to keep the power in the hands of the people, and the Second Amendment ensures that that's where the power stays. It enshrines the inalienable right of the people to protect themselves, their family, their community, and their country. It prevents any power from infringing on that right.

I believe the legislation proposed in SB 3196 and SB 2845 is in direct violation of the Second Amendment to the United States Constitution, and is neither necessary or likely to be effective for the intended purpose (presumably to reduce violence where firearms are involved). Hawaii is blessed to have one of the lowest rates of firearms-related deaths in the country. Therefore, what is the need for the proposed legislation? It appears to be legislating away a problem that doesn't exist. Hawaii already has some of the strictest gun laws in the nation. We are required to have training, procure a permit from the police department (which requires a background check), and then register our firearms with the police department. Firearms purchased from FFLs will also trigger another background check for the purchaser. The people who complete all of these steps to obtain firearms are not interested in using them for malicious purposes. These people are purchasing them to be secure in their person and to provide them with the power to protect their family, community, and country. These people deserve the best available tools, to give them the best chance of protecting their life or way of life.

Many firearms are also used for recreational purposes. Common activities in Hawaii include target shooting, hunting, trap, skeet, sporting clays, and competition pistol and rifle shooting. These activities can all be done safely, and can be an excellent avenue for making friends, building community, and even teaching our next generation about safe firearm handling and providing them with activities that keep them engaged and away from drugs, alcohol, vandalism, or other forms of mischief. The proposed legislation in SB 3196 and SB 2845 will reduce the people's ability to participate in these activities.

In summation, I believe that there is no need for these legislative measures and that they violate the Second Amendment to the United States Constitution. I hope that you will consider the needs and rights of the people as these bills advance through the legislative session. Thank you for taking the time to read my testimony, and I hope your actions will not disempower the people.

The basis of this bill, that young adults under the age of 21 cannot purchase firearms in Hawai'i, is unlawful.

A U.S. District Court Judge struck down a Virginia law banning the sale of firearms to this age group in May 2023. A federal judge in Minnesota recently ruled that a law prohibiting 18- to 20-year-olds from getting permits to carry handguns in public is unconstitutional. A judge struck down a similar law last year on gun restrictions for young adults in Texas.

Many of the rights and responsibilities of citizenship are granted at the age of 18, including the right to vote, enlist in the military without parental permission and serve on a federal jury.

If you wish to enact a gun restriction you must look back into history to show it is consistent with the country's historical tradition of firearm regulation, as the U.S. Supreme Court has ruled.

You have failed to do this because there is no evidence of age-based restrictions on the purchase or sale of firearms or ammunition from the colonial era, Founding or Early Republic. The lack of similar regulations from those time periods indicates that the Founders considered age-based regulations on the purchase of firearms or ammo to circumscribe the right to keep and bear arms confirmed by the Second Amendment.

If this bill were to pass you would exclude 18-to-20-year-olds from the Second Amendment's protection and would impose limitations on the Second Amendment that do not exist with other constitutional guarantees.

For these reasons you must vote "no" on S.B. 2845.
