Chairs Wakai and Keohokalole and Members of the Committees:

The Department of the Attorney General provides the following comments on this bill.

This bill amends chapter 127A, Hawaii Revised Statutes, by adding nine new sections that automatically impose various restrictions whenever the Governor or a mayor issues an emergency proclamation. The restrictions include suspension of rent collection and summary possession for residential and small business commercial tenants, foreclosures, mortgage and loan payments, credit reporting, and insurance for homeowners' associations. The bill also makes clarifying amendments to section 127A-14(d).

The automatic imposition of all these restrictions of broad scope may be susceptible to legal challenges and potentially subject the State to monetary liability. The mandatory nature of these emergency provisions, without regard to the nature of the emergency, could potentially impair an unknown number of existing contracts under the Contract Clause of the U.S. Constitution or impermissibly take unaccounted for property rights on a large scale under the Takings Clauses of the U.S. and Hawaii Constitutions. *See, e.g., Palazzolo v. Rhode Island*, 533 U.S. 606, 617-18 (2001) (the purpose of the Takings Clause is to prevent the government from "forcing some people

alone to bear public burdens which, in all fairness and justice, should be borne by the public as a whole").

To address this issue, we recommend that the bill be amended by adding wording for each section that "the governor or mayor may declare" the restriction when declaring a state of emergency, as opposed to having all restrictions be invoked automatically. This way, the restriction can be imposed on a case-by-case factual finding, which should help the restrictions better withstand legal scrutiny. The proposed changes are as follows:

Page 1, lines 9-11: "with respect to any residential dwelling unit in the area that is the subject of the proclamation, <u>the governor or mayor may declare that</u> the landlord of the rental unit shall:"

Page 3, lines 2-3: "with respect to any residential dwelling unit in the area that is the subject of the proclamation[<u>:</u>], the governor or mayor may declare that:"

Page 4, lines 9-11: "with respect to any residential property, as defined in section 667-1, that is in the area that is the subject of the proclamation[<u>:</u>], the governor <u>or mayor may declare that:</u>"

Page 5, lines 18-21: "with respect to any mortgaged property, as defined in section 667-1, that is in the area that is the subject of the proclamation, <u>the governor or</u> <u>mayor may declare that</u> the mortgagee of the property shall:"

Page 7, lines 13-16: "with respect to any rented commercial property in the area that is the subject of the proclamation, <u>the governor or mayor may declare that</u> the landlord of the commercial property, if the tenant is a small business commercial tenant, shall:"

Page 10, lines 17-20: "with respect to any student loan, commercial loan, or consumer loan (including any credit extension) of any borrower who resides in the area that is the subject of the proclamation, <u>the governor or mayor may declare that</u> the lender or holder of the loan shall:"

Page 12, lines 1-2: "or any portion thereof, <u>the governor or mayor may declare</u> <u>that</u> any person who resides in the area that is the subject of the proclamation may contact any:" Testimony of the Department of the Attorney General Thirty-Second Legislature, 2024 Page 3 of 4

We also recommend inserting a purpose to further bolster the bill against potential Contract Clause challenges. Even where a law is found to impair a preexisting contract, the Court looks to whether the state law is drawn in an appropriate and reasonable way to advance a significant and legitimate public purpose. *See Galima v. Ass'n of Apartment Owners of Palm Ct. by & Through Bd. of Directors*, 453 F. Supp. 3d 1334, 1355 (D. Haw. 2020). Therefore, we recommend adding a preamble to identify the public purpose and how that purpose is advanced by these provisions.

In particular, the three-year mortgage deferment imposed by section 127A-D(a)(1) and the subsequent deferment for undetermined years imposed by section 127A-D(a)(2) raise concerns. The purpose of the bill should explain how the time set by these sections is appropriately and reasonably drawn. The committee may also wish to consider whether the deferment period should be lowered to better withstand judicial scrutiny.

Section 127A-G raises potential federal preemption issues. The Fair Credit Reporting Act (FCRA) expressly preempts certain categories of state laws, such as the time by which a consumer reporting must take any action in any procedure related to the disputed accuracy of the information in a consumer's file. *See* 15 U.S.C. § 1681t(b). Thus, page 12, line 14 should be amended to provide: "(1) Respond to the requestor within [five days;] the time period prescribed by 15 U.S.C. § 1681i; and"

The FCRA also preempts state laws relating to certain topics contained in consumer reports, such as how long certain information (e.g., bankruptcies) may continue to appear on a consumer report and information relating to a veteran's medical debt. See 15 U.S.C. § 1681c(a). However, according to the Bureau of Consumer Financial Protection's interpretive rule from June 28, 2022, a state law prohibiting a consumer reporting agency from including information (or certain types of information) about a consumer's eviction, rental arrears, or arrests on a consumer report would generally not be preempted under the FCRA.

Rather than putting the onus on the consumer to determine what information qualifies to be excluded, we recommend prescribing the obligation to the credit reporting agency. Page 12, line 15, should be amended to provide an exception: "(2) Honor the

person's request[-], or in the alternative, should federal law bar the consumer reporting agency or user of a consumer report from honoring the request, provide a written explanation identifying the basis for the refusal."

We respectfully ask the Committee to consider our recommended amendments. Thank you for the opportunity to offer comments.

Chair Wakai, Chair Keohokalole, and Members of the Committees:

My name is Mana Moriarty, and I am the Executive Director of the Department of Commerce and Consumer Affairs' (Department) Office of Consumer Protection. The Office of Consumer Protection offers comments and opposes section 127A-I of this bill which would make a violation of any of the provisions of sections 127A-A through 127A-H unfair methods of competition or unfair or deceptive acts or practices in the conduct of trade or commerce under section 480-2, Hawaii Revised Statutes.

The purposes of this bill are to: 1) Amend emergency management law to protect tenants, mortgagors, consumers, and residents for certain periods of time after the issuance of a gubernatorial or mayoral emergency proclamation; and 2) Classify violations as unfair methods of competition and unfair and deceptive acts or practices.

Existing law declares that unfair methods of competition and unfair or deceptive acts or practices in the conduct of any trade or commerce are unlawful. Existing law

authorizes a consumer, the Attorney General, or the Director of the Office of Consumer Protection to bring an action based upon unfair or deceptive acts or practices declared unlawful. This bill creates new legal requirements for a wide range of businesses including mortgage lenders, credit reporting agencies, and condominium associations as well as landlords and "users of consumer reports," which may deal with persons affected by disasters after a declared state of emergency.

Section 127A-I of this bill makes a violation of any of these new legal requirements an unfair method of competition or an unfair or deceptive act or practice in trade or commerce. Since the Office of Consumer Protection does not enforce Hawaii's anti-trust laws, our comments address only the unfair or deceptive act or practice aspect of this section of the bill. Depending on the particular violation in the bill, designating each and every violation of a legal requirement as an unfair or deceptive act or practice may stretch the notion of an unfair or deceptive act or practice.

A "deceptive" act is defined as "(1) a representation, omission, or practice that (2) is likely to mislead consumers acting reasonably under the circumstances where (3) the representation, omission, or practice is material." *State ex rel. Shikada v. Bristol-Myers Squibb Co.*, 152 Hawaii 418, 424, 526 P.3d 395, 401 (2023) (citation omitted). Certain conduct made unlawful by this bill and designated as "unfair or deceptive" is designated as such even though the conduct seems not "likely to mislead consumers" by either affirmative representation or omission.

"A practice is unfair if it (1) offended public policy, (2) was immoral, unethical, oppressive, or unscrupulous, or (3) substantially injured Hawai'i consumers." *Bristol-Myers Squibb Co.*, 152 Hawaii at 443, 526 P.3d at 420. Hawaii courts, however, have not weighed in on whether a civil enforcement action brought by the State alleging an unfair practice can be sustained solely on the basis that the conduct is offensive to public policy.

For the foregoing reasons, OCP opposes section 127A-I of this bill, and requests that the legislature adopt an enforcement method that is not tied to section 480-2 if this bill moves forward.

The unprecedented events of the August 8, 2023 wildfires on Maui have pointed out the need to offer emergency economic assistance to those directly impacted by devastating emergency situations.

I am writing to convey my endorsement of Senate Bill 2904, which seeks to establish that the emergency management powers held by the Governor and mayors align with the provisions delineated in the state's statutes.

Under this legislation, state or local emergency proclamations shall grant residential tenants, business and home owners, as well as other affected individuals – the right to manage their personal and business affairs in response to the event, allowing them to put their lives back in order amidst the emergency.

The provisions outlined in this Senate Bill aim to provide all parties with a comprehensive understanding of their rights and options before, during, and after an emergency. This includes ensuring that individuals are fully informed about their rights and available courses of action throughout the duration of a proclamation, as well as any extensions to that proclamation.

My name is Lyndsey Garcia, Director of Advocacy, testifying on behalf of the Hawai'i Association of REALTORS[®] ("HAR"), the voice of real estate in Hawai'i and its over 11,000 members. HAR provides **comments** on Senate Bill 2904, which amends emergency management law to protect tenants, mortgagors, consumers, and residents for certain periods of time after the issuance of a gubernatorial or mayoral emergency proclamation. Classifies violations as unfair methods of competition and unfair and deceptive acts or practices.

In times of natural disasters or emergencies, the challenges faced by impacted residents and businesses, including housing providers and tenants, can be significant. This proposal suggests allowing tenants, upon written request, to suspend rent collection for a three-month period without proof of hardship. Both housing providers and tenants can be adversely affected by natural disasters, with housing providers facing financial burdens themselves. Prohibiting rent collection during such times could add to these hardships.

Ultimately, rental assistance programs prove to be the most effective solution. These programs not only assist renters who require support with covering their rents but also provide relief to housing providers who may have lost their jobs or rely on the rental property income.

TESTIMONY OF EVAN OUE ON BEHALF OF THE HAWAII ASSOCIATION FOR JUSTICE (HAJ) IN SUPPORT OF SB 2904

My name is Evan Oue and I am presenting this testimony on behalf of the Hawaii Association for Justice (HAJ) in SUPPORT of SB 2094, RELATING TO EMERGENCY MANAGEMENT.

In light of the recent Maui Wildfire in August 2023, HAJ appreciates the legislature considering the concepts proposed in this measure which intends to promote greater consumer protection during emergency responses. First and foremost, HAJ expresses its condolences for the individuals lost in the August wildfire.

As background, HAJ is an association focused on consumer protection policies. In support of the Maui wildfire recovery efforts, HAJ members have: 1) provided pro bono volunteer legal services for victims on a wide range of legal matters including insurance claims; 2) assisted with the Hawaii State Bar Association (HSBA) hotline; 3) gathered and advocated for monetary contributions for the Hawaii Community Foundation (HCF) and the HSBA Foundation; and 4) volunteered on the frontlines of recovery by staffing both government and community-based relief tents in the days and weeks following the tragic blazes.

Through our members volunteer efforts, HAJ has found that many residents have expressed concerns relating to housing and shelter. Several housing concepts contained in this measure including: 1) deferment of mortgage payments; 2) residential rent suspension; 3) a foreclosure moratorium; and 4) suspension of rent collection may be helpful to individuals looking to recovery from emergency situations. These housing policies may immediately relieve resident concerns regarding housing immediately following a disaster or emergency. For example, from our understanding, mortgage deferments may fall under federal jurisdiction, with residents who have federally backed mortgages being encouraged to obtain mortgage forbearance through Fannie Mae. In fact, in a federally declared disaster, many lenders are required to offer disaster forbearance for mortgage payments up to 12 months without late charges at the request of the borrower. However, the State could encourage lenders to provide further extensions of mortgage forbearance as provided in this measure.

Additionally, HAJ believes that a foreclosure moratorium may provide relief for afflicted disaster victims. A temporary suspension of Hawaii Revised Statutes (HRS) Chapter 667 may provide residents without federally backed mortgages or residents of condominium associations, additional relief during this recovery period. A suspension of HRS Chapter 667 may alleviate any concerns surrounding potential foreclosures for impacted residents.

HAJ applauds the legislature's current handling of the Maui wildfires response and seeks to support consumer protection measures in connection with recovery as well as potential future emergency situations.

We fully understand and acknowledge that these are complex matters that require further refinement, however, HAJ is grateful for the legislature hearing this measure and considering consumer rights. We are writing on behalf of Lahaina Strong, an organization that was initially formed in 2018 following the Hurricane Lane fire in Lahaina and re-energized last year after the devastating Lahaina fires on August 8. Our organization is the largest grassroots, Lahaina-based community organization, with over 20,000 supporters, engaged in providing support and assistance to the victims of these disasters.

Lahaina Strong stands in support of SB2227, which authorizes the Governor to suspend the mortgage foreclosure provisions of chapter 667, HRS, for three years, for properties having substantial damage resulting from a Governor declared state of emergency.

Lahaina Strong has been at the forefront of relief and advocacy efforts, including the initiation of the "Fishing for Housing" camp, which has been in operation for over eleven weeks along Kaanapali Beach, championing dignified housing for Lahaina fire victims. We commend the legislature for considering measures that address the pressing issues faced by our community, and we believe that the proposed bill encompasses crucial provisions that align with our organization's goals and demands.

While our primary focus is on the displaced fire victims of Lahaina, we firmly believe that stronger protections are needed for all homeowners in Hawaii, as we have borne witness to the impact that the Lahaina fire has had on many homeowners, struggling to pay mortgages for homes that were lost in the fire, during a time of deep economic uncertainty.

This is a critical step in providing stability and security to those who have already endured so much. Lahaina Strong stands firmly in support of such protections for homeowners, recognizing the immediate relief they would bring to the many affected individuals and families on Maui who are being forced to pay mortgages on uninhabitable properties.

We urge the legislature to pass this bill to provide much-needed relief and support to the Lahaina community and beyond.

My name is Stefanie Sakamoto, and I am testifying on behalf of the Hawaii Credit Union League, the local trade association for 47 Hawaii credit unions, representing over 864,000 credit union members across the state.

HCUL offers the following comments in opposition to SB 2904, Relating to Emergency Management. This bill amends emergency management law to protect tenants, mortgagors, consumers, and residents for certain periods of time after the issuance of a gubernatorial or mayoral emergency proclamation, and classifies violations as unfair methods of competition and unfair and deceptive acts or practices.

The majority of Hawaii's credit unions currently offer loans to their members. Credit unions are not-for-profit organizations whose members ultimately bear any losses. If there is a default in payment of their obligations, a credit union may have to take legal action to collect the debt. If the credit union cannot collect the debt, its members suffer the loss, and this may also have the unintended consequence of making it more difficult for credit union members to qualify for loans, as the risk incurred by financial institutions would be inherently higher.

This bill is extremely broad, and would essentially stop lending in the state. For example, if there is declared an emergency in the State of Hawaii, all loans in the entire state would potentially be affected. This would essentially mean that all financial institutions would be unable to collect on loans for at least three years. This would potentially decimate financial institutions.

Dear Chair Wakai, Chair Keohokalole and Members of the Joint Committees:

We submit this testimony on behalf of the Hawaii Bankers Association (HBA). HBA represents seven Hawai`i banks and one bank from the continent with branches in Hawai`i.

HBA submits **comments** on S.B. 2904, which amends the emergency management law to allow for a moratorium on foreclosures, commercial and residential rent payments, mortgage payments, rent increases, evictions for certain periods of time after the issuance of an emergency proclamation.

HBA has concerns regarding the broad nature of this bill and the unintended impact it could have on the financial institutions market, and in turn on consumers. Lenders are heavily regulated institutions that are regularly reviewed for their safety and soundness and evaluated, among other things, based on the level of risk they carry within their lending portfolios. This bill would elevate the risks of lending if any emergency proclamation is issued, and count potentially shut down the lending market with no time limit.

While banks regularly work with those impacted by disasters and consider foreclosures to be a mechanism of last resort, this measure imposes an automatic moratorium on foreclosures, commercial and residential rent payments, mortgage payments, rent increases, evictions no matter the type of emergency or how long it lasts. In recent years, emergency proclamations have been used for all types of emergencies, some of which have lasted for years. At any given time, there are numerous emergency declarations that exist in the state, many of them unrelated to natural disasters. The uncertainty caused by the

bill could freeze consumer access to lending and significantly drive up the cost of capital or halt it altogether because it greatly increases uncertainty and risk.

HBA would also note that there is already a process in the law under HRS 127A-30 which prohibits rent increases and evictions during an emergency proclamation. The proposal in this bill appears to conflict with the existing statutory process to prevent rent increases and evictions in this bill.

We appreciate that this measure is trying to address very real impacts felt by consumers in times of emergency in the State but believe that additional discussion is necessary to ensure that consumers and the lending markets they rely on are not negatively impacted.
