Re: S.B. 2942 S.D.1 RELATING TO EMPLOYMENT OF A MINOR

I. OVERVIEW OF PROPOSED LEGISLATION

The **DLIR supports** this measure that seeks to provide greater protections under Child Labor Law for children working in theatrical employment. SB2942 SD1 proposes to add a new subsection 390-2(e), Hawaii Revised Statutes (HRS), to require a nurse certified in basic life support to accompany, supervise, and advocate on behalf of a minor under the age of one year working in theatrical employment.

The measure also requires a studio teacher to accompany, teach, and attend to the health, safety, and well-being of the minor whenever a minor between the ages of five and fifteen years of age is working in theatrical employment during periods when the minor is legally required to attend school.

"Nurse" and "Studio teacher" are also defined to not include the minor's parent or guardian.

II. CURRENT LAW

There is no current law requiring a nurse or studio teacher to be present on set when minors are employed in theatrical employment. Section 390-2, HRS, Employment of minors under eighteen years of age, and §§12-25-22 and 12-25-23, Hawaii Administrative Rules (HAR), contain hours and times provisions for minors that are 16-17, 14-15, and under 14 years of age.

III. COMMENTS ON THE SENATE BILL

Employment certificates for television or motion picture productions comprise the majority of the theatrical employment certificates issued by the DLIR. The duration of these productions ranges from a television commercial shooting for a few hours in one day only to a television series or motion picture production filming for several hours a day for several months.

Prior to the DLIR issuing a theatrical certificate of employment, the DLIR ensures that the minor is performing satisfactorily in school. Under §12-25-22, HAR, Theatrical employment permitted, whenever a minor under fourteen years of age works during a school year, the employer must submit to the DLIR a statement signed by an authorized school official indicating that the minor's attendance and schoolwork are satisfactory. When the minor's schoolwork or attendance is not satisfactory, the DLIR cannot issue the certificate of employment and the application is denied.

Currently, §12-25-22, HAR, requires that a minor under fourteen years of age employed in theatrical employment be accompanied by and under the immediate and direct control of the minor's parent or a responsible adult designated by the parent. The primary purpose of this is to ensure that the employment does not injuriously affect the minor's health, safety, or well-being.

This bill expands the requirement to be accompanied by a parent, guardian, or responsible adult to minors ages fourteen and fifteen years of age (Pg 4, lines 5 to 8). The DLIR notes that under §390-2(c), HRS, a minor age fourteen or fifteen may be employed in non-hazardous occupations without being accompanied by a parent, guardian, or responsible adult.

§12-25-23, HAR, Hours and conditions of employment, addresses issues pertaining to adequate rest periods, rest facilities, transportation, compensation, safety, supervision, and tutoring. §12-25-23, HAR, also permits variances for "good cause" including practical difficulties and undue hardship by the employer in complying with the work hour restrictions.

Shows have scheduled child actors to work two days, skip a day and then work two more days in order to avoid having a set teacher on set.

A film set is a dangerous and fast-moving place. It is imperative that minors employed in theatrical work have qualified and certified Set Teachers (and Registered Nurses for infants) to accompany, supervise and advocate on behalf of the infant or child to ensure the employer has provided a safe work environment for minors and is compliant with state child labor law and union agreements.

The Set Teacher ensures the child actor is tutored and works within the legal limits of Hawai'i State Law. As Hawai'i is ranked at 49th lowest GPA in the nation (D+ rating https://www.alecreportcard.org/state/hi/), we need to require that our keiki receive tutoring while away from school to give them the best opportunity for a prosperous and stable life.

This bill will help protect and nurture Hawai'i's child performers by having a certified Set Teacher (and nurse for infants) with them every step of the way. Please **PASS SB2942 SD1**.

Aloha, Chair Scot Z. Matayoshi, Vice Chair Andrew Takuya Garrett and LGO Committee Members:

MAHALO for allowing us to provide testimony in **STRONG SUPPORT** of **SB2942 SD1**. The IATSE is the largest entertainment union in the world, and Local 665 is its Hawai'i Chapter, representing nearly 800 members and 700 future members across all Hawaiian Islands.

We would like to recommend to <u>replace "Studio"</u> Teacher with "Set" Teacher. The reason for the change is because Studio Teachers are from California and Set Teachers are from all other jurisdictions. The changes would effect Page 5, Lines 4, 9 and 18 and on the last page in the Report Title and Description.

If enacted, this bill will require that a Set Teacher (for school-aged children) and a Registered Nurse (for infants) be hired every day that a minor is working in theatrical employment, as long as they have obtained a valid certificate from DLIR and are accompanied by a guardian or parent. Currently, California is the only state that has this requirement, and we would like to have the same level of care and protection for our keiki.

A film set is a fast-paced, often dangerous, adult environment that focuses on staying on schedule and staying on budget. Minors and their starstruck parents are thrown into this environment, not wanting to "rock the boat" and not knowing what their rights are or what the rules are. Our Set Teachers are professionally trained to navigate and guide the child actor and their guardians through the quagmire of a film set's logistical dangers and contractual terms.

There are currently no agreements that require a Set Teacher on the film set every day. The SAG-AFTRA agreement requires a Set Teacher be present every three consecutive days. Sometimes production companies schedule a child's work for two days, skip a day, work for two days, etc. so as to avoid having a Set Teacher on set. One employer did this for three years. It is our opinion that a Hawai'i school-aged child working on set should have some form of education every day they are working to keep up with their studies and their peers when they return to school.

Hawai'i's public school rating is still below the national average, so even one day of missed schooling is too many.

RE: SB2942 SD1 - Relating to Employment of a Minor

Regarding the role of a Set Teacher:

- The Set Teacher is an IATSE Local 665 worker, certified teacher with the DOE and hired by the employer. So, there is no cost to the State.
- The Set Teacher is the only person on set who is tasked to ensure the **employer complies with** Hawai'i Child Labor Law, Chapter 390, HRS (attached).
- A Set Teacher is professionally trained to keep the child safe, will ensure the child takes
 necessary meal and rest breaks, has the required amount of schooling, follows the terms of
 the SAG-AFTRA Agreement and the necessary labor laws for the safety and welfare of the child.
- Shows come to Hawai'i to film in our beautiful locations. As such, our working children are
 often exposed to rough weather and terrain. in the surf, in the sun, on the beach, in the
 jungle, trudging through mud, etc. Our Set Teachers live here and they know how to adapt to
 adverse conditions, assess the abilities of the child and deem whether a situation is safe.
- Our Set Teachers know that our sets are dangerous. For example, California Labor Law prohibits
 an infant to be exposed to the intensity of our movie lights for more than 30 seconds at a time
 so as not to burn the sensitive skin or eyes of the baby. A parent or guardian, and even most
 crew members, would not know that these lights are that harmful. Set Teachers act as an
 intermediary between the guardians and the production company to be sure the family feels
 safe and informed. They help to temper overzealous parents and help the child manage
 ambitious production schedules.
- To protect the child's privacy and modesty, a Set Teacher is required to escort the child through make-up, hair and wardrobe fittings. They are also there during the placement of microphones under the child's clothing. The Set Teacher knows to ask questions and prepare against unsafe or inappropriate situations. They work with the director or assistant directors on how to adjust accordingly.

In conclusion, MAHALO NUNUI for your support of Hawai'i's keiki actors and film workers. Please <u>pass</u> <u>SB2942 SD1 with the suggested amendment</u>.

Chair Matayoshi, Vice Chair Garrett, and members of the committee:

The Hawaii State AFL-CIO is a federation of 74 affiliate labor organizations who represent over 68,000 union members within the State of Hawaii. The Hawaii State AFL-CIO serves its affiliates by advocating for workers and their families before the state legislature and other branches of state and county government.

I am testifying on SB 2942 SD 1 in support of having only a state-licensed teacher working as a studio teacher on set whenever there is a minor involved. There is great concern for the well-being and continual education for the children working on sets not being met due to the lack of laws in place to protect their welfare while employed in the entertainment industry here in Hawai'i. Currently, there is nothing stopping an unlicensed person to work as a studio teacher.

I strongly believe that no one should be able to work in the position of studio teacher that does not have the degree & state-license to be a teacher in the first place. Anything less is detrimental to the child's growth & stability while on set and moving forward as they will potentially go weeks & months without the proper guidance & learning. If someone who isn't a licensed teacher is able to fill the position, it ensures that the child is not receiving the proper education or support that should be provided. This is only possibly by requiring someone licensed and educated to do so. It is an ongoing issue that there are those not even licensed teachers able to work as a studio teacher; Sadly, only the child is being hurt by this.

This is a huge liablility that needs to be taken into consideration and only allowing state-licensed teachers to work as studio teachers. As long as a minor is on set at all, there should be a licensed studio teacher employed with them. It is imperative that we not only protect our children but nurture their growth and education at all times. The entertainment industyry can be fickle & grueling, but I believe that if we do our best for the children, especially in this type of environment, by requiring licensing to ensure they receive proper education & have enforced rules, everyone involved will benefit, rather than allowing an untrained, unlicensed, and uneducated body be paid to simply watch them.
