Purpose of Bill: Establishes a working group within the Department of Transportation to address the workforce shortage of commercial drivers in the State. Requires a report to the Legislature. Effective 7/1/2050. (SD2)

Department's Position:

The Hawaii State Department of Education (Department) supports SB 2943, SD 2, which establishes a working group within the Department of Transportation to address the workforce shortage of drivers with a valid Commercial Driver's License (CDL).

The Department appreciates the Legislature's efforts to address workforce shortages and appreciates being included in the conversation. As it has been well documented, the shortage in bus drivers has impacted our ability to transport our students to and from school. Thus, we know how important it is to build the pool of CDL drivers, especially CDL drivers certified to drive school buses. Identifying strategies to recruit and retain qualified CDL drivers will not only fill current vacancies but will also create a stable workforce pipeline. While our students do not meet the age requirements to obtain a CDL learner's permit to participate in training, the Department understands that it is important for the workforce pipeline that we prepare our students through exposure to the career field and through developing the skills necessary for them to succeed as CDL drivers, including the employability skills and an understanding of supply chains and logistics and customer service. Regardless of the outcome of this measure, the Department is committed to working with the Department of Transportation and other stakeholders in finding a solution to address this critical need.

The Department defers to the Department of Transportation with regards to the implementation of this measure.

SUBJECT: SB2943 SD2 RELATING TO WORKFORCE DEVELOPMENT

The Hawaii State Council on Developmental Disabilities is in **SUPPORT OF SB2943 SD2**, which establishes a working group within the Department of Transportation to address the workforce shortage of commercial drivers in the State. Requires a report to the Legislature. Effective 7/1/2050. (SD2)

In Hawaii, the shortage of school bus drivers poses a significant challenge for our education system, particularly for our special education students who rely on school bus transportation to access their educational programs and services. The establishment of a working group dedicated to examining the school bus driver shortage is important to ensure reliable transportation for all students, including those with disabilities. In the past, the lack of qualified Commercial Driver's License (CDL) drivers has resulted in disruptions to transportation services, leading to missed school days and inconsistency in attendance for our special education students. As consistency is crucial to the success of our special education programs, addressing the school bus driver shortage is essential for ensuring that all students have equitable access to education and support services.

Additionally, we propose leveraging the Oahu city and county para-transit system, Handi-Van, as a potential model to help alleviate the school bus driver shortage. The Handi-Van system, which only requires a driver's license and high school diploma or GED, could offer insights into alternative approaches to recruiting and training drivers for school transportation services. Exploring innovative solutions, such as adapting the Handi-Van model, can contribute to addressing the workforce shortage and ensuring the continuity of transportation services for our students.
