## TESTIMONY IN OPPOSITION OF SB 3011, SD2

Honorable Chair Tarnas, Honorable Vice Chair Takayama, and Members of the Committee on Judiciary & Hawaiian Affairs, the Hawai'i County Department of Parks and Recreation submits the following in OPPOSITION of SB 3011, SD2.

This Bill makes it unlawful for any entity or agent thereof to operate a weed whacker in or within one hundred feet of a residential zone, except between 8:00 a.m. and 7:00 p.m. on most days. Provides exceptions for government entities and agents acting on behalf of government entities during emergencies. Defines weed whacker.

I am writing to express our OPPOSITION to SB3011 SD2, which seeks to restrict the operation of leaf blowers and weed whackers during certain hours. As the Director of Hawai'i County Parks and Recreation, I believe this Bill, if enacted, will have detrimental effects on our ability to maintain the vast network of parks and recreational facilities across Hawai'i Island.

Currently, under HRS 342F-30.8, government entities, including our Parks and Recreation Department, are exempt from certain restrictions on the operation of landscaping equipment. This exemption is crucial for us to effectively manage and maintain over 300 park facilities that are open to the public seven days a week.

The proposed Bill would limit the exemption for government entities only to emergencies as defined in HRS 127A-2, effectively prohibiting the use of leaf blowers and weed whackers during regular operational hours. This change would severely impact our ability to provide clean, safe, and enjoyable spaces for the residents and visitors to County parks on Hawai'i Island.

Our parks typically open at 7 am, and we operate with a minimal workforce to handle the extensive maintenance needs to ensure our park facilities are at the highest standards when users arive. Utilizing leaf blowers and weed whackers during these early hours is essential for

preparing the facilities for public use and ensuring their upkeep. Restricting the hours during which we can conduct maintenance activities will undoubtedly strain our operations and compromise the quality of our parks.

Moreover, maintaining well-groomed parks not only enhances the overall experience for visitors but also contributes to public safety and environmental conservation. Regular maintenance helps prevent the accumulation of debris and invasive plant species, mitigates fire hazards, and preserves the natural beauty of our landscapes.

We understand the concerns regarding noise and environmental impact associated with landscaping equipment. However, it's essential to strike a balance between environmental stewardship and practical maintenance needs. Our department is committed to implementing sustainable practices and minimizing disturbances to the community while fulfilling our responsibility to manage public spaces effectively.

Therefore, we urge the committee to reconsider the proposed amendment to HRS 342F-30.8 and maintain the current exemption for government entities. This will enable us to continue our essential maintenance operations and uphold the highest standards of our parks and recreational facilities.

Thank you for considering our perspective on this matter.

For the foregoing reasons, the Hawai'i County Department of Parks and Recreation OPPOSES the passage of SB 3011, SD2. Thank you for the opportunity to testify on this matter.

I support SB3011, but I would rather see a stronger measure. Probibiting leaf blowers and weed wackers during the hours of darkness is not enough. They are typically used during the day already. These machines are extremely annoying when powered by 2 cycle gas engines. And it's well known that the 2 cycle tools are major polluters. There is no paradise when one is in use.

Electric leaf blowers and weed wackers are much quieter and more tolerable. Electricity isn't pollution free, but it's generated by methods that emit less than small gas engines that are often worn out and smokey.

It's good to address this problem, but we should ban 2 cycle yard equipment completely. Electric machines should be considered separately, and possibly approved during daytime hours, as the bill specifies.

Making a rule affective in 2050 won't help anybody I know. It's good for our grandchildren. Let's make a stronger law that takes effect sooner. It would be reasonable to allow a transition period for yard crews to gradually switch to newer technology. 2028 would be about right.
