EXECUTIVE OFFICE ON EARLY LEARNING'S POSITION: Support

The Executive Office on Early Learning (EOEL) is committed to expanding early learning opportunities for all keiki across the State and is in strong support of S.B. No. 3087.

High-quality early learning programs yield substantial positive immediate and long-term, multigenerational benefits. High-quality early learning programs have positive effects on the physical, cognitive, linguistic, social and emotional outcomes of children. In addition, these programs allow families opportunities to continue education or work by providing a safe and secure place to enroll their children.

In 2020, legislation was enacted demonstrating the State's commitment to increasing access to early learning programs by charging EOEL and DHS with ensuring all three and four-year old keiki have access to prekindergarten by 2032. As EOEL continues to expand the EOEL public prekindergarten program, it is critical to also focus on expanding community-based options as these programs are necessary to meet families' unique needs and demands. Community-based programs offer services that may be longer in duration, assisting families who work traditional and non-traditional hours; culturally and linguistically based; provided in a home-setting, which may be more comfortable or preferred by families; or may accept younger children from birth onward.

Although the State continues to address access, affordability is still a significant barrier for Hawai'i's families. Despite efforts to keep rates low, community-based programs continue to operate on razor-thin margins, making the sustenance of these beneficial programs difficult.

The intention of this bill is to expand public-private partnerships for all young keiki by administering programs in existing vacant public spaces. Presently, section 302L-1.7, HRS, authorizes EOEL to administer pre-plus programs through private-public partnerships on Department of Education (HIDOE) public school campuses. S.B. No. 3087 would expand access to affordable early learning programs through offering potentially more cost-effective spaces by allowing programs to be administered on other public properties in addition to HIDOE campuses.

EOEL is committed to working with other State agencies that own or oversee these properties to provide early learning spaces, with priority given to communities and areas with limited access to early learning programs and services.

EOEL would like to note that this bill would utilize the terminology "early learning", rather than "pre-plus", as "early learning" is already defined in section 302 L-1, HRS. This bill also does not require any funding or fiscal support.

We appreciate the Legislature's continued investments to our youngest keiki and families and respectfully request the committee to pass this measure. Mahalo for the opportunity to provide testimony in strong support.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS and offers comments</u> on SB3087, which expands access to early learning programs on other state properties and public lands besides Department of Education public school campuses.

OHA is in its fourth year of its 15-year strategic plan, Mana i Mauli Ola. The development of this strategic plan included gathering community input via surveys and focus groups as well as mana'o from internal staff. **One of the most critical needs that our community repeated was 'ohana's ability to provide high-quality keiki and kūpuna care.**

SB3087 will support the state's ongoing efforts to expand early childhood care and education. In 2020—the same year our strategic plan began—the State Legislature passed Act 46 setting a vision for 100% access to early learning opportunities. We believe this measure is one component that will help the state both achieve the Legislature's vision and meet the needs that OHA has identified for the Hawaiian people.

The Pre-Plus Program has been an important piece of the early learning puzzle, allowing community-based Head Start providers to offer early learning programs on public school campuses. OHA sees SB3087 as having the potential to expand the impact of a program like Pre-Plus. It sets the tone to prioritize the development of early learning programs in facilities, and it adjusts the existing pre-plus statute to have the possibility for greater reach. The inclusion of other public properties will provide the Executive Office on Early Learning (EOEL) the authority to work beyond public schools to realize its obligations for universal access.

OHA would also like to respectfully remind the State Legislature of the state's obligations to steward crown and government lands, also known as ceded or public land trust lands. Our understanding of this measure is that it will provide facilities for low- or no-cost to community-based providers. This is consistent with the way **early childhood**

care and education must be seen as a public good. We support these lands being used for this purpose rather than for the purpose of generating revenue. We would also like to ensure that the implementation of this expanded program taking careful precautions not to allow for the alienation of any public property that may be part of the public land trust.

OHA believes this program can be an integral component to the State's efforts to actualize Act 46 (SLH 2020). We respectfully request the committee advance SB3087. Mahalo nui for the opportunity to testify on this important issue.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) supports this administration measure and defers to the Executive Office on Early Learning for implementation.

PURPOSE: The purpose of this bill is to expand access to early learning programs to other state properties and public lands besides public school campuses.

The Department supports efforts to expand availability and access to child care throughout the State. This measure is an additional piece of legislation to fully implement a goal set out in Act 46, Session Laws of Hawaii 2020, of providing all children who are 3 to 4 years old who are in the two years prior to kindergarten entry with enrollment in a preschool program by the year 2030.

The DHS child care program staff will work with the Executive Office on Early Learning and be available to child care providers and facilities on other state properties and public lands to ensure providers are informed of the health and safety requirements for licensing should they be required to be licensed by the Department.

The Early Learning Board supports the Executive Office on Early Learning's (EOEL) commitment to expanding early learning opportunities for all keiki across the State and is, therefore, in strong support of S.B. No. 3087.

The intention of this bill is to expand public-private partnerships for all young keiki by administering programs in existing vacant public spaces. Presently, section 302L-1.7, HRS, authorizes EOEL to administer pre-plus programs through private-public partnerships on Department of Education (HIDOE) public school campuses. S.B. No. 3087 would expand access to affordable early learning programs through offering potentially more cost-effective spaces by allowing programs to be administered on other public properties in addition to HIDOE campuses.

The Board is confident that EOEL will work collaboratively and effectively with other State agencies that own or oversee these properties to provide early learning spaces, with priority given to communities and areas with limited access to early learning programs and services.

Early Childhood Action Strategy (ECAS) is a statewide cross-sector collaborative designed to improve the system of care for Hawai'i's youngest children and their families. ECAS partners work to align priorities for children prenatal to age eight, streamline services, maximize resources, and improve programs to support our youngest keiki.

ECAS strongly supports passage of SB3087, which would expand access to early learning programs on other state properties and public lands besides Department of Education public school campuses.

High-quality early care and learning programs are fundamental to providing children with dependable, nurturing relationships, safe environments, and stimulating experiences that are critical for brain development and school readiness. Experiences in high-quality early care and learning programs can lead to improved educational, economic, health and well-being outcomes for children, lasting into adulthood. Hawaii, however, faces a significant shortage of early care and learning programs, with only one program space for every four children under the age of six.

SB3087 would support the State's commitment to increasing access to early learning programs by allowing for the use of space for early learning programs beyond HIDOE campuses to other, existing vacant public spaces. This expansion of options will help facilitate growth of a larger specturm of early care and learning programs to better meet the unique needs and preferences of children and families, such as the needs for full-day, full-year programs, or programs for infants and toddlers.

Thank you for this opportunity to provide testimony **in support of SB3087**. With the limited availability of quality early care and learning seats we strongly support the bill's proposal to expand available options and increase access to early learning opportunities for a wider range of children.

TITLE: A BILL FOR AN ACT RELATING TO EARLY LEARNING.

- PURPOSE: To expand access to affordable and highquality early learning programs on other state properties and public lands besides those located on Department of Education public school campuses.
- MEANS: Amends sections 302A-1151.5, 302D-35, 302L-1.7, and 302L-7, Hawaii Revised Statutes (HRS).

Research affirms the immediate and long-term JUSTIFICATION: positive effects of high-quality early learning programs on the physical, cognitive, linguistic, social, and emotional outcomes of children. Studies also demonstrate that high-guality early learning programs are especially effective for atrisk children, yielding significant benefits to their lifetime trajectories. Act 46, Session Laws of Hawaii 2020, demonstrated the State's commitment to increase access to early learning programs by charging the Executive Office on Early Learning and the Department of Human Services with ensuring all three and four-year olds have access to prekindergarten by 2032. However, access and affordability continue to be a significant barrier for Hawaii's families. Despite efforts to keep rates low, private early learning providers are operating on razor-thin margins. Presently, section 302L-1.7, HRS, authorizes the Executive Office on Early Learning to administer a pre-plus program through public-private partnerships for children from families with low-incomes on Department of Education public school campuses. The amendments to this section would amend the name of the pre-plus program to early learning program in order to expand access to affordable

early learning programs through privatepublic partnerships and broaden the program to be administered on other state properties besides the Department of Education public school campuses, opening more affordable opportunities for families to access an array of early learning programs. The amendments to sections 302A-1151.5, 302D-35, and 302L-7 amend the references to the preplus program to align with amendments made in section 302L-1.7, HRS.

Impact on the public: Expands access to the public to affordable early learning programs.

Impact on the department and other agencies: Agencies would have the ability to establish early learning programs on state properties and public lands in collaboration with the Executive Office on Early Learning.
