# Testimony in SUPPORT of SB3122 SD1 RELATING TO PUBLIC HEALTH STANDING ORDERS.

- 1 Fiscal Implications: N/A.
- 2 **Department Testimony:** The Department of Health (DOH) strongly supports SB3122, which is
- 3 part of the Govenor's Administrative Package.
- 4 DOH's goal is to encourage Hawaii's healthcare system to prioritize prevention by making
- 5 routine health screeings easier to access. Currently, the U.S. Preventive Services Task Force
- 6 recommends many secondary prevention interventions, i.e. tests that are routinely recommended
- 7 to screen for certain conditions in asymptomatic populations, and for which the Affordable Care
- 8 Act (P.L. 111-148) requires no patient copay or cost-share for most insurance coverage.
- 9 Examples include screenings for:
- Breast cancer for women aged 50 75 years;
- Lung cancer for adults 50 80 years with a history of smoking;
- Aortic aneurysm in men aged 65 75 years who have ever smoked; and
- Hepatitis C and HIV for most adults.
- To access these screenings today, a patient must schedule an office visit with their provider to
- receive an order, then schedule another appointment for the actual screening. SB3122 removes
- the need for the first doctor visit and allows the patient to self-refer for the screening test, saving

- time and money. Individuals with symptoms or diagnosed disease should receive care directly
- 2 from their provider. For example, this measure seeks to allow a woman who may have a full
- 3 time job, child care responsibilities, and perhaps transportation challenges to directly schedule
- 4 her screening mammogram. But a women who detected a lump would need to see her provider to
- 5 determine the appropriate diagnostic test.
- 6 This proposal requires good faith attempts to share results with the patient's provider, as well as
- 7 to the patient at an appropriate literacy level, similar to clinic visit summaries that have become
- 8 more prevalent.
- 9 The intent is to increase receipt of preventive care, advance population health, move routine care
- that can be moved out of the exam room, and create more time for providers to address
- individualized patient care.
- DOH recognizes the need to engage further with healthcare community stakeholders prior to
- beginning with the first and a single standing order, and that more discussions with stakeholders
- are necessary. However, the downstream benefits of easier access to healthcare, the greatly
- increased potential for catching illness such as cancer, an aneurysm, and various infections
- sooner, and increasing patient activitation and interest in their own health return significant value
- in time, money, and avoidance of suffering.

AlohaCare appreciates the opportunity to provide testimony in **support with comments** on **SB3122 SD1**. This measure authorizes the Director of the Department of Health to issue public health standing orders for patients who are 18 years or older to self-refer to evidence-based preventive health care screening services.

Founded in 1994 by Hawai'i's community health centers, AlohaCare is a community-rooted, non-profit health plan serving over 84,000 Medicaid and dual-eligible health plan members on all islands. Approximately 40 percent of our members are keiki. We are Hawai'i's only health plan exclusively dedicated to serving Medicaid and Medicaid-Medicare dually-eligible beneficiaries. Our mission is to serve individuals and communities in the true spirit of aloha by ensuring and advocating for access to quality, whole-person care for all.

AlohaCare is committed to improving access to care and strengthening the Medicaid program. As you may know, Medicaid enrollment in our State has grown by over 46% from 327,000 enrollees in March 2020 to 476,000 in January 2024. This tremendous growth has put a further strain on our State's already challenged provider capacity. We support this measure as one way to increase timely access to evidence-based clinical preventive care and screenings, while also relieving some of the burden faced by our existing provider workforce.

In addition to the United States Preventive Services Task Force recommendations, there are also other national organizations that issue evidence-based guidelines. However, the guidelines may vary slightly. For example, age ranges for testing or clinical parameters may differ, but the goal is the same evidence-based preventive services. We ask that you consider broadening the organizations from which the DOH Director may issue evidence-based preventive services beyond USPSTF and include "other nationally recognized professional academies and specialty organizations," such as the American Academy of Family Physicians, the American College of Obstetricians and Gynecologists, and the American College of Preventive Medicine.

As a parent, community member and healthcare professional I am writing in **strong support for SB 3122 SD1**, which authorizes the Director of Health to issue public health standing orders for patients to self-refer to certain health care screening services.

Public health standing orders empower both clinical and non-clinical staff to integrate evidence-based recommendations into the practice's workflow. Standing orders can focus on screenings, immunizations, labs, and point of care testing.

Standing orders improve access to included health care screening services, especially on the neighbor islands chronically impacted by provider shortages.

During the COVID-19 pandemic federal authorization (e.g., PREP) demonstrated how extending the scope of care provided by Hawai'i health professionals beyond their currently licensed limits, while within the spectrum of their professional training, helped protect the wellbeing of all of the people of our communities, including our kupuna and keiki.

Providing the Director of Health authorization to issue public health standing orders gives Hawai'i a local tool to quickly respond to unexpected/emerging health care needs.

I **strongly support SB 3122 SD1**, respectfully ask you to reject this bill.
