Chair DeCoite, Vice Chair Wakai and members of the Committee.

The Department of Business, Economic Development and Tourism (DBEDT) supports the sections of SB3265 which seeks to 1) establish a Hawai'i Film Advisory Council for the department and its film program, 2) increase the annual cap to \$60 million for the Hawai'i motion picture, digital media and film production income tax credit (HRS 235-17), 3) extend the sunset date of the tax credit to January 1, 2039, 4) reinstitute the requirement for an independent third-party certification for productions over \$1 million, 5) expand the definition of "qualified production" to include episodic series on streaming platforms, 6) provide a general excise tax exemption for certified development of film studio facilities and requests one full-time equivalent (1.0 FTE) film industry development liaison position within the Creative Industries Division of DBEDT.

We defer to the Office of the Attorney General on the sections related to the requirements and credits for native Hawaiian content and staffing incentives.

DBEDT recognizes the opportunity to advance the economic benefits of the film and media industries in our state. This measure, along with the Administration's SB3049 and HB2360 aligns with our collective commitment to advancing this industry cluster as a key economic driver for our state. Increasing the cap to \$60 million, extending the sunset date and adding an infrastructure credit component to advance facilities and studio development. These proposed amendments to HRS 235-17 are integral to

providing a stable, reliable tax credit program which drives workforce and infrastructure development.

As lead for creative jobs in the state under the UH Good Jobs Hawai'i program, DBEDT and its Creative Industries Division have partnered with industry and labor unions to ramp up training and certification through our community colleges this summer and fall. Along with community based economic development programs, this is crucial to increasing our local resident qualified workforce, not only for film but for theatrical and events jobs in our state.

The department priorities of increasing our workforce in film and related sectors, advancing purpose-built studio development, providing accountability in tax credit oversight and empowering local content creators and filmmakers through programs and investments from the Hawai'i Film and Creative Industries Development Fund (HRS 201-113) are necessary to strengthen and grow this vibrant sector of our economy.

We understand that there are concerns raised by the Department of the Attorney General regarding constitutionality of incentives specifically for one cultural community over another. The importance of the intent behind this proposed amendment to the film credit program is underscored by the needs for advancing native Hawaiian content development that elevates our indigenous community.

We will work with the Legislature and our Deputy Attorney General to find a balance in language which could allow for this aspect of the measure to be included.

The Department of Taxation ("Department") offers the following <u>comments</u> regarding S.B. 3265 for your consideration.

S.B 3265 proposes several statutory changes relating to film industry development, including creating a new a general excise tax (GET) exemption in chapter 237, Hawaii Revised Statutes (HRS), for certified development of film studio facilities, and amending provisions governing the motion picture, digital media, and film production income tax credit ("film credit") in section 235-17, HRS.

The bill's new GET exemption would be certified by the Department of Business, Economic Development, and Tourism (DBEDT), and would apply to the gross proceeds of a qualified person arising from the planning, design, construction, or retrofitting of film studio infrastructure in the State.

The bill's amendments to the film credit would extend the credit's sunset date from 2032 to 2038, increase the annual aggregate cap from \$50,000,000 to \$60,000,000, and require that any taxpayer with qualified production costs exceeding \$1,000,000 include

an independent third-party certification by a certified public accountant verifying their representations to DBEDT.

The bill would also eliminate the \$17,000,000 per-project cap for productions that are qualified and certified by DBEDT to meet the requirements of "Native Hawaiian content and staffing," with "Native Hawaiian content" meaning "a production that contains a minimum of fifty-one percent or more content of a film, media, or television project, and is written, directed, produced, and includes actors of Native Hawaiian descent." The bill also expands the film credit's definition of a "qualified production" to include productions on both broadcast and streaming platforms, with one "qualified production" constituting up to 22 episodes for broadcasting platforms and 8 episodes for streaming platforms.

S.B 3265 is effective July 1, 2024, with the measure's tax law changes applying to expenditures made after December 31, 2024.

The Department defers to DBEDT on its ability to certify the proposed exemption and the proposed changes to the film credit, particularly the credit's new definitions for "Native Hawaiian content" and "streaming platform, but requests that certification provisions be maintained for both. The Department does not have the subject-matter expertise or administrative capability to certify either the exemption or the credit.

The Department requests that the effective date of this measure be amended so that section 2 is effective January 1, 2025 and section 3 applies to expenditures made after December 31, 2024.

Chair DeCoite and Members of the Committee:

The Department of the Attorney General has concerns with this bill and provides the following comments.

This bill establishes the Hawaii Film Advisory Council; provides a tax exemption for certified development of film studio facilities; amends the motion picture, digital media, and film production income tax credit; establishes one full-time film industry development liaison position; and makes an appropriation. On page 8, lines 12-16, section 3 of the bill exempts "Native Hawaiian content and staffing" from the per qualified project cap of \$17,000,000 for the motion picture, digital media, and film production income tax credit established by section 235-17, Hawaii Revised Statutes, and on page 9, lines 12-15, defines "Native Hawaiian content" as "a production that contains a minimum of fifty-one percent or more content of a film, media, or television project, and is written, directed, produced, and includes actors of Native Hawaiian descent." This exemption is subject to challenge as violating the First Amendment of the United States Constitution because the government may not regulate speech based on its substantive content or the message it conveys. See Rosenberger v. Rector & Visitors of Univ. of Virginia, 515 U.S. 819, 828 (1995). Additionally, the exemption could be subject to First Amendment challenge because "[i]n the realm of private speech or expression, government regulation may not favor one speaker over another." Id.

We note that these provisions are also subject to an additional challenge under the Equal Protection clauses of article I, section 5, of the Hawaii Constitution and the Fourteenth Amendment of the United States Constitution for treating one race differently than another. The bill requires Native Hawaiians or those of Native Hawaiian descent to constitute the membership of the sub-committee of the Hawaii Film Advisory Council, which has the sole purpose of making recommendations on "tax credit qualifications for Native Hawaiian cultural content requirements," and to be part of the writing, directing, production, and acting on a production for the production to qualify for the exemption to the \$17 million per project cap to the motion picture, digital media, and film production income tax credit. Page 3, lines 11-15; page 6, lines 12-15. These are racial classifications, and the provisions are therefore subject to an equal-protection challenge. *Miller v. Johnson*, 515 U.S. 900, 904 (1995) (the "central mandate" of the Equal Protection Clause is "racial neutrality in governmental decisionmaking").

To address these serious constitutional concerns, we recommend deleting the exemption to the per project cap for Native Hawaiian content and staffing on page 8, lines 12-16, and the definition of "Native Hawaiian content" on page 9, lines 12-15. We also recommend deleting section 201- (e) on page 3, lines 11-15, concerning the subcommittee of the Hawaii Film Advisory Council, which has both a membership and mandate that is subject to constitutional challenge.

SB 3265 – RELATING TO FILM INDUSTRY DEVELOPMENT

Chair DeCoite, Vice Chair Wakai, and Members of the Committee:

The University of Hawai'i (UH) supports SB 3265 that aims to diversify our economy, increase workforce development, grow our successful production industry, and keep our graduates in the islands with living wage jobs.

Independent economists Professor Emeritus James Mak and Sumner LaCroix of UHERO have previously written on the role of the Hawai'i TV/film/digital production tax credit in diversifying the Hawai'i economy. According to their research, since the passage of the Act 88 film credit in 2006, spending in Hawai'i on TV/film productions has soared, with inflation-adjusted spending increasing by 116 percent between 2007 (\$164.5 million) and 2019 (\$355.6 million).

This is much larger than the overall increase in Hawai'i real gross domestic product over the same period, a modest 17 percent. Before Act 88, Hawai'i never saw more than \$100 million in production per year. Since then, our industry has climbed to a DBEDT reported average of \$396 million dollars in direct spend per annum.

In 2022, the latest figures from DBEDT, the total Hawai'i film production direct spend was \$420.04 million (includes qualified tax credit spend and non-tax credit spend). The breakdown by island is as follows:

O'ahu: \$354.88 million

Hawai'i County: \$39.32 million Kaua'i County: \$12.56 million Maui County: \$13.28 million

With Hawai'i household income generated at \$168.02 million and tax revenue generation of \$45.36 million, DBEDT estimates the total economic impact from film production on our economy at an impressive \$726.68 million.

As with all industries, growth depends on three factors: workforce development, physical infrastructure and incentives.

Workforce development has been accomplished in part by the statewide expansion of the Academy for Creative Media System (ACM System) which has developed or enhanced educational programs across the entire UH System. Thanks to the Legislature, several governors, UH alumni, the production industry, supporters in the community, and students and faculty across the islands, ACM is now celebrating our 20th year.

SB 3265 aids in both incentivising production in the islands and the building of much needed physical infrastructure. SB 3265 will help ensure that our graduates remain in the islands with their families through living wage jobs.

Chair DeCoite and Members of the Committee,

I am writing on behalf of the Hawai'i Lodging & Tourism Association, the oldest and largest private sector tourism organization in the state, to express our **support for SB3265 related to Film Industry Development.**

This measure aims to establish the Hawai'i Film Advisory Council, and enhance the motion picture, digital media, and film production income tax credit by increasing the annual cap to \$60,000,000. It also seeks to extend the sunset date of the tax credit to January 1, 2039, refine the requirement for an independent third-party certification, and expand the definition of "qualified production" to include streaming platforms. Additionally, the bill introduces a tax exemption for certified development of film studio facilities and proposes the creation of a full-time equivalent (1.0 FTE) film industry development liaison within the Creative Industries Division of the Department of Business, Economic Development, and Tourism.

Film and television production have long been integral to our state's economy, fostering a collaborative relationship with our largest private sector industry: tourism. This symbiotic connection contributes significantly to our visitor industry product, with production participants supporting local businesses by patronizing hotels, retail stores, and restaurants. Elevating the motion picture, digital media, and film production income tax credit annual cap to \$60,000,000 will incentivize film makers to create and showcase work in our beautiful islands, thereby boosting exposure and infusing vital funds into our economy.

The establishment of the Hawai'i Film Advisory Council, comprised of 13 members with professional experience in the film and entertainment sector, is a commendable step towards ensuring comprehensive representation and expertise within the industry. The provision for a subcommittee of Native Hawaiian members further underscores the preservation and promotion of Hawai'i's unique cultural heritage.

SB3265 also recognizes the need for effective communication between the government and the film industry by proposing a full-time Film Industry Development Liaison within the Department of Business, Economic Development & Tourism's Creative Industries Division. This position is anticipated to play a pivotal role in streamlining processes and providing essential support, emphasizing a commitment to understanding the distinctive needs of our local film industry.

The bill's encouragement of development for certified film studio facilities through a tax exemption aligns with efforts at the county level, as seen in legislation before the Honolulu City Council. While the State of Hawai'i currently has a sole film studio near Diamond Head, facilitating the construction of film facilities through financial incentives will enhance our production infrastructure and further attract filmmakers and TV productions to Hawai'i.

Passing SB3265 would send a clear message to the film and media industry that Hawai'i welcomes them to our islands. We wholeheartedly urge you to support and pass this measure.

RE: SB3265 Relating to Film Industry Development

My name is Kiran Polk, and I am the Executive Director of the Kapolei Chamber of Commerce. The Kapolei Chamber is an advocate for businesses in the Kapolei region which includes Waipahu to Ka'ena Point. The Chamber works on behalf of its members and the entire business community to improve the regional and state economic climate and help Kapolei businesses thrive. We are a member- driven, member-supported organization representing the interests of all types of business: small, medium or large, for profit or non-profit businesses or sole proprietorship.

The Kapolei Chamber is in <u>support of HB3265</u> that establishes the Hawaii Film Advisory Council, amends the motion picture, digital media, and film production income tax credit to increase the annual cap to \$60,000,000 and extends the sunset date of the tax credit to January 1, 2039. It also clarifies and amends the requirement for an independent third-party certification and expands the definition of "qualified production" to include streaming platforms. It also provides a tax exemption for certified development of film studio facilities and establishes one full-time equivalent (1.0 FTE) film industry development liaison within the Creative Industries Division of the Department of Business, Economic Development, and Tourism. There is a declaration that the general fund expenditure ceiling is exceeded, and makes an appropriation.

The Kapolei Chamber of Commerce has prioritized the effort to support the establishment of a film studio in West O'ahu. One of the priorities of the Business Revitalization Task Force is to "Advocate for job growth in digital media, film production and technology industries in West O'ahu."

This measure will provide the needed incentives to grow a billion-dollar industry here in Hawai'i.

According to the Motion Picture Association, the film and television industry is directly responsible for more than 3,630 jobs in the Islands, which includes more than \$192 million in wages statewide. Hawai'i's Motion Picture, Digital Media and Film Production Income Tax Credit production reports data indicates that local hires are at 80% on average, if not higher.

A film studio would only bring revenue into O'ahu county, it will provide an opportunity for our students to stay here in Hawai'i making a living wage and provide an opportunity for Hawai'i residents to return home. **There are opportunities to employ Hawai'i people across a range of sectors, from construction, catering, costuming, camera, post-production, and beyond.** We also believe that West O'ahu provides the ideal location for a film studio, with the University of Hawai'i – West O'ahu's Academy of Creative Media establishing just a couple of years ago. The measure also supports providing internships for our future workforce which is also essential to grow this industry.

More jobs, specifically living wage, professional jobs are needed on the west side to keep pace with the population growth in West O'ahu. Decades ago, the City and County of Honolulu adopted a goal of creating a "Second City" and moving residential and economic growth toward West O'ahu. West O'ahu's growing population of almost 200,000 includes the Wai'anae Coast, 'Ewa, and Waipahu. In Kapolei and 'Ewa alone households are expected to exceed 56,000 by the year 2035 and over the next 30 years the population in Kapolei and 'Ewa will increase by 40 percent and housing by 52 percent.

We believe incentives for job growth, especially in West O`ahu are warranted and needed. We also specifically support job growth in film production on the west side including the incentives so greatly needed to support the effort.

Exemption; Motion Picture, Digital Media, and Film Production Income Tax Credit

BILL NUMBER: SB 3265

INTRODUCED BY: DECOITE, AQUINO, CHANG, LEE, MCKELVEY, SAN

BUENAVENTURA, SHIMABUKURO, Wakai

EXECUTIVE SUMMARY: Establishes a Hawai'i Film Advisory Council within DBEDT. Provides a general excise tax exemption for the gross proceeds arising from certified development of film studio facilities.

Amends the motion picture, digital media, and film production income tax credit to increase the annual cap to \$60,000,000; extend the sunset date of the tax credit to January 1, 2039; clarify and amend the requirement for an independent third-party certification; and expand the definition of "qualified production" to include streaming platforms.

SYNOPSIS: Our analysis will be limited to the sections of the bill involving taxation.

GET Exemption for Certified Development of Film Studio Facilities

Adds a new section to chapter 237, HRS, that adds an exemption for gross proceeds of a qualified person arising from the planning, design, construction, or retrofitting of film studio infrastructure in Hawaii. Prequalification for the exemption must be made with DBEDT. Exemption shall not apply to gross proceeds "received" after December 31, 2034.

Defines "film studio infrastructure" to include: 1) new or retrofit construction of structures to accommodate soundstages, 2) permanent space primarily used for production including catering and laundry facilities, editing suites, galleries, screening and control rooms and 3) facilities that are used for production purposes that may include dining and food prep, office accommodations for production personnel and departments, prop and vehicle parking and related storage, sustainable alternative energy sources; security facilities and infrastructure.

Defines a "qualified person" for this purpose as an individual, partnership, joint venture, corporation, association, limited liability partnership, limited liability company, business, trust, or any organized group of persons or legal entities, or any combination thereof, that possesses all professional or vocational licenses necessary to do business in the State in conjunction with the planning, design, construction, or retrofitting of film studio infrastructure.

Amendments to Income Tax Credit for Productions

Amends HRS section 235-17(h), to require an independent third party certification performed by a qualified certified public accountant if qualified production costs of a taxpayer exceed \$1,000,000 in a taxable year. The certification is to be submitted to DBEDT with the section

235-17(h) identification statement and shall verify all representations made for purposes of claiming the credit.

Amends HRS section 237-17(n) to increase the tax credits allowed in any particular year from \$50 million to \$60 million and extends the availability of credits from 12-31-2032 to 12-31-2038.

Adds to HRS section 237-17(n) an exception to the sec 235-17(l) \$17 million per project cap for productions meeting the DBET certification requirements of Native Hawaiian content and staffing.

Adds to HRS section 237-17(o) a definition for "Native Hawaiian Content" and includes broadcast and streaming platforms as Qualified Productions.

Adds amendments to exclude the Film Industry Development Liaison as a civil service position and appropriating \$130,000 out of the general revenues for the fiscal year 2024-2025 to establish one FTE position.

EFFECTIVE DATE: July 1, 2024, with sections 2 (relating to GET exemption) and 5 (credit certification requirements) applicable to expenditures made after December 31, 2024.

STAFF COMMENTS:

GET Exemption for Certified Development of Film Studio Facilities

Rather than handing out a GET exemption for persons planning, designing, constructing or retrofitting film infrastructure, be it a studio or ancillary facilities used for production purposes, consideration should be given to appropriating a specific sum of money and issue requests for proposals to build such a project and see which bidder would come forward with the best proposal. This way each bidder could be evaluated as to what they have to offer and what benefit the state would get. Based on the responses to the request, a careful review done by experts in the field could be made and the best proposal selected. The persons responsible for making the final selection would then be held accountable for their selection and provide the justification for the selection. Another alternative would be the use of special purpose revenue bonds. These alternatives would be far more efficient and transparent than the GET exemption proposed by this measure.

Merely handing out a GET exemption to entice an economic activity is the "easy way" out for lawmakers. To really ensure the success of this incentive, it will take creative thinking and hard work. An appropriation of funds, perhaps the issuance of special purpose revenue bonds, a joint venture, contributions of land or acceleration of the permitting process are but a few ways government could incentivize such a project without spending one cent of cold hard cash. If, in fact, lawmakers believe infrastructure to be critical to the development of the film industry, then lawmakers need to take a more active role as opposed to sitting back and granting selected exemptions to drive the activity.

Apparently, the tax burden is perceived to be enough of a drag on the film industry that they are now seeking an exemption to reduce its infrastructure costs. If this exemption is passed, we can expect to hear from other industries wanting the same treatment to help reduce their investments in infrastructure.

A concern to be addressed is how much additional assistance is needed for the film industry. A review should be made to avoid possible overlapping benefits; as an example, with the proposed GET exemption for "set design"; and with "costs of set construction" as a qualified production costs for the film production income tax credit.

Amendments to Income Tax Credit for Productions

The production credit in HRS section 235-17 was enacted as Act 107, SLH 1997, as a percentage of the costs incurred in the State in the production of motion picture or television films. As enacted, the credit was 4% of regular production costs plus 6% of transient accommodations, mirroring the GET and TAT rates at the time. Act 156, SLH 1988, raised the TAT credit to 7.25% while also raising the TAT rate to 7.25%.

After a period where this credit took a back seat to the qualified high tech business program enacted by Act 221, SLH 2001, this credit was next amended by Act 88, SLH 2006, which added credits for digital media and replaced the GET and TAT bifurcation with a unified credit of 15% of qualified production costs incurred in the C&C of Honolulu and 20% in any other county. The act added a per-production cap of \$8 million and sunset the credit on Jan. 1, 2016.

Act 89, SLH 2013, changed the credit percentages to 20% in Honolulu and 25% in any other county; raised the per-production limit to \$15 million; and extended the sunset date to Jan. 1, 2019.

Act 143, SLH 2017, extended the sunset date for the credit to Jan. 1, 2026, and first imposed an aggregate cap of \$35 million. Act 275, SLH 2019, raised the aggregate cap to \$50 million.

Act 217, SLH 2022, increased the credit percentages to 22% in Honolulu and 27% in any other county and extended the sunset date to January 1, 2033.

This bill yet again is proposing an increase to the aggregate credit cap from \$50 million to \$60 million and extending the sunset date for another 5 years to January 1, 2039.

We in Hawaii have had our production credit since 1997, so it's been more than twenty years. Have there been any studies about what the program has done for Hawaii's economy or Hawaii's tax revenue? None were cited to the Legislature when the Hawaii production tax credit was increased in 2013. Maybe we don't care as much about the hard dollars as we do about other intangible effects like local jobs, the development of a skilled workforce, or robust media education programs that simply weren't around at the turn of the century. Even if so, lawmakers

should have data on these intangibles, and other cost-benefit information, so they can make rational decisions on this matter.

Certainly, the film industry promises increased opportunities. Some of them certainly have materialized. But chasing these opportunities needs to be balanced against the cold hard reality of solving the problems at hand. Lawmakers need to ask whether production tax credits create sustainable economic development. It's well known that most productions shoot for a while and then wrap; the crew that supports the production then jumps to the next one. A case may be made for the production credits if they keep the productions rolling in and contributing to the economy. But the people need to see that case to justify continued redirection of resources to these credits while those resources could instead lower the overall tax burden not only for families but for the businesses that provide long-term employment for Hawaii's people.

There is also a constitutional issue. The cap on credits in this bill does not apply to a Native Hawaiian production that contains a minimum of fifty-one percent or more content of a film, media, or television project, and is written, directed, produced, and includes actors of Native Hawaiian descent. This distinction could be unconstitutional under the Commerce Clause of the U.S. Constitution because the same preferential tax treatment is not allowed for competing productions from other States. *In re Hawaiian Flour Mills, Inc.*, 76 Haw. 1, 868 P.2d 419 (1994); *Bacchus Imports, Inc. v. Dias*, 468 U.S. 263 (1984); Hawaii Tax Information Release No. 93-4. In Hawaiian Flour Mills, the Hawaii Supreme Court determined that a general excise tax exclusion for locally grown, raised, or caught agricultural, meat, or fish products for consumption out-of-state violated the Commerce Clause of the United States Constitution. The Court found that appellant Hawaiian Flour Mills, Inc. was entitled to the exemption from the general excise tax on its sales of fresh food products to be consumed out-of-State by persons engaged in interstate or foreign commerce, whether or not the fresh food products were locally grown, raised, or caught.

The Tax Foundation has no comments on establishing a Hawaii film advisory council nor the FTE position for the film industry development liaison.

I am a filmmaker born and raised in Honolulu, Hawai'i, now living in Los Angeles, who comes home to make independent films. Over the past ten years, I have produced, directed, and written two feature films, AUGUST AT AKIKO'S and I WAS A SIMPLE MAN, along with numerous short films, which have gone on to play all over the world to critical acclaim. My second feature film, the independently produced, award winning I WAS A SIMPLE MAN, which premiered at the Sundance Film Festival, was a recipient of the tax credit. This film is a personal story, one based on the local stories of my family, and was a labor of love. We were so elated for the film to go on to have the impact that it did: wonderful reviews, threatrical distribution, streaming distribution, and recognized on a number of best of lists in 2021, including in the prestigious New Yorker Magazine. This locally made film would have not been possible if it were not for the tax credit. Making independent, grassroots films in Hawai'i is extremely hard, especially on a budget, and so we needed all the help that we could get. Looking forward, I now have two independent films in development, both with high profile collaborators, and we will be hoping once again to get the help of the tax credit in order for us to be able to make our work and provide an alternative to the typical studio fare that shoots in the islands. Our local independent filmmaking community is young, and it is VIBRANT, and one of the most exciting filmmaking communities in the country. Many, many important, local films will be produced in the coming decade, and it is essential that we as a community fully support this work. Not only does independent work provide a vital cultural alternative to the commercial films, highlighting voices previously unrecognized, but it is also an extremently important training ground for filmmakers who will inevitably go on to to bigger work and continue to bring productions to the islands. The last thing that I would want is for the all of these tax credit funds to go only to studio, corporate entities, and so the establishment of the panel is a heartening step and I hope that the panel will see the necessity of making sure that our local filmmakers are getting all the support that they need. This will pay off in many ways down the line.
