SENATE BILL NO. 3365, SD2 RELATING TO PLANT CARE COMPONENTS

Chair Gates, Vice Chair Kahaloa and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill 3365, SD2 which requires the Department of Agriculture (Department) to certify treatments performed on wood chips, compost, and filter socks; and places certain restrictions on the distribution or transportation of plant care components without prior treatment certification from the Department.

The Department strongly supports this bill and recognizes that amendments offered in testimony on the previous draft of this bill have been incorporated into this version of the bill. However, in section (b), the term "entering the State" appears to conflict with HRS 150A-5(9) as a commodity is not considered to have "entered the State" until it has been inspected and passed. Treatments for pests either occur prior to entry into the State, or if required upon entry due to a pest infestation, the shipment is placed under guarantine until the treatment can occur and an inspector can verify that



the treatment was sufficient to eradicate the pest. The Department suggests the following language for section (b): "No person shall distribute within the State any plant care component that originated from outside the State unless treated prior to entering the State. Any plant care component that originated from outside the State and not subjected to a treatment prior to entering the State shall be placed in quarantine until subjected to a treatment witnessed and certified by the Department." This bill will provide the Department with another way to protect the State against invasive species.
