- 2 **Department Testimony:** The Office of Health Care Assurance (OHCA) provides the following
- 3 comments.

4 The intent of this concurrent resolution is to request flexibility to dietitians who practice in a hospital setting to assist physicians with diet assessment, order, and monitoring. This 5 6 measure recommends amendments to Title 11, Chapter 83, Hawaii Administrative Rules, regarding dietitian licensure from "qualified dietitian" to "licensed dietitian," essentially making 7 8 licensure mandatory for dietitians who practice dietetics in hospitals in the State of Hawaii. The Department understands the additional flexibility that this recommendation may 9 provide to dietitians in the hospital setting. Since almost all hospitals require their dietitians to 10 11 be licensed for insurance billing purposes, there should not be a significant influx of dietitian license applications, and the extra burden on DOH is likely to be minimal. There are currently 12 two hundred and forty six (246) licensed registered dietitians in the State of Hawaii. Licensure, 13 at the moment, is required by some facilities in their policies, or could be required by insurance 14 companies for billing. 15
