#### TESTIMONY TO THE HOUSE COMMITTEE ON HEALTH & HOMELESSNESS

House Bill 131 – Relating to Advisory Committees

The Disability and Communication Access Board (DCAB) supports the intent of House Bill 131 – Relating to Advisory Committees.

House Bill 131 would rename the "statewide voters with special needs advisory committee" to "statewide elections accessibility needs advisory committee" and rename the "county voters with special needs advisory committee" to "county elections accessibility needs advisory committee." The advisory committee's revised name would be more consistent with the advisory committee's purpose to ensure people with disabilities have equal and independent access to voter registration, casting of ballots, and all other Office of Elections services. Also, language is the basis of thoughts and attitudes about people with disabilities. Terminology continually evolves. Staying current is important, not to show political correctness, but to communicate effectively and appropriately on the subject of disability. Without being aware of what is current and appropriate language, a person may inadvertently offend another person or convey a message that they did not intend to convey. Terminology, such as "special" or "people with special needs," may be intended to be a positive alternative but may be perceived as patronizing and distancing by people with disabilities.

House Bill 131 would replace "physical disability" with "disability," thereby recognizing that voting accessibility needs may arise from disabilities other than those of a physical nature. Under the Americans with Disabilities Act (ADA), "Disability means, with respect to an individual: (i) A physical or mental impairment that substantially limits one or more of the major life activities of such individual; (ii) A record of such an impairment; or (iii) Being regarded as having such an impairment as described in paragraph (f) of this section." The ADA specifies that "Physical or mental impairment includes, but is not limited to, contagious and noncontagious diseases and conditions such as the following: orthopedic, visual, speech and hearing impairments, and cerebral palsy, epilepsy, muscular dystrophy, multiple sclerosis, cancer, heart disease, diabetes, intellectual disability, emotional illness, dyslexia and other specific learning disabilities, Attention Deficit Hyperactivity Disorder, Human Immunodeficiency Virus infection (whether symptomatic or asymptomatic), tuberculosis, drug addiction, and alcoholism."

To: The Hawaii House Committee on Health and Homelessness

Chairman Au Belatti, Vice Chair Takenouchi, and Committee Members:

I very strongly support HB 131 on behalf of the Statewide Voters with Special Needs Advisory Committee. The purpose of HB 131 is to: 1) change the name of the Statewide Voters with Special Needs Advisory Committee to the Statewide Elections Accessibility Needs Advisory Committee; 2) change the name of parallel county committees to County Elections Accessibility Advisory Committee(s); and 3) delete the reference to "physical" disability in the text of the legislation. These changes to the statute establishing Hawaii state advisory committees were recommended by the Statewide Voters with Special Needs Advisory Committee, supported by the County of Honolulu Voters with Special Needs Advisory Committee, and shared with the Hawaii Office of Elections, which then brought these technical amendments to the attention of the Committee on Health and Homelessness. We greatly appreciate everyone's interest, attention, support, and quick action.

These technical amendments will clarify the purpose of the committee in its title and the scope of voters or potential voters who will benefit from committee actions. The term "voters with special needs" in the title in the current law is too general and vague. Its replacement with "elections accessibility needs" is directly tied to the committee's purpose – identifying barriers to access to any part of the election process from registration to voting for Hawaii voters with disabilities and recommending ways to remove such barriers to the Office of Elections and the Legislature. The deletion of the reference to "physical disabilities" ensures that the committee's work related to barriers and recommendations will be inclusive of all voters with disabilities, not just those with physical disabilities.

We respectfully request that the Committee on Health and Homelessness also include in HB 131 a technical amendment to change any reference to "voters with special needs" in Hawaiian law to "voters with accessibility needs associated with the voting process" to make all relevant Hawaiian statutory text consistent with the amendments currently in HB 131.

The Statewide Voters with Special Needs Advisory Committee is currently conducting a statewide survey of voters with disabilities. We anticipate using survey results in 2023 to establish focus groups to guide recommendations for the Office of Elections and the Legislature.

SUBJECT: HB131 RELATING TO ADVISORY COMMITTEES.

The Hawaii State Council on Developmental Disabilities **SUPPORTS HB131**, which renames the statewide and county-level voters with special needs advisory committees to elections accessibility needs advisory committees. Recognizes that voting accessibility needs may arise from disabilities other than those of a physical nature.

Clarifying the language of the committee will ensure that it is clear and purposeful; the title of "Elections Accessibility Needs" directly ties to committee purpose, while reducing any likelihood the term "Special Needs" will be interpreted as stigmatizing or otherwise derogatory towards the disability community. Acknowledging that barriers to voting can also stem from non-physical disabilities will ensure that the committee can ensure systems are as accessible as possible to all people, including those will Intellectual/Developmental Disability who have no physical disability but still find voting significantly unattainable.

Testimony of James Gashel Committee on Health and Homelessness (HLT)) Hawaii State House of Representatives Thirty-second legislature, regular session of 2023 February 15, 2023, 8:30 AM, hearing on HB131

Good morning chair, vice chair, and members. I am James Gashel, testifying today to support HB131.

This bill will change the name of the Statewide Voters with Special Needs Advisory Committee to the Statewide Elections Accessibility Advisory Committee. The proposed name change would also apply to county level advisory committees having the same mission. These committees were established in legislation passed in 2021 as part of SB548, making several election law changes. I currently serve on the statewide committee.

Our committee proposed and voted unanimously for this name change. The term, "special needs," has been used in the election laws basically to refer to people with disabilities who may need some form of accommodation to participate. According to the Americans with Disabilities Act, disability is a "normal part of the human experience." Accommodations, which may be needed by people with disabilities are best understood as "normal," not "special." We may use different techniques and technology to register to vote and cast a ballot, but there is nothing special or unusual about our participation. It's really all about having access to participate.

Aside from the above, I want to associate myself with the testimony of PATRICIA MORRISSEY, chair of the statewide committee. We also suggest replacing the term "special needs," with "disability access needs," wherever applicable in the law. Section HRS 11-107(c), regarding electronic transmission of ballots, is one example of where "special" should be changed to "disability access, but I'm sure there are others."

Replacing "special" with "disability access" will help to avoid confusion with the terminology in the future. Also, Ms. Morrissey points out that the term, "physical," as applied to "disability" in the existing law is too limiting, and I agree.

Mahalo for considering the changes requested here and for your efforts on behalf of our accessibility needs.
