The HPD supports House Bill No. 145, Relating to Fireworks. This bill will impose a statewide limitation on consumer fireworks, except by permit for cultural events.

Chair Tarnas, Vice-Chair Takayama and members of the House Committee on Judiciary and Hawaiian Affairs, the Department of the Prosecuting Attorney, City and County of Honolulu ("Department"), submits the following testimony in <u>support</u> of H.B. 145.

The purpose of this bill is to discontinue the use of consumer fireworks, aside from cultural practices between 9:00 a.m. and 9:00 p.m. and any licensed professional use of fireworks.

For years, Oahu residents have seen and heard evidence of illegal fireworks being set off at seemingly every street corner and public park on the island. Residents have become accustomed to the skies being lit up like a battlefield by illegal aerial devices, not only for New Year's Eve and Fourth of July, but for weeks before and after those special occasions. In recent years, many communities have been forced to endure an endless barrage of fireworks year-round. Concerns about the incessant noise of these illegal fireworks; their effects on respiratory health and air quality; and effects on those with post-traumatic stress disorder, are further heightened by the fact that national and local statistics have also shown a rise in firework related injuries.¹

While a "ban" on consumer fireworks would certainly not be expected to stop the importation or use of illegal fireworks altogether, in and of itself, the Department does believe that this type of statutory change is a critical component to getting the problem under control. The Department applauds the introducer of H.B. 145 for this bold proposition, and stands ready to do its part in enforcing any relevant measures passed by the Legislature.

For all of the foregoing reasons, the Department of the Prosecuting Attorney of the City and County of Honolulu **<u>supports</u>** the passage of H.B. 145. Thank you for the opportunity to testify on this matter.

American Promotional Events, Inc. **opposes** House Bill 145 which imposes a statewide limitation on consumer fireworks, except by permit for cultural events.

While we understand the intent of this measure, we do not believe it will achieve the desired outcome. In 2010, the Honolulu City Council banned nearly all consumer fireworks on Oahu and since that time, consumers have obtained fireworks through the black market.

As it's been reported and observed over the past decade, the proliferation of illegal aerial devices is at an all-time high. Legislation aimed at strengthening enforcement and penalties for the use of illegal aerial devices has not proved successful. With the ban on Oahu proving to be unsuccessful and producing unintended consequences, a similar statewide ban would net the same negative results.

Instead of driving consumers to the black market, a safer alternative should be available. New York, New Jersey, Arizona, Delaware and others have modified their ban on consumer fireworks and allow the sale of consumer fireworks such as fountains and ground spinners, which produce significantly less smoke and noise. Currently, fireworks are allowed in 49 states plus the District of Columbia and Puerto Rico. Hawaii consumers are enamored with fireworks and have a long history of fireworks being an integral part of New Years and July 4th family celebrations.

Aloha Chair, Vice-Chair and Members of the Committee,

Thank you for allowing me to submit testimony on behalf of Phantom Fireworks in **OPPOSITION** to House Bill 145 – Relating to Fireworks. House Bill 145 seeks to ban all fireworks, including consumer fireworks, except by permit for cultural events. Although Phantom Fireworks supports the intent of the bill to control the spread of illegal fireworks, this bill would not achieve such purpose.

Consumer fireworks are an important part of Hawaii's local culture. In addition to ethnic cultural events such as Chinese Lunar New Year or festivals with dragon dances, locals enjoy celebrating with fireworks on other occasions. In fact, the largest use of consumer fireworks is during New Year's Day and 4th of July celebrations. A statewide ban would not prevent the illegal fireworks from continuing to be sold but would encourage the illegal sale as has continued since Honolulu's ban in 2010. The better approach would be to provide better regulation and increase the enforcement of current laws, including fireworks sales outside of the allowed time periods.

Simply put, the outright ban of all fireworks during the most popular fireworks periods would not serve to address the sale and use of illegal fireworks. We appreciate the willingness of the legislature to tackle the issue of illegal fireworks, and we are thankful to be able to continue to work with the many Representatives and Senators who are committed to finding the appropriate solution. For these reasons, we urge the committee to defer House Bill 145.

Aloha Chair Tarnas and members of the committee,

Poi Dogs & Popoki (PDP) is a nonprofit animal welfare organization with a mission to help people and their pets. We are in strong support of HB 145.

The suggestion by some that fireworks is part of our culture or tradition in Hawaii is a misnomer. The ugly reality is that it is only the past 15 to 20 years that the proliferation of illegal fireworks has caused our communities so much terror and trauma. Our ohana – born and raised in Papakolea on Hawaiian homestead – did NOT grow up with illegal fireworks like aerials. We respected our neighbors. Ignited firecrackers ONLY on New Years Eve. Cleaned up the entire street the next morning. And enjoyed the rest of the year without concern. As Hawaiians, we celebrated the 4th of July with our ohana from our homestead in Papakolea - watching the professional fireworks show at Ala Moana Beach Park.

Because of the lack of respect by people who have decided that EVERY DAY is worthy of a NYE celebration – be it a football game, MMA fight, or first birthday luau, it is time to say aloha to consumer fireworks. The few have ruined it for the many. Those of us with pets, or kupuna, or ohana with PTSD.....we have not been able to enjoy NYE for years. But the months leading up to NYE is out of control. First it was Thanksgiving. Then Halloween. Now – for no reason – the bombs start in early October. Every weekend. With no notice. My rescue dogs – so terrified and traumatized – sadly fight each other as they run in fear. Since 2016, three of my dogs have died as a result of unanticipated bombs which I could not properly prepare for. For one dog, I spent \$12,000 trying to save him. I took out a line of credit on my home to pay for his emergency surgery. He died 5 days later. Over the years, I have spent more than \$25,000 in veterinary care for pets affected by illegal fireworks.

People dying. Properties damaged. All in the name of entertainment? Its time for a ban. Please pass HB 145. Aloha to fireworks. And aloha to getting our lives back.

The Kaua`i Humane Society (KHS) supports House Bill 145 and the campaign to limit the use of consumer fireworks. Fireworks can cause extreme stress in animals, domestic and wild. The bright lights, strong odor, and harsh sounds can be terrifying. Humane societies, everywhere, prepare on an annual basis for an influx of animals entering their facilities after the fourth of July and New Year's Eve. Pets are more sensitive than their owners to the lights, smells, and sounds causing many to try to escape their homes out of fear and confusion, resulting in multiple lost animals, an increase in animal-vehicle collisions, and distraught pet owners. The stress of the experience can also weaken a pet's immune system resulting in disease.

Wildlife responds in a similar manner abandoning their nests or homes in hopes of escaping the explosions. Birds have been reported to fly for longer, attempting to escape, exhausting themselves beyond recovery while also being exposed to the harmful chemicals in fireworks while flying. The remains of fireworks are also harmful. The materials can pollute the homes of our land and sea animals as well as be toxic when consumed or fed to young.

Though fireworks can be an exciting experience, it is not worth the trauma and terror it causes to pets, wildlife, and residents. We urge you to pass House Bill 145. Thank you for considering our testimony.

Comments:

I am writing in regards to the huge amount of illegal fireworks and bombs that are set off every Fourth of July and New Year's Eve. I might also add that the bombs are not limited to those two holidays, but continue intermittently throughout the year. Not only do they startle and disturb humans, but the adverse effect on companion animals, pastured animals, and wildlife is unconscionable, not to mention sometimes deadly.

I cannot accept that there is nothing that can be done. I do understand that it is currently difficult to examine every shipping container that reaches Hawai'i, but perhaps it is time to fund and staff such an endeavor. Not only would illegal fireworks and related supplies be stopped or at least decreased, but drugs could also be targeted as well as any other illegal items.

Portions of legal fireworks sales could be set aside to partially fund such an endeavor. Fines from citations could also be used.

Perhaps incentivizing reporting illegal activity anonymously would help to make a dent. Drones? Increased patrols in neighborhoods where such activity is rampant?

I live in Kapahi, and the bombs and aerials were unbelievable, with seemingly more each year. This is a common complaint from my friends and relatives who live not only on Kaua'i, but also on O'ahu. My elderly 14 year old dog would jerk spasmodically when a bomb exploded, my younger dog paced and barked and was more clingy than usual, despite having had calming supplements. My three cats would sometimes run and look back at me, hiding under the bed or moving about restlessly. I ran an air purifier and a fan and closed windows, which of course did nothing to mitigate the noise.

Here are comments that others have shared, primarily animal related:

Three dogs were affected "all night."

The kitchen was "hazy" from the smoke.

Geriatric cat "is pacing around and looking at windows." Other cats were going "into cupboards with the pots."

Dog was "a mess last night. I gave a second dose 4 hours after first dose and nothing would calm him down. He was shaking so bad." "I felt so bad for him." We had to hold him but that still didn't help."

Dog "was shaking most of the night...in my arms...I had my hand over her ears most of the night."

Senior dog: "It's like he gave a sigh of relief this morning. Even with all meds, he was panting and pacing. Noisiest New Year's ever! So glad it's over, even though I'm sure we'll still hear the occasional bombs." "Dog was breathing so heavily, it was like he was gonna have a heart attack. We were so relieved when he survived the night!"

Dog "majorly stressed. We are in the laundry room just try and keep it quiet." Dog "got anxiety."

Dog "is trying to hide under my legs."

Dog "was quite jittery especially with the bombs. Had to be held or nestled right next to husband or me."

Dog "was traumatized." "He stayed on couch all night and didn't want to go potty in the dark. The next night seemed like he was afraid of the dark!"

Dog is "usually unaffected but they were so exceptionally loud, she was a nervous wreck."

Multiply this by the thousands of pet owners AND consider the many pets who disappeared once the fireworks started. FaceBook pages and animal groups have many reports of disrupted lives and lost pets, including injured and dead animals.
